Regional Summary:

- COVID-19 cases
 - Guam has reported 8,477 total cases and 142 deaths with 46 new cases and 1 new death reported this week
 - CNMI has reported 187 total cases and 2 deaths with 2 new cases (both imported) and 0 new deaths reported this week
 - American Samoa, FSM, Palau, and RMI have had no community transmission
- COVID-19 Vaccine distribution summary (See USAPI Vaccine Summary with 25 updated tables and figures listed below)
 - Based on jurisdictional reports: a total of 201,111 people in the region are fully vaccinated (63% of all eligible individuals)
 - An additional 14,063 people in the region are partially vaccinated (4% of eligible individuals in the region)
 - Based on CDC submitted into Tiberius via WeblZ: **66% of all people aged 12 years and older have had at least one dose of a COVID-19 vaccine; 59% are fully vaccinated.** This percentage includes islands who have yet to start vaccinating their adolescents due to no Pfizer availability: Palau, Marshall Islands, and FSM. Note that Palau has ordered and is expecting to initiate Pfizer vaccinations for their adolescents the last week of July.
 - Current percentages of eligible population **aged 12 and over** fully vaccinated (**with change from last week's data in parenthesis**):
 - **American Samoa: 61% (+2%)**
 - **FSM: Chuuk: 32% (+2%), Kosrae: 47% (+2%), Pohnpei: 39% (+2%), Yap: 46% (+3%)**
 - **Guam: 70% (+6%)**
 - **RMI: 47% (+1%)**
 - **CNMI: 68% (+2%)**
 - **Palau: 89% (No Change)**
 - Outer island vaccinations: Outer Island coverage rates from jurisdictional outer island outreach activities due to difficulty in determining denominators and true residence in Tiberius.
 - **RMI Outer Islands: At least one dose 23% (+5%); Fully 15% (8%)**
 - **Yap Outer Islands: At least one dose 37% (+2%); Fully 23% (2%)**
 - **Chuuk Outer Islands: Underway, no data from jurisdiction yet**
 - **Pohnpei Outer Islands: Not yet initiated**
 - Vaccine redistribution: The first vaccine redistribution for USAPI occurred last week. Palau transferred 1000 Johnson & Johnson/Janssen COVID-19 vaccine to FSM (Yap). Guam is in the transferring 2000 Johnson & Johnson/Janssen COVID-19 vaccine to FSM (Chuuk) sometime this week.
- COVID-19 Containment strategies
 - Guam and CNMI are allowing travelers with facility quarantine and testing requirements (some exceptions for vaccinated travelers)
 - Palau has just opened regular Guam flights with quarantine exemptions for vaccinated travelers (but with restricted movement)
 - AS has regular repat flights ongoing with HNL/AS quarantine and testing requirements
 - RMI has regular repat flights ongoing with HNL/RMI quarantine and testing requirements
 - FSM continues smaller repat flights with Guam/FSM quarantine and testing requirements
- COVID-19 Laboratory Testing capacity
 - Some stock-outs of Abbott ID NOW being reported
- Community mitigation strategies
 - Guam is in PCOR-3 and continues to relax mitigation measures
 - CNMI, American Samoa, FSM, Palau, and RMI have relaxed most mitigation measures
- PPE: All USAPI have a stockpile of PPE for COVID-19, though quantities vary

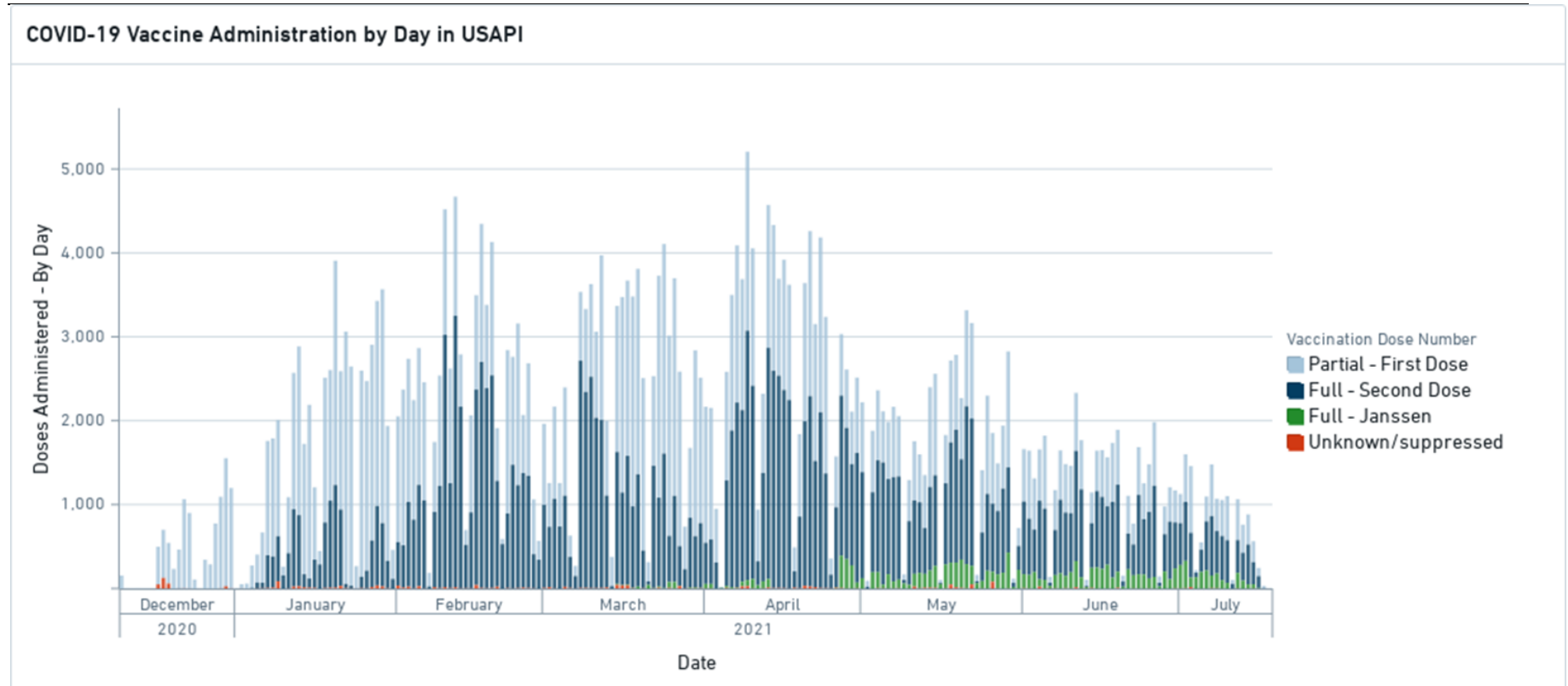

US-affiliated Pacific Islands Region

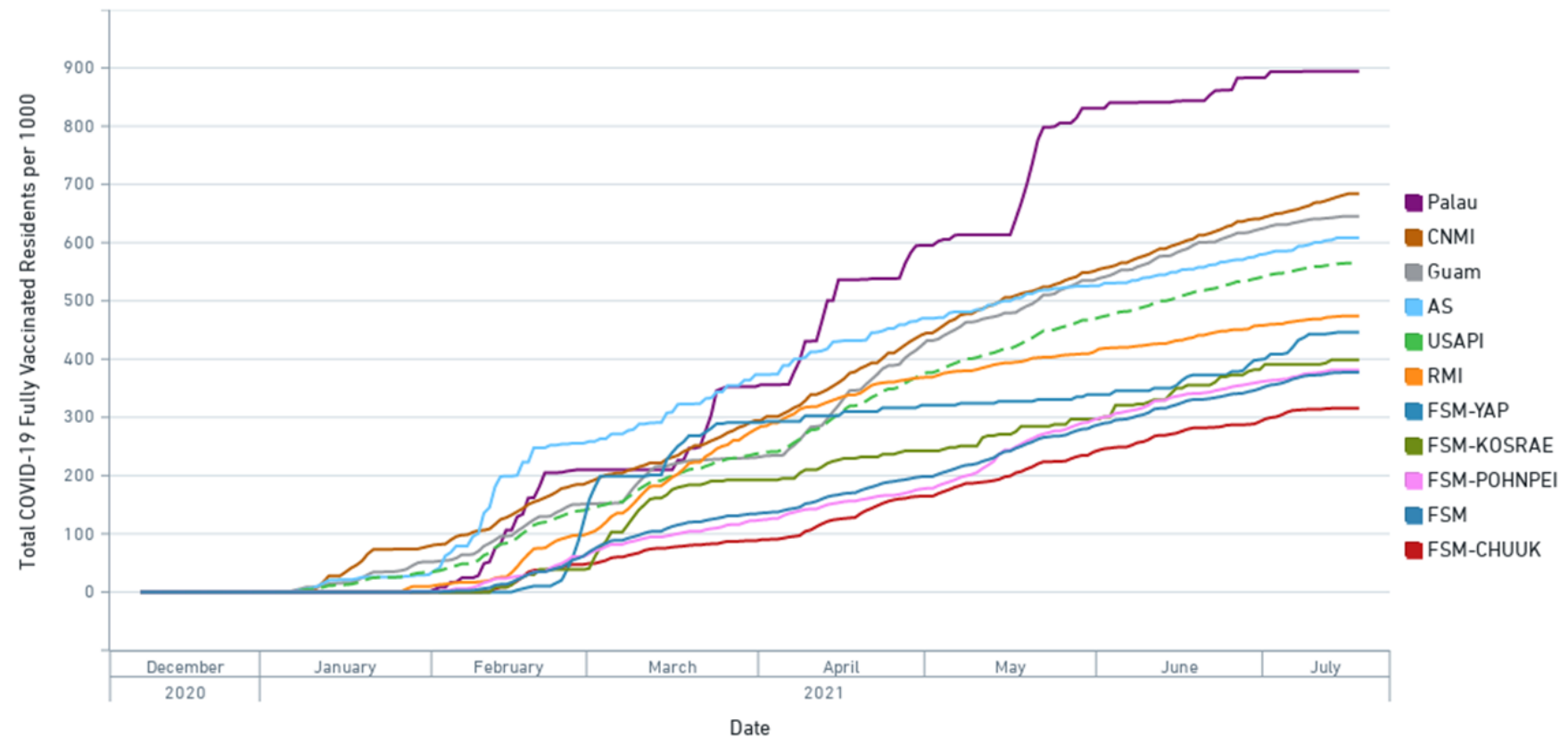

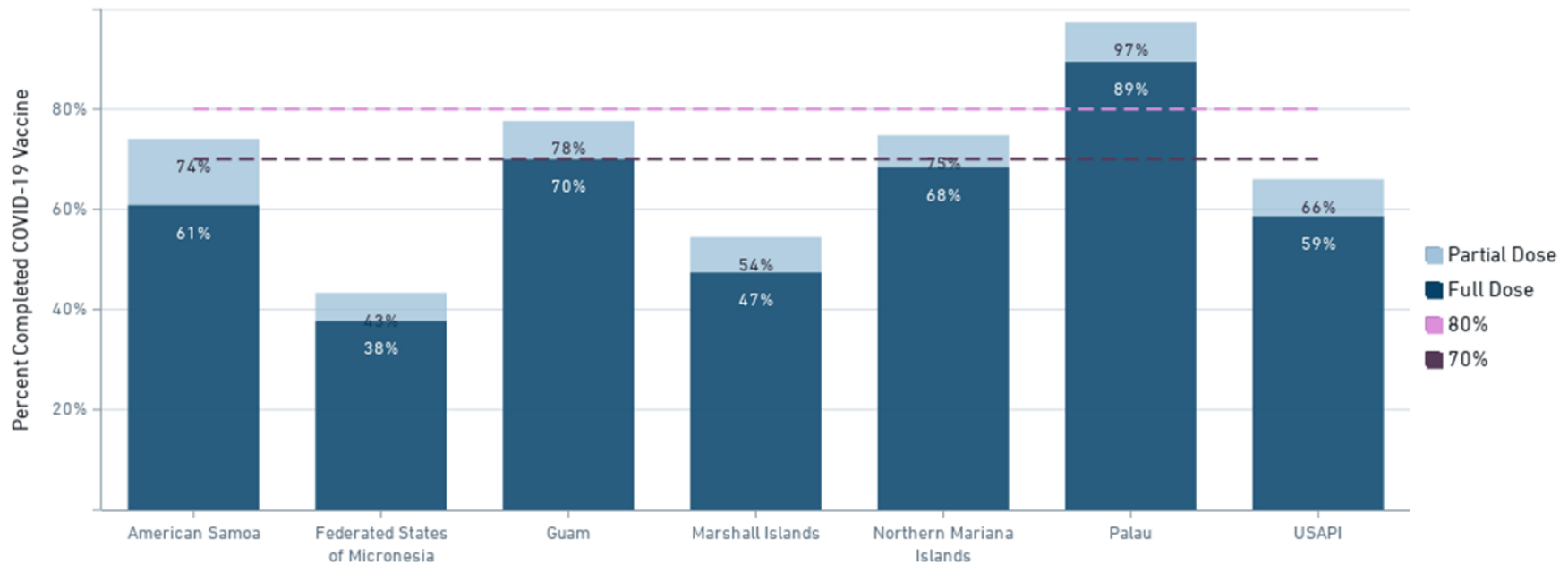

Striving for 80% USAPI COVID-19 Vaccine Progress (12+ yrs old as eligible population)



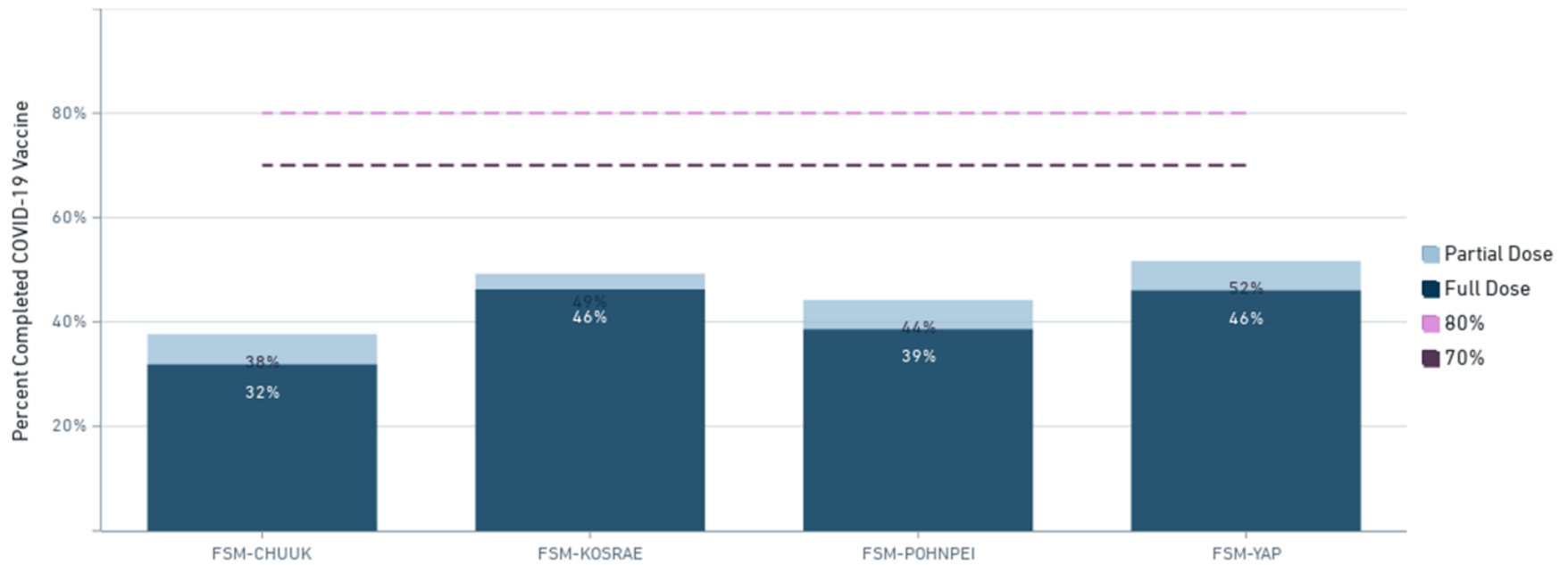

Striving for 80% USAPI COVID-19 Vaccine Progress (12+ yrs old as eligible population) (FSM States)

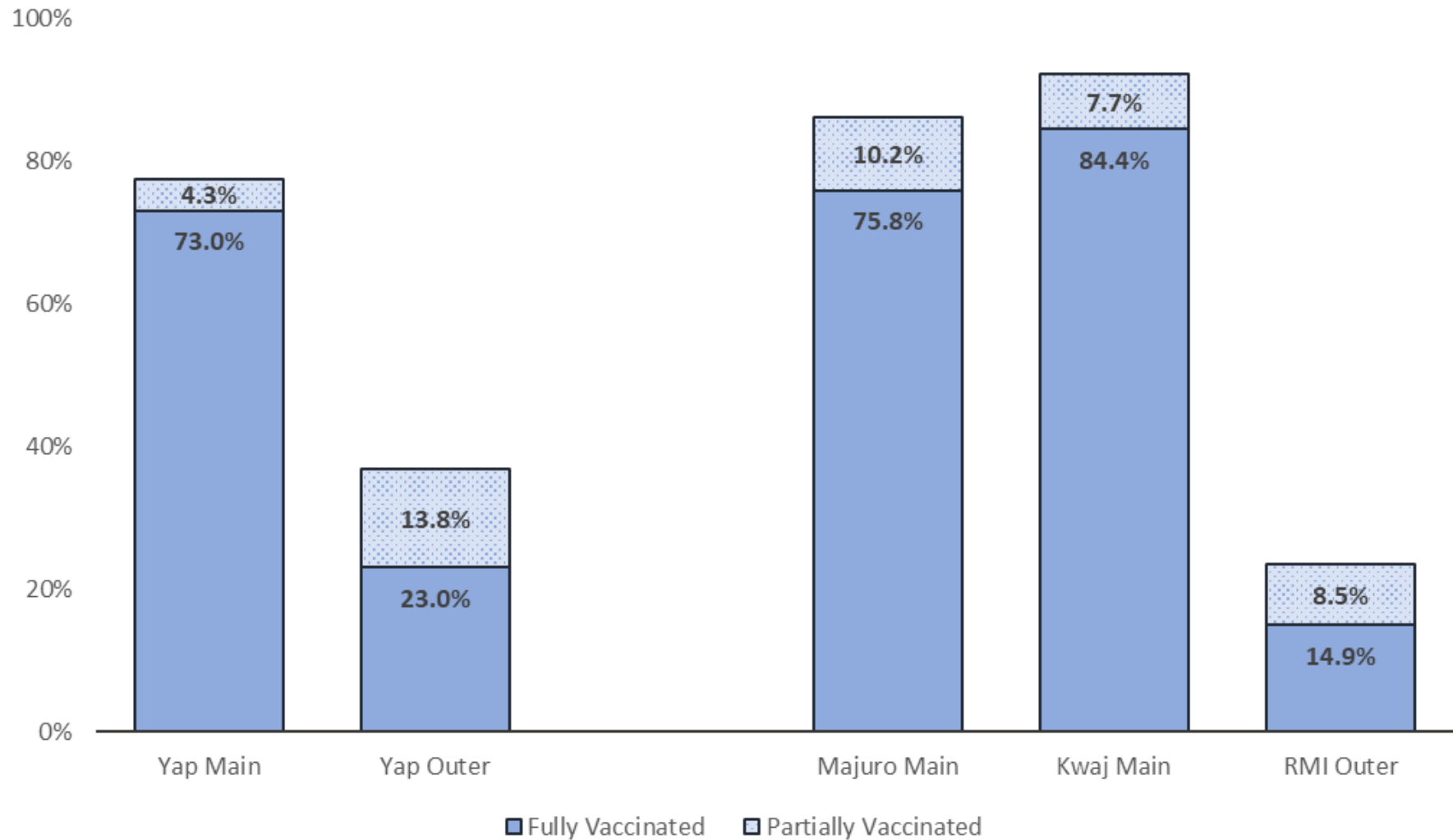

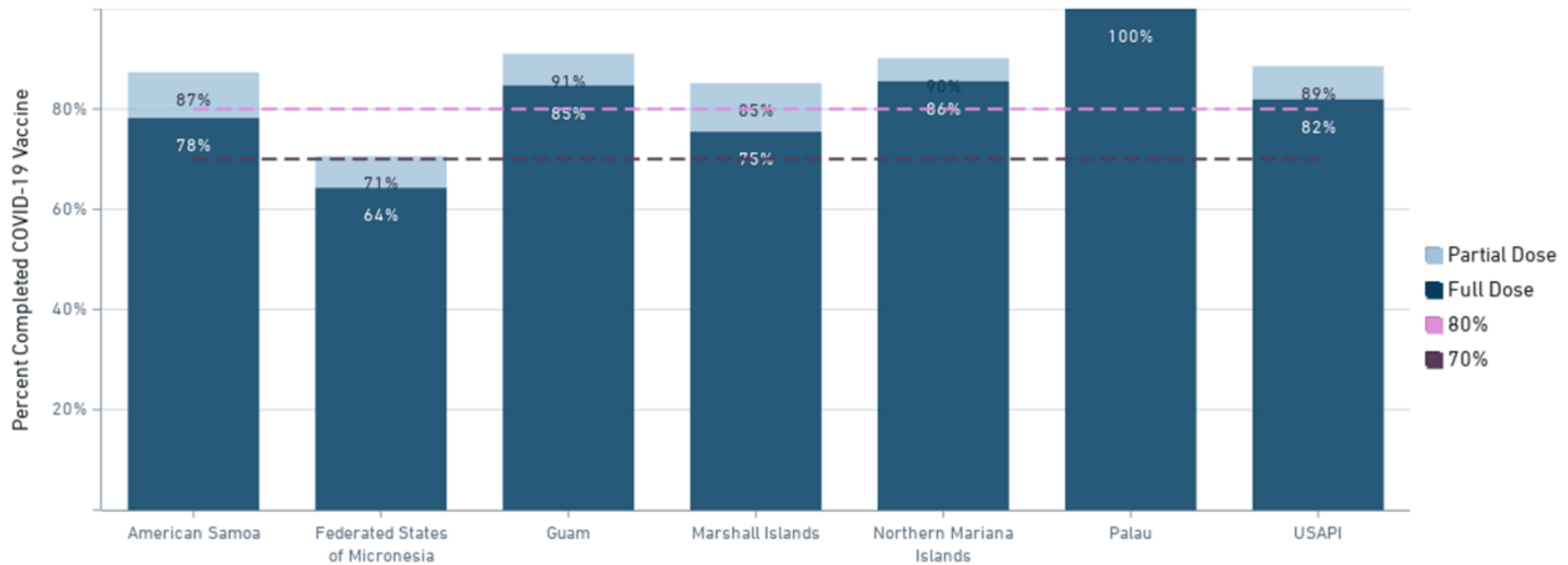

USAPI COVID-19 Vaccine Progress: 50 yrs and over



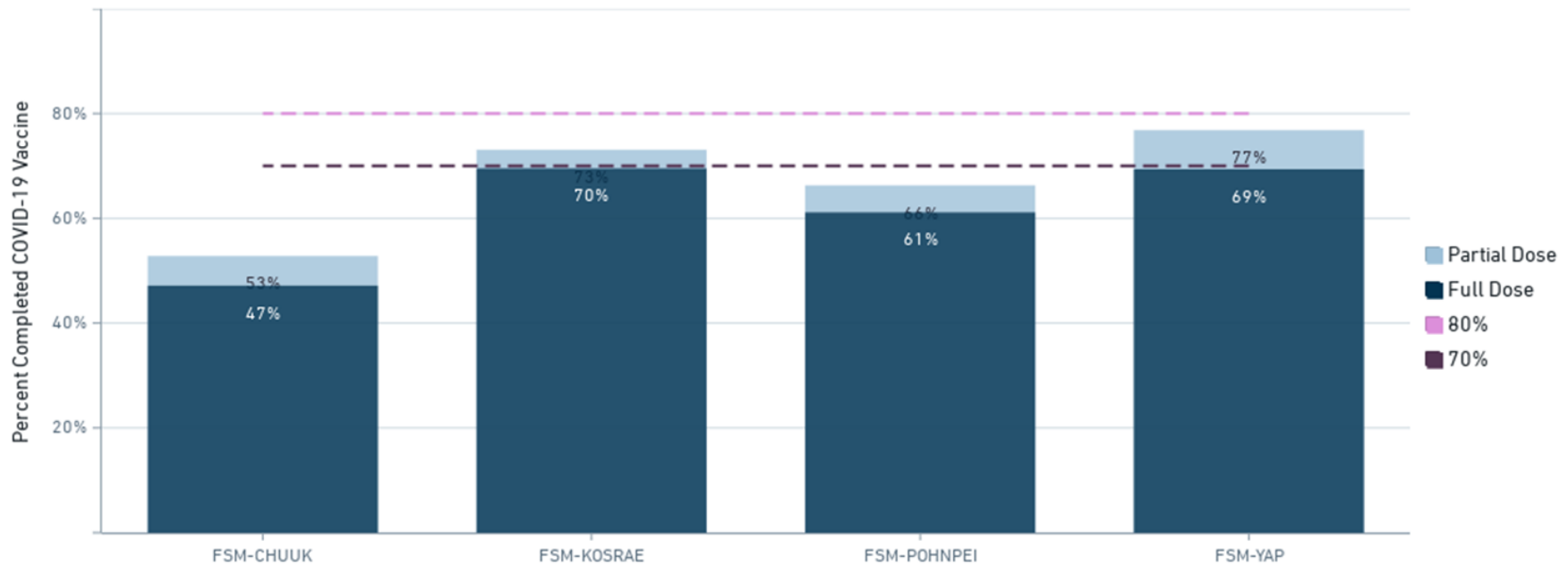

USAPI COVID-19 Vaccine Progress: 50 yrs and over (FSM States)



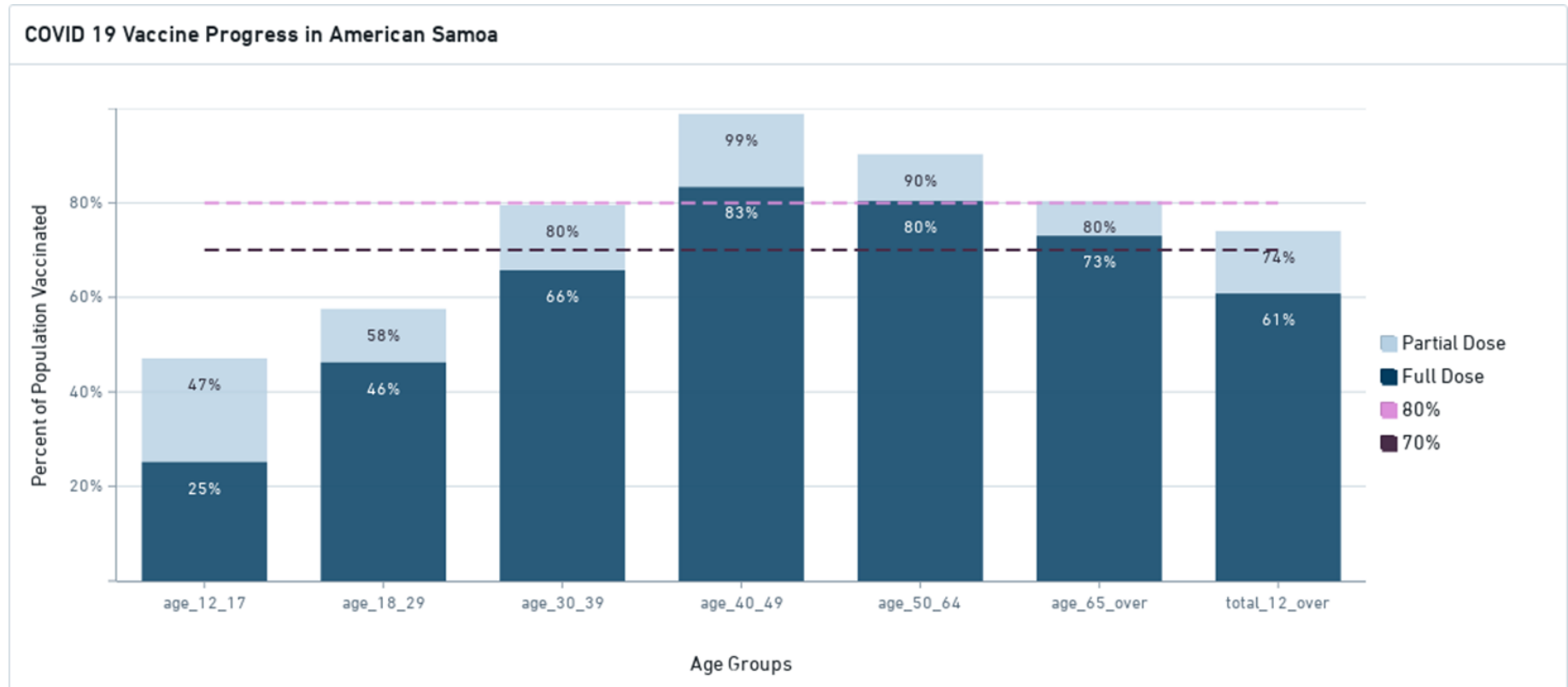

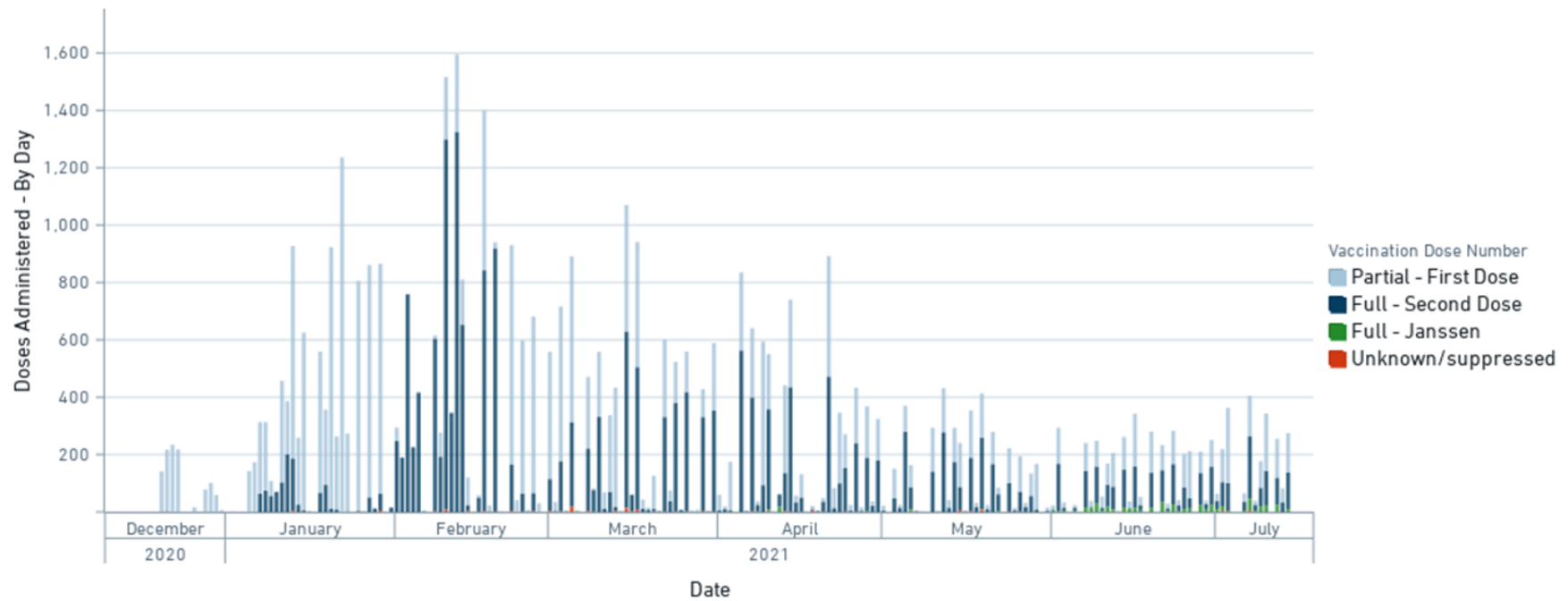

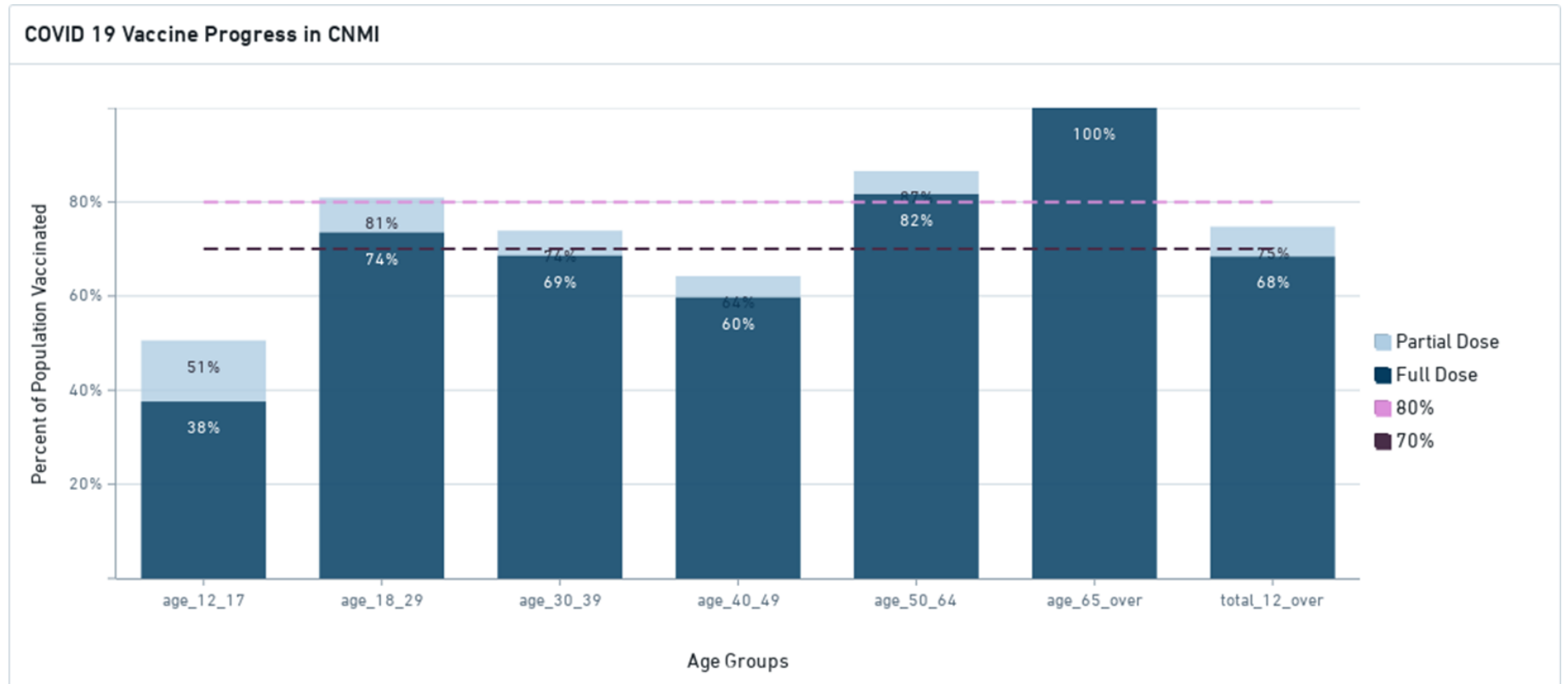
COVID-19 Vaccine Administration by Day in American Samoa

Commonwealth of the Northern Mariana Islands



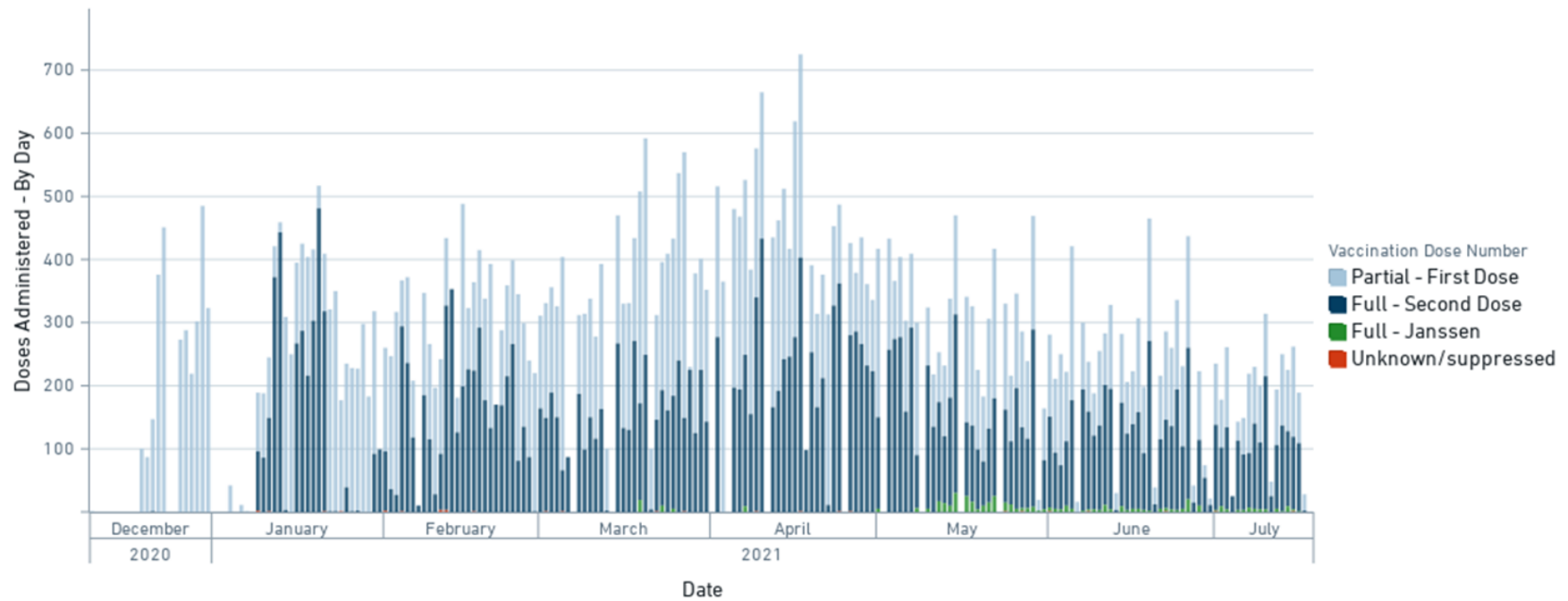

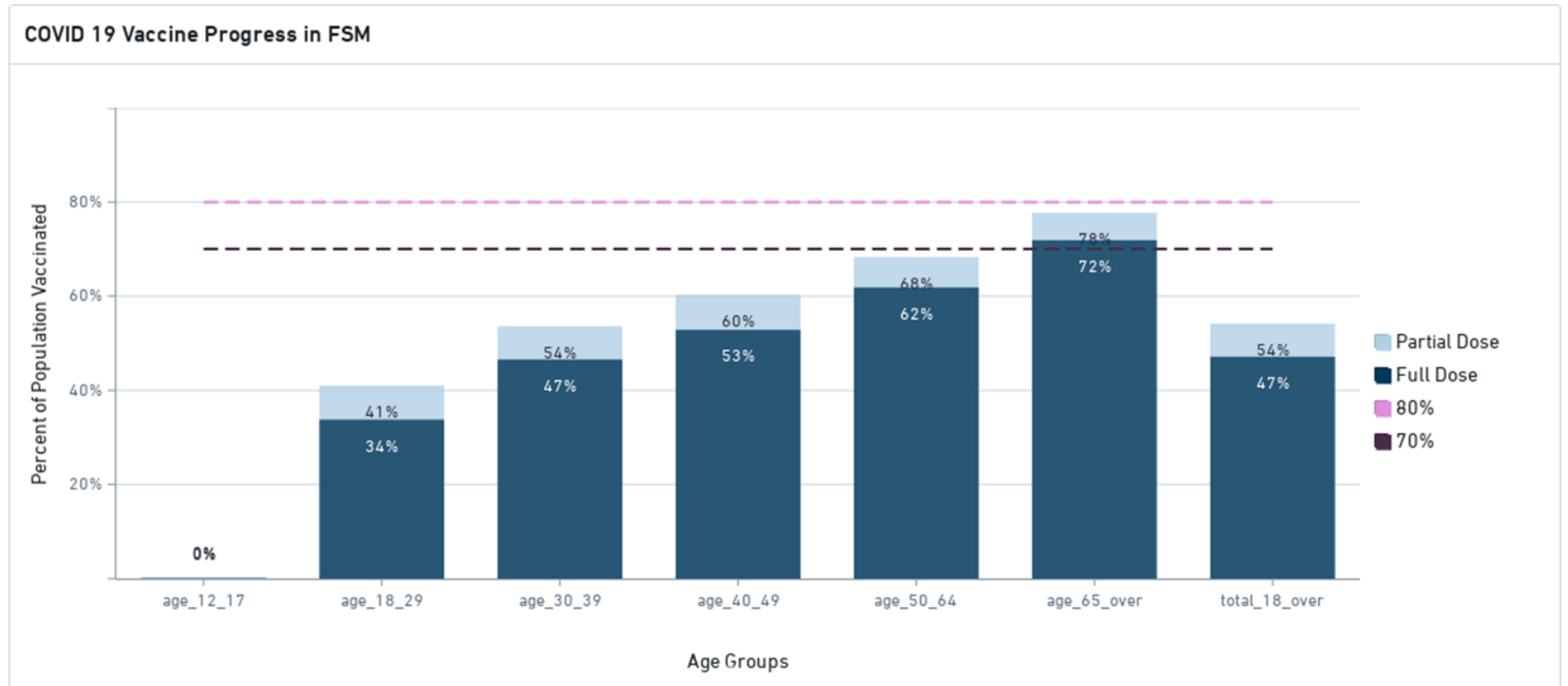
COVID-19 Vaccine Administration by Day in CNMI

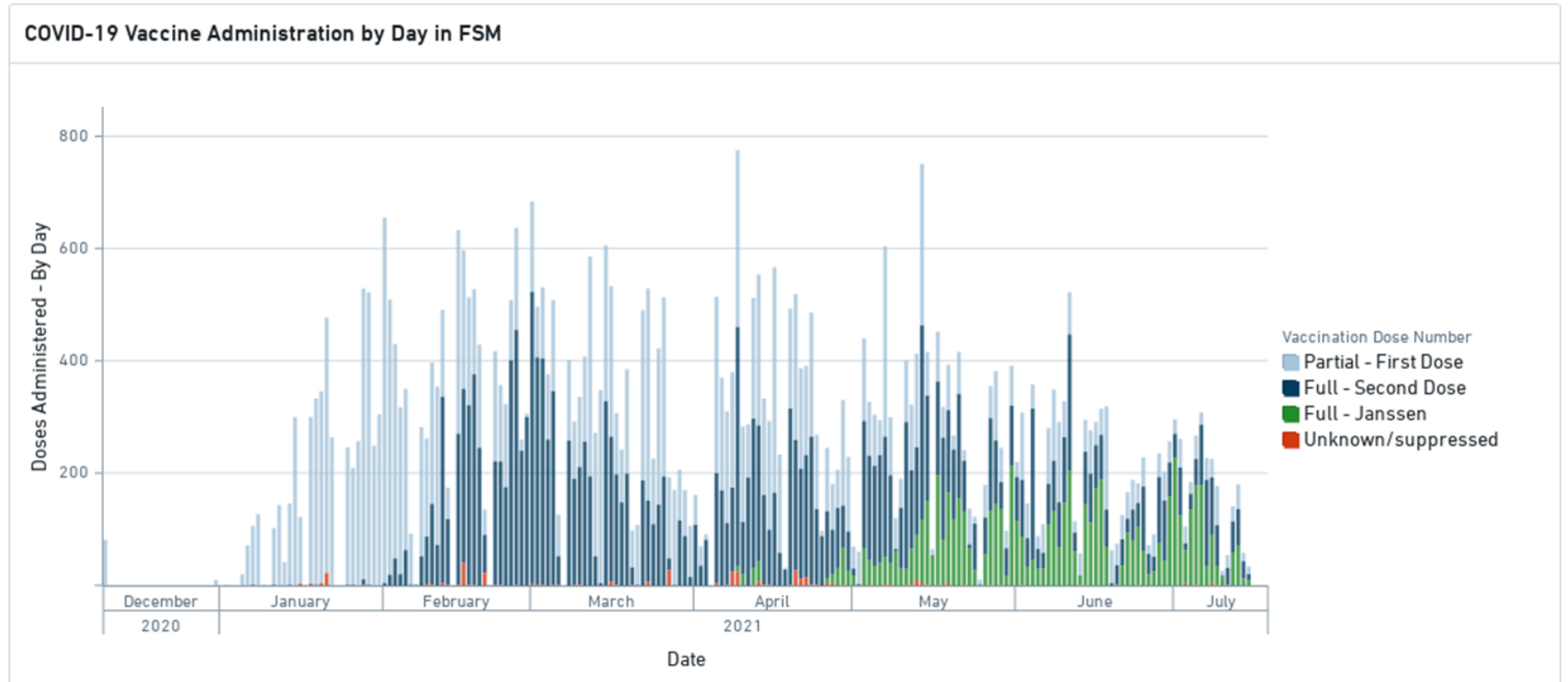

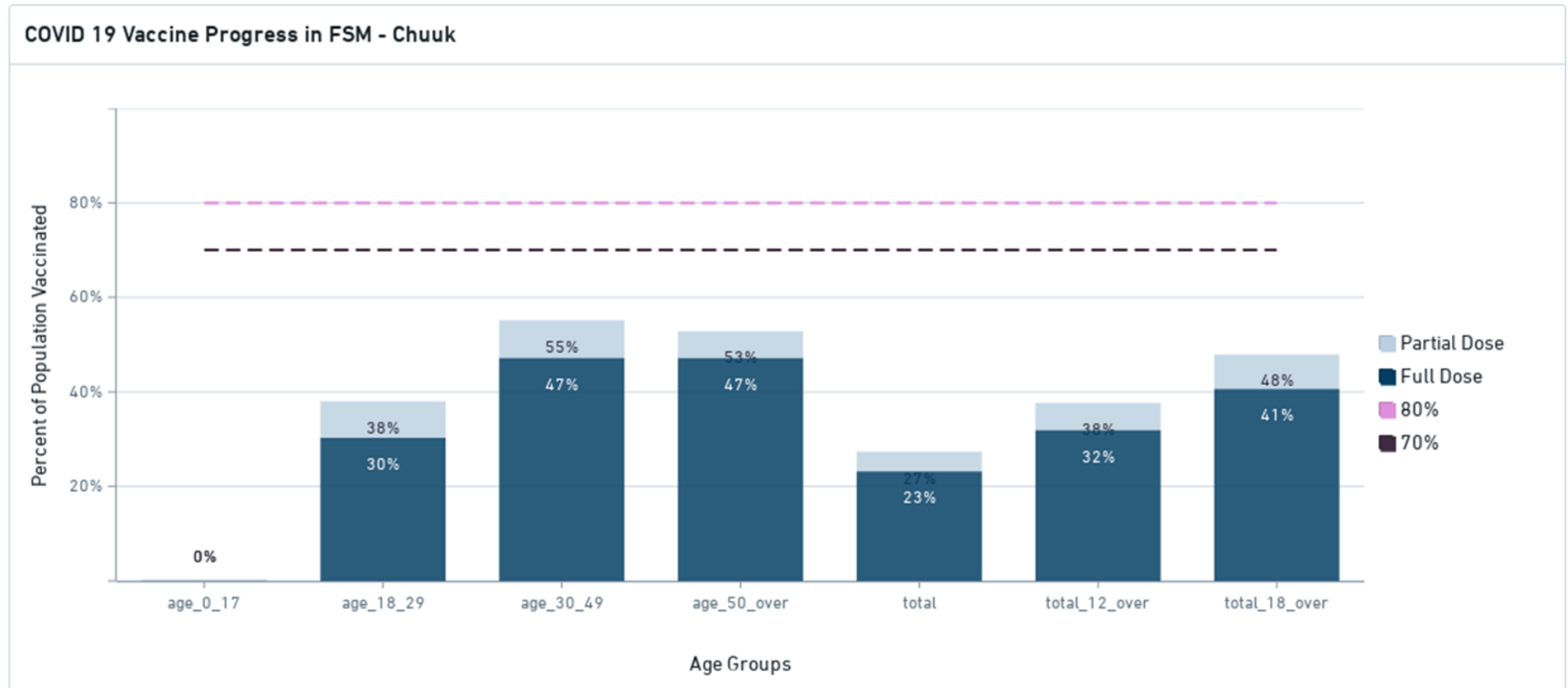

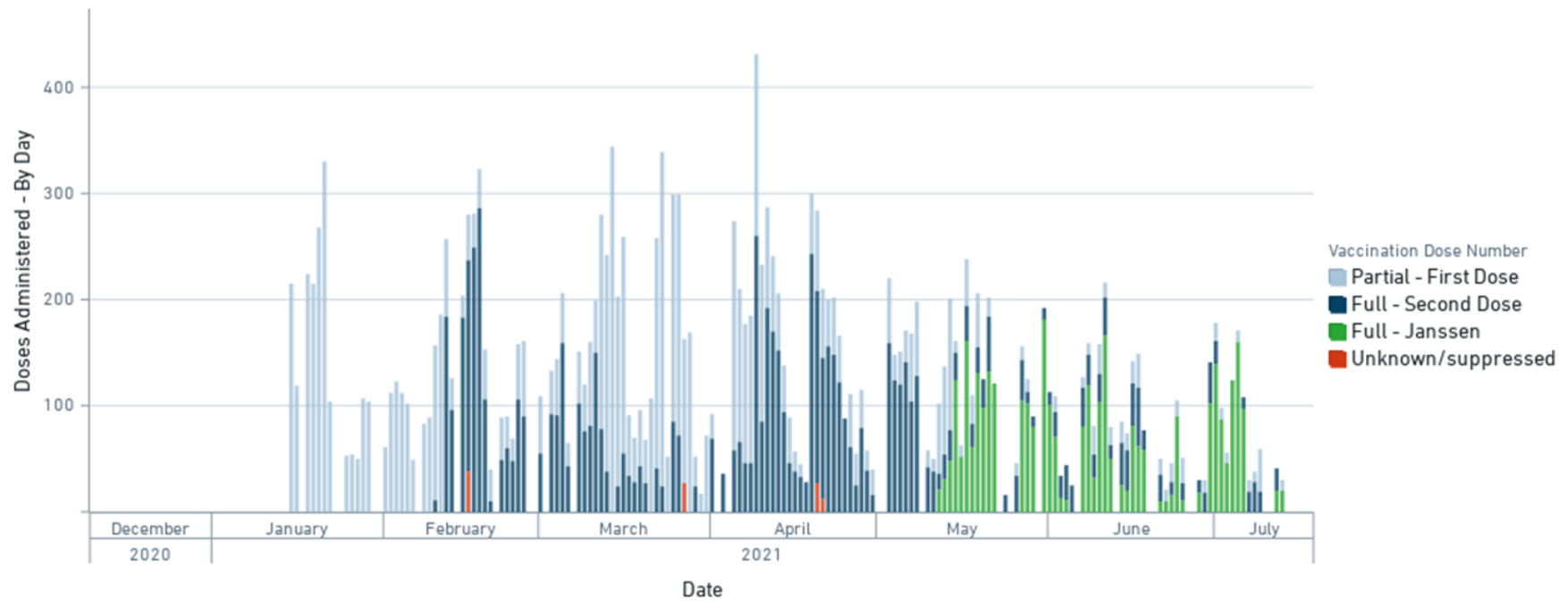

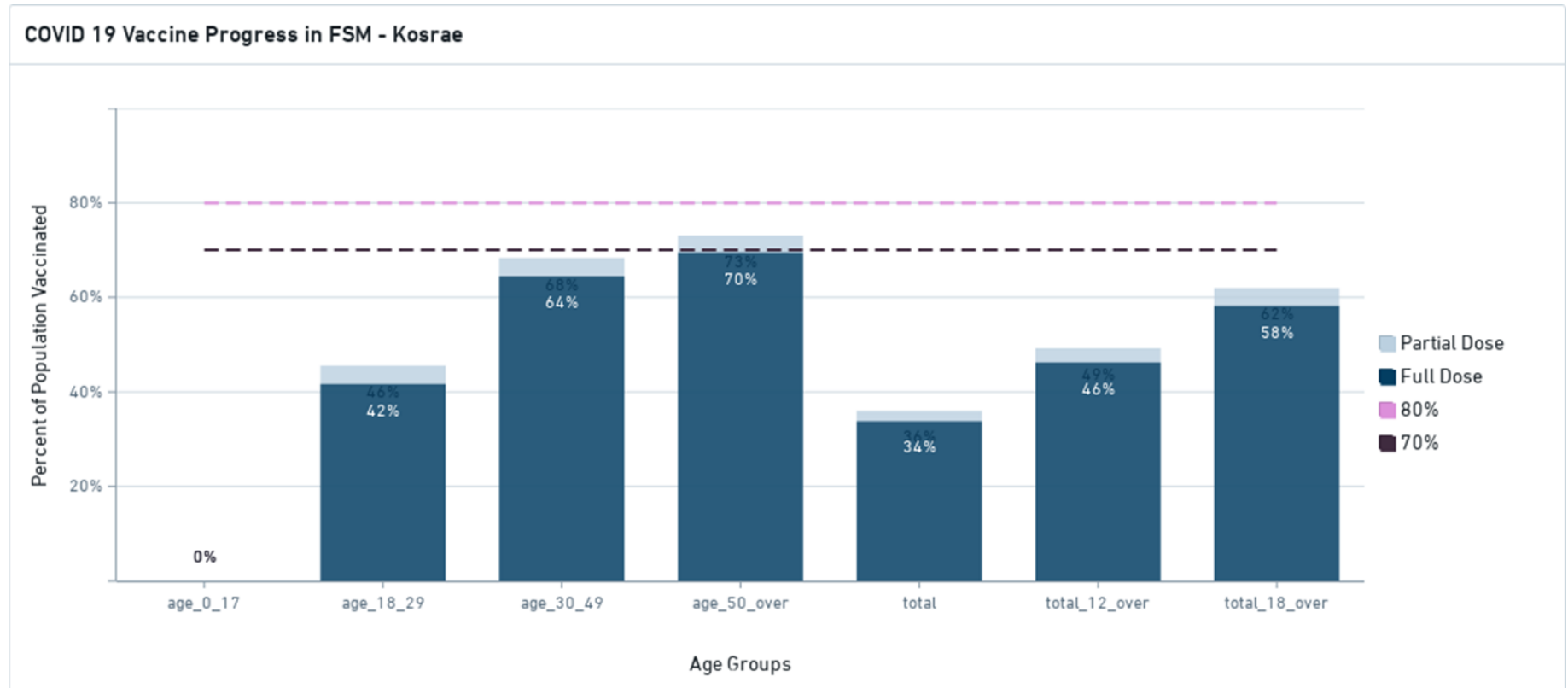
COVID-19 Vaccine Administration by Day in FSM - Chuuk

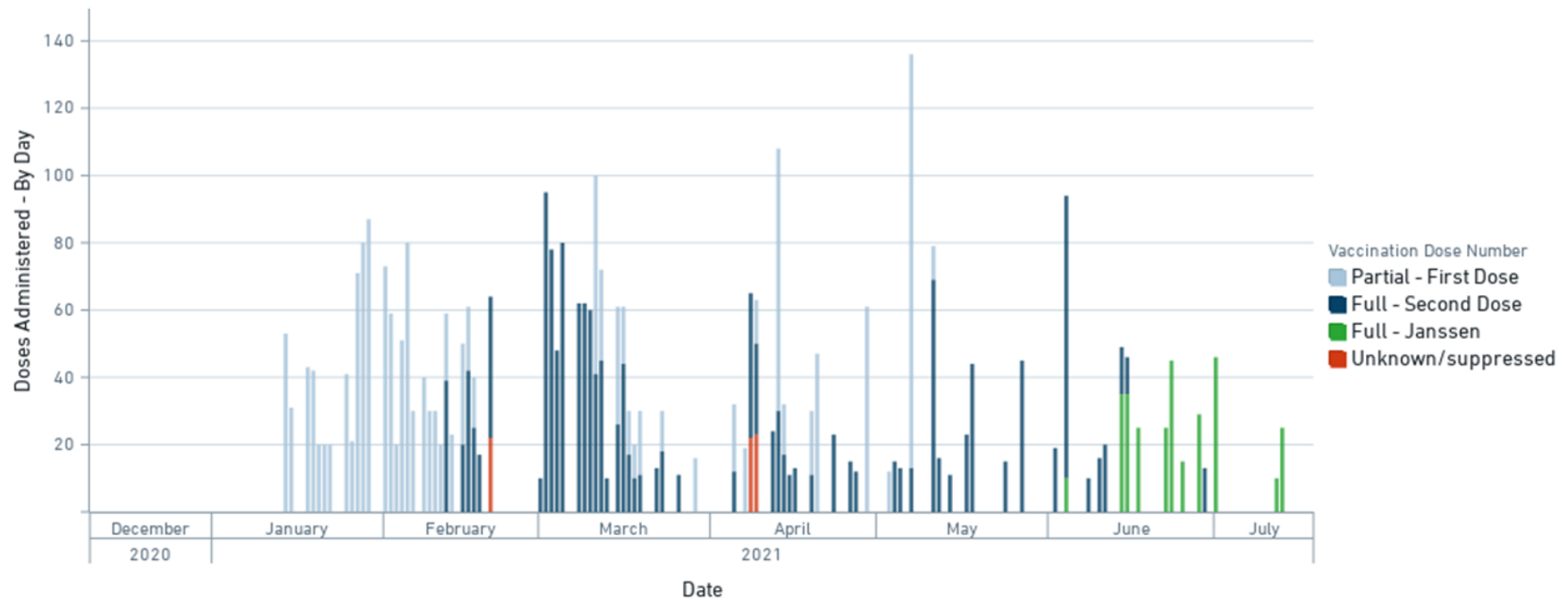

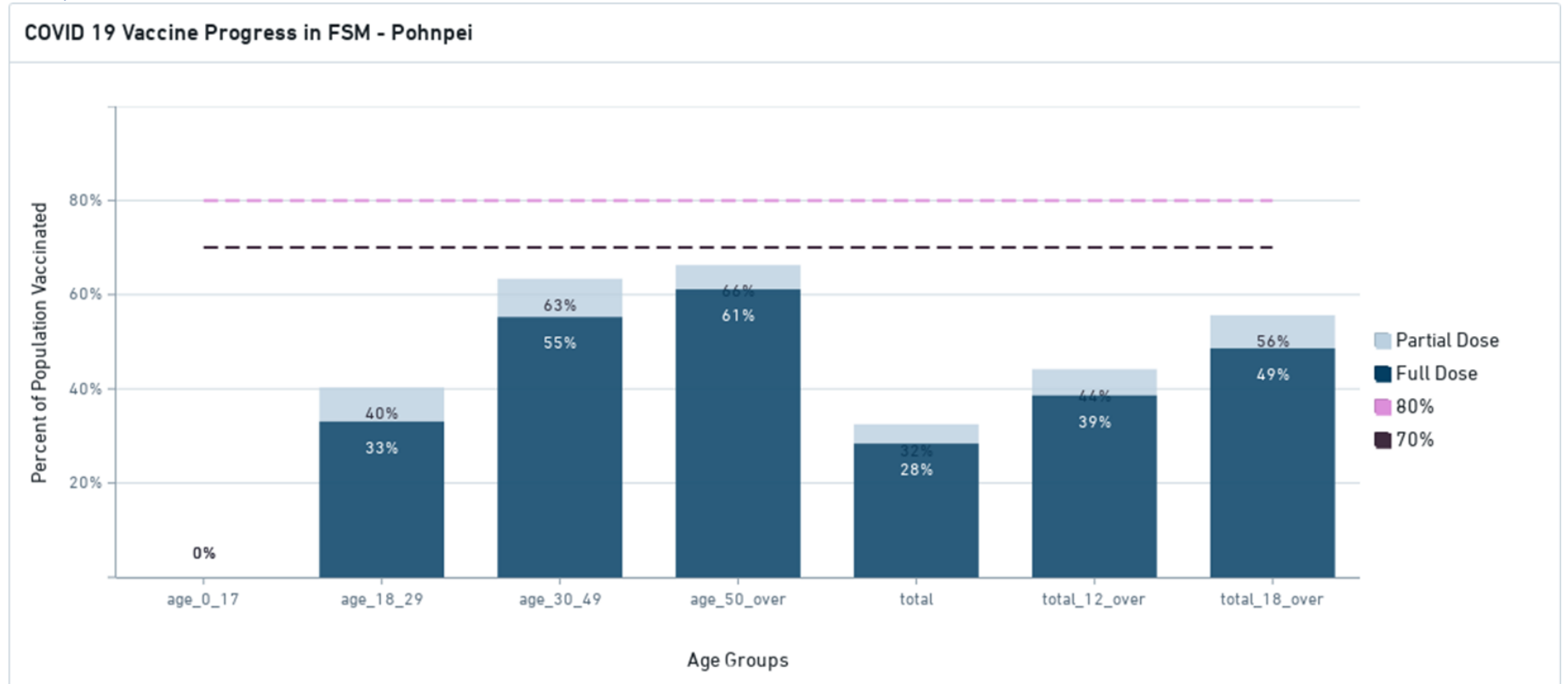
COVID-19 Vaccine Administration by Day in FSM - Kosrae

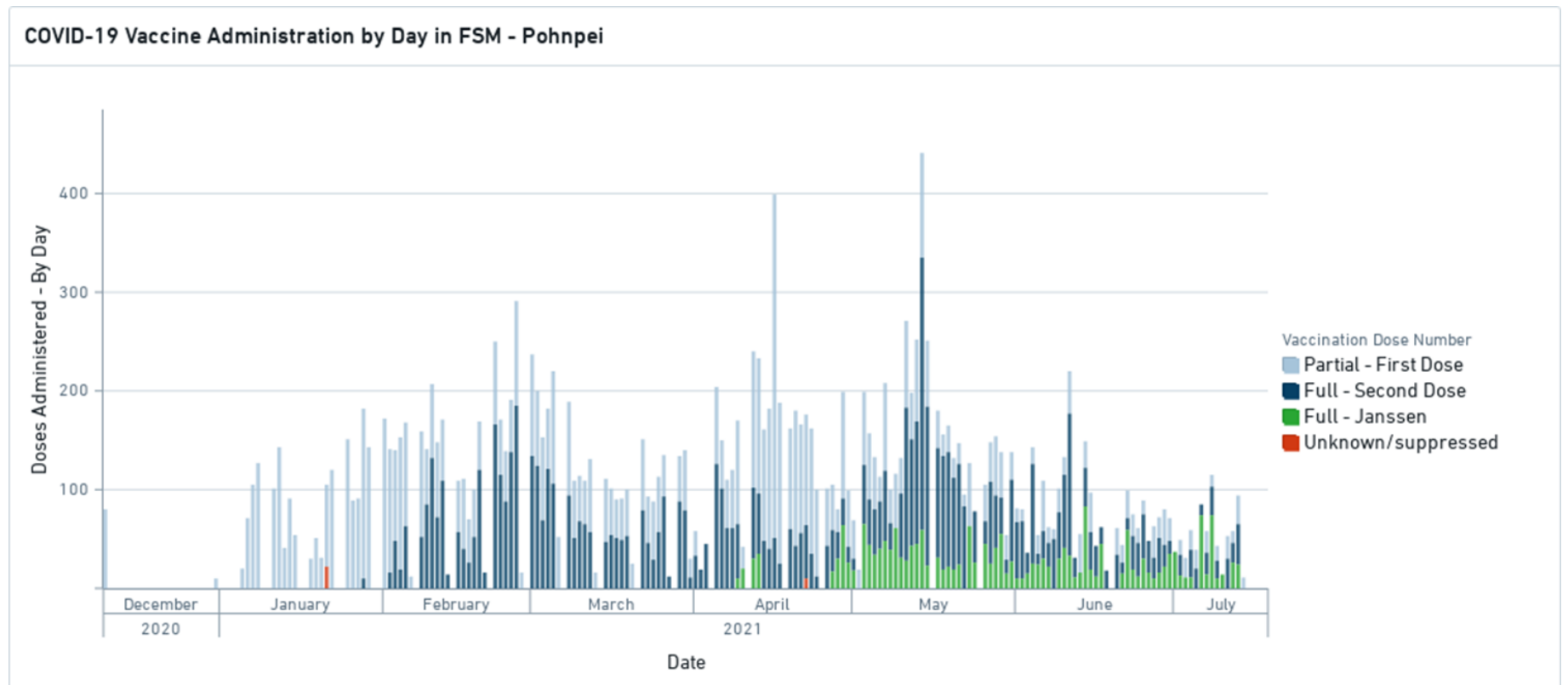

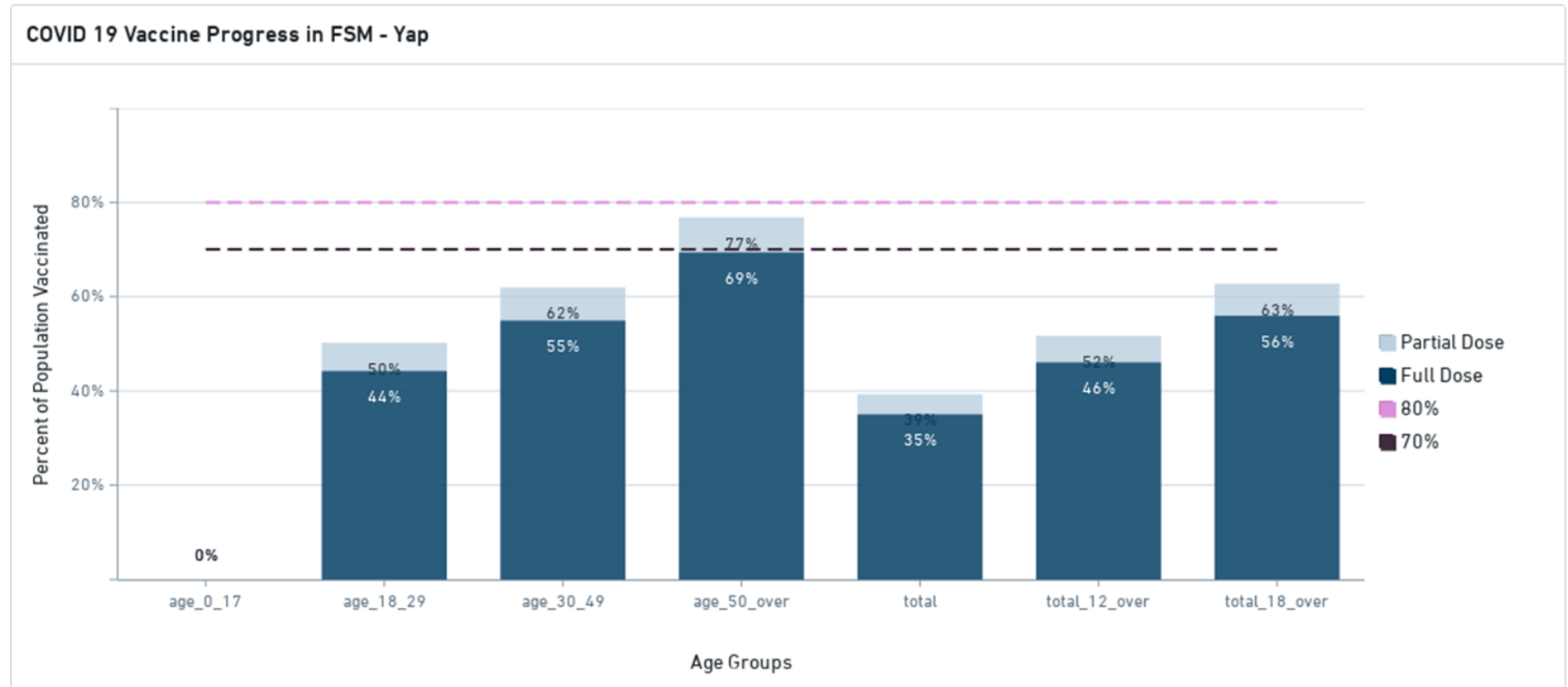

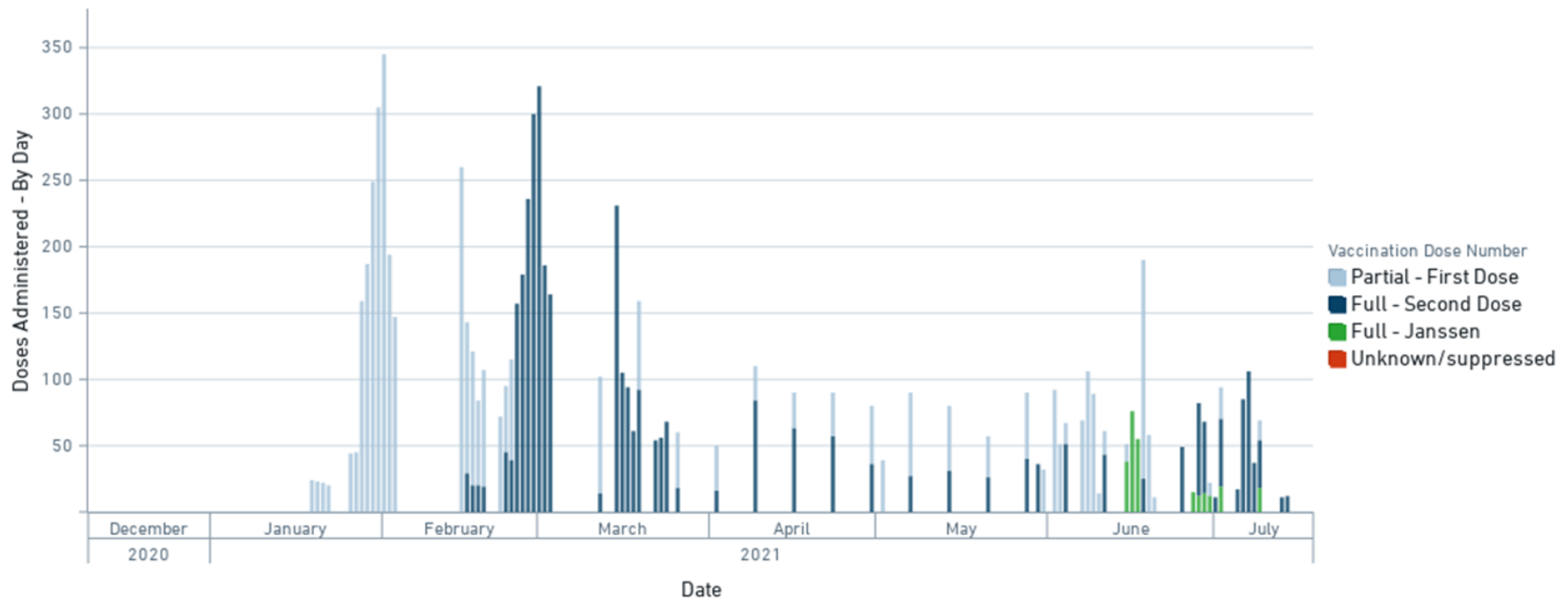

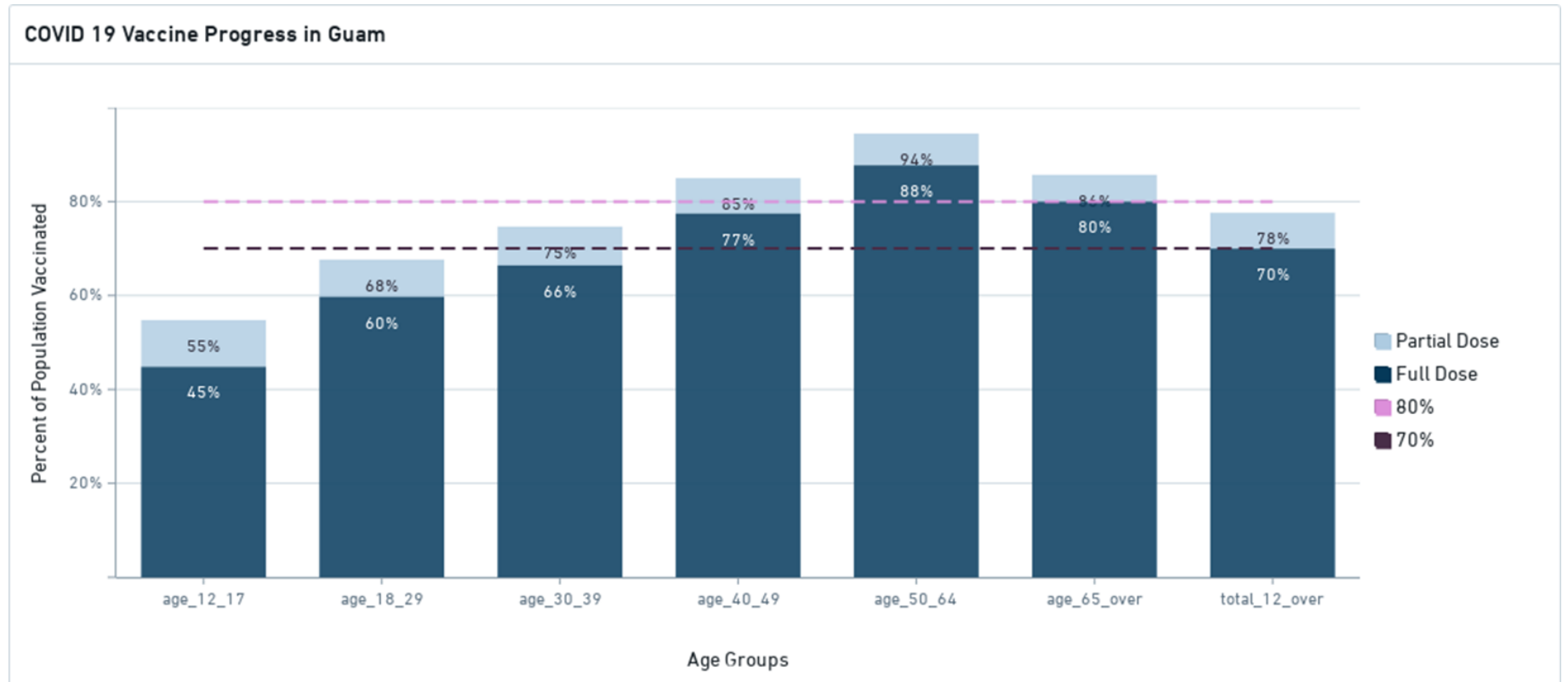
COVID-19 Vaccine Administration by Day in FSM - Yap

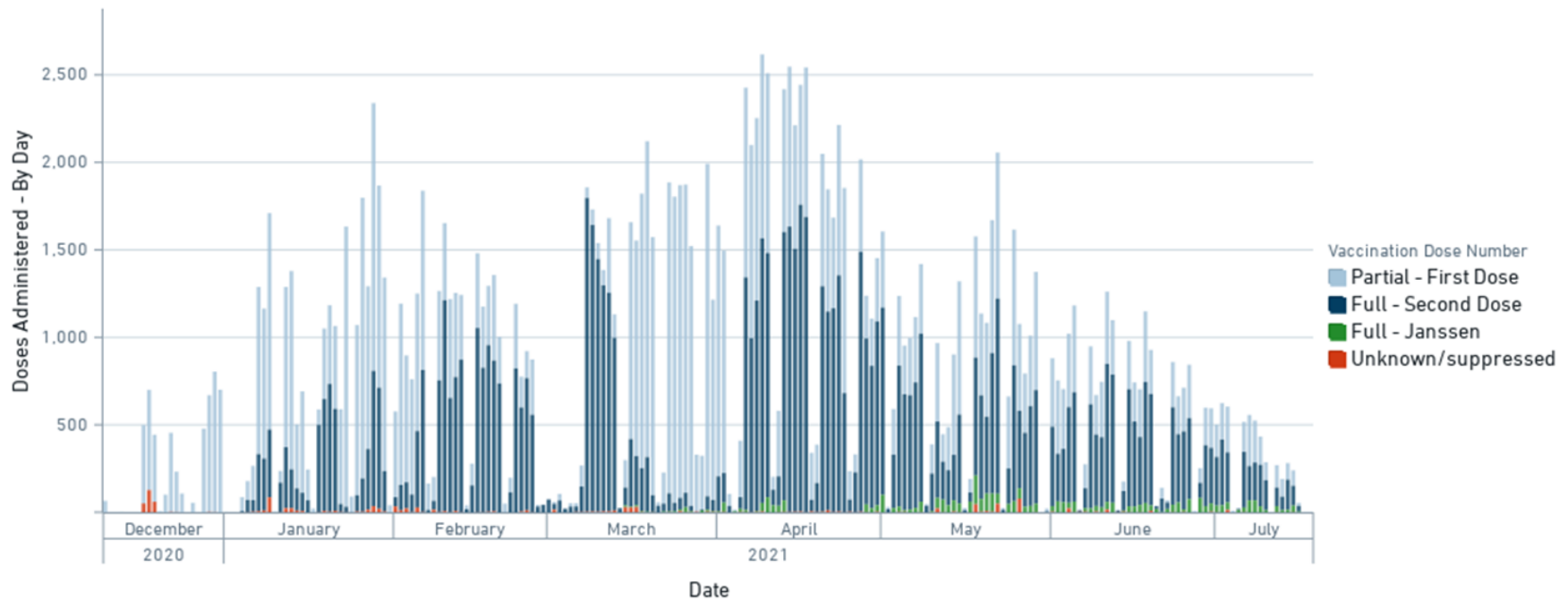

COVID-19 Vaccine Administration by Day in Guam

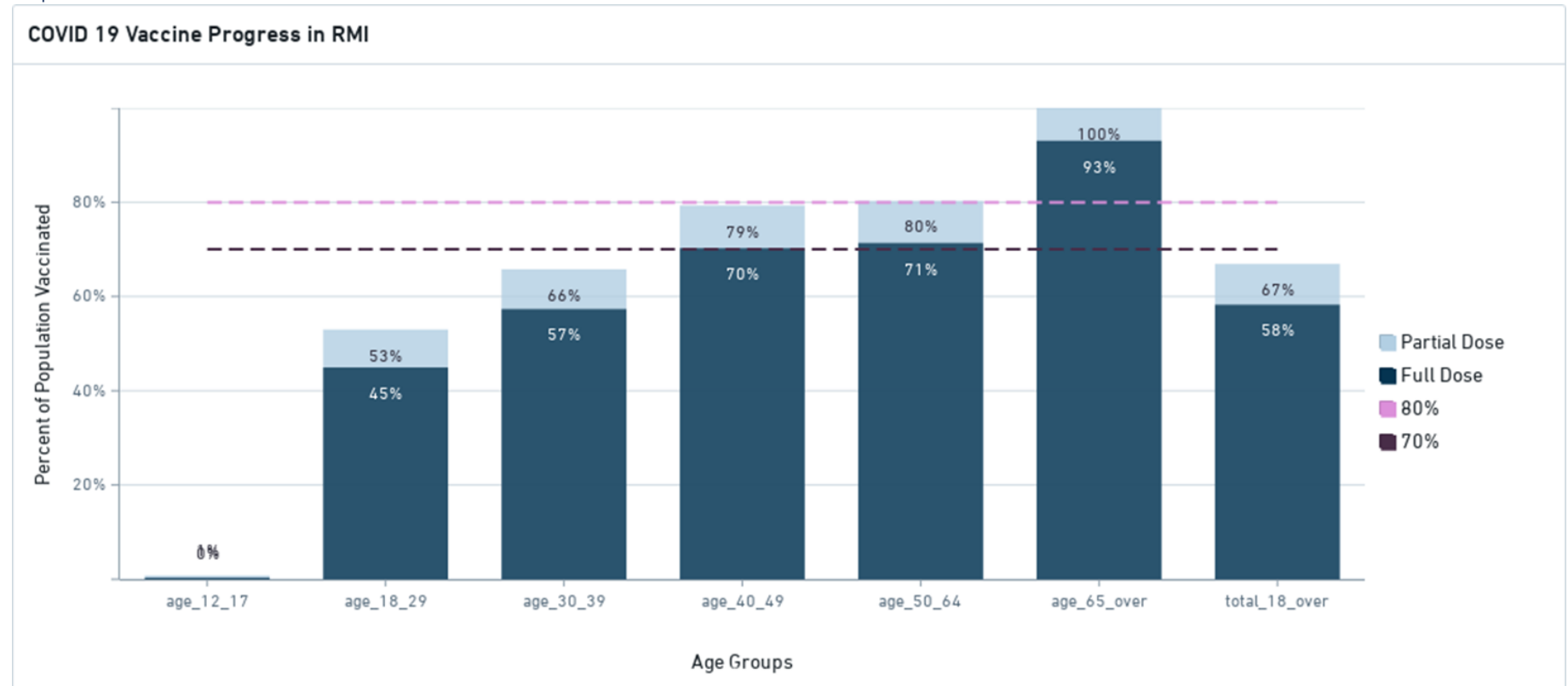

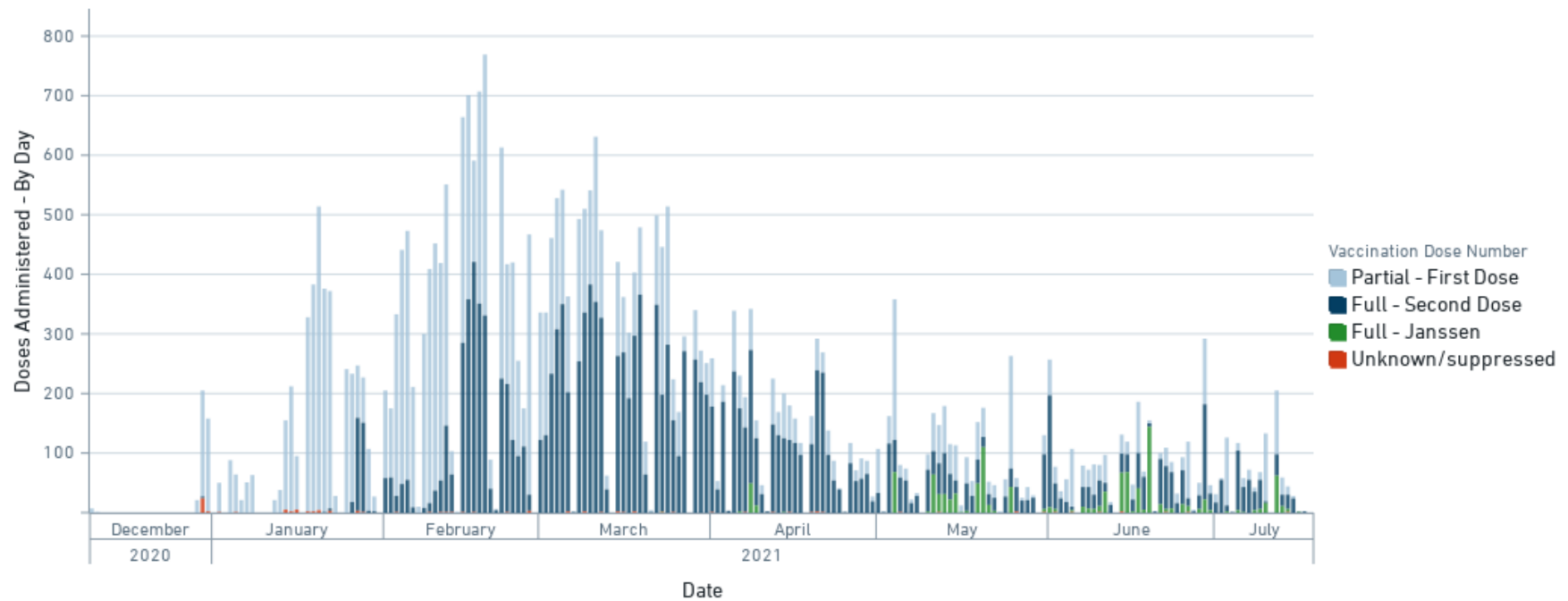

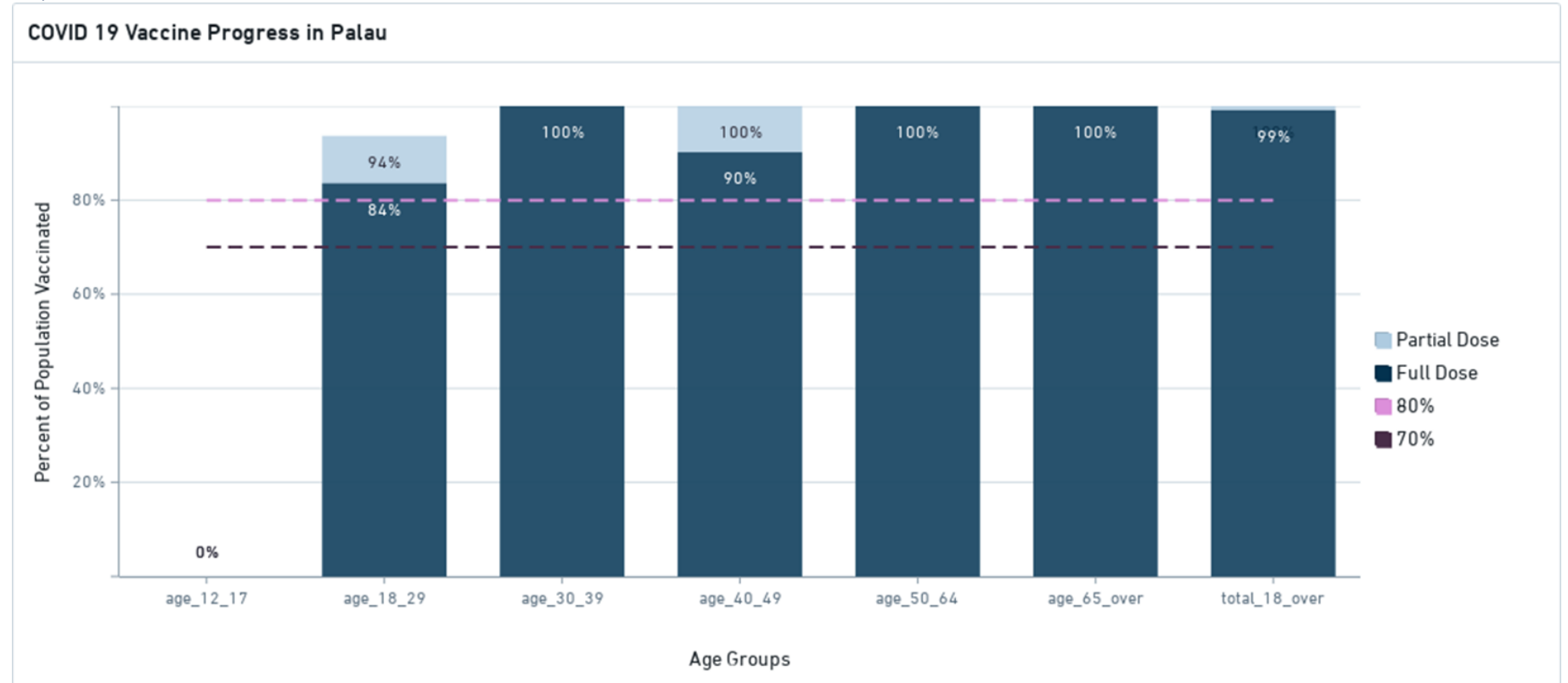
COVID-19 Vaccine Administration by Day in RMI

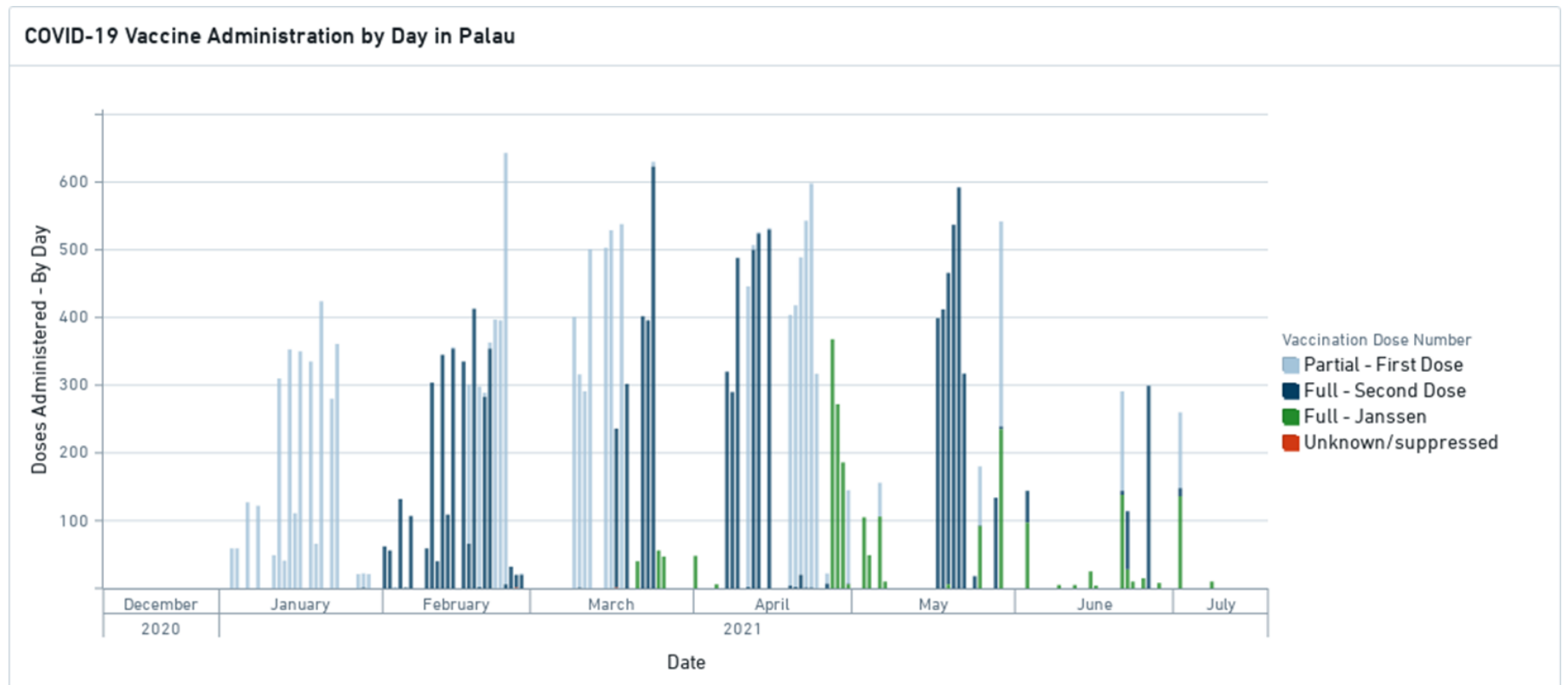
