

**CDC/PIHOA one-on-one USAPI weekly check-ins**  
**Week: 7/24/2021-7/30/2021**

**Regional Summary:**

- COVID-19 cases
  - Guam has reported 8,541 total cases and 143 deaths with 40 new cases and 0 new deaths reported this week
  - CNMI has reported 190 total cases and 2 deaths with 2 new cases (imported) and 0 new deaths reported this week
  - American Samoa, FSM, Palau, and RMI have had no community transmission
- COVID-19 Vaccine distribution summary (See USAPI Vaccine Summary with 25 updated tables and figures listed below)
  - Based on jurisdictional reports: a total of 208,320 people in the region are fully vaccinated (65% of all eligible individuals)
    - An additional 15,125 people in the region are partially vaccinated (5% of eligible individuals in the region)
    - Note: eligible individuals is now 12+ for AS, CNMI, Guam and Palau, but still 18+ for FSM and RMI
  - Based on CDC submitted into Tiberius via WebIZ: **68% of all people aged 12 years and older have had at least one dose of a COVID-19 vaccine; 61% are fully vaccinated.** This percentage includes islands who have yet to start vaccinating their adolescents due to no Pfizer availability: Palau, Marshall Islands, and FSM. Note that Palau has received their first Pfizer shipment and will initiate adolescent vaccinations this week.
  - Current percentages of eligible population **aged 12 and over** fully vaccinated (**with change from last week's data in parenthesis**):
    - **American Samoa: 64% (+2%)**
    - **FSM: Chuuk: 33% (--%), Kosrae: 50% (+2%), Pohnpei: 40% (--%), Yap: 51% (+1%)**
    - **Guam: 72% (+1%)**
    - **RMI: 48% (--%)**
    - **CNMI: 71% (+1%)**
    - **Palau: 92% (+1%)**
  - Outer island vaccinations: Outer Island coverage rates from jurisdictional outer island outreach activities due to difficulty in determining denominators and true residence in Tiberius.
    - **RMI Outer Islands:** At least one dose **25% (--%)**; Fully **16% (--%)**
    - **Yap Outer Islands:** At least one dose **36% (--%)**; Fully **32% (+8%)**
    - **Chuuk Outer Islands (out of the lagoon):** Fully **14% (--%)** (no OI numbers reported this week from Chuuk)
    - **Pohnpei Outer Islands:** Not yet initiated
  - Vaccine redistribution: No redistribution this past week
  - J&J Vaccine Extended Expiration Date by 6 weeks
- COVID-19 Containment strategies
  - Guam and CNMI are allowing travelers with facility quarantine and testing requirements (some exceptions for vaccinated travelers)
  - Palau is running regular Guam flights with quarantine exemptions for vaccinated travelers (but with restricted movement)
  - RMI has regular repat flights ongoing with HNL/in-country quarantine and testing requirements, but AS has paused their HNL repat flights
  - FSM continues smaller repat flights with Guam/FSM quarantine and testing requirements
- COVID-19 Laboratory Testing capacity
  - Some stock-outs of Abbott ID NOW being reported
- Community mitigation strategies
  - Guam is in PCOR-3 with some mitigation measures still in place
  - CNMI, American Samoa, FSM, Palau, and RMI have relaxed most mitigation measures







Striving for 80% USAPI COVID-19 Vaccine Progress (12+ yrs old as eligible population)





Striving for 80% USAPI COVID-19 Vaccine Progress (12+ yrs old as eligible population) (FSM States)





USAPI COVID-19 Vaccine Progress: 50 yrs and over





USAPI COVID-19 Vaccine Progress: 50 yrs and over (FSM States)









Commonwealth of the Northern Mariana Islands
















COVID-19 Vaccine Administration by Day in FSM - Kosrae








COVID-19 Vaccine Administration by Day in FSM - Yap








COVID-19 Vaccine Administration by Day in RMI


