Regional Summary:

- COVID-19 cases
 - Guam has reported 8,873 total cases and 143 deaths with 132 new cases and 0 new deaths reported this week
 - CNMI has reported 206 total cases and 2 deaths with 16 new cases (imported) and 0 new deaths reported this week
 - o American Samoa, FSM, Palau, and RMI have had no community transmission
- COVID-19 Vaccine distribution summary (See USAPI Vaccine Summary with 25 updated tables and figures listed below)
 - o Based on jurisdictional reports: a total of 211,523 people in the region are fully vaccinated (66% of all eligible individuals)
 - An additional 14,342 people in the region are partially vaccinated (5% of eligible individuals in the region)
 - Note: eligible individuals is now 12+ for AS, CNMI, Guam and Palau, but still 18+ for FSM and RMI
 - Based on data submitted into Tiberius via WebIZ: 69% of all people aged 12 years and older have had at least one dose of a COVID-19 vaccine; 62% are fully vaccinated. This percentage includes islands who have yet to start vaccinating their adolescents due to no Pfizer availability: RMI and FSM.
 - Current percentages of eligible population aged 12 and over fully vaccinated (with change from last week's data in parenthesis):
 - American Samoa: 65% (+1%)
 - FSM: Chuuk: 34% (1%), Kosrae: 51% (+1%), Pohnpei: 41% (+1%), Yap: 51% (--%)

 - RMI: 49% (+1%)
 - CNMI: 73% (+2%)
 - Palau: 92% (--%)
 - Outer island vaccinations: Outer Island coverage rates from jurisdictional outer island outreach activities due to difficulty in determining denominators and true residence in Tiberius.
 - RMI Outer Islands: At least one dose 26% (+1%); Fully 18% (+2%)
 - Yap Outer Islands: At least one dose 36% (--%); Fully 32% (--%) (awaiting numbers from recent OI vaccination voyage)
 - Chuuk Outer Islands (out of the lagoon): Fully 14% (--%) (no OI numbers reported this week from Chuuk)
 - Pohnpei Outer Islands: Underway, awaiting numbers.
 - Vaccine redistribution: No redistribution this past week
- COVID-19 Containment strategies
 - Guam and CNMI are allowing travelers with facility quarantine and testing requirements (some exceptions for vaccinated travelers)
 - o Palau is running regular Guam flights with quarantine exemptions for vaccinated travelers (but with restricted movement)
 - o RMI has regular repat flights ongoing with HNL/in-country quarantine and testing requirements, but AS has paused their HNL repat flights
 - FSM continues smaller repat flights with Guam/FSM quarantine and testing requirements
- COVID-19 Laboratory Testing capacity
 - Some stock-outs of Abbott ID NOW being reported
- Community mitigation strategies
 - Guam is in PCOR-3 with some mitigation measures still in place
 - CNMI, American Samoa, FSM, Palau, and RMI have relaxed most mitigation measures










