Week: 9/18/2021-9/24/2021

Regional Summary:

- COVID-19 cases
 - Guam has reported 14,248 total cases and 185 deaths with 899 new cases (↓ 20%) and 6 new deaths (↓ 70%) reported this week; test positivity 13.5% (↓ from 12.3% last week)
 - CNMI has reported 265 total cases and 2 deaths with 7 new cases (imported) and 0 new deaths reported this week; no community transmission
 - Palau has reported 5 total cases (3 travelers in restricted movement, 2 contacts) with 0 new cases this week; no community transmission detected
 - American Samoa reported their first imported case last week (traveler from Honolulu who tested positive in quarantine)
 - FSM and RMI have had no community transmission
- COVID-19 Vaccine distribution summary (See USAPI Vaccine Summary with 25 updated tables and figures listed below)
 - Based on jurisdictional reports: a total of 244,279 people in the region are fully vaccinated (76% of all eligible individuals)
 - An additional 13,054 people in the region are partially vaccinated (4% of eligible individuals in the region)
 - Note: eligible individuals are 12+ for AS, CNMI, Guam and Palau, Kosrae but still 18+ for Chuuk, Pohnpei, Yap, and RMI
 - Based on data submitted into Tiberius via WebIZ: **80% of all people aged 12 years and older have had at least one dose of a COVID-19 vaccine; 71% are fully vaccinated.** This percentage includes islands who have yet to start vaccinating their adolescents due to no Pfizer availability: RMI and Pohnpei, Chuuk, and Yap of the FSM. Note: RMI and Yap to roll out Pfizer within the next week or two.
 - Current percentages of eligible population **aged 12 and over** fully vaccinated (**with change from last week's data in parenthesis**):
 - **American Samoa: 75% (+3%)**
 - **FSM: Chuuk: 43% (+1%), Kosrae: 64% (+8%), Pohnpei: 52% (+2%), Yap: 66% (+1%)**
 - **Guam: 82% (+2%)**
 - **RMI: 55% (--%)**
 - **CNMI: 82% (+1%)**
 - **Palau: >99% (--%)**
 - Outer island vaccinations: Outer Island coverage rates from jurisdictional outer island outreach activities due to difficulty in determining denominators and true residence in Tiberius.
 - **RMI Outer Islands:** At least one dose **39% (--%)**; Fully **25% (--%)**
 - **Yap Outer Islands:** At least one dose **67% (--%)**; Fully **63% (--%)**
 - **Chuuk Outer Islands (out of the lagoon):** Fully **31% (+17%)** (updated OI numbers received this week, though they are likely still incomplete)
 - **Pohnpei Outer Islands:** Fully **16% (--%)**
- COVID-19 Containment strategies
 - Guam is allowing vaccinated travelers or unvaccinated travelers with negative test 72 hours prior to arrival to enter without testing or quarantine.
 - CNMI is allowing travelers with facility quarantine requirement (5-day test out option).
 - Palau is running regular Guam flights with quarantine exemptions for vaccinated travelers (but with restricted movement) and testing on days 1&5.
 - RMI has regular repat flights ongoing with HNL/in-country quarantine and testing requirements.
 - AS is running HNL flights using "Talofa Pass" system with pre-travel testing and AS quarantine (no longer HNL quarantine).
 - FSM continues smaller repat flights with Guam/FSM quarantine and testing requirements.
- COVID-19 Laboratory Testing capacity
 - Supplies of Abbott ID NOW, Abbott Binax, and GeneXpert are low in some USAPI as travel testing demands increase; difficulties with procurement.
- Community mitigation strategies
 - Guam is in PCOR-3 but is now requiring vaccination to enter indoor locations; schools also remain closed due to delta surge.
 - CNMI, American Samoa, FSM, Palau, and RMI have relaxed most mitigation measures.

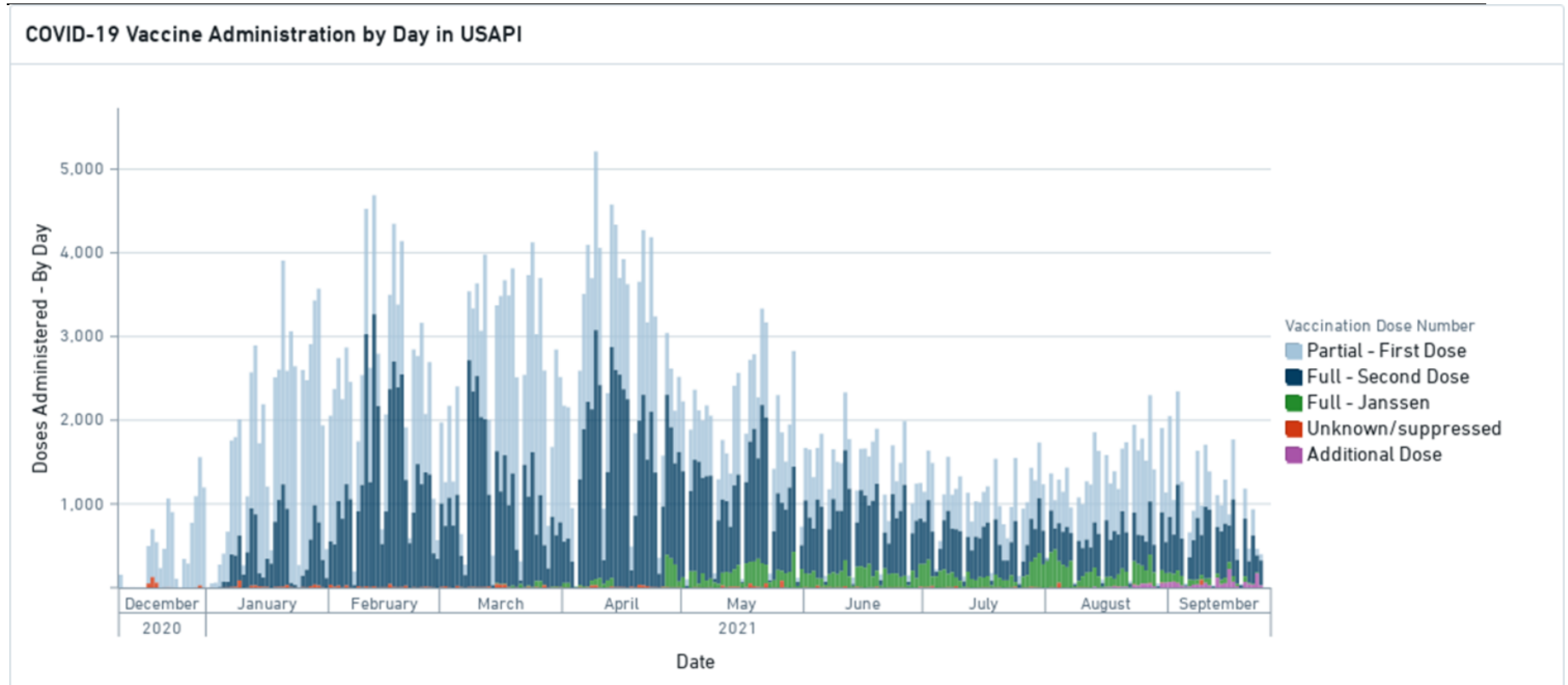

US-affiliated Pacific Islands Region

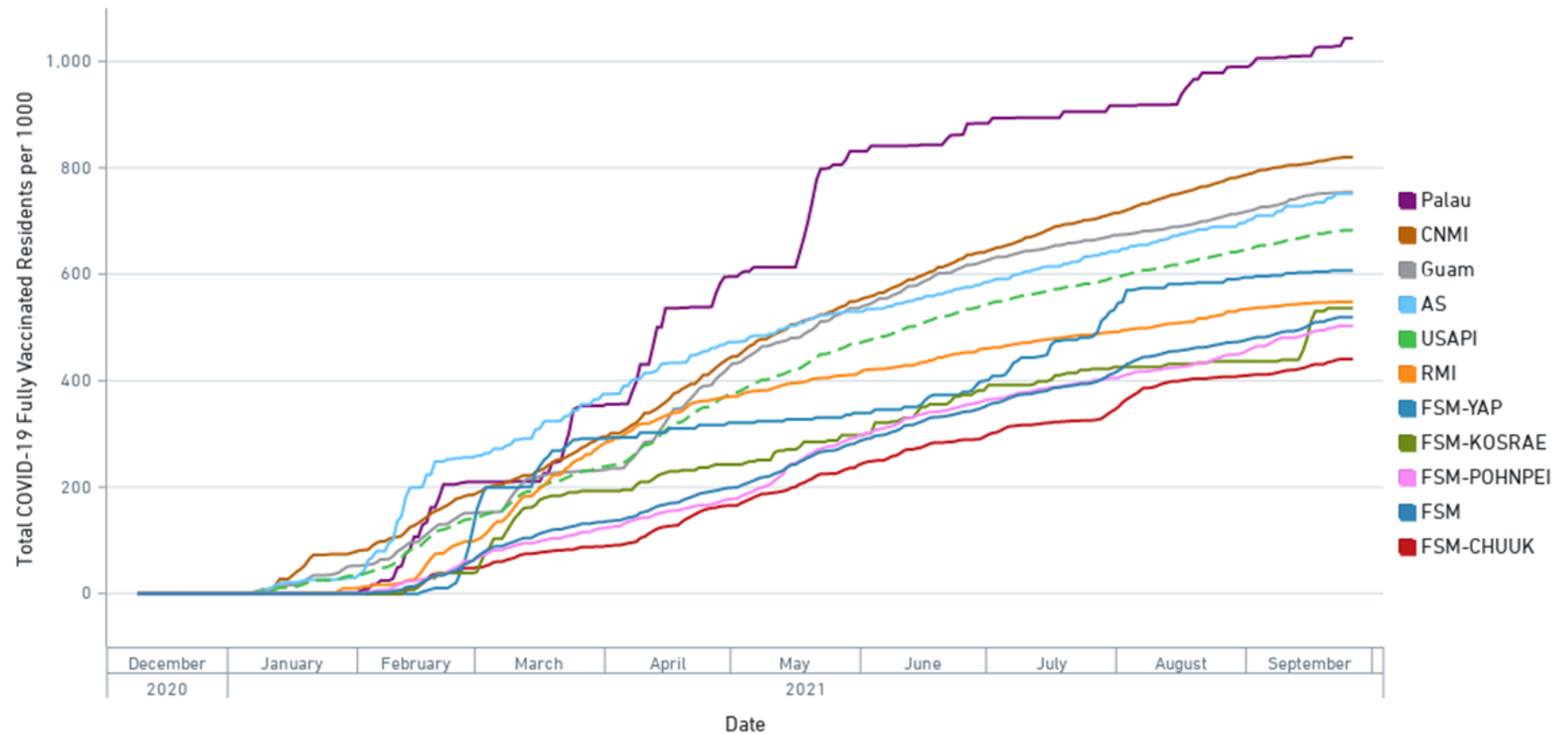

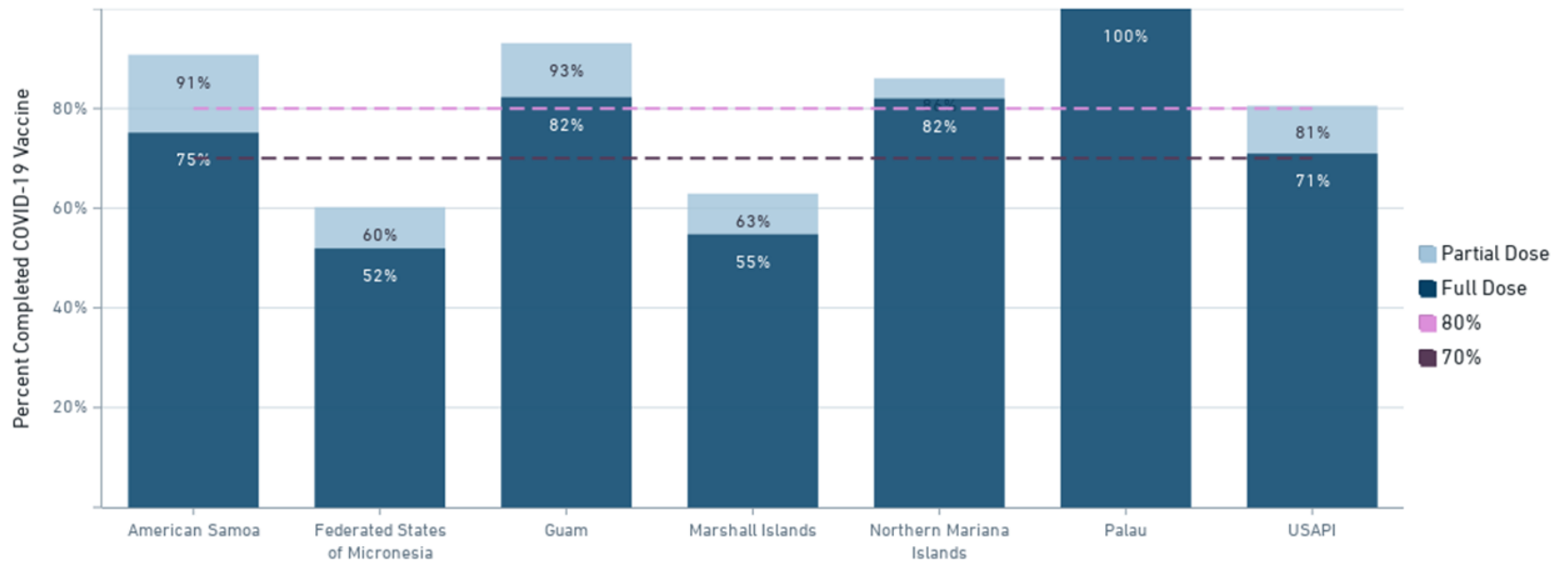

Striving for 80% USAPI COVID-19 Vaccine Progress (12+ yrs old as eligible population)



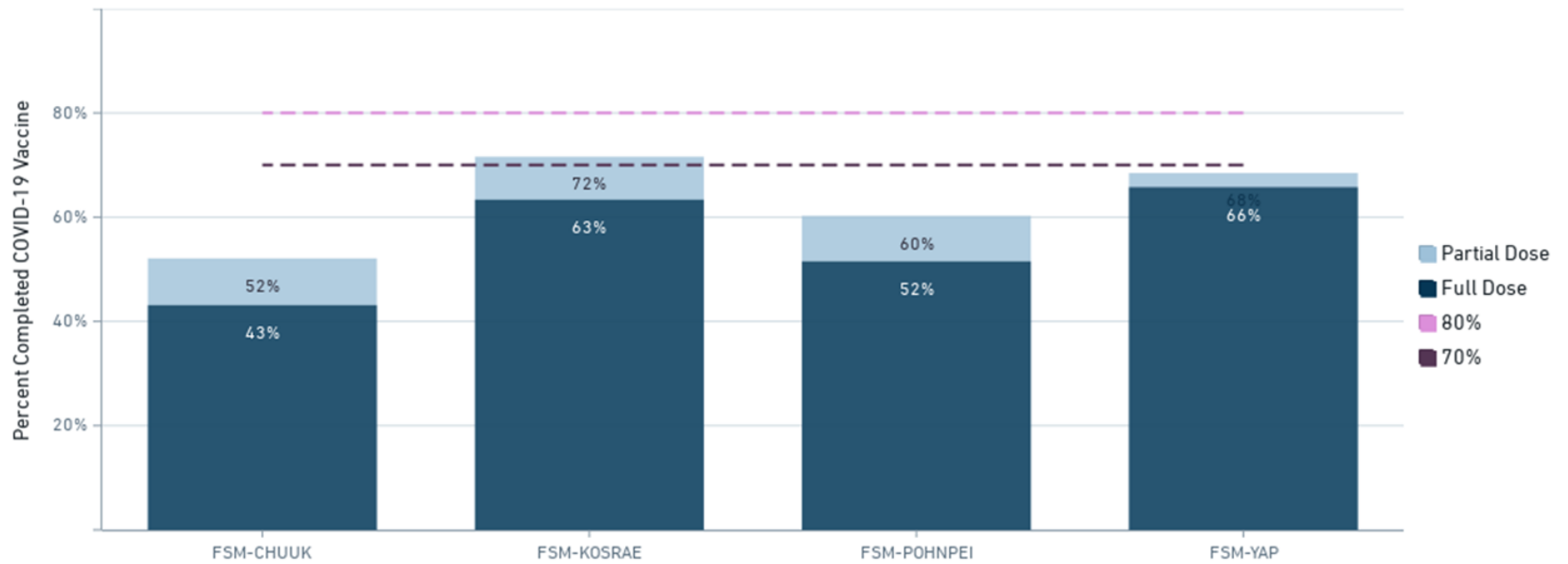

Striving for 80% USAPI COVID-19 Vaccine Progress (12+ yrs old as eligible population) (FSM States)

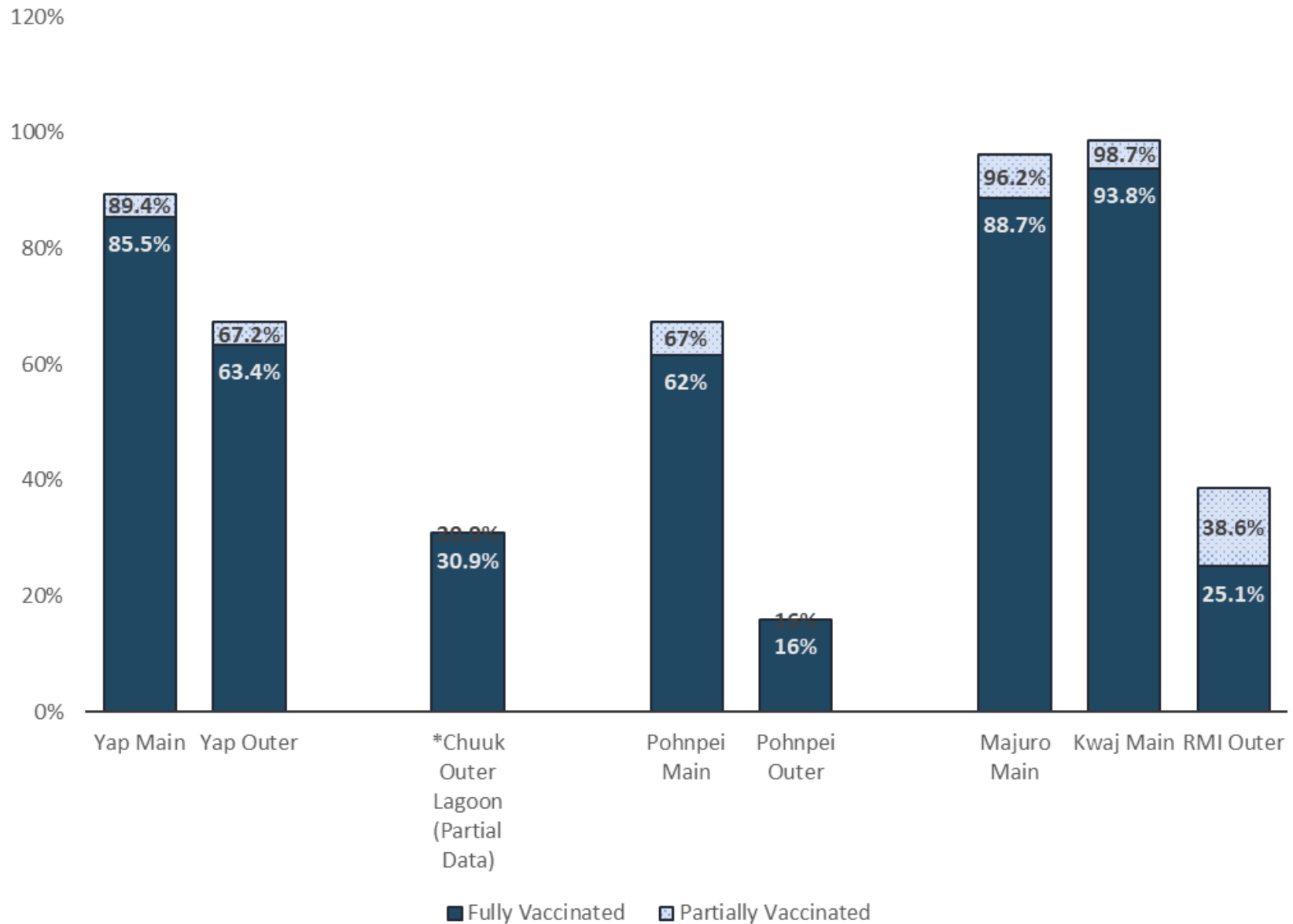

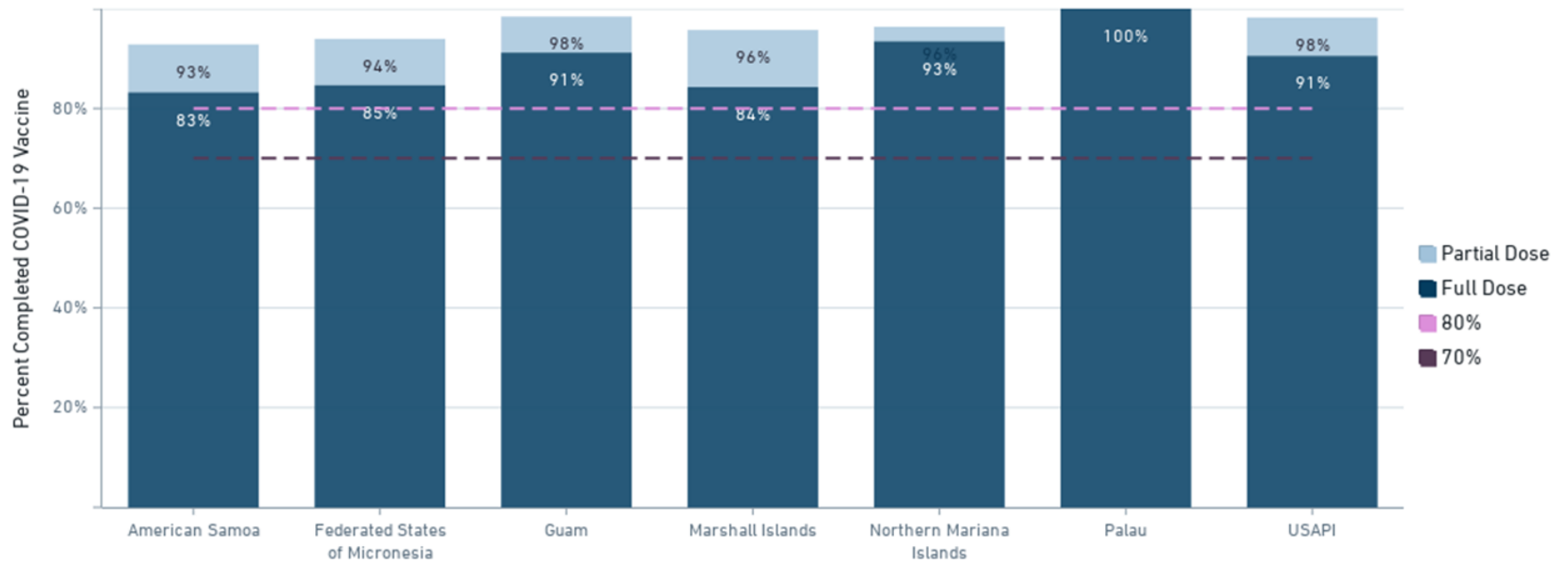

USAPI COVID-19 Vaccine Progress: 50 yrs and over

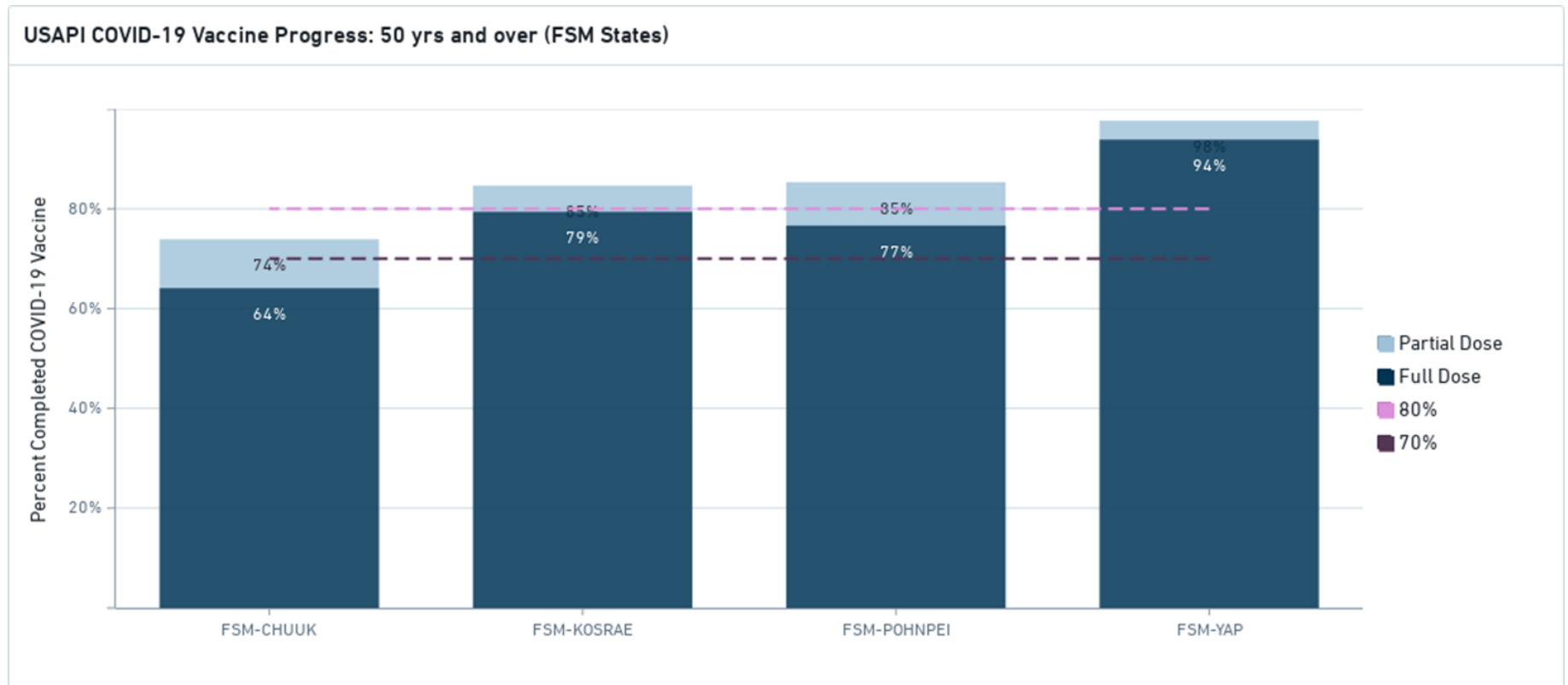

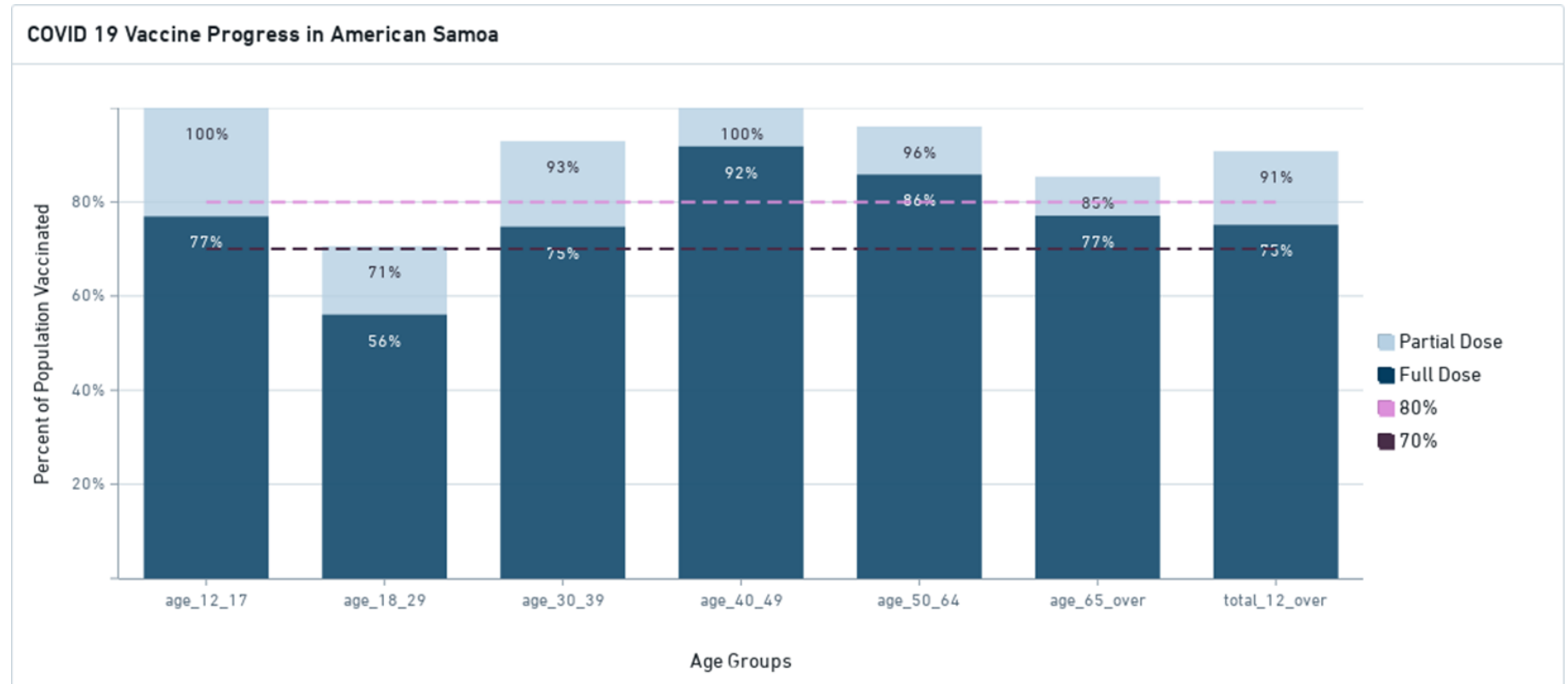

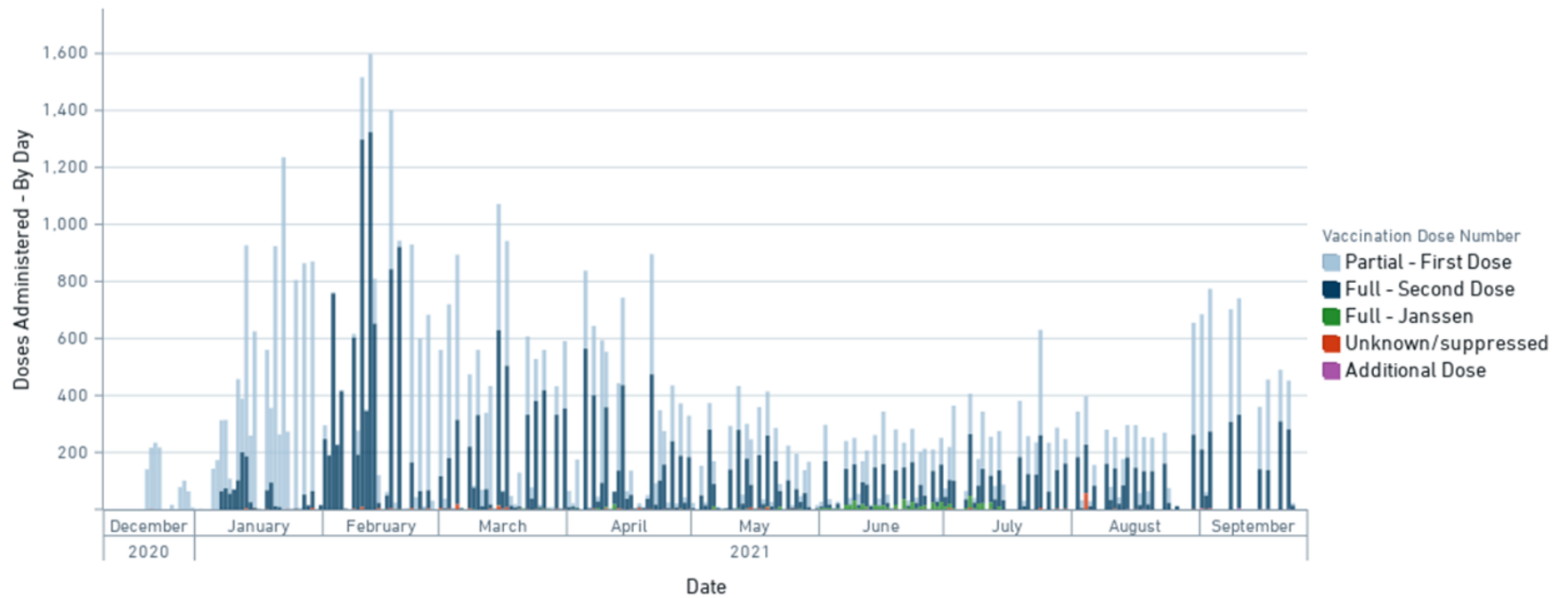

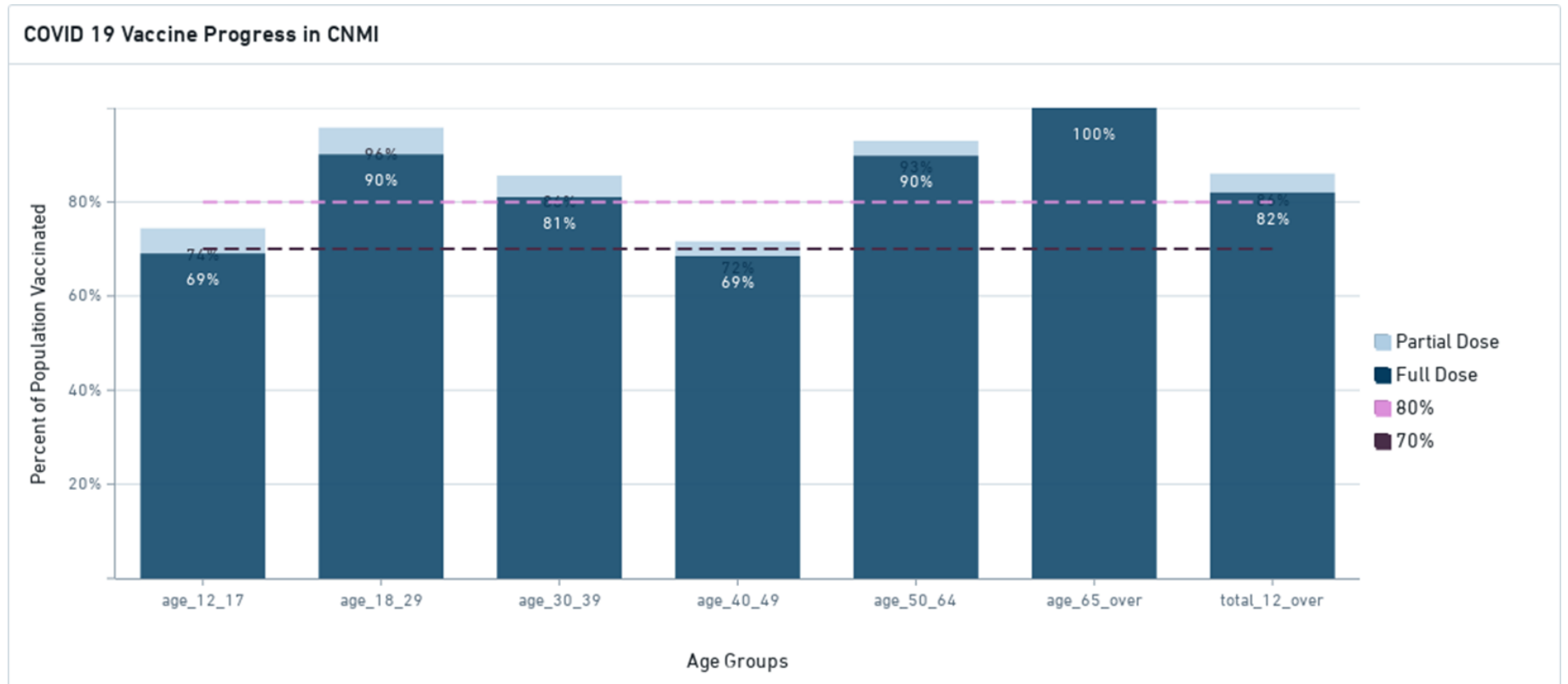
COVID-19 Vaccine Administration by Day in American Samoa

Commonwealth of the Northern Mariana Islands

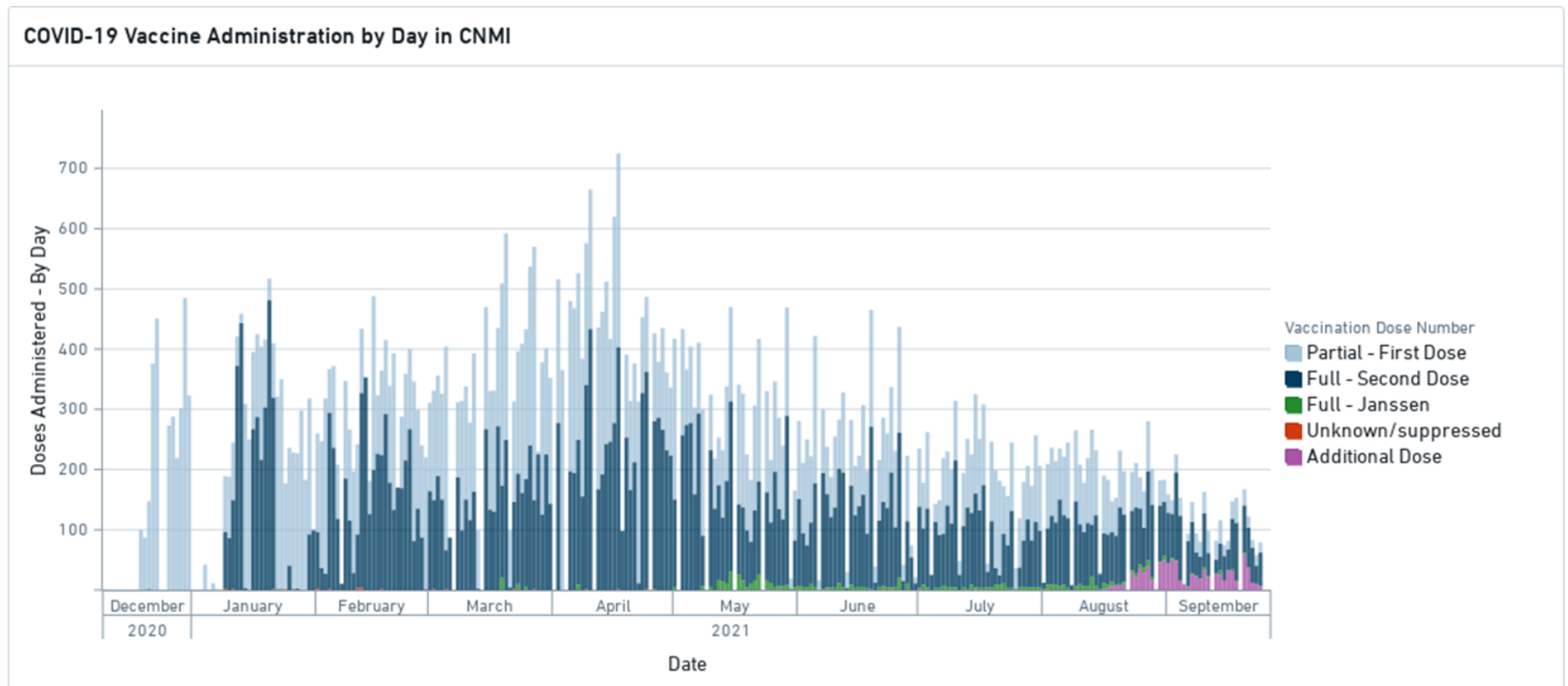

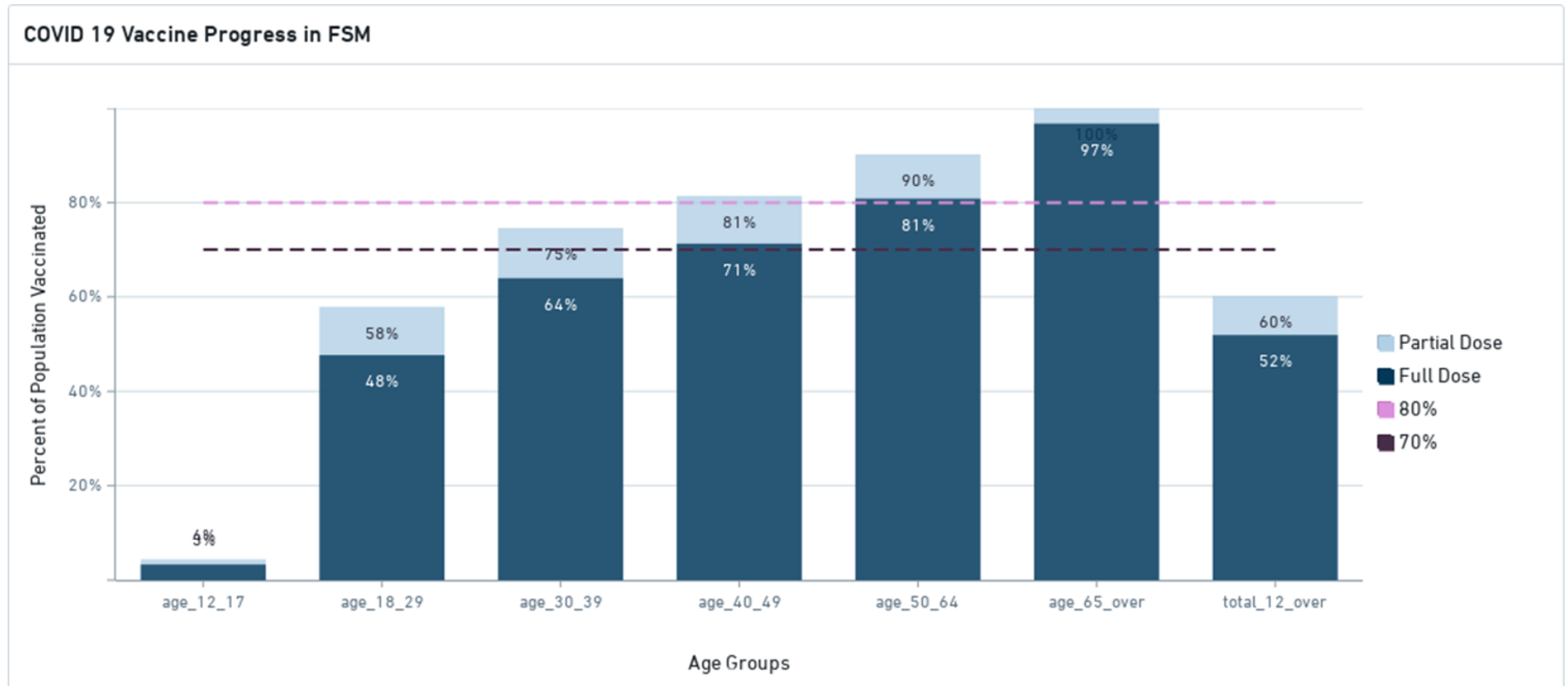

Federated States of Micronesia

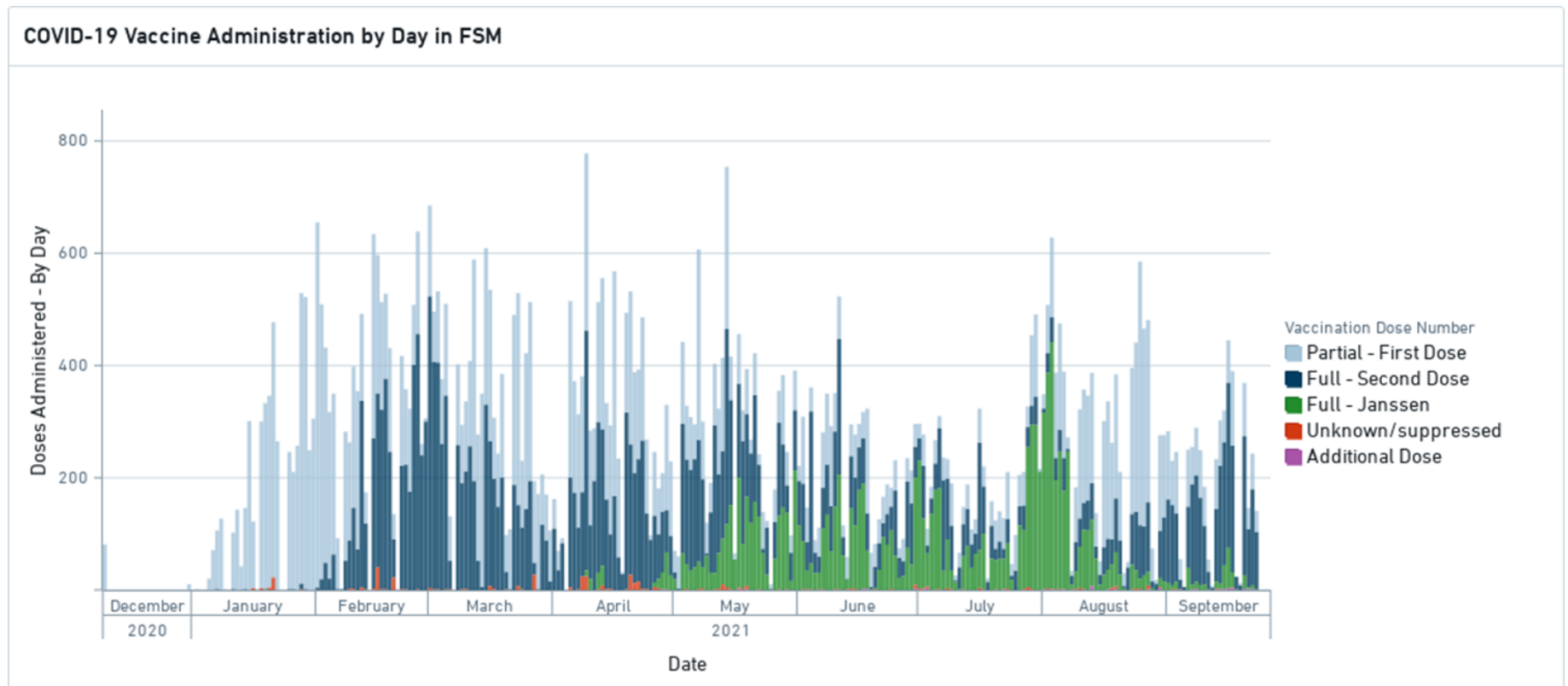

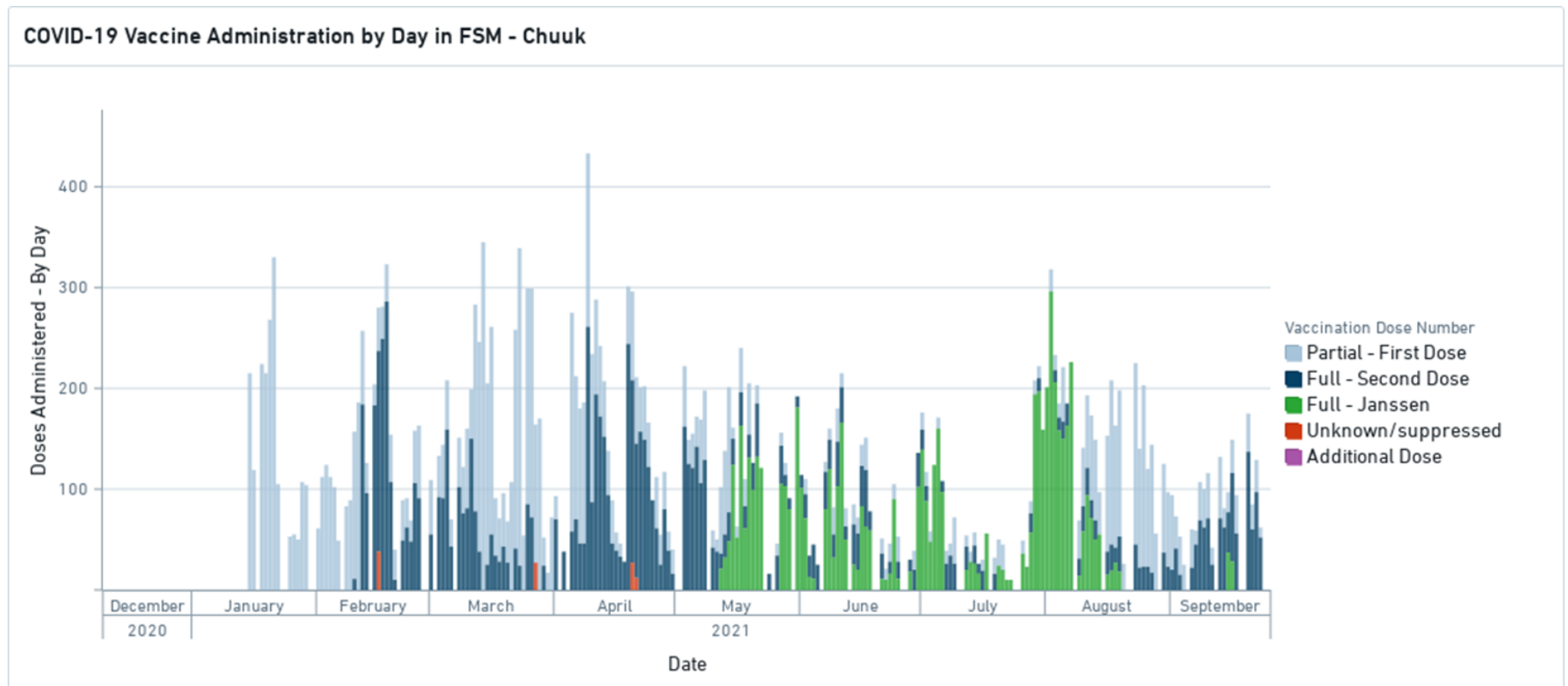

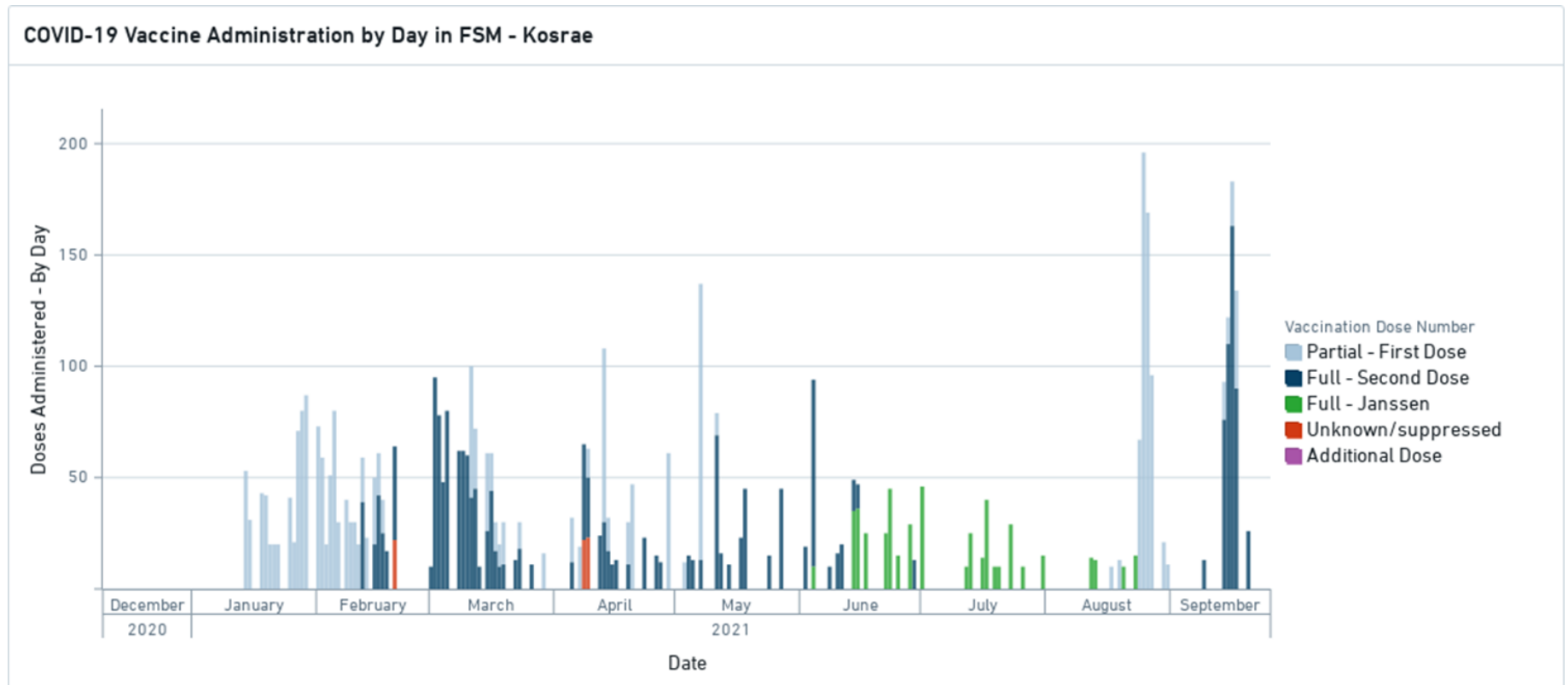

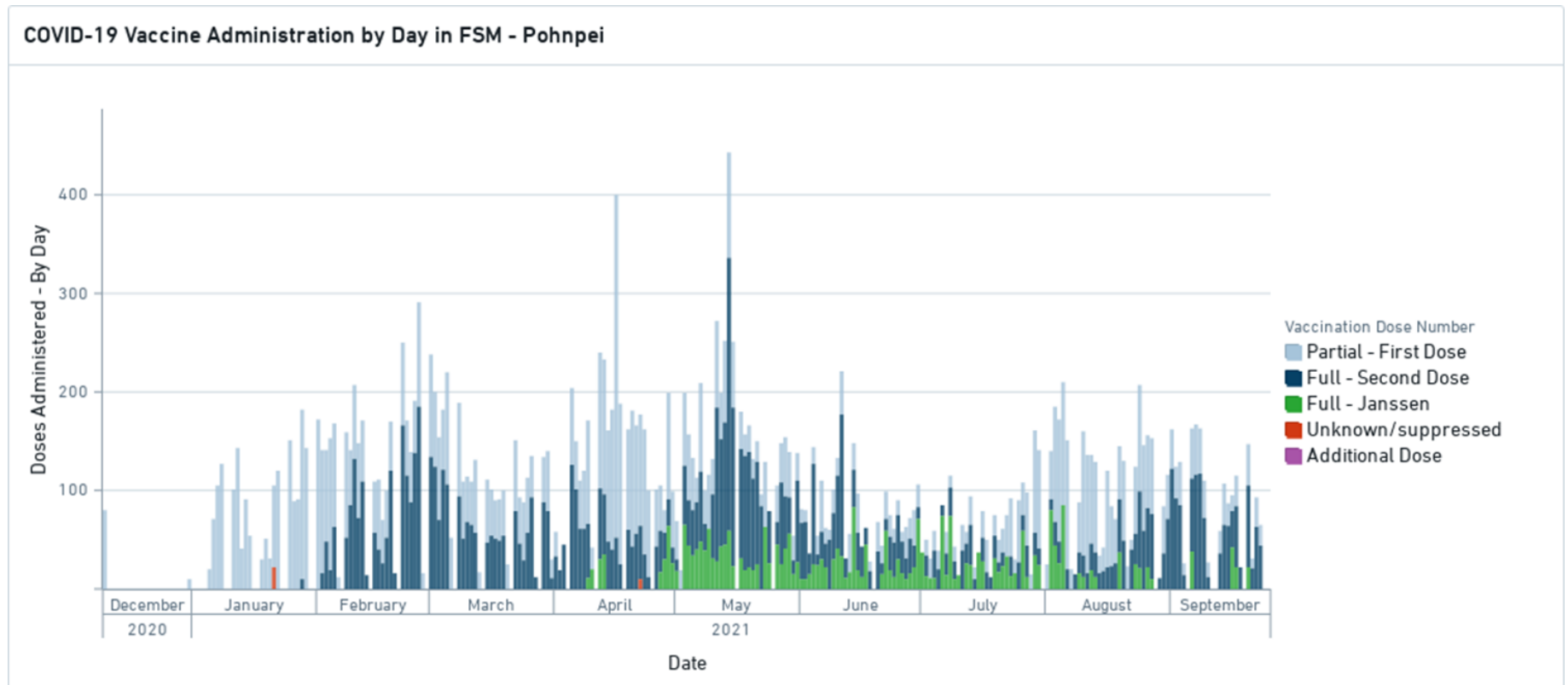

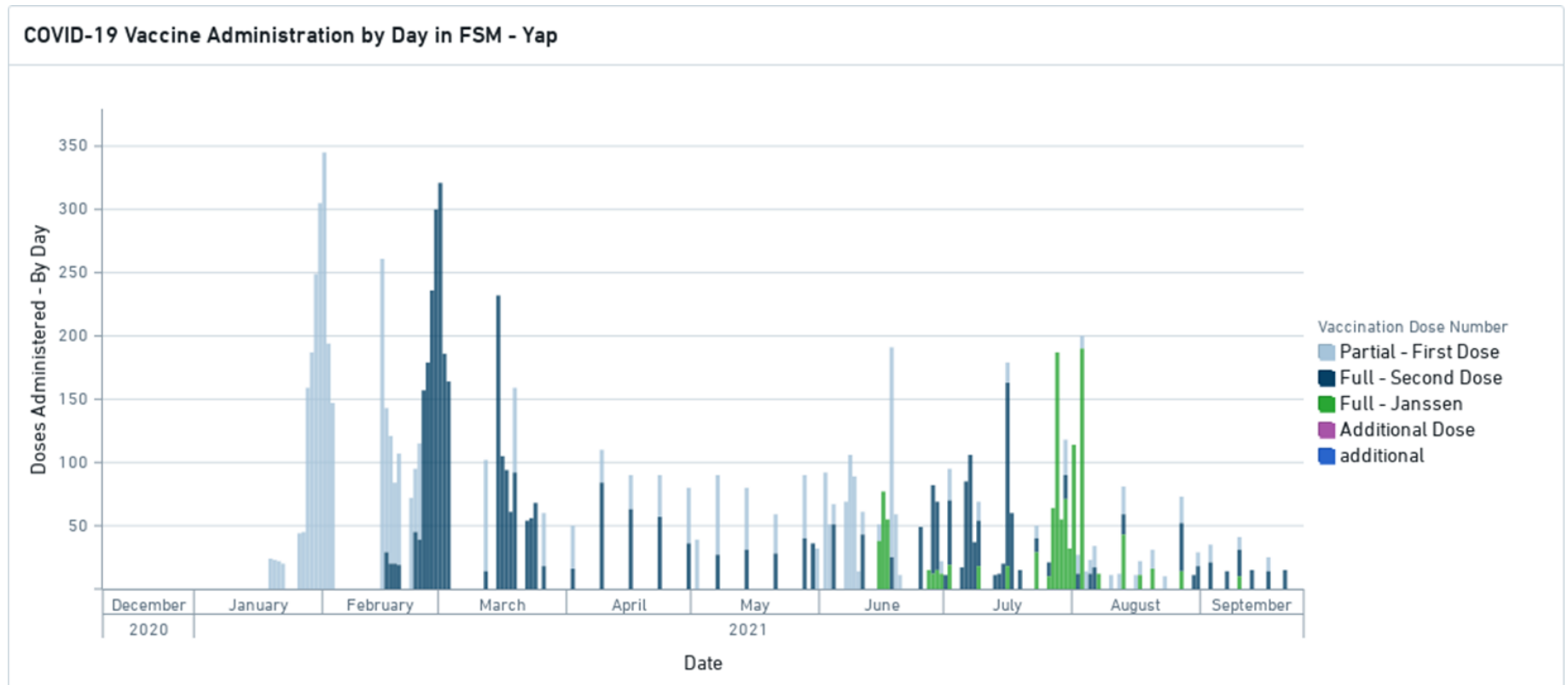

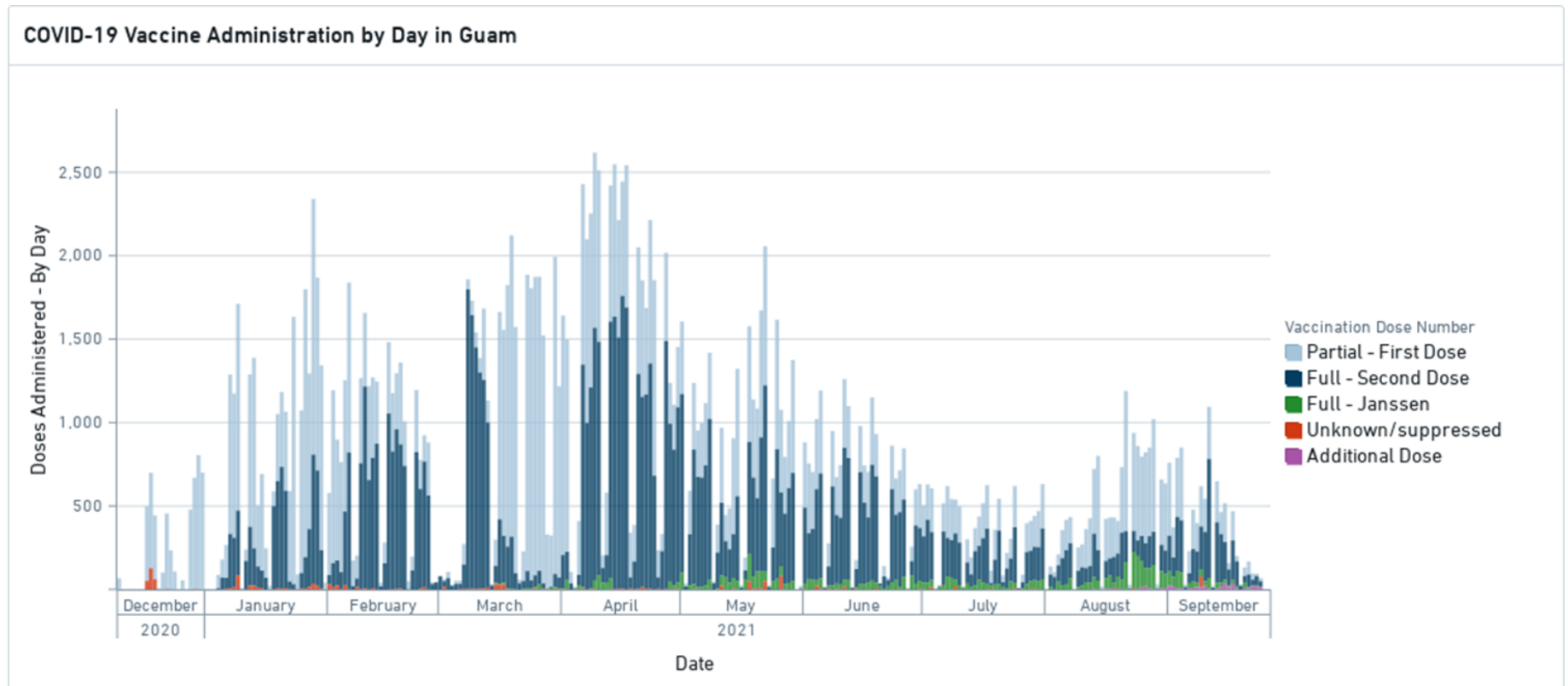

Republic of Marshall Islands

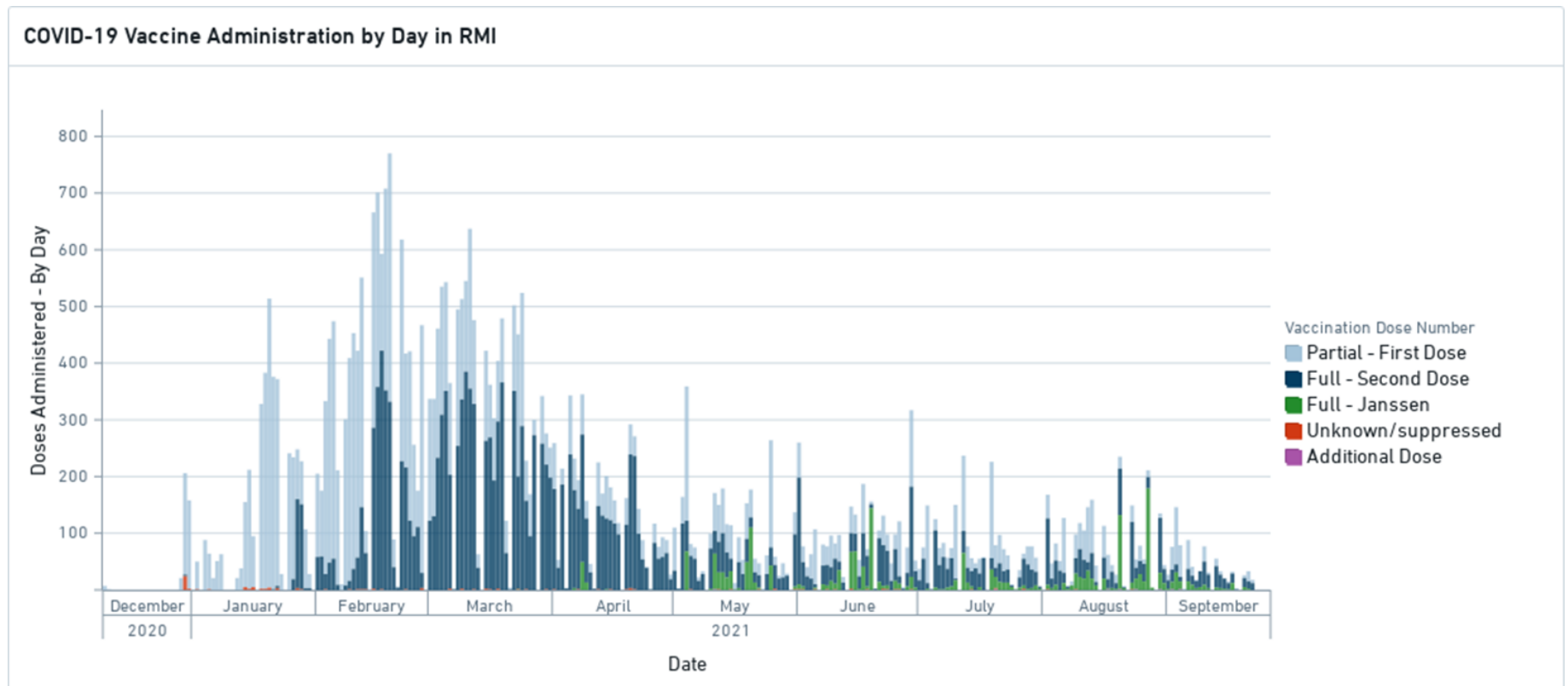

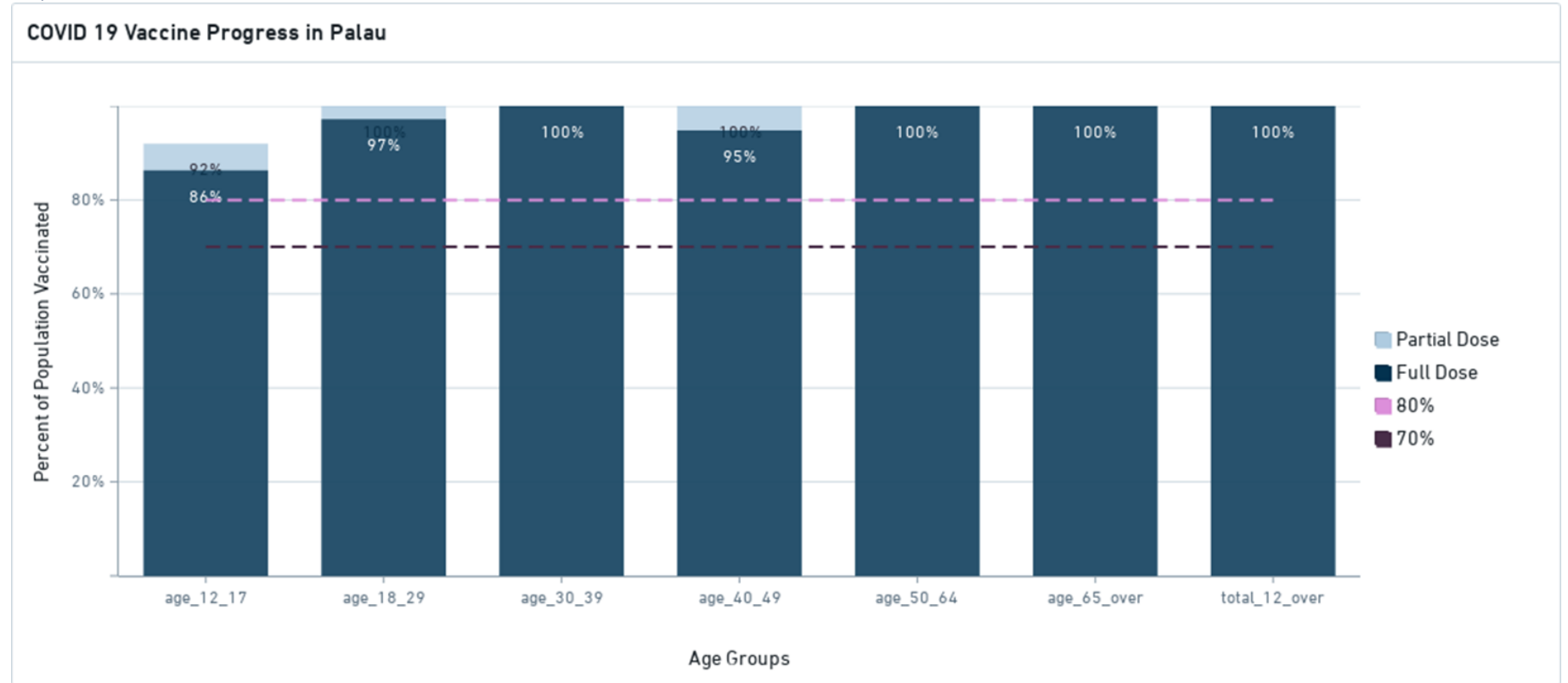

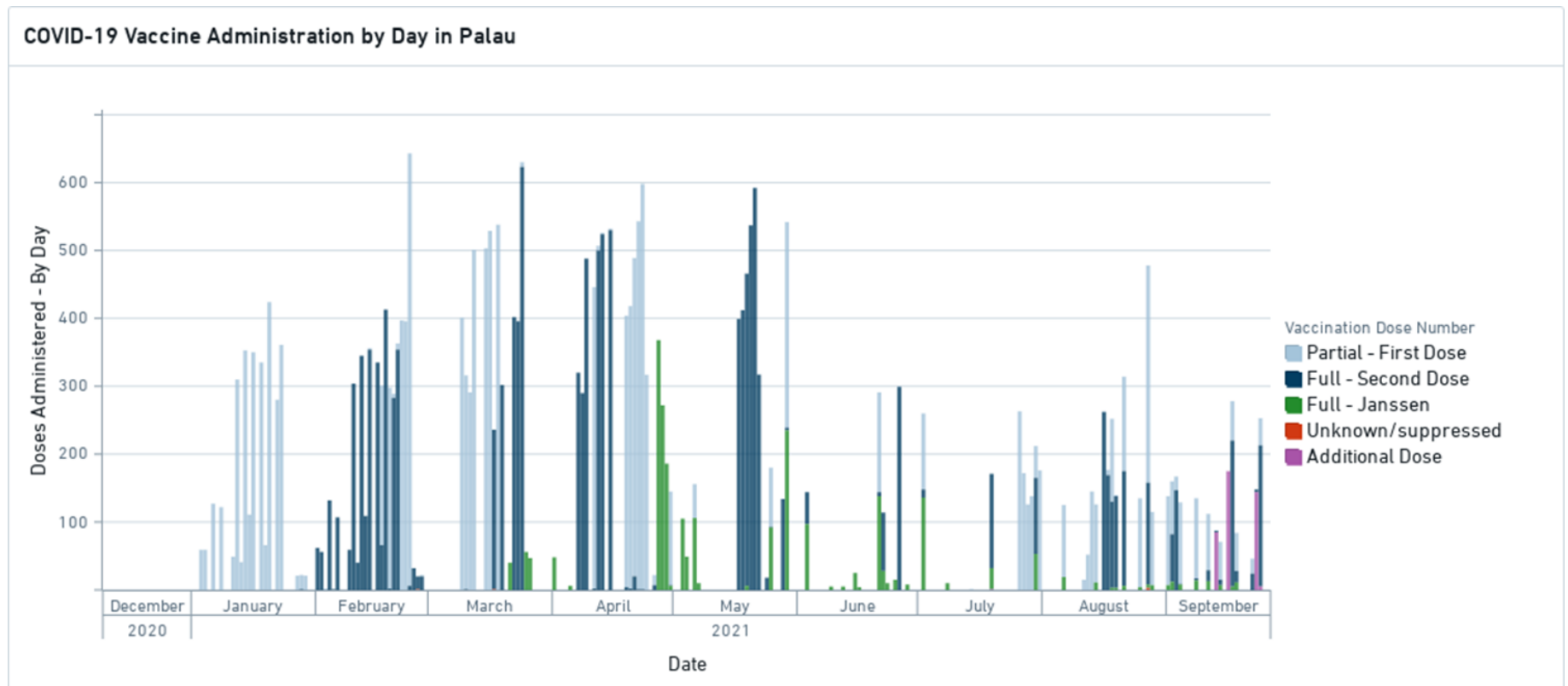
