Regional Summary:

- COVID-19 cases
 - Guam has reported 17,472 total cases and 227 deaths with 677 new cases (↓ from 737 new cases reported last week) and 5 new deaths reported this week (↓ from 10 new death last week); test positivity 10.5% (↓ from 11.6% last week)
 - CNMI has reported 289 total cases and 3 deaths; 7 new cases (imported) and 0 new deaths reported this week; no community transmission
 - Palau has reported 8 total cases (6 travelers in restricted movement, 2 contacts) with 0 new cases this week; no community transmission
 - American Samoa has reported 4 total cases (all imported) with 1 new case reported this week
 - FSM and RMI have had no community transmission
- COVID-19 Vaccine distribution summary (See USAPI Vaccine Summary with 25 updated tables and figures listed below)
 - Based on jurisdictional reports: a total of 255,789 people in the region are fully vaccinated (79% of all eligible individuals / +0%)
 - An additional 11,888 people in the region are partially vaccinated (4% of eligible individuals in the region)
 - Note: eligible individuals are 12+ for AS, CNMI, Guam, Palau, Kosrae, and RMI but still 18+ for Chuuk, Pohnpei, and Yap (though Yap to begin adolescent Pfizer administration soon)
 - Based on data submitted into Tiberius via WebIZ: **86% of all people aged 12 years and older have had at least one dose of a COVID-19 vaccine; 77% are fully vaccinated.** This percentage includes islands who have yet to start vaccinating their adolescents due to no Pfizer availability: Pohnpei, Chuuk, and Yap of the FSM. Note: RMI began Pfizer rollout in Majuro this week and Yap to begin Pfizer rollout next week.
 - Current percentages of eligible population **aged 12 and over** fully vaccinated (**with change from last week's data in parenthesis**):
 - **American Samoa: 83% (+3%)**
 - **FSM: Chuuk: 48% (+1%), Kosrae: 68% (+1%), Pohnpei: 55% (+1%), Yap: 68% (+1%)**
 - **Guam: 89% (+2%)**
 - **RMI: 56% (--%)**
 - **CNMI: 84% (+1%)**
 - **Palau: >99% (--%)**
 - Outer island vaccinations: Outer Island coverage rates from jurisdictional outer island outreach activities due to difficulty in determining denominators and true residence in Tiberius.
 - **RMI Outer Islands:** At least one dose **48% (+9%)**; Fully **35% (+6%)** (denominators adjusted based on OI reports and expanded to 12+)
 - **Yap Outer Islands:** At least one dose **98% (--%)**; Fully **95% (--%)** (denominators adjusted to locally collected denominators)
 - **Chuuk Outer Islands (out of the lagoon):** Fully **31% (--%)** (OI numbers are incomplete)
 - **Pohnpei Outer Islands:** Fully **63% (+47%)** (new data received, and denominator adjusted based on OI reports)
- COVID-19 Containment strategies
 - Guam is allowing vaccinated travelers or unvaccinated travelers with negative test 72 hours prior to arrival to enter without testing or quarantine.
 - CNMI is allowing travelers with facility quarantine requirement (5-day test out option).
 - Palau is running regular Guam flights with quarantine exemptions for vaccinated travelers (but with restricted movement) and testing on days 1&5.
 - RMI has regular repat flights ongoing with HNL/in-country quarantine and testing requirements.
 - AS is running HNL flights using "Talofa Pass" system with pre-travel testing and AS quarantine (no longer HNL quarantine).
 - FSM continues smaller repat flights with Guam/FSM quarantine and testing requirements.
- COVID-19 Laboratory Testing capacity
 - Supplies of Abbott ID NOW, Abbott Binax, and GeneXpert are low in some USAPI as travel testing demands increase; difficulties with procurement.

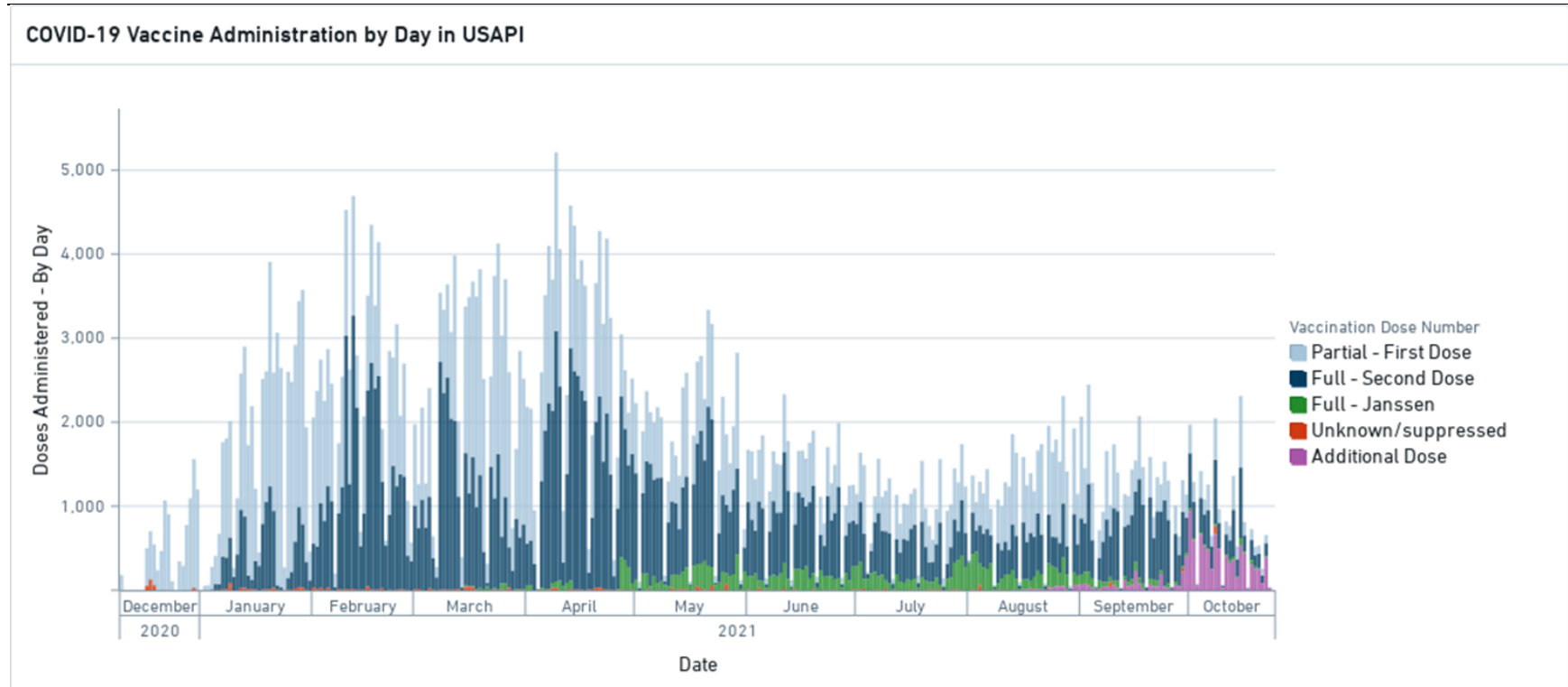

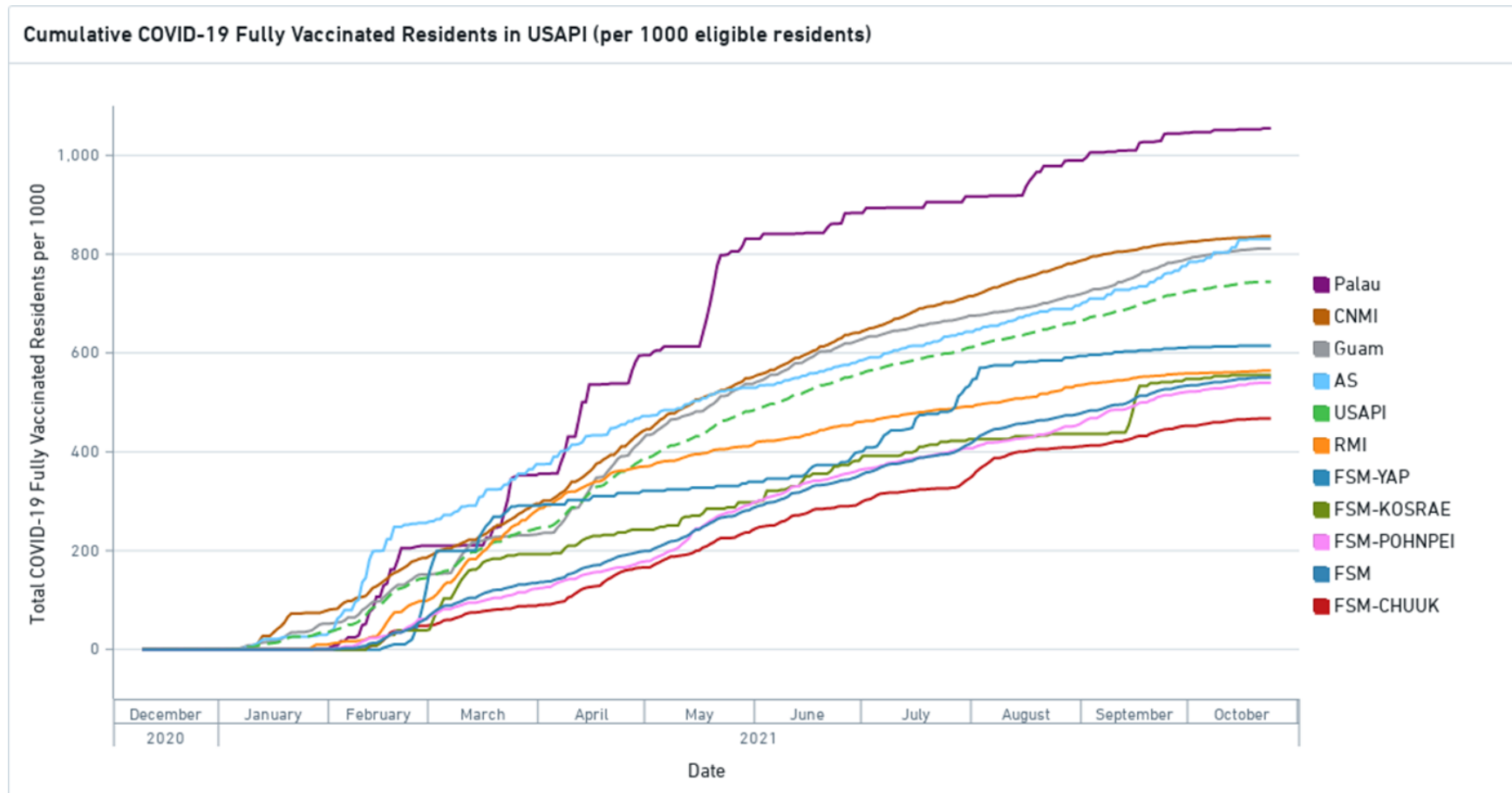
US-affiliated Pacific Islands Region

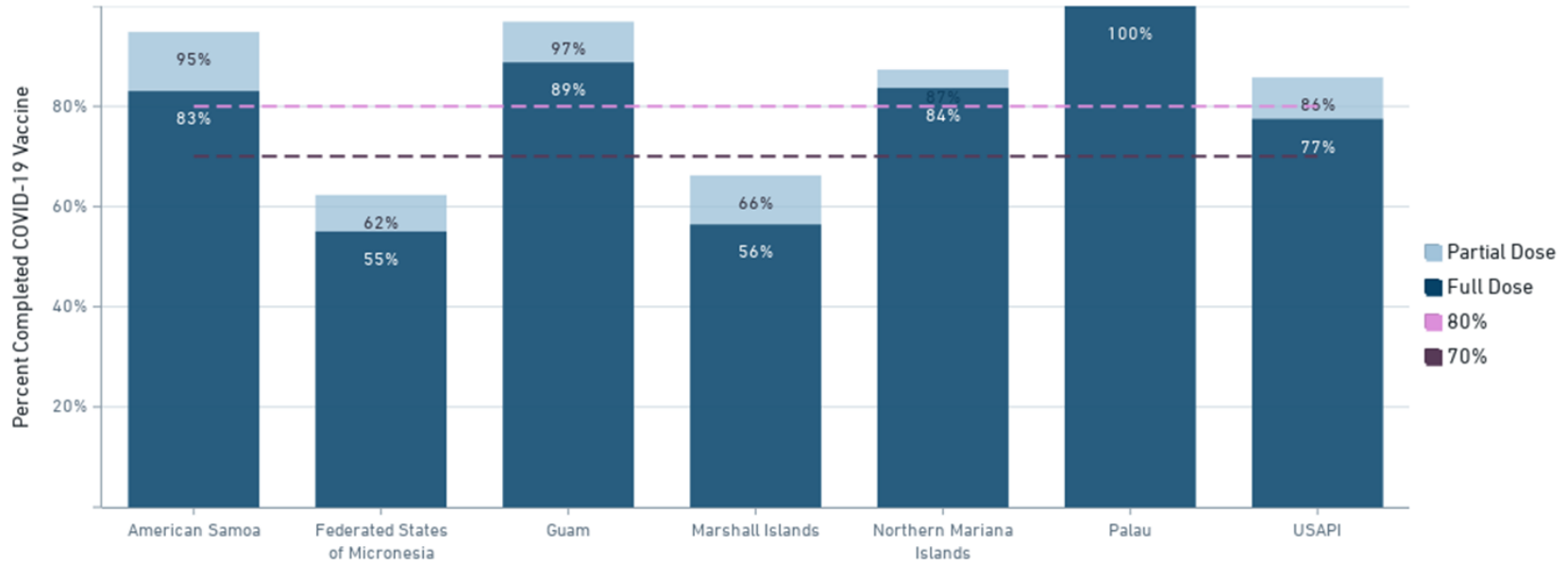

Striving for 80% USAPI COVID-19 Vaccine Progress (12+ yrs old as eligible population)



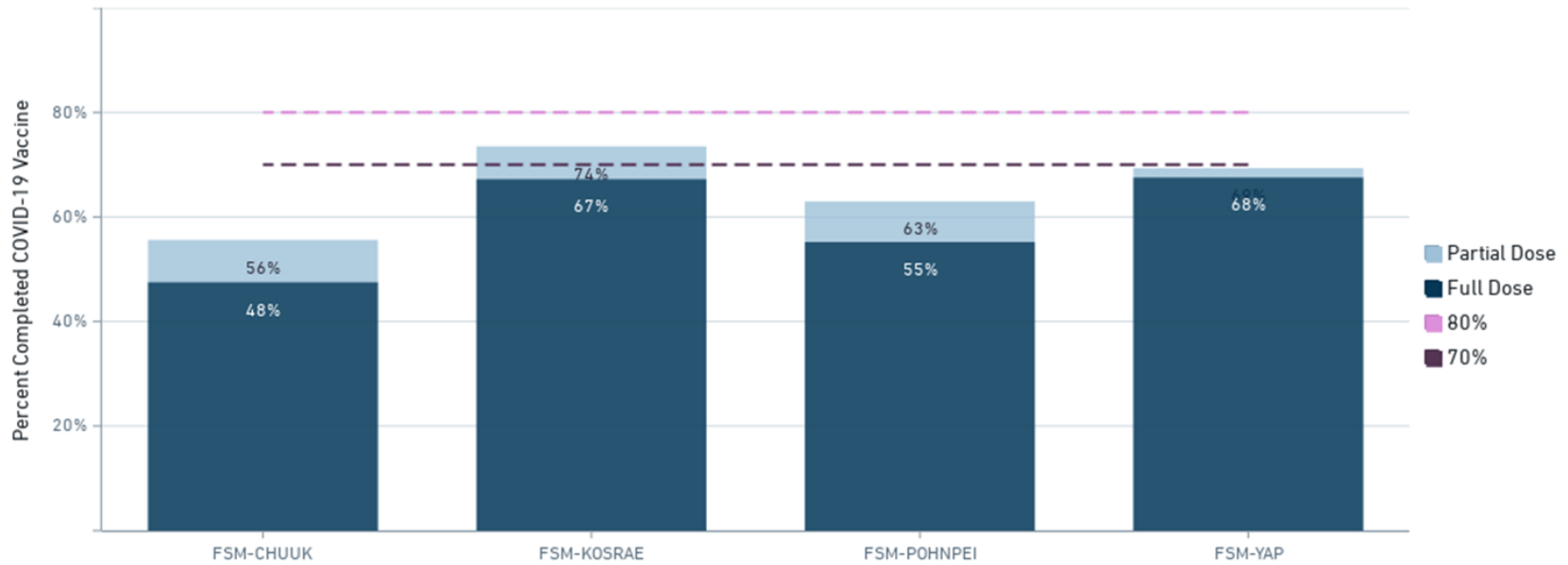

Striving for 80% USAPI COVID-19 Vaccine Progress (12+ yrs old as eligible population) (FSM States)

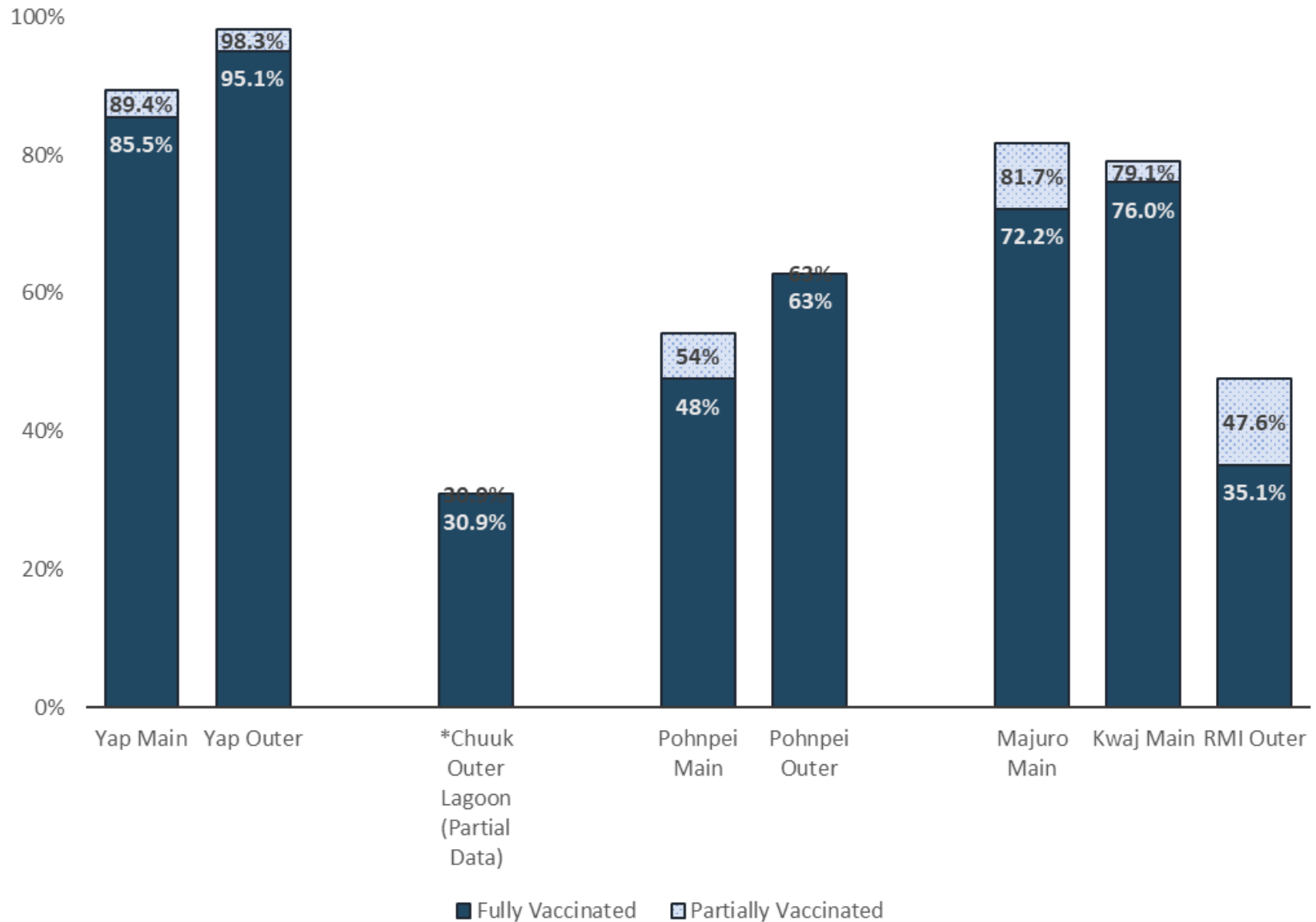

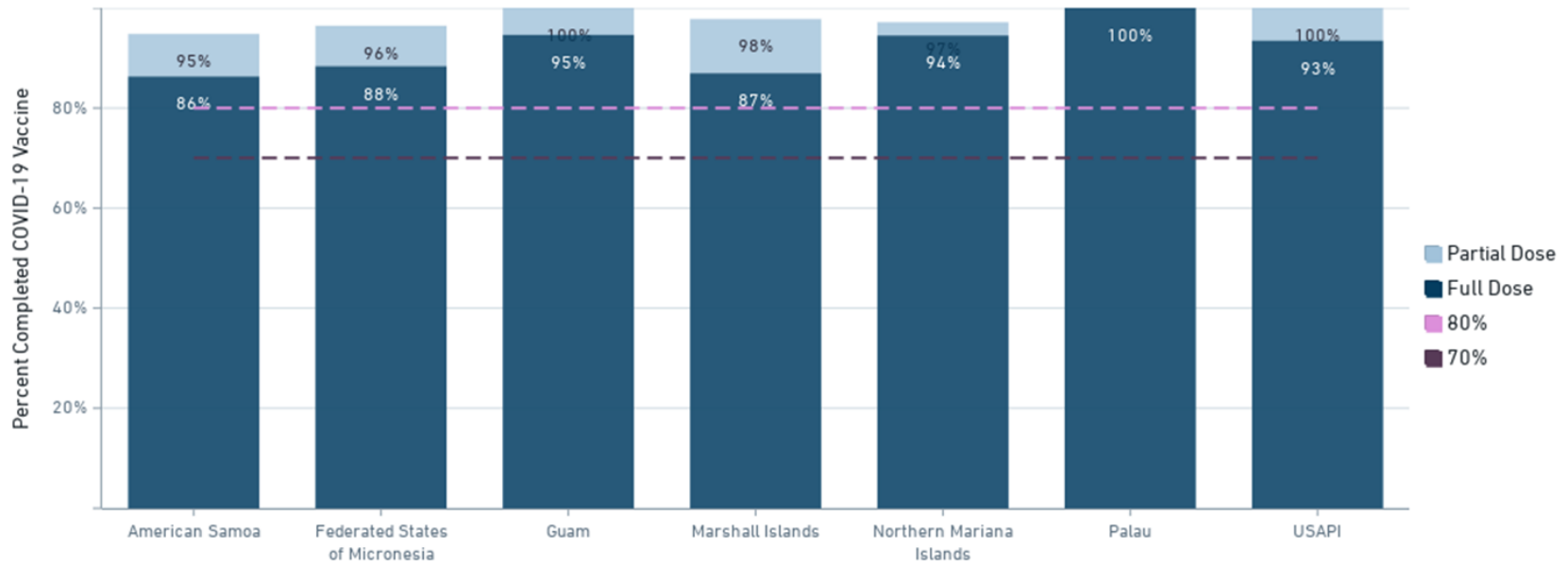

USAPI COVID-19 Vaccine Progress: 50 yrs and over

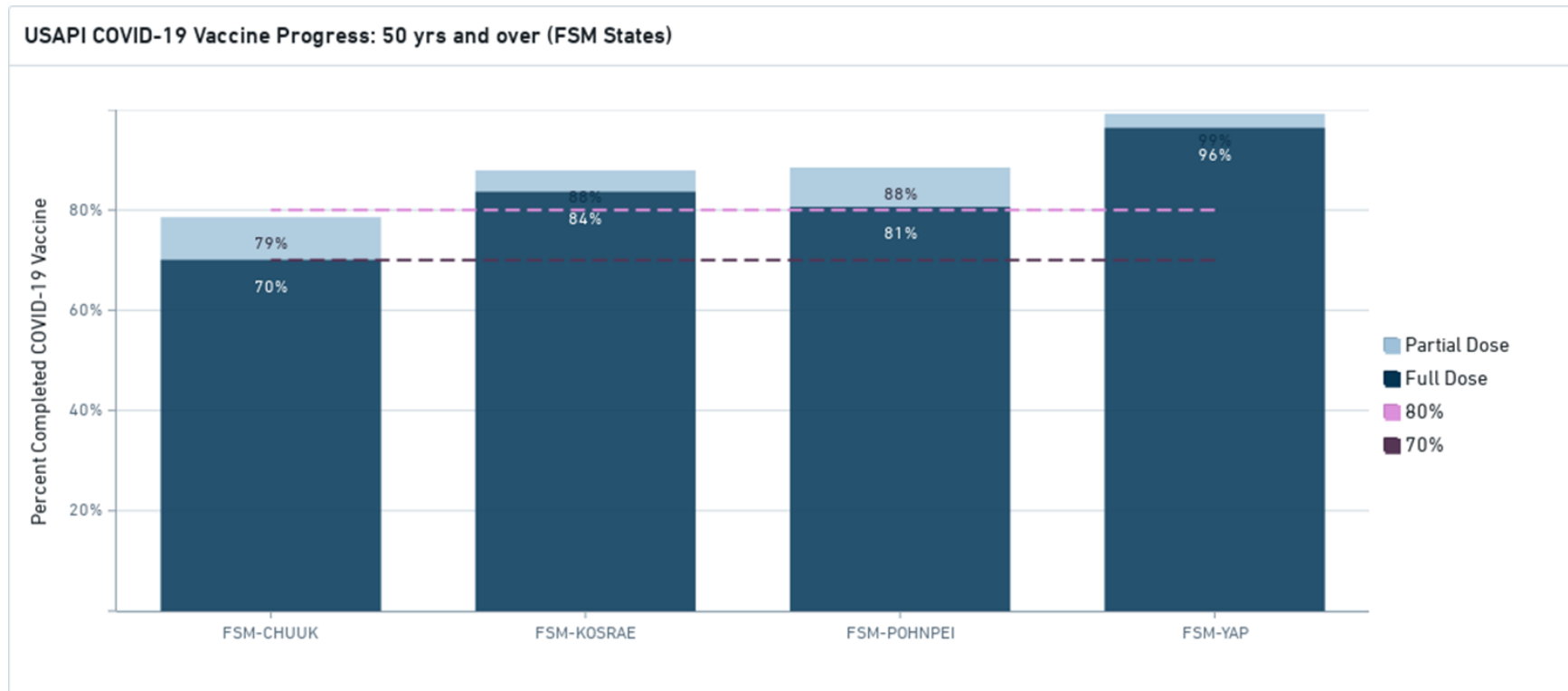

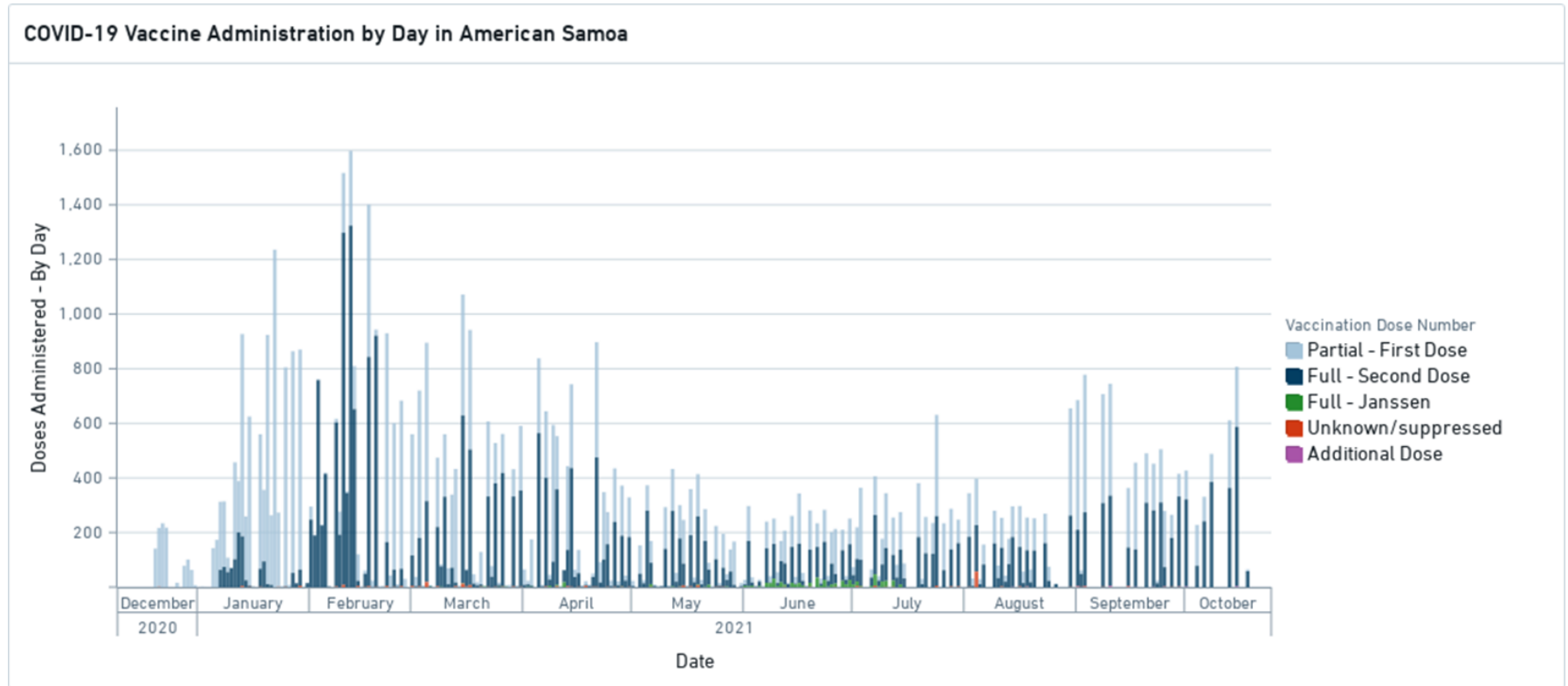

Commonwealth of the Northern Mariana Islands

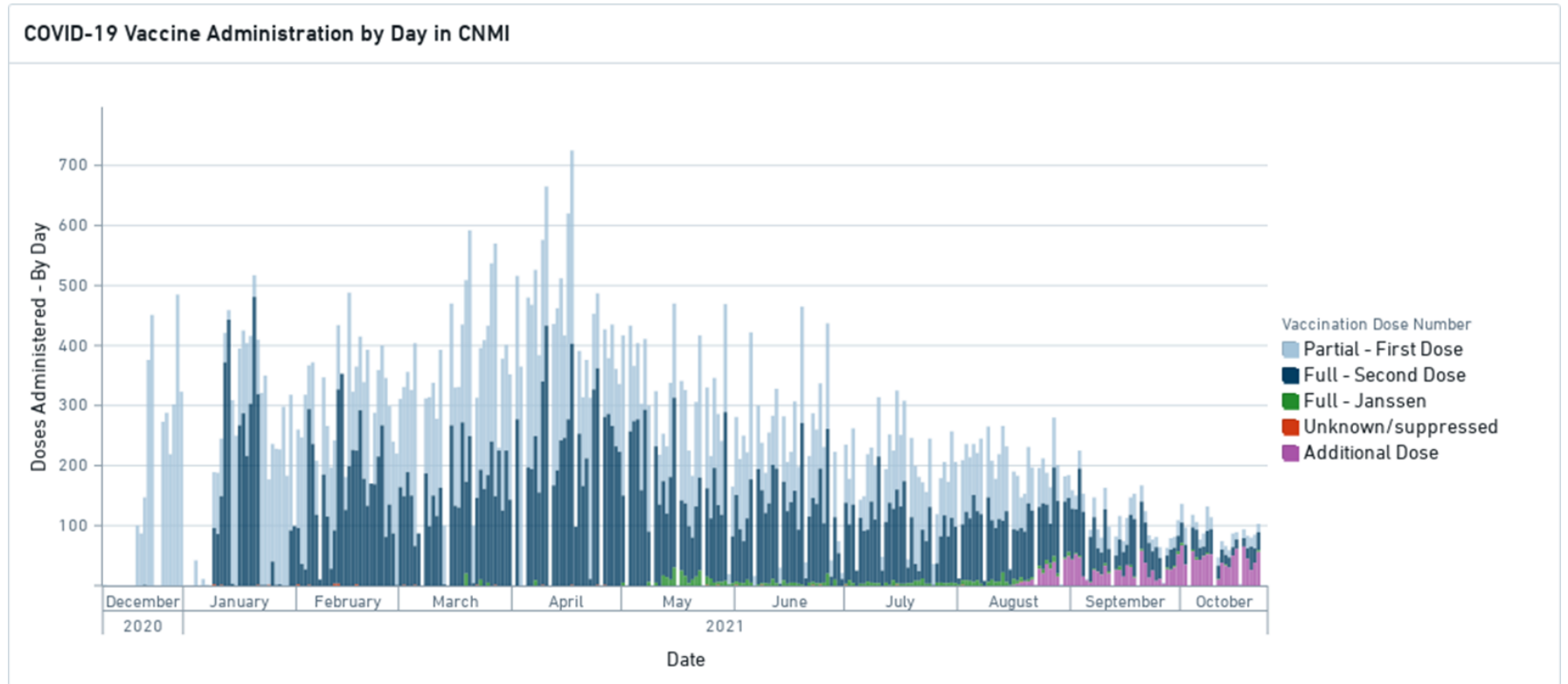

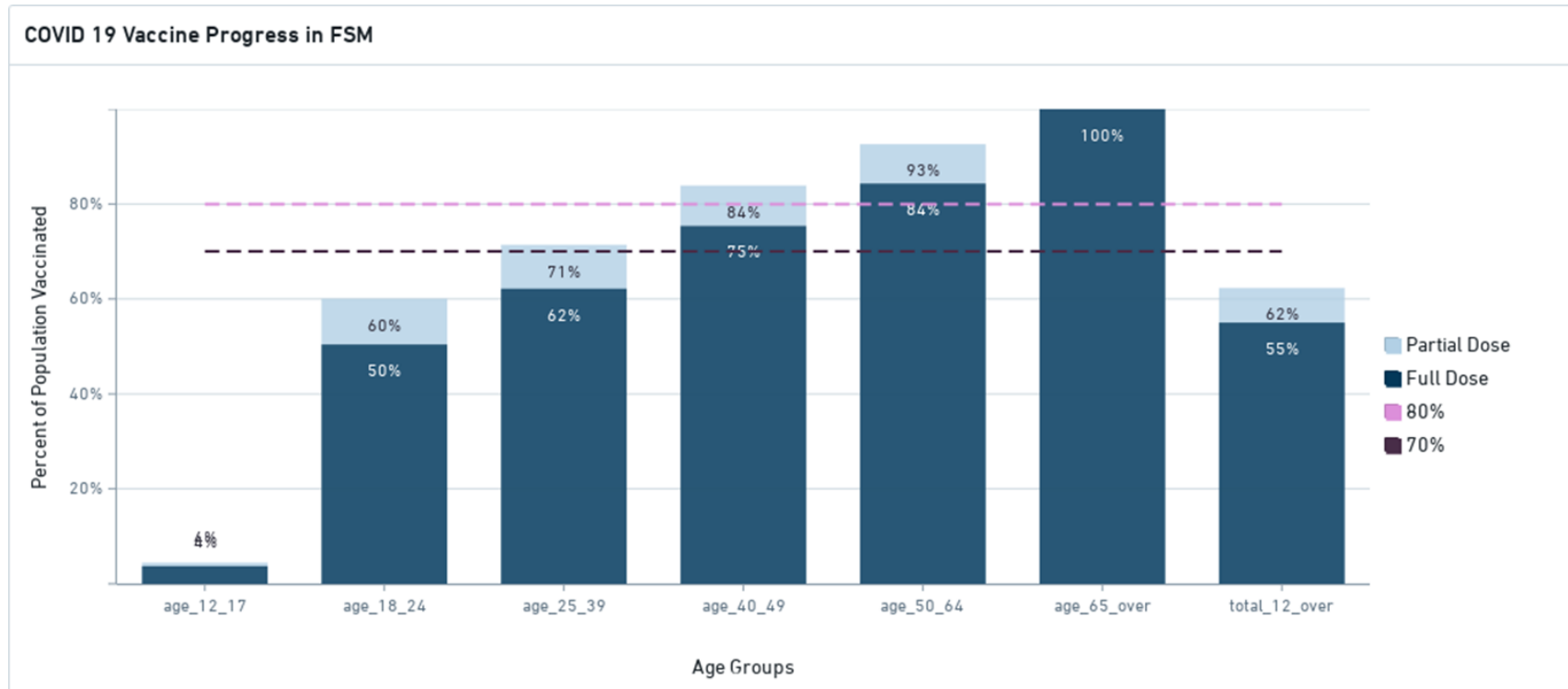

Federated States of Micronesia

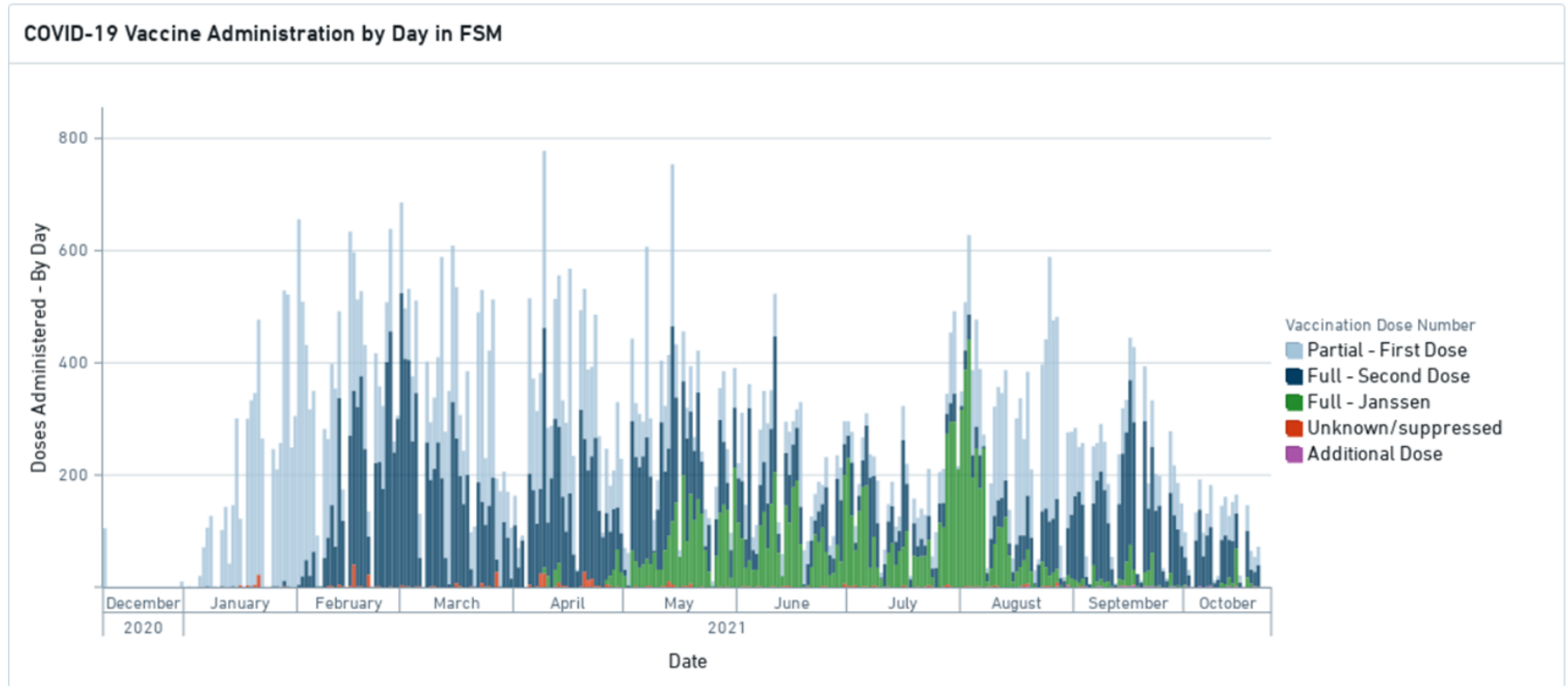

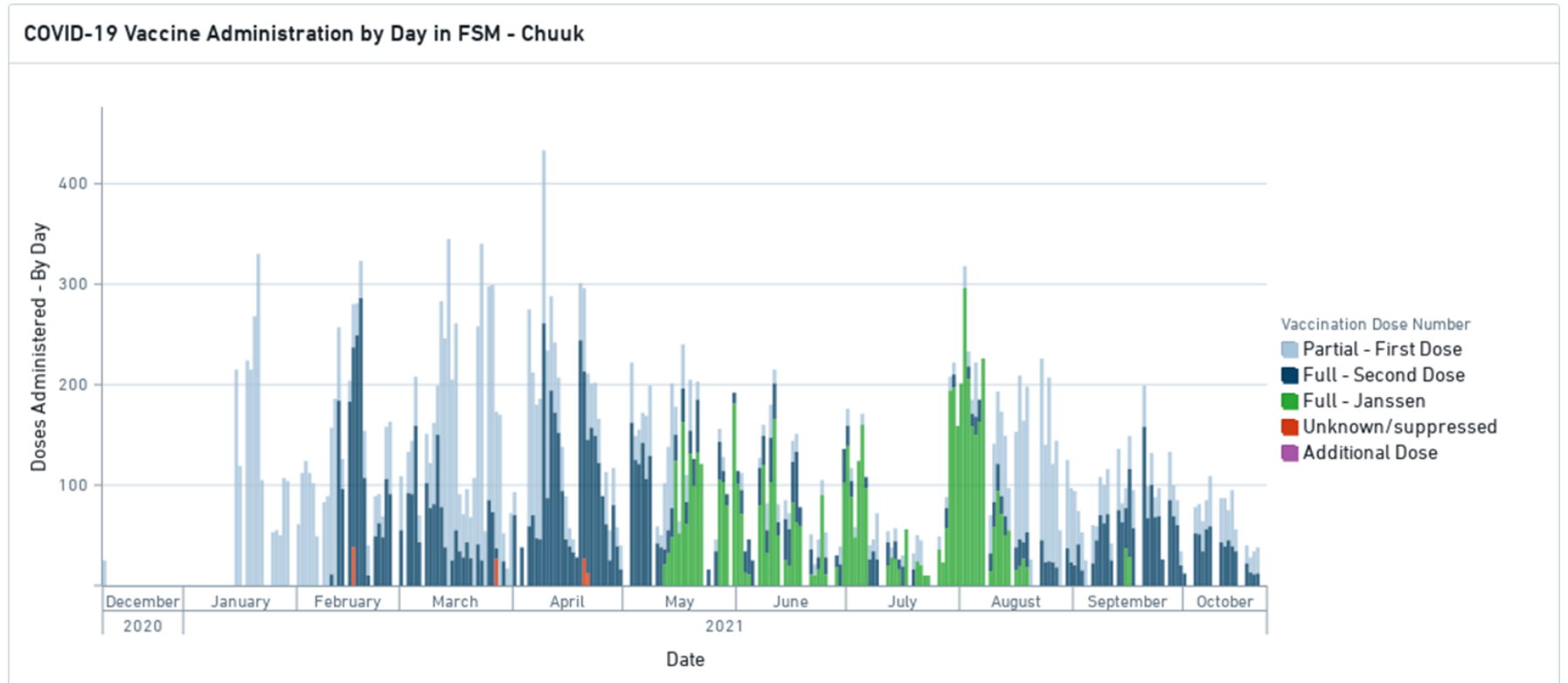

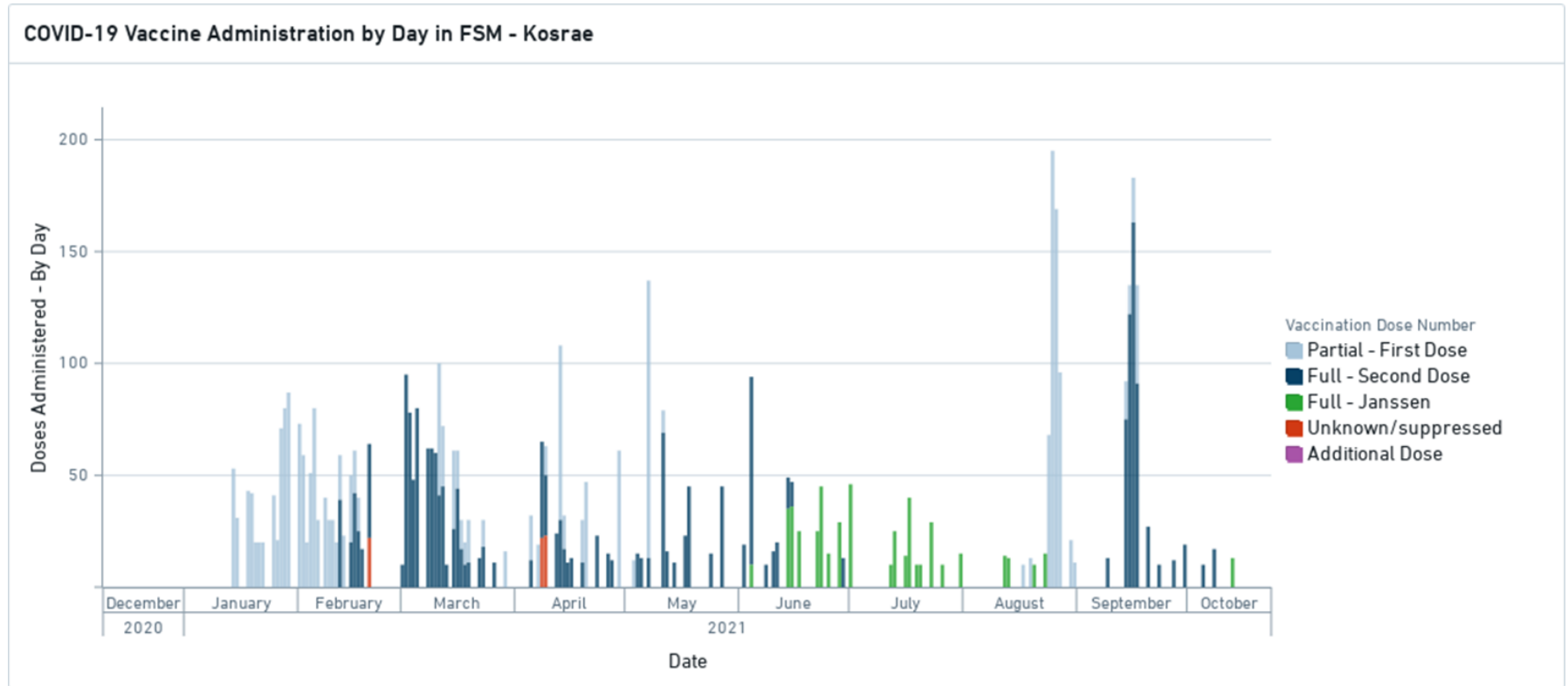

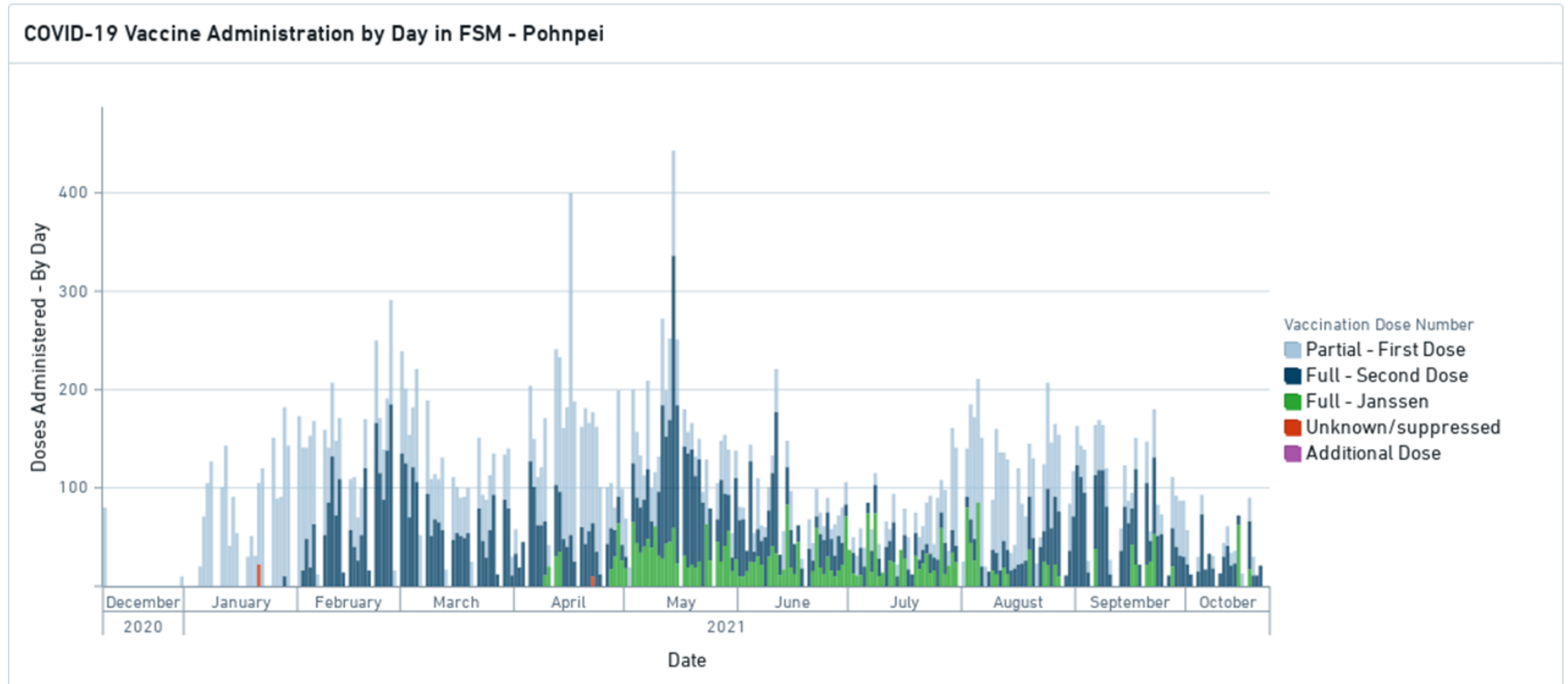

Republic of Marshall Islands

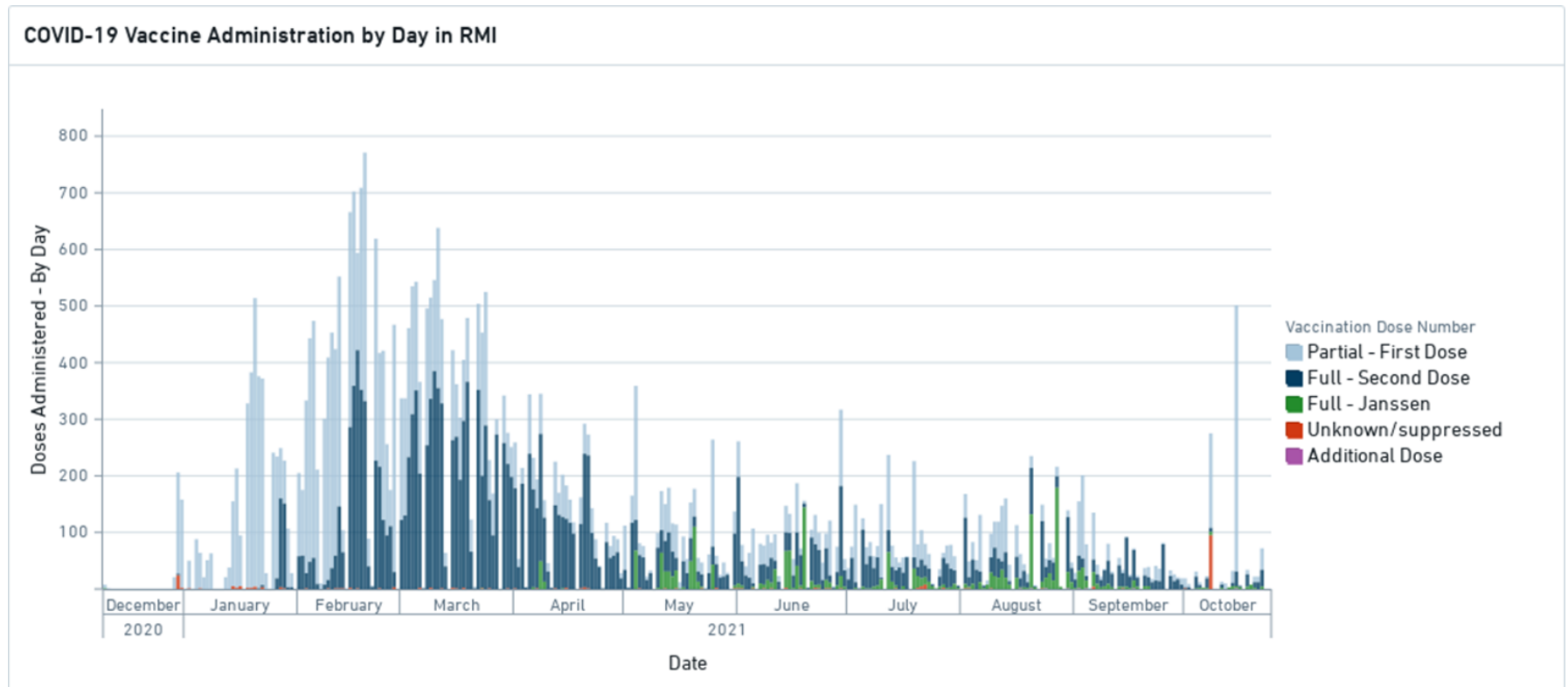

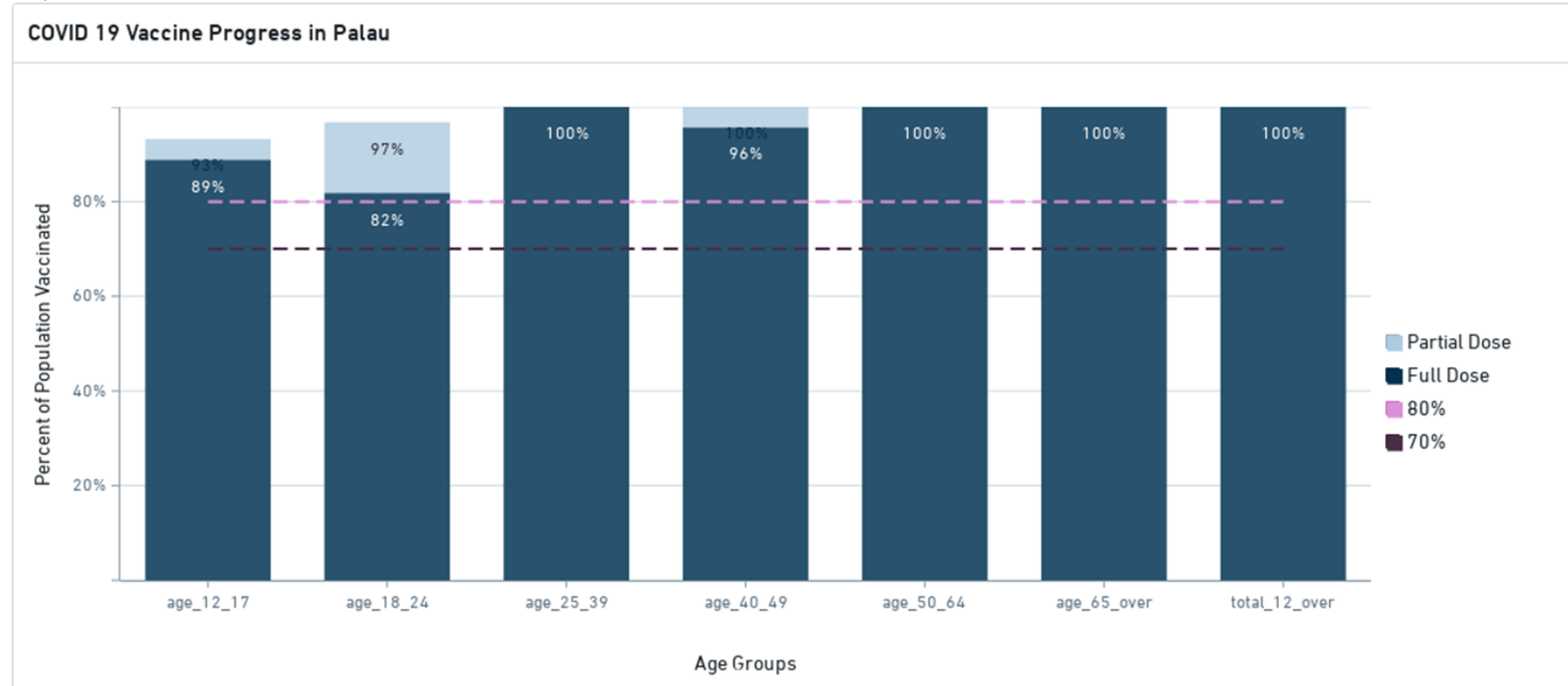

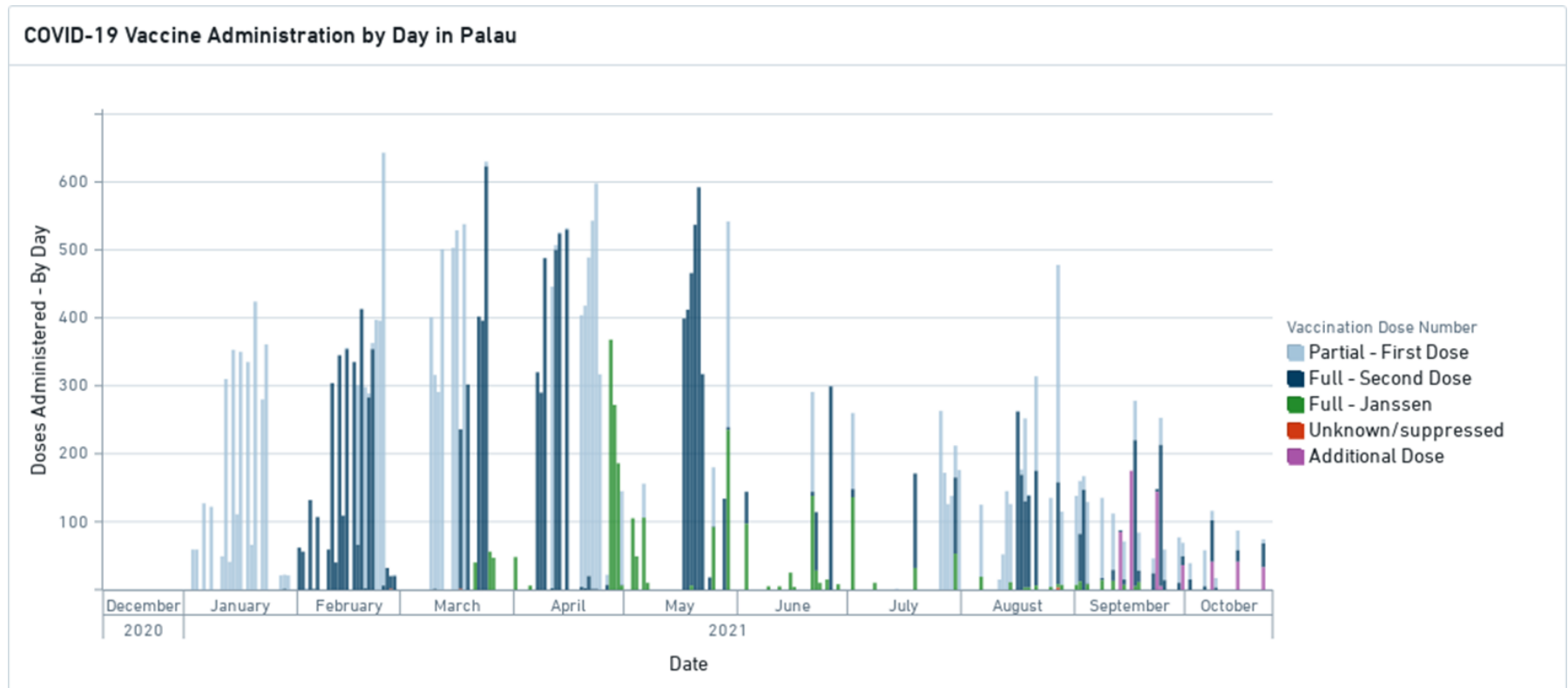
