Regional Summary:

- COVID-19 cases
 - Guam has reported 31,038 total cases and 285 deaths with 4,572 new cases (↑ from 3,549 last week) and 9 new deaths reported this week (↑ from 2 last week); test positivity 29.0% (↑ from 25.4% last week); 37 hospitalized cases (↑ from 27 last week)
 - CNMI has reported 4,692 total cases and 23 deaths; 484 new cases (↑ from 303 last week) and 1 new death this week (-- from 1 last week); 9 hospitalized cases (↑ from 8 last week)
 - Palau has reported 1,393 total cases with 1,060 new cases reported this week (↑ from 277 last week); community transmission continues; 2 cases hospitalized for COVID-19 (-- from 2 last week; 7 other COVID-19 cases hospitalized for non-COVID-19-related conditions)
 - American Samoa has reported 18 total cases (all imported) with 0 new cases reported this week
 - FSM and RMI have had no community transmission with 0 new cases reported this week
- COVID-19 Vaccine distribution summary (See USAPI Vaccine Summary with 22 updated tables and figures listed below)
 - Pediatric formulation of the Pfizer vaccine was ordered and delivered to each of the 6 USAPI, pediatric vaccination campaigns have started in all jurisdictions except for most outer islands in FSM and RMI
 - Based on jurisdictional reports: a total of 287,000 people in the region are fully vaccinated (76.4% of all eligible individuals / -1.1% / denominator was adjusted for Pohnpei as adolescent and pediatric vaccination campaigns have now started)
 - An additional 25,000 people in the region are partially vaccinated (7.0% of eligible individuals in the region)
 - Note: eligible individuals are 5+ for American Samoa, Chuuk, Northern Mariana Islands, Guam, Kosrae, Kwajalein, Majuro, Palau, Pohnpei and Yap
 - Based on data submitted into Tiberius via WebIZ: **83% of all people aged 5 years and older have had at least one dose of a COVID-19 vaccine; 74% are fully vaccinated.**
 - Current percentages of eligible population **aged 5 and over** fully vaccinated (from Tiberius via WebIZ)
 - **American Samoa: 86% (+1%)**
 - **FSM: Chuuk: 42% (--%), Kosrae: 60% (+1%), Pohnpei: 49% (--%), Yap: 64% (+1%)**
 - **Guam: 85% (+1%)**
 - **RMI: 51% (--%)**
 - **CNMI: 86% (--%)**
 - **Palau: 100% (--%)**
 - Outer island vaccinations: Outer Island coverage rates from jurisdictional outer island outreach activities due to difficulty in determining denominators and true residence in Tiberius.
 - **RMI Outer Islands:** At least one dose **59% (--%)**; Fully **46% (--%)** (among those 12+)
 - **Yap Outer Islands:** At least one dose **98% (--%)**; Fully **95% (--%)** (denominators adjusted to locally collected denominators for 18+)
 - **Chuuk Outer Islands (out of the lagoon):** Fully **31% (--%)** (OI numbers are incomplete)
 - **Pohnpei Outer Islands:** Fully **63% (--%)** (denominator adjusted based on OI reports for 18+)
 - Boosters: A total of 82,248 boosters/additional doses have been provided across the USAPI: American Samoa: 5,030; FSM: 5,370; Guam: 42,993; RMI: 2,006; CNMI: 16,940; Palau: 9,909
- COVID-19 Containment strategies
 - Guam is allowing vaccinated travelers to enter without testing or quarantine and unvaccinated travelers with negative test 72 hours prior to arrival with 10-day home quarantine.
 - CNMI is allowing vaccinated travelers to enter without quarantine with testing on arrival and day 5 and unvaccinated travelers to enter with facility quarantine requirement for 5 days or home quarantine with prior approval, both with testing on day 5.

- Palau is running regular Guam and Taiwan flights with restriction of movement for vaccinated travelers with negative PCR test within 3 days of departure to Palau or negative antigen test within 1 day of departure to Palau and testing on day 4.
- AS is running HNL flights using “Talofa Pass” system with pre-travel testing and 7-day AS quarantine; flights from Samoa suspended due to lock-down in Samoa.
- RMI has regular repat flights ongoing with HNL/in-country quarantine and testing requirements.
- FSM continues smaller repat flights with Guam/FSM quarantine and testing requirements.
- COVID-19 Laboratory Testing capacity
 - Supplies of Abbott ID NOW, Abbott BinaxNOW, and GeneXpert are low in some USAPI as travel and outbreak testing demands increase; difficulties with procurement.

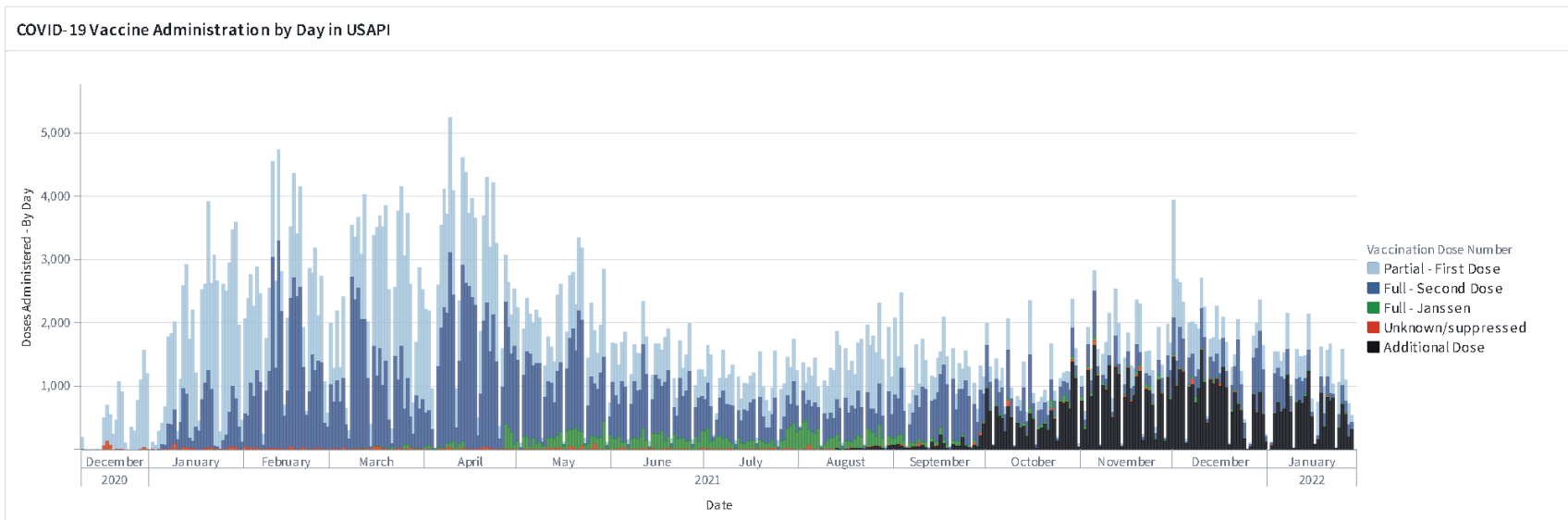

US-affiliated Pacific Islands Region

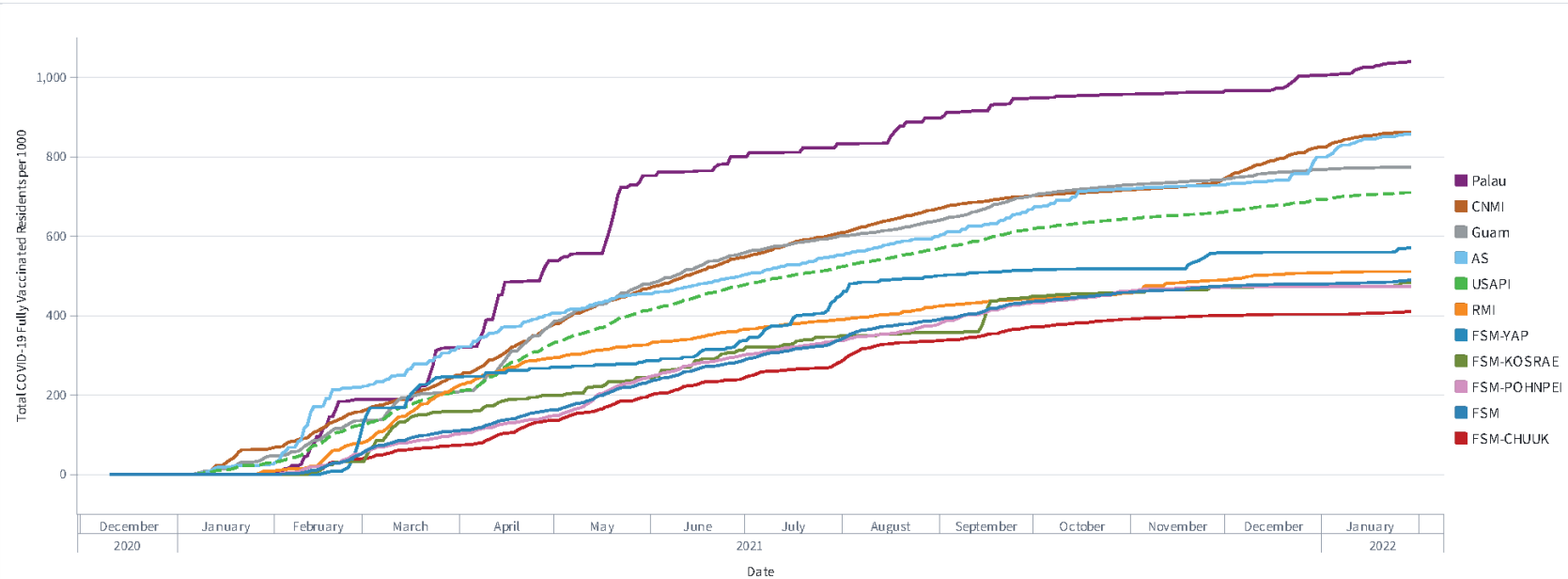

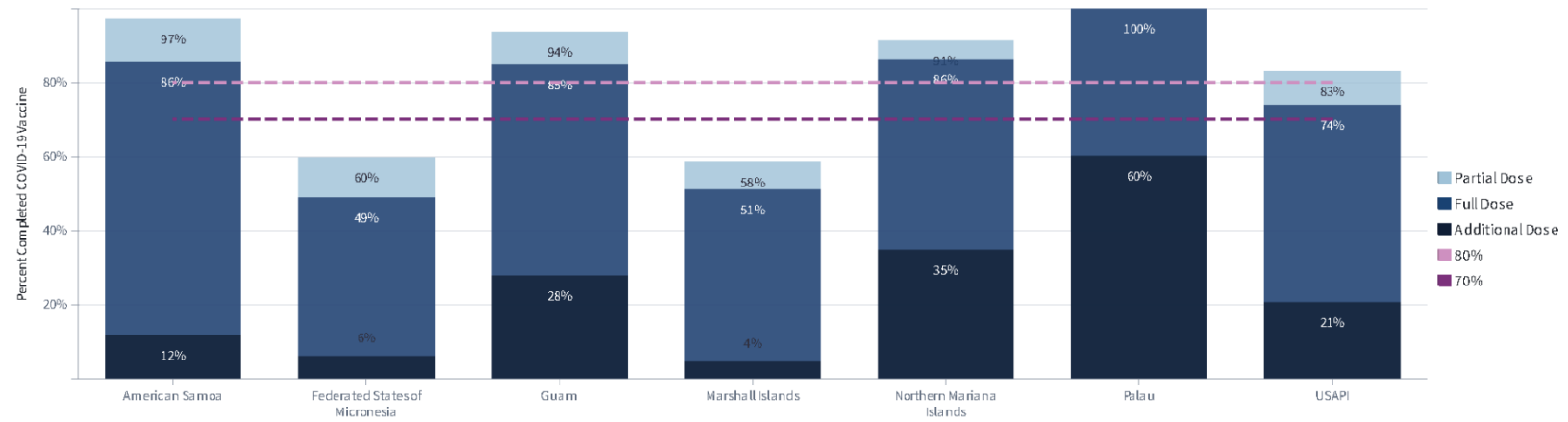

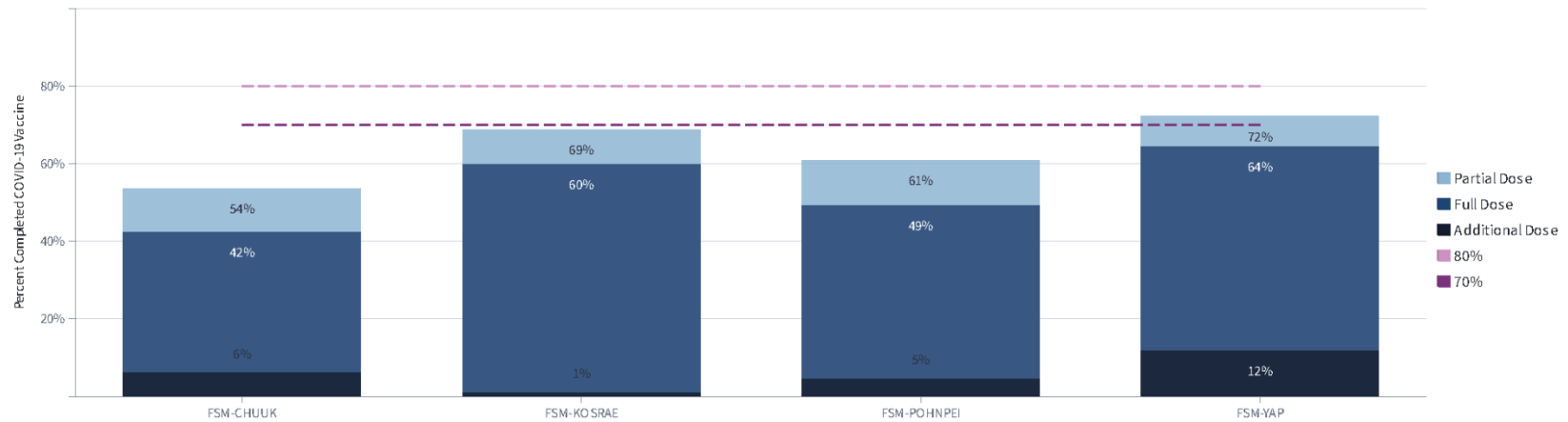

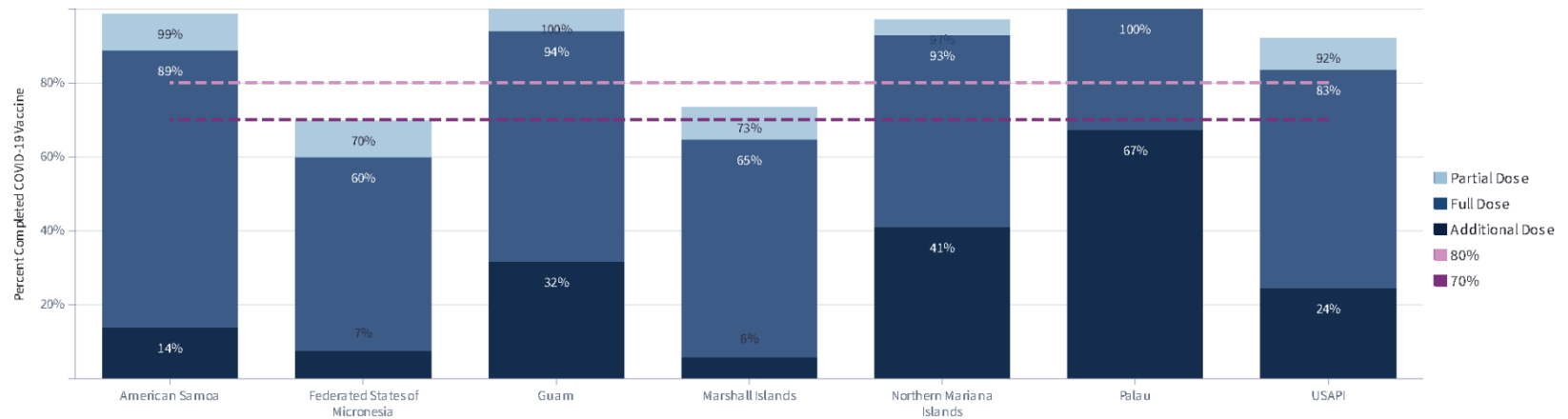

Striving for 80%: USAPI 12+ COVID-19 Vaccine Progress



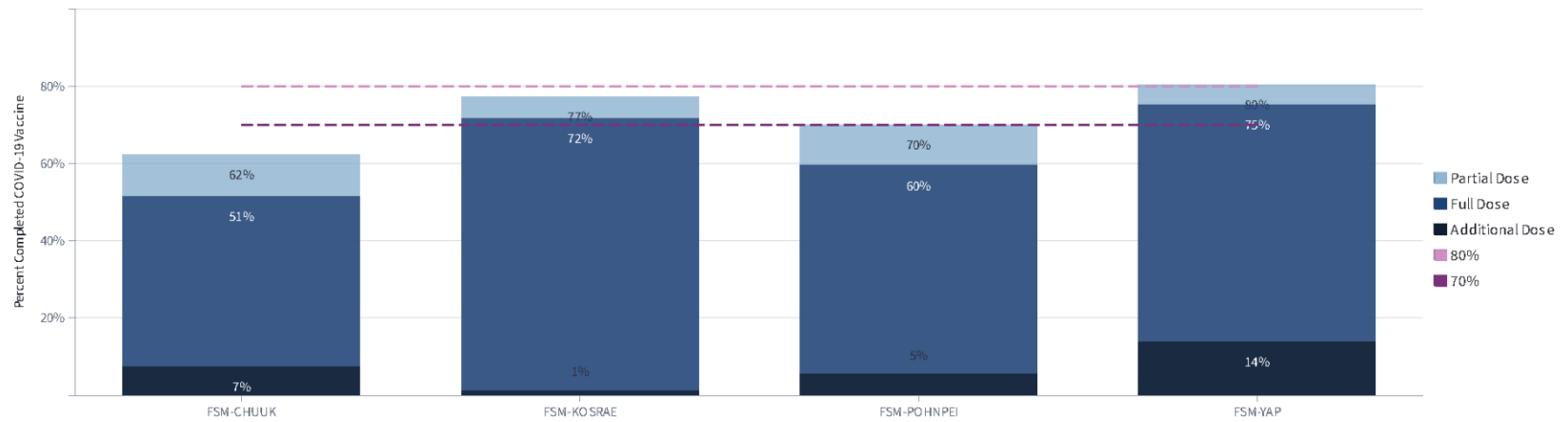

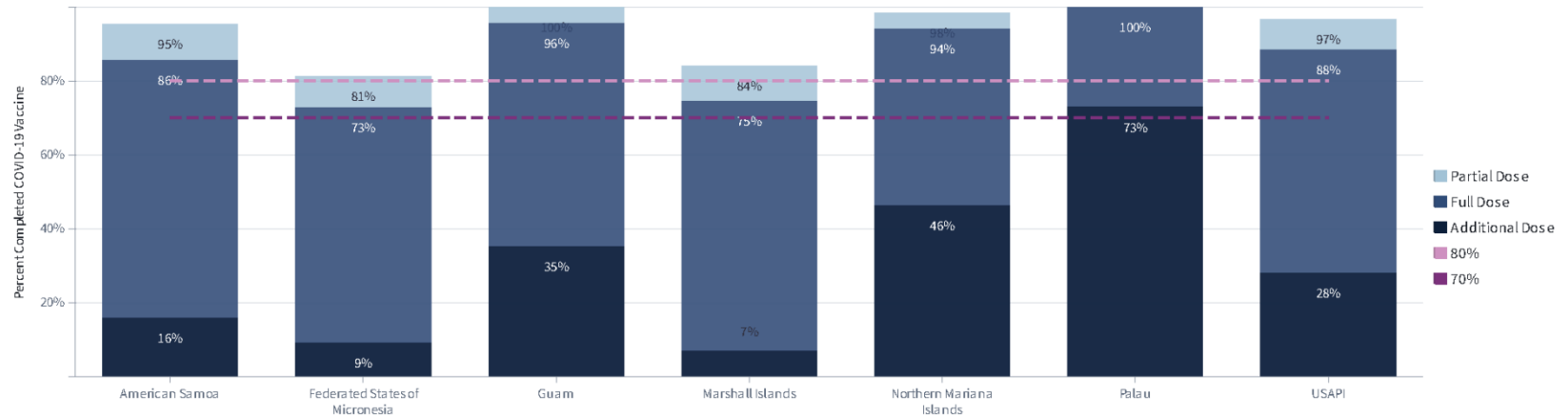

Striving for 80%: USAPI 18+ COVID-19 Vaccine Progress



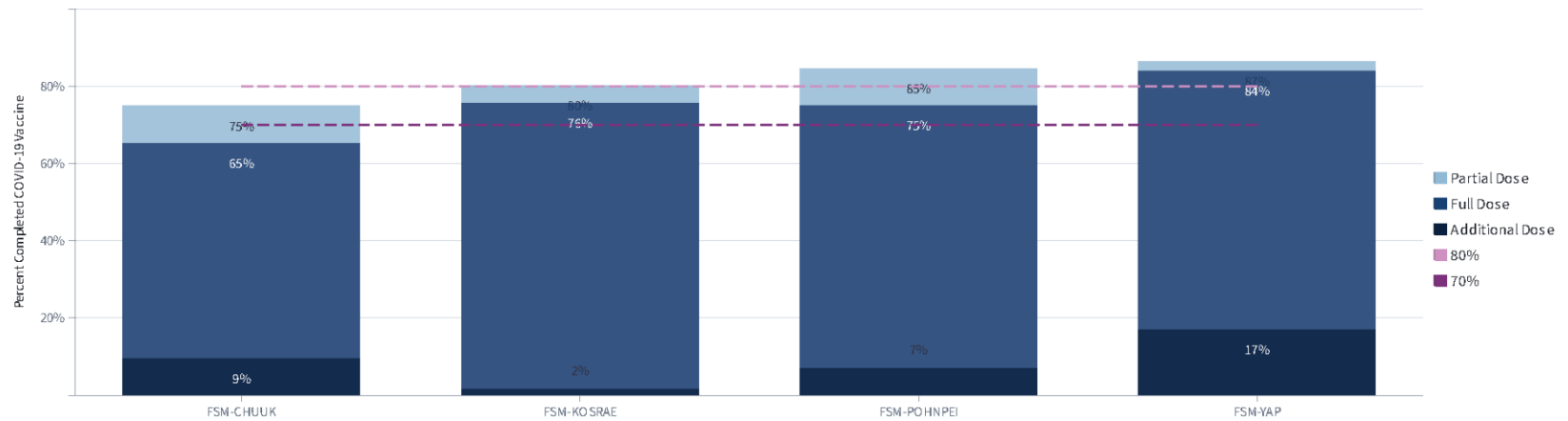

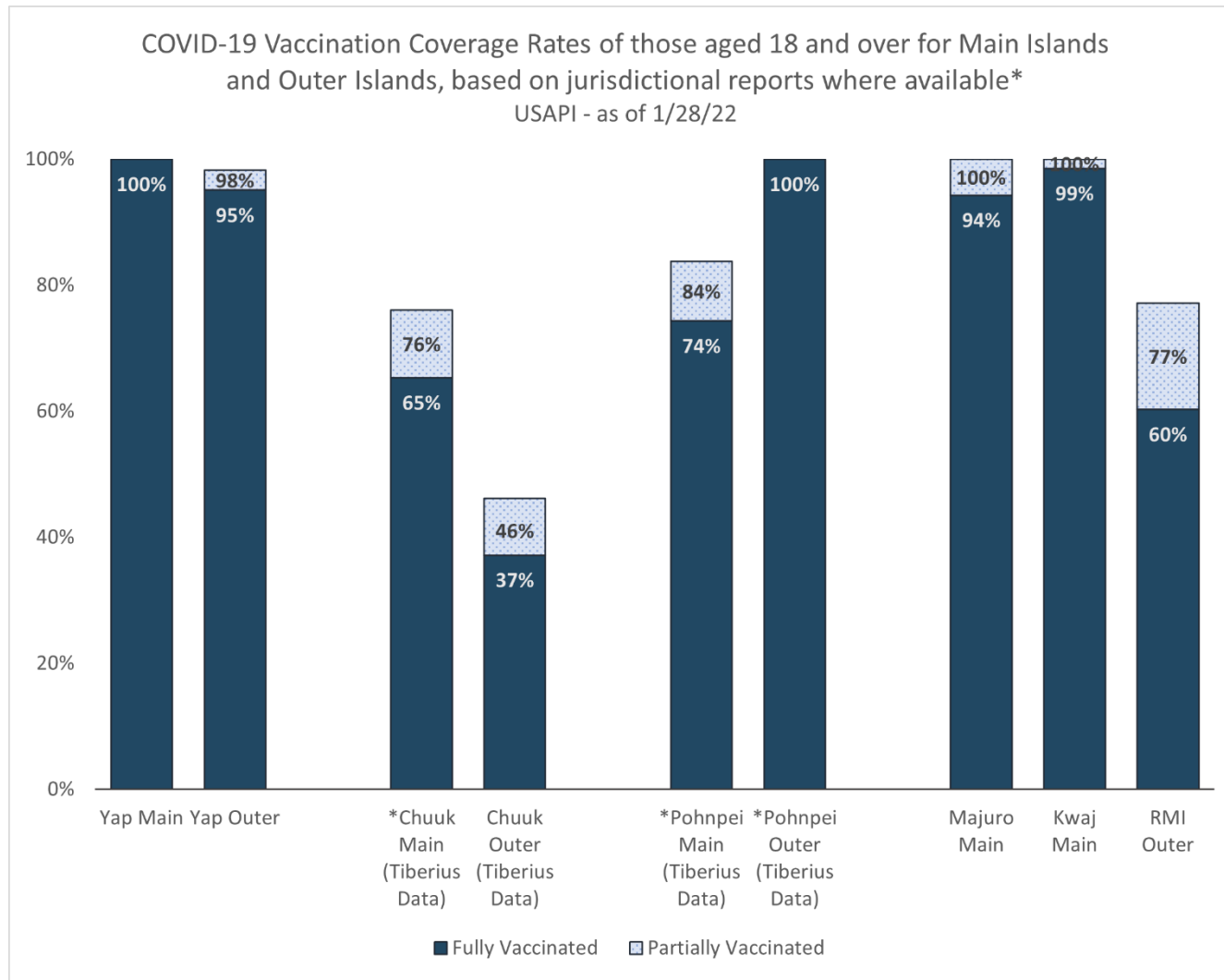

Striving for 80%: USAPI 18+ COVID-19 Vaccine Progress (FSM States)



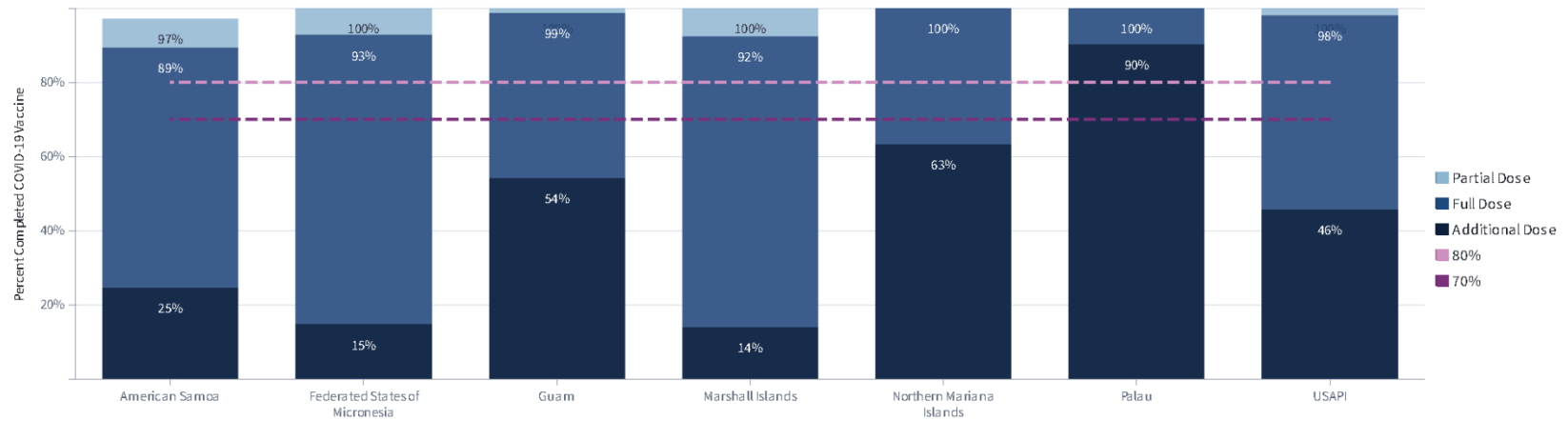

Striving for 80%: USAPI 50+ COVID-19 Vaccine Progress



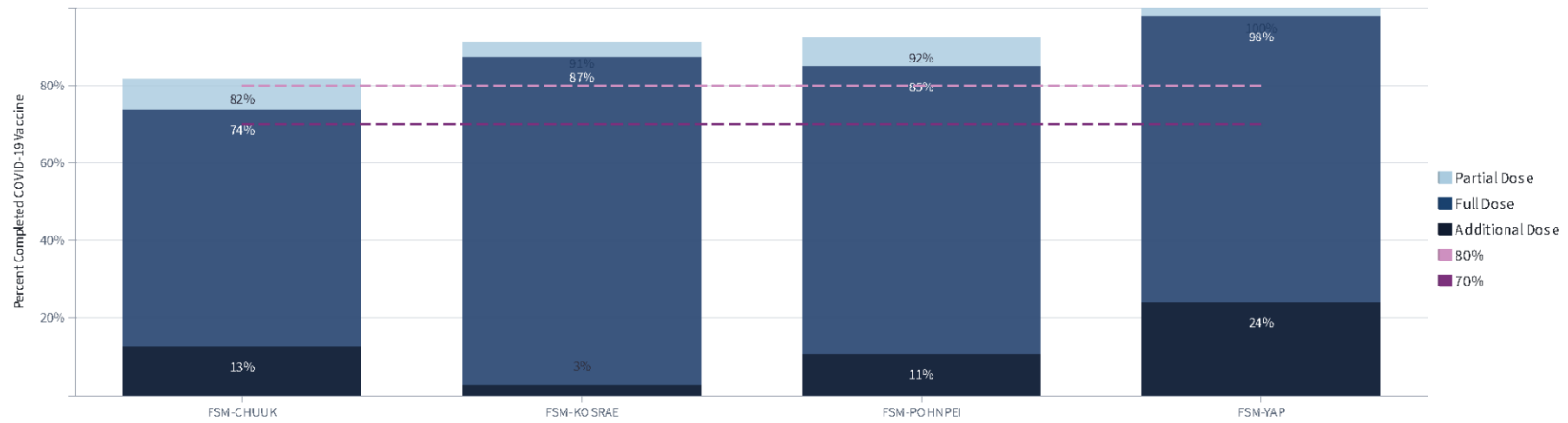

USAPI COVID-19 Vaccine Progress: 50+ (FSM States)



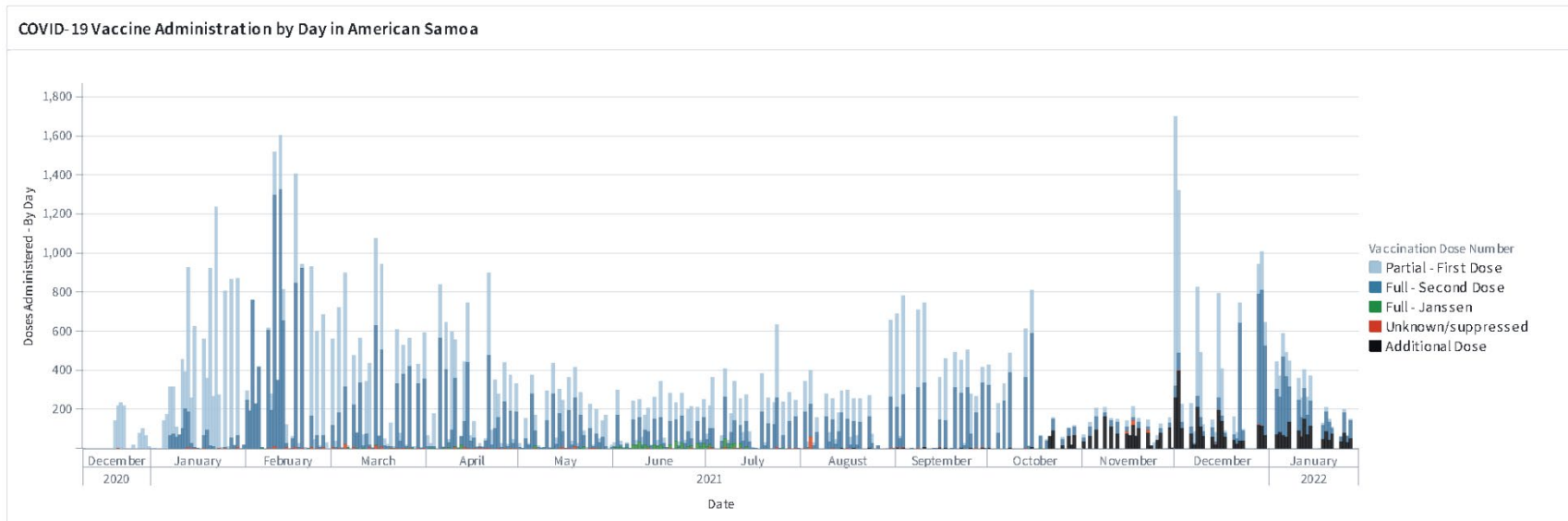

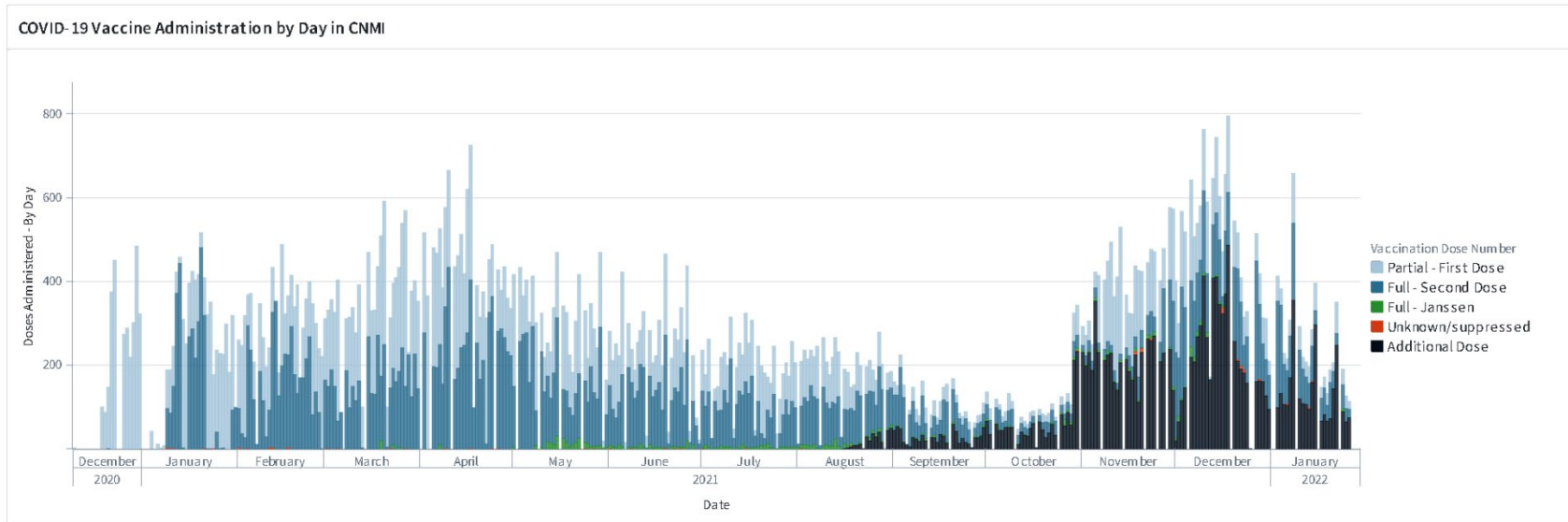

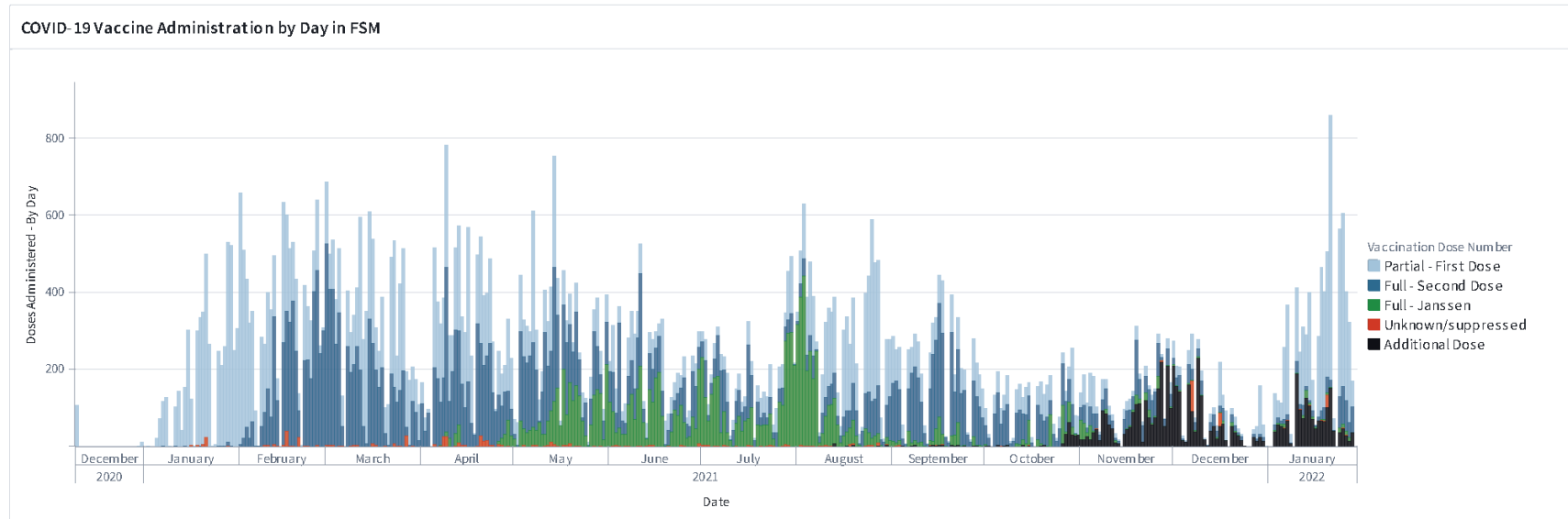
Commonwealth of the Northern Mariana Islands

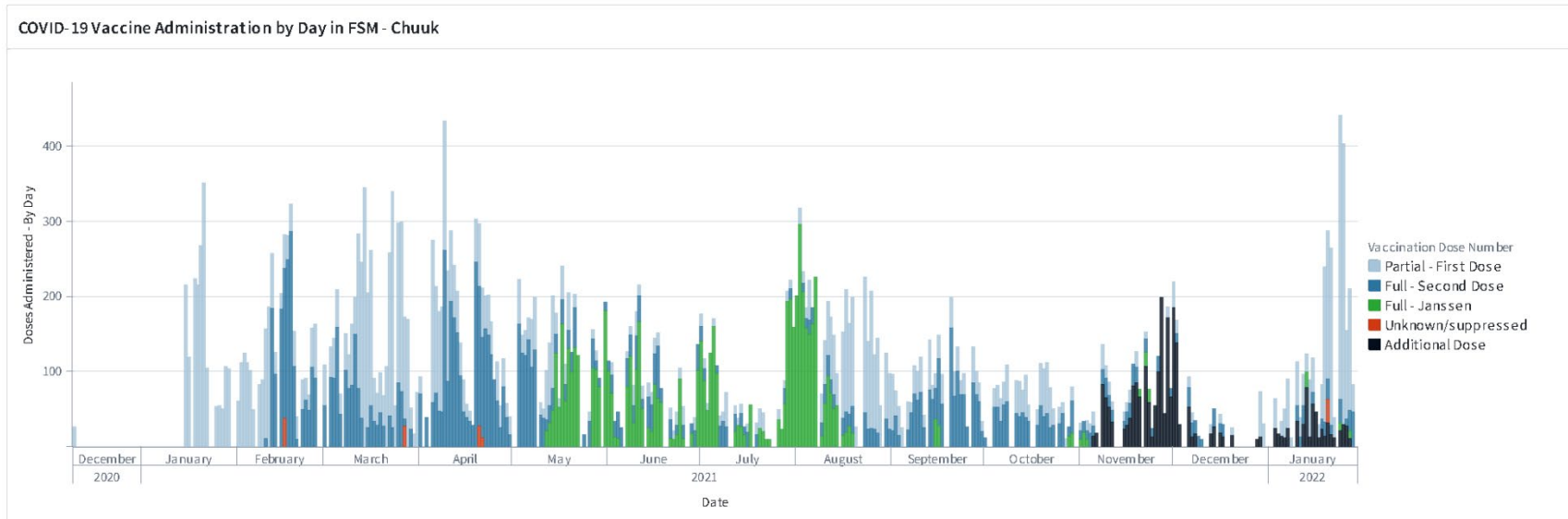
Federated States of Micronesia

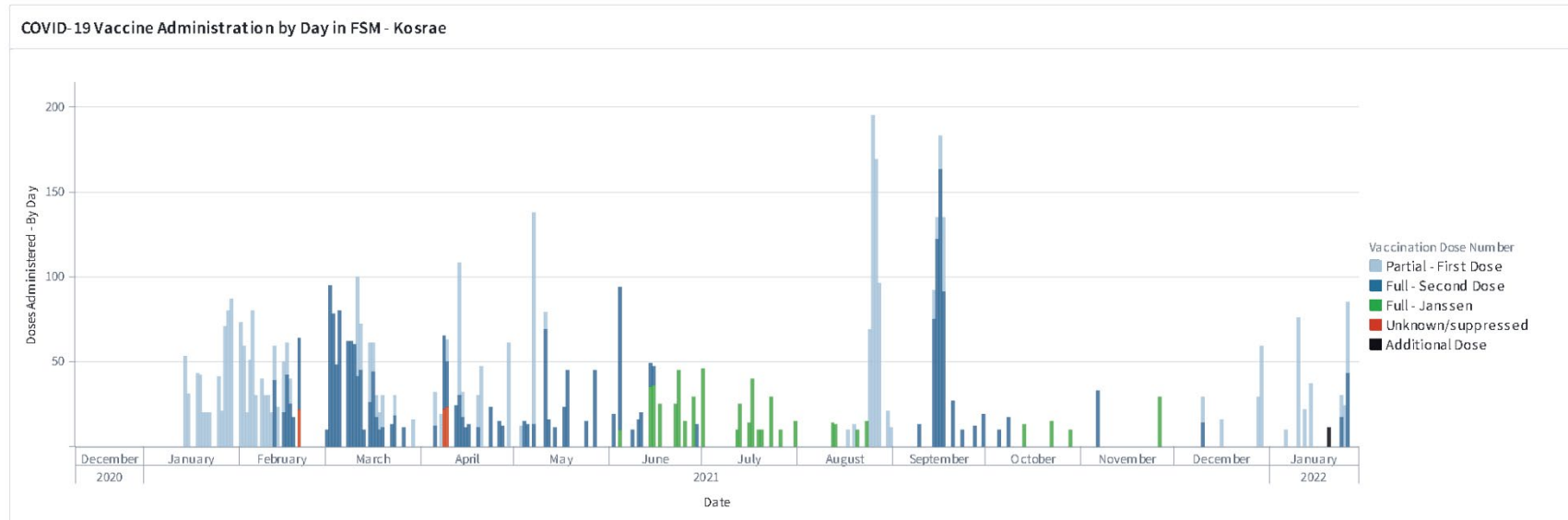
Chuuk

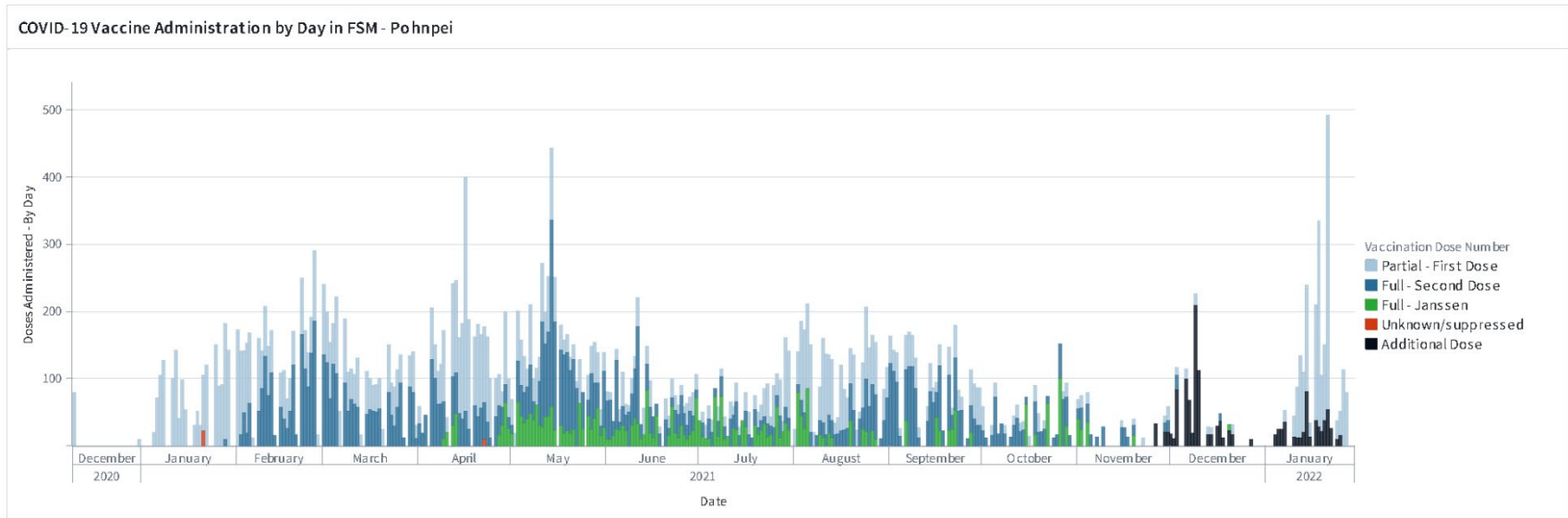
Kosrae

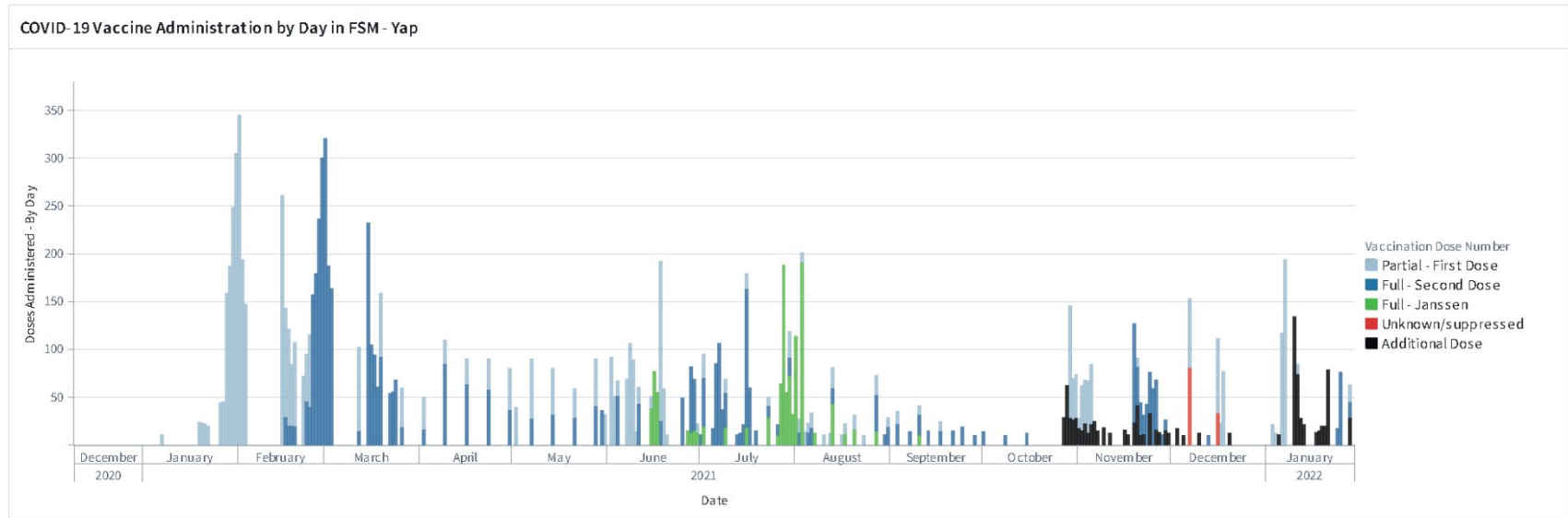
Pohnpei

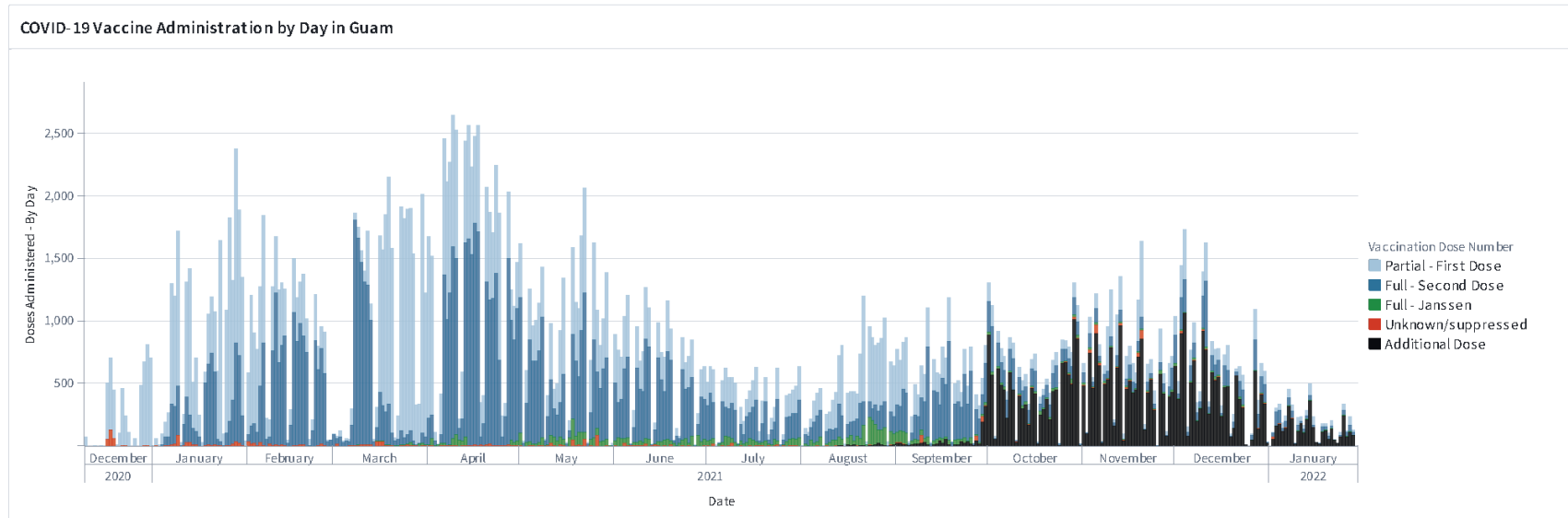

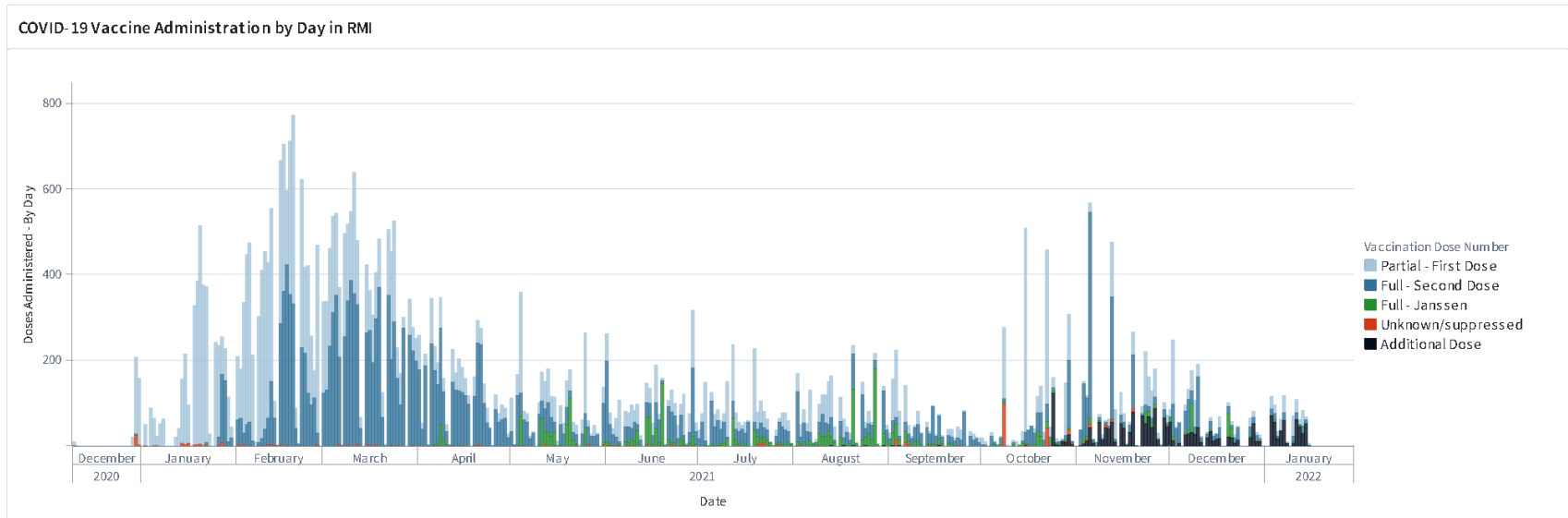

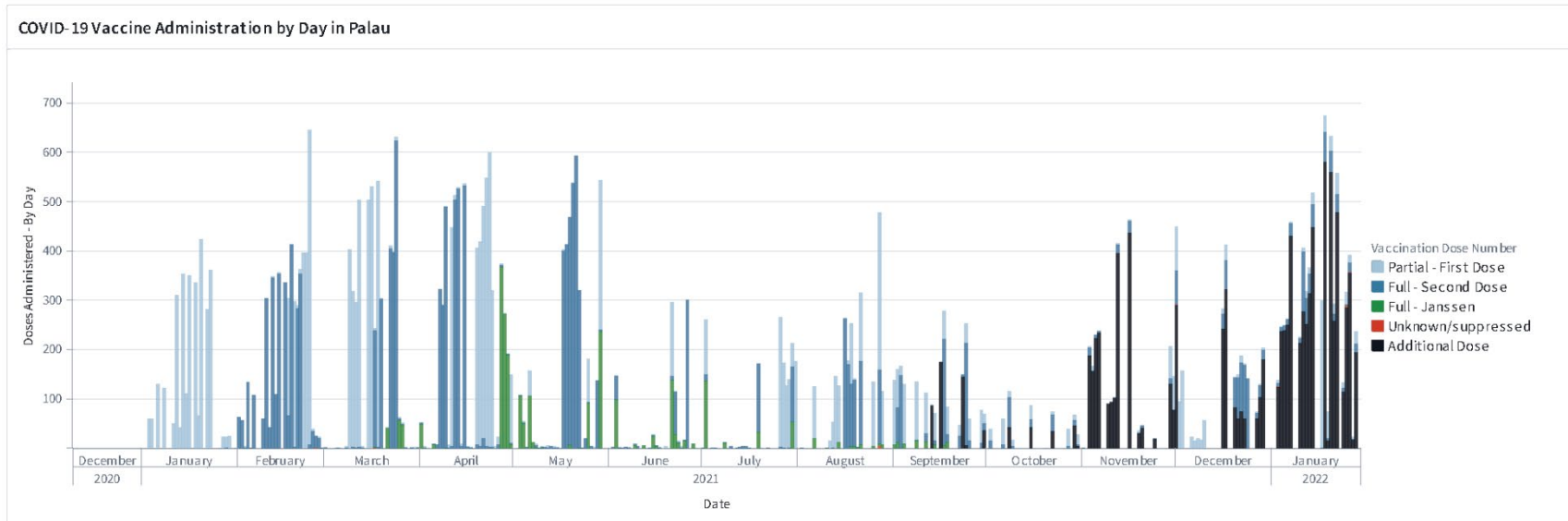
Republic of the Marshall Islands
