Week: 2/5/2022-2/11/2022

Regional Summary:

- COVID-19 cases
 - Guam has reported 39,295 total cases and 306 deaths with 3,923 new cases (↓ from 4,334 last week) and 10 new deaths reported this week (↓ from 11 last week); test positivity 37.0% (↑ from 35.4% last week); 52 hospitalized cases (↑ from 45 last week)
 - CNMI has reported 7,199 total cases and 23 deaths with 1,512 new cases (↑ from 995 last week) and 0 new deaths reported this week (→ from 0 last week); test positivity 23.0% (↑ from 16.2% last week); 7 hospitalized cases (↓ from 10 last week)
 - Palau has reported 3,119 total cases with 767 new cases reported this week (↓ from 959 last week); 6 cases hospitalized for COVID-19 (↑ from 3 last week); 12 other COVID-19 cases hospitalized for non-COVID-19-related conditions)
 - American Samoa has reported 61 total cases with 39 new cases reported this week among individuals associated with the 1/27 flight – total: 43 cases (35 travelers and 8 quarantine staff)
 - FSM and RMI have had no community transmission with 0 new cases reported this week
- COVID-19 Vaccine distribution summary (See USAPI Vaccine Summary with 22 updated tables and figures listed below)
 - Pediatric formulation of the Pfizer vaccine was ordered and delivered to each of the 6 USAPI, pediatric vaccination campaigns have started in all jurisdictions except for most outer islands in FSM and RMI
 - Based on jurisdictional reports: a total of 291,000 people in the region are fully vaccinated (77.3% of all eligible individuals / +0.8%)
 - An additional 26,000 people in the region are partially vaccinated (7.0% of eligible individuals in the region)
 - Note: eligible individuals are 5+ for American Samoa, Chuuk, Northern Mariana Islands, Guam, Kosrae, Kwajalein, Majuro, Palau, Pohnpei and Yap
 - Based on data submitted into Tiberius via WebIZ: **85% of all people aged 5 years and older have had at least one dose of a COVID-19 vaccine; 75% are fully vaccinated.**
 - Current percentages of eligible population **aged 5 and over** fully vaccinated (from Tiberius via WebIZ)
 - **American Samoa: 88% (+1%)**
 - **FSM: Chuuk: 44% (+1%), Kosrae: 63% (+1%), Pohnpei: 51% (+2%), Yap: 65% (→%)**
 - **Guam: 86% (+1%)**
 - **RMI: 52% (+1%)**
 - **CNMI: 87% (→%)**
 - **Palau: 100% (→%)**
 - Outer island vaccinations: Outer Island coverage rates from jurisdictional outer island outreach activities due to difficulty in determining denominators and true residence in Tiberius.
 - **RMI Outer Islands:** At least one dose **59% (→%)**; Fully **46% (→%)** (among those 12+)
 - **Yap Outer Islands:** At least one dose **98% (→%)**; Fully **95% (→%)** (denominators adjusted to locally collected denominators for 18+)
 - **Chuuk Outer Islands (out of the lagoon):** Fully **31% (→%)** (OI numbers are incomplete)
 - **Pohnpei Outer Islands:** Fully **63% (→%)** (denominator adjusted based on OI reports for 18+)
 - Boosters: A total of 92,752 boosters/additional doses have been provided across the USAPI: American Samoa: 5,592; FSM: 6,690; Guam: 48,576; RMI: 3,031; CNMI: 18,178; Palau: 10,685
- COVID-19 Containment strategies
 - Guam is allowing vaccinated travelers to enter without testing or quarantine and unvaccinated travelers with negative test 72 hours prior to arrival with 10-day home quarantine.
 - CNMI is allowing vaccinated travelers to enter without quarantine and unvaccinated travelers to enter with 5-day quarantine, both with testing on day 5.

- Palau is running regular Guam and Taiwan flights with restriction of movement for vaccinated travelers with negative PCR test within 3 days of departure to Palau or negative antigen test within 1 day of departure to Palau and testing on day 4.
- AS is running HNL flights using “Talofa Pass” system with pre-travel testing and 7-day AS quarantine; flights from Samoa suspended due to lock-down in Samoa.
- RMI has regular repat flights ongoing with HNL/in-country quarantine and testing requirements.
- FSM has paused all repatriation flights.
- COVID-19 Laboratory Testing capacity
 - Supplies of Abbott ID NOW, Abbott BinaxNOW, and GeneXpert are low in some USAPI as travel and outbreak testing demands increase; difficulties with procurement.

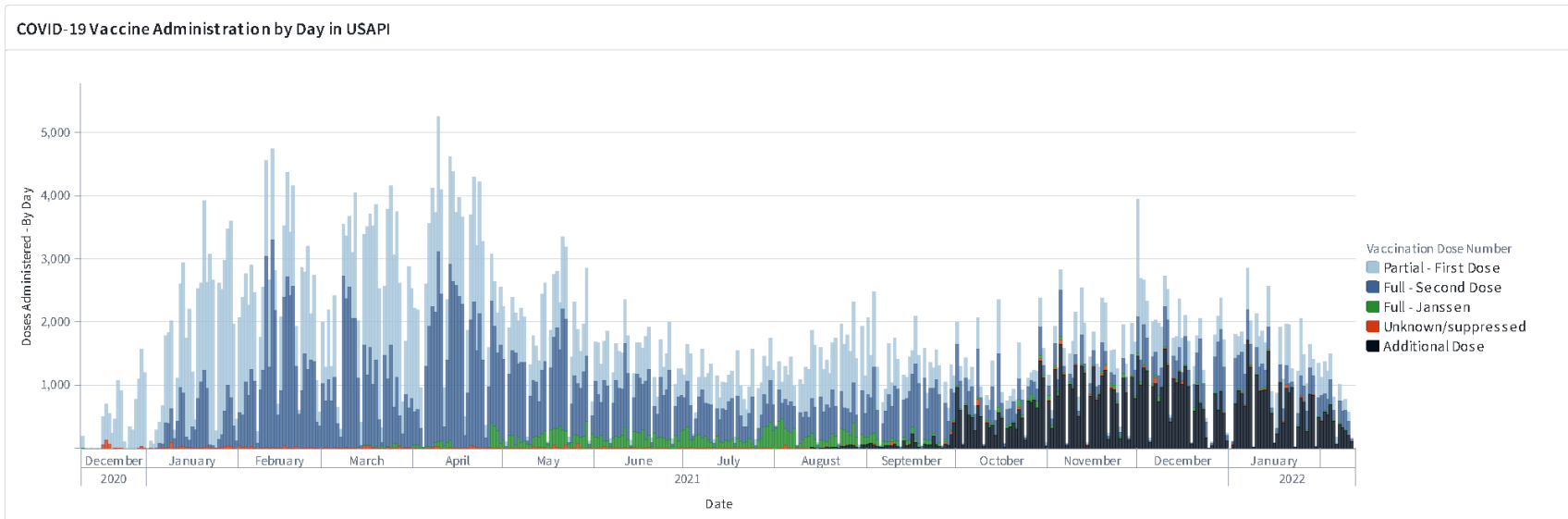

US-affiliated Pacific Islands Region



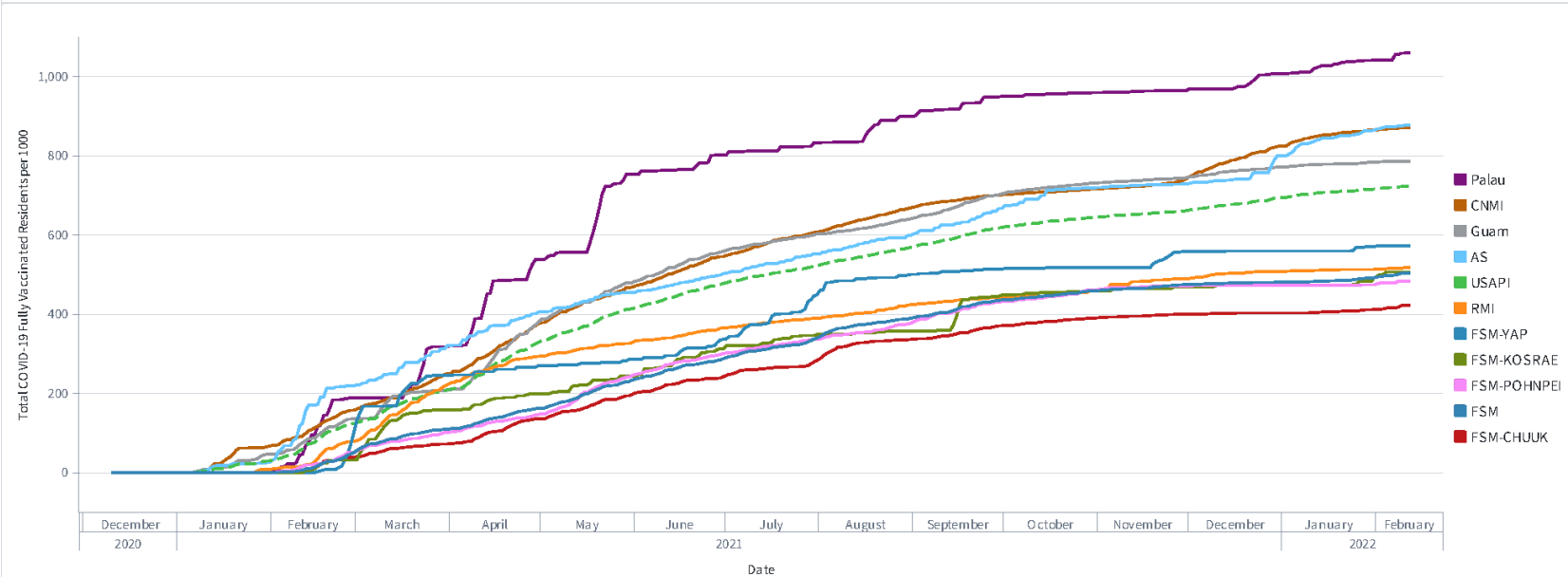

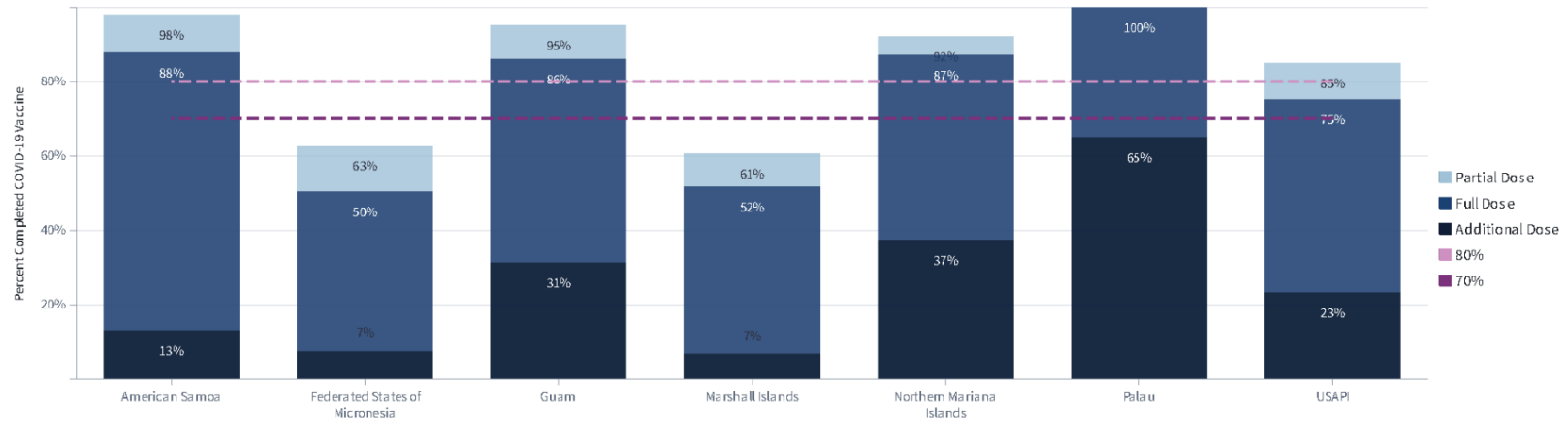

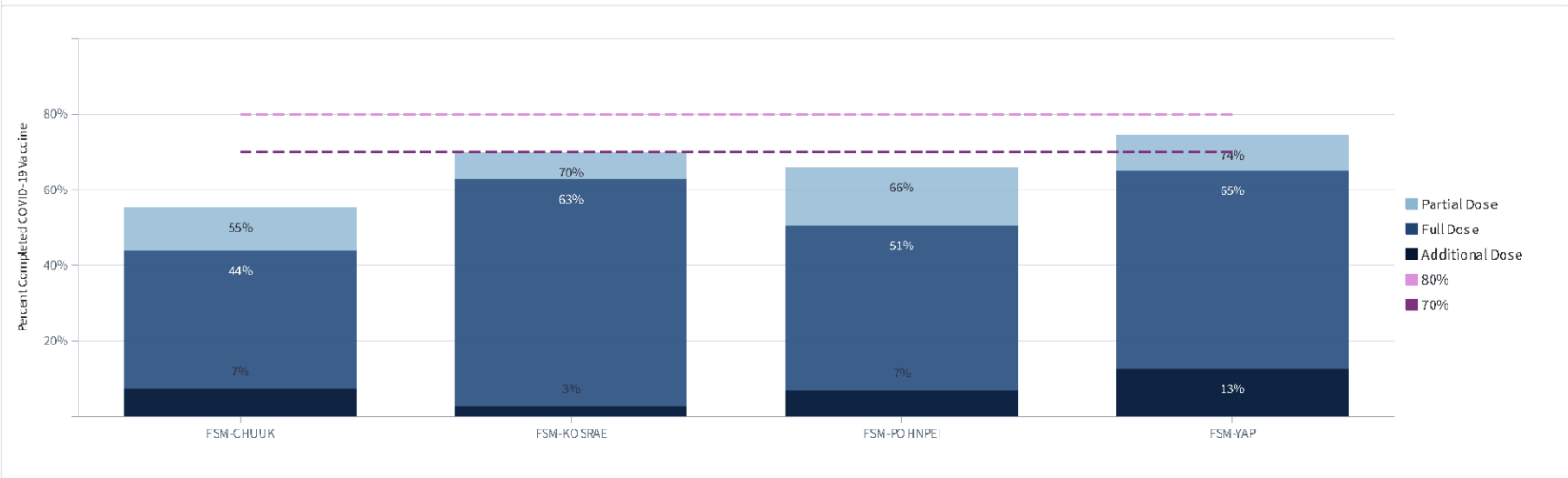

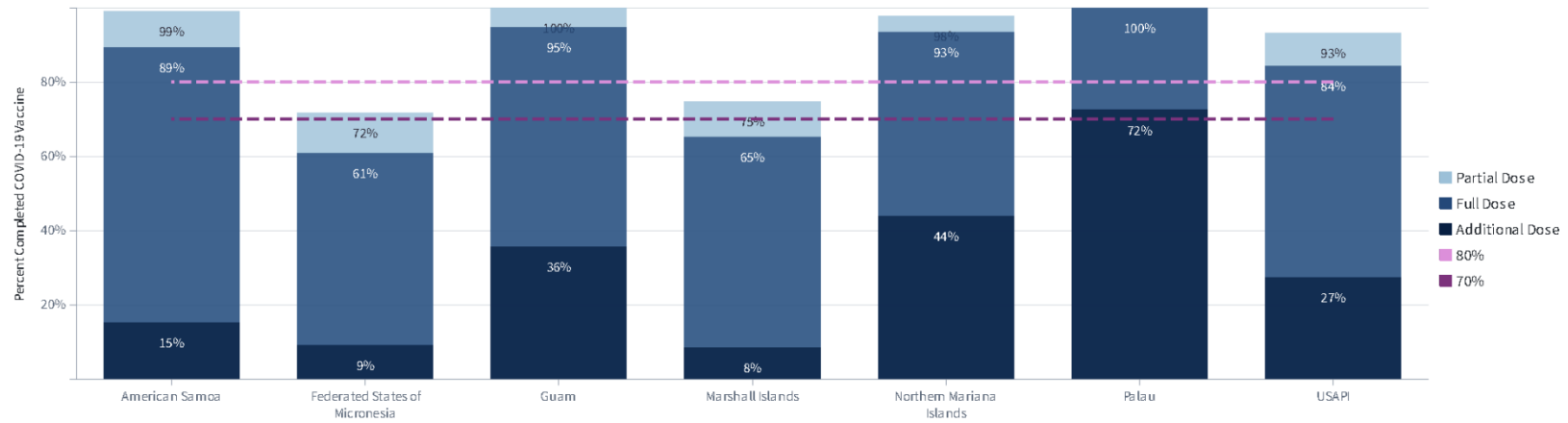

Striving for 80%: USAPI 12+ COVID-19 Vaccine Progress



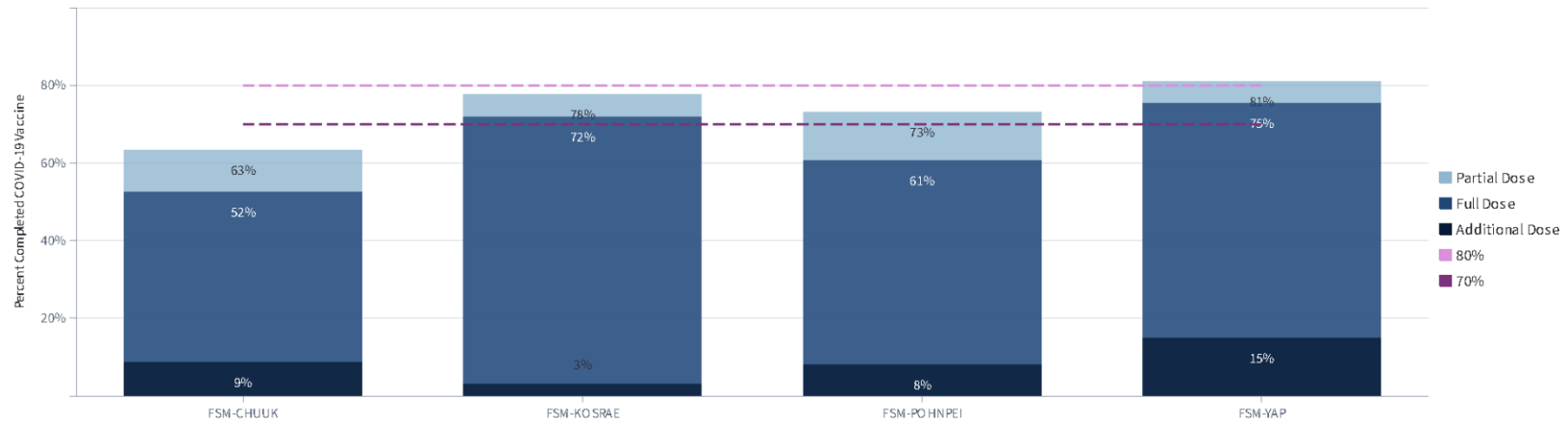

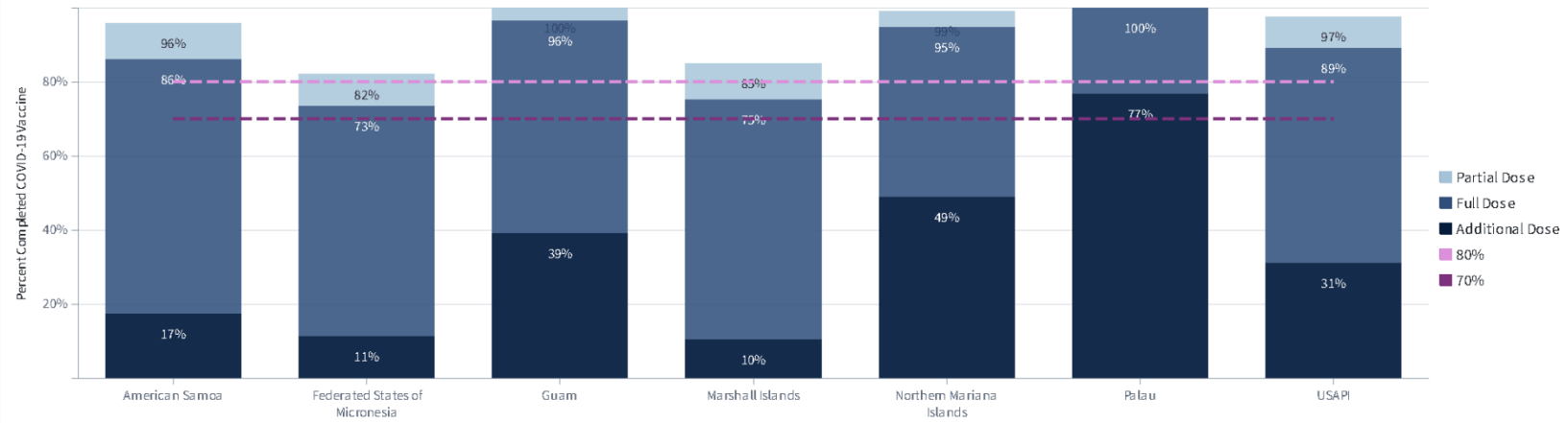

Striving for 80%: USAPI 18+ COVID-19 Vaccine Progress



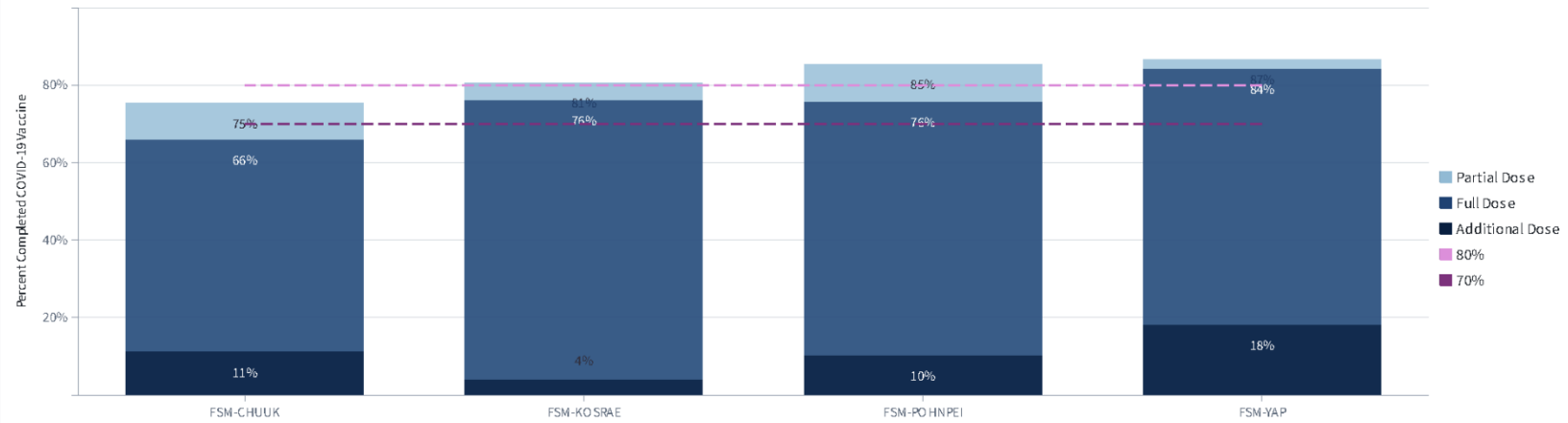

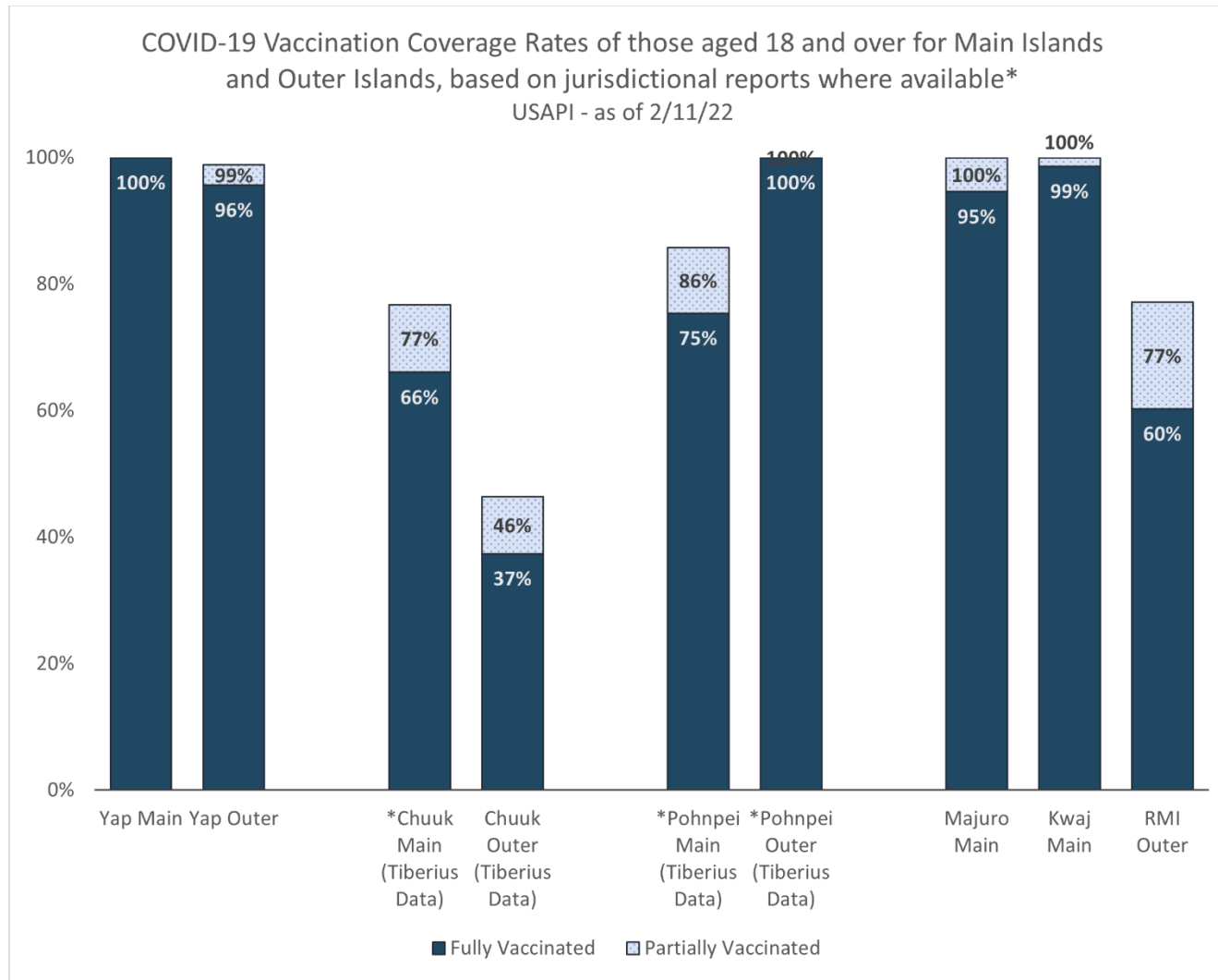
Striving for 80%: USAPI 18+ COVID-19 Vaccine Progress (FSM States)

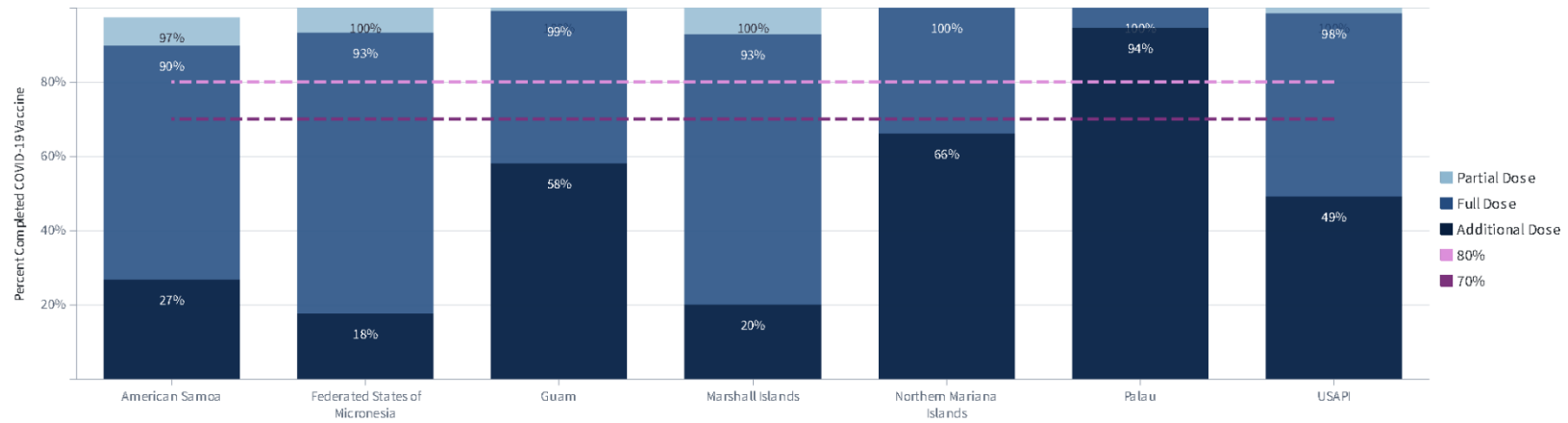

Striving for 80%: USAPI 50+ COVID-19 Vaccine Progress



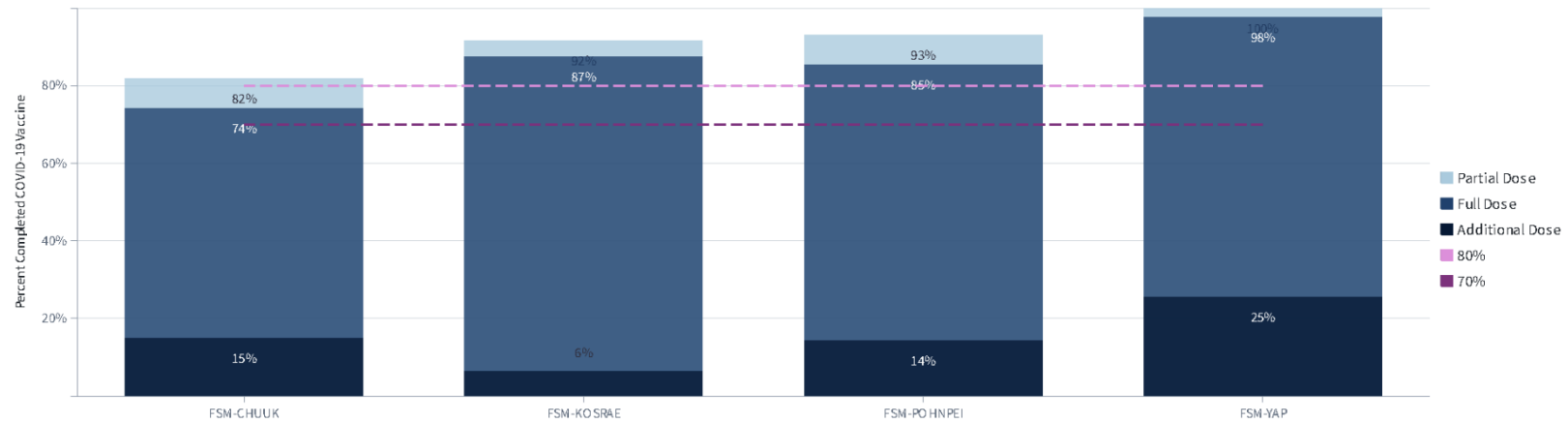

USAPI COVID-19 Vaccine Progress: 50+ (FSM States)



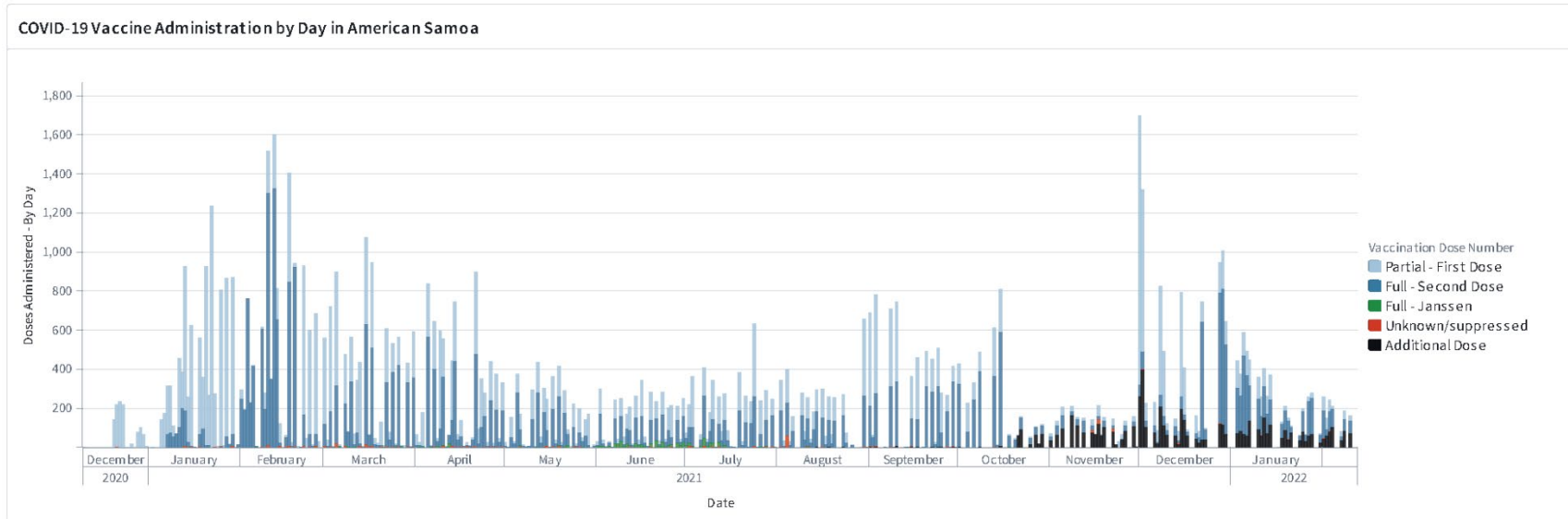

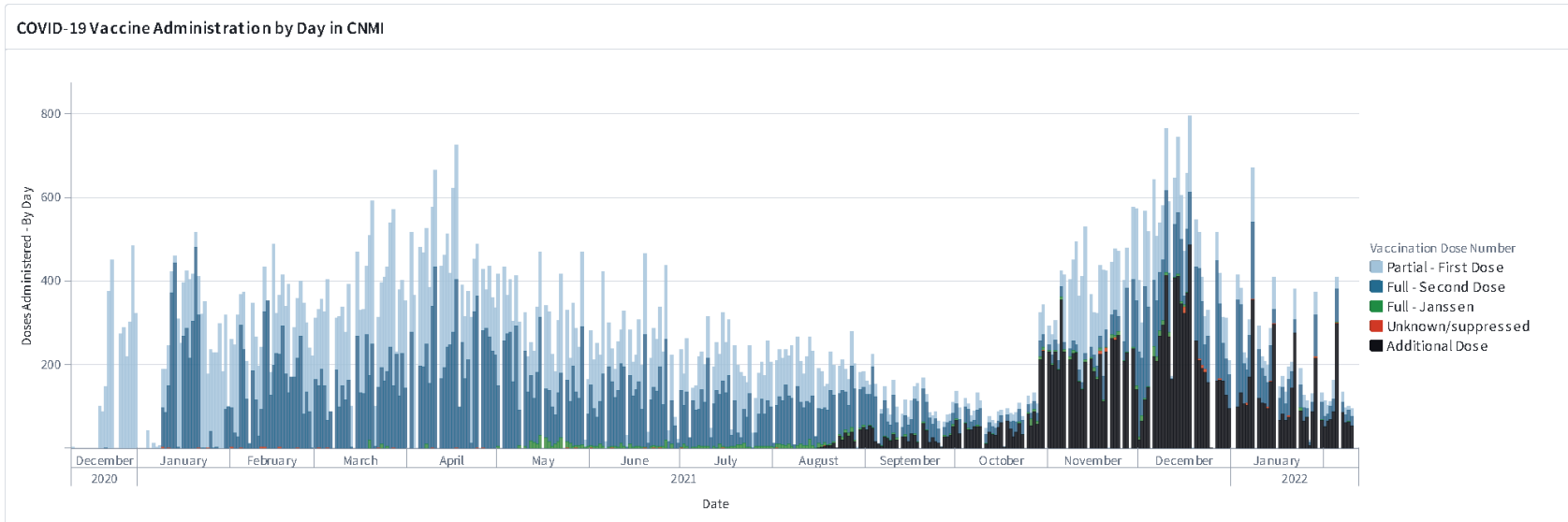
American Samoa

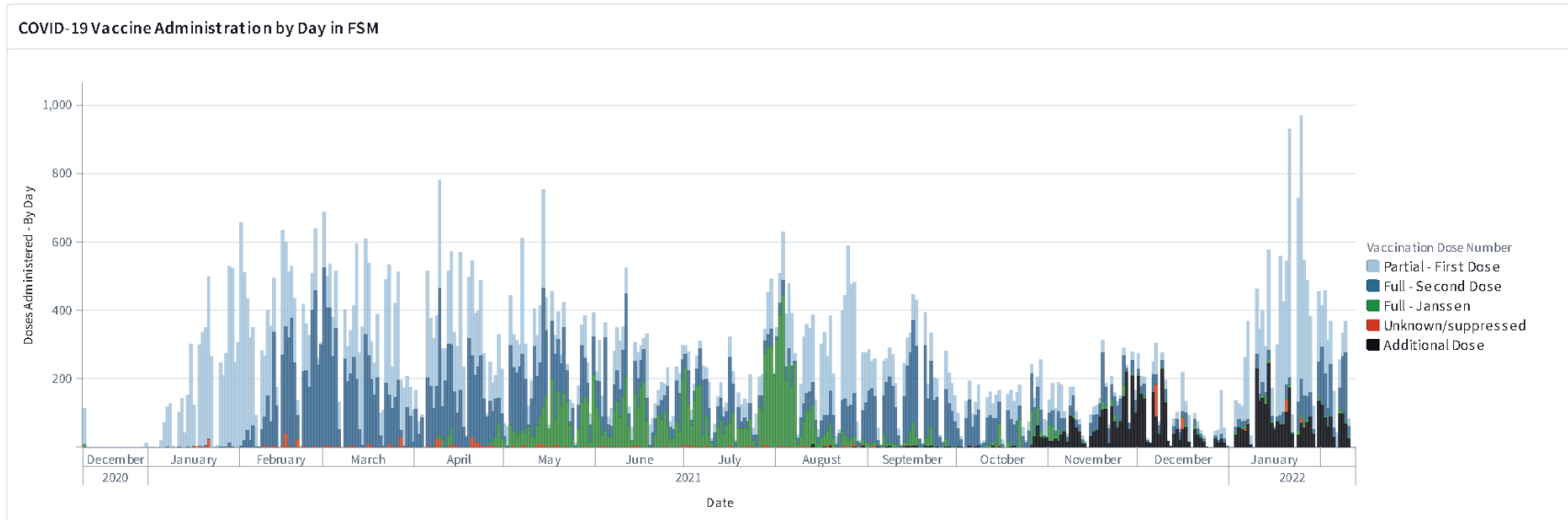
Commonwealth of the Northern Mariana Islands

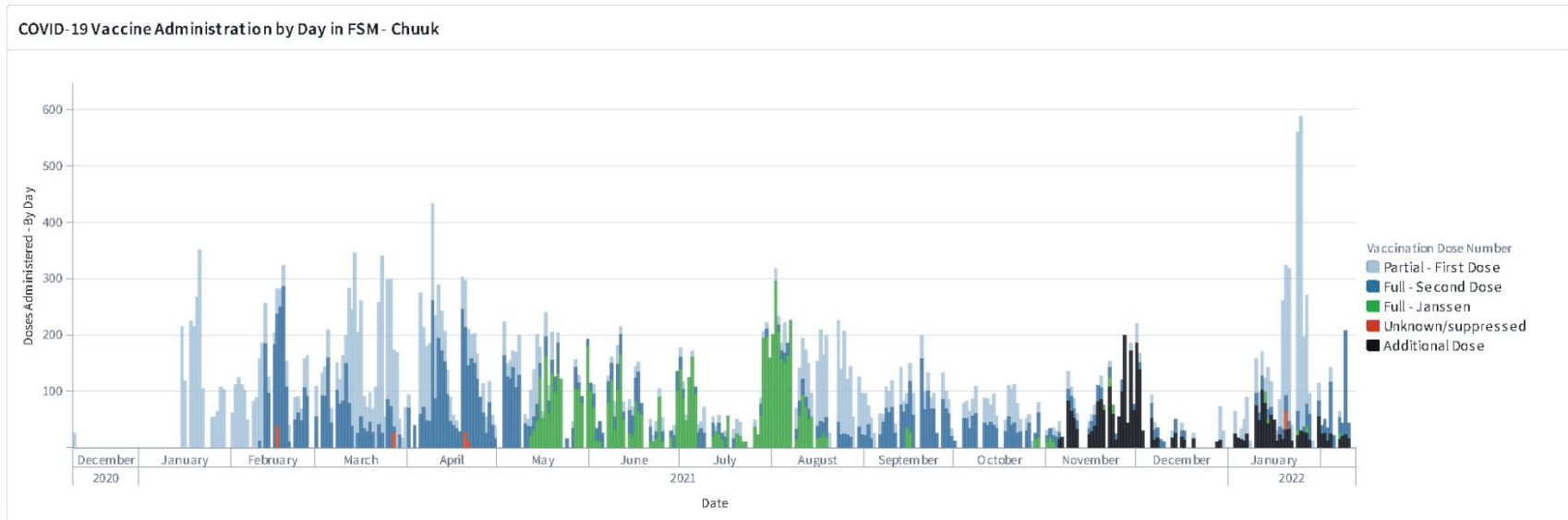
Federated States of Micronesia

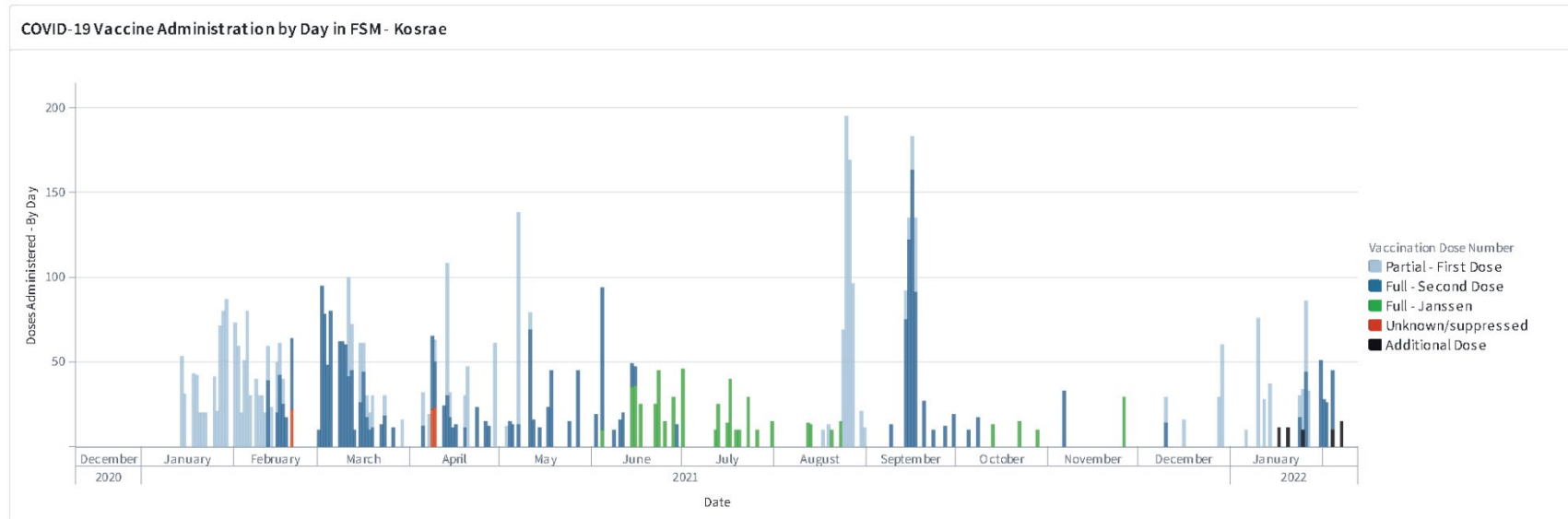
Chuuk

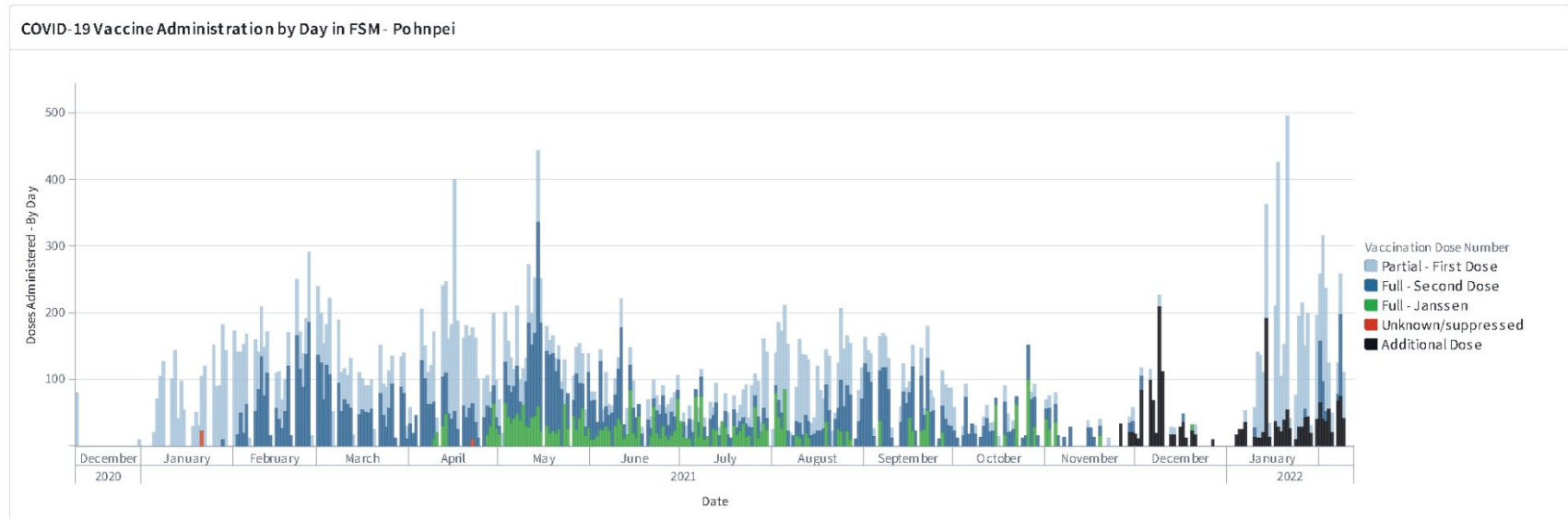
Kosrae

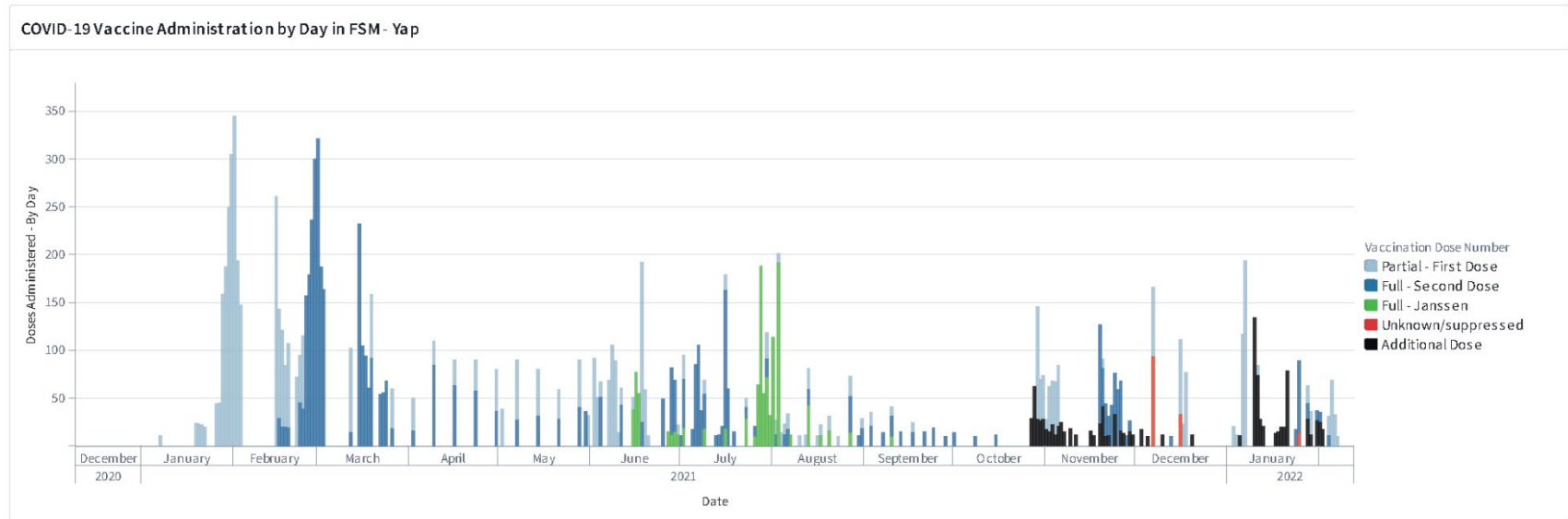
Pohnpei

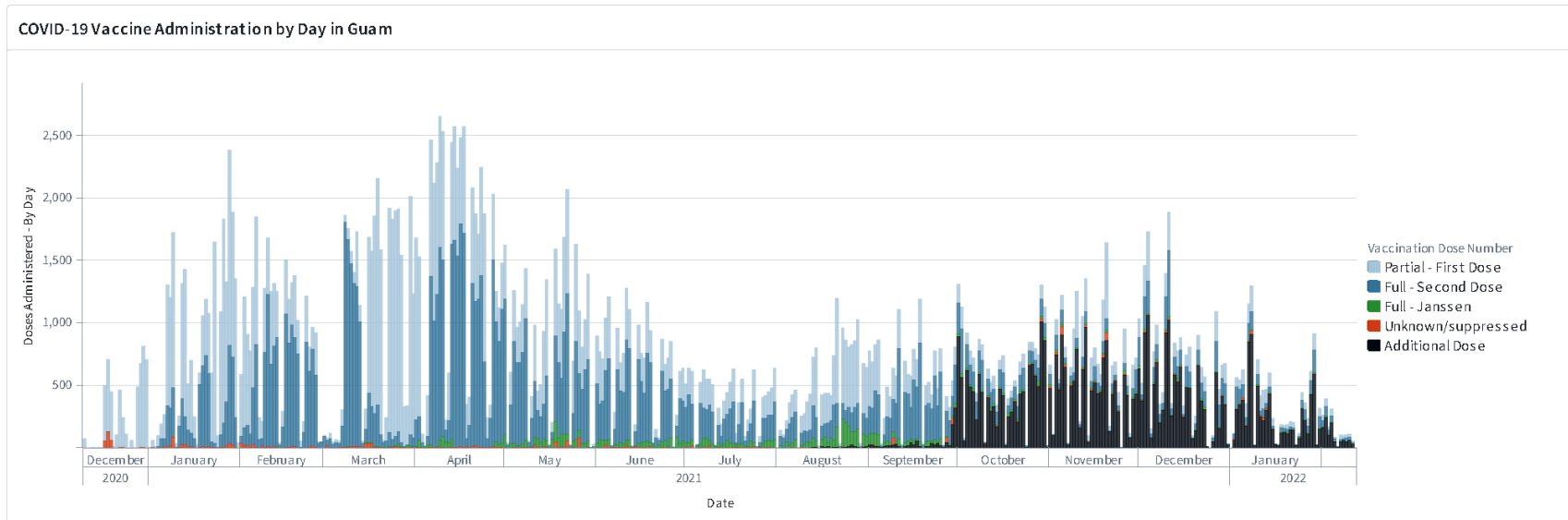
Yap

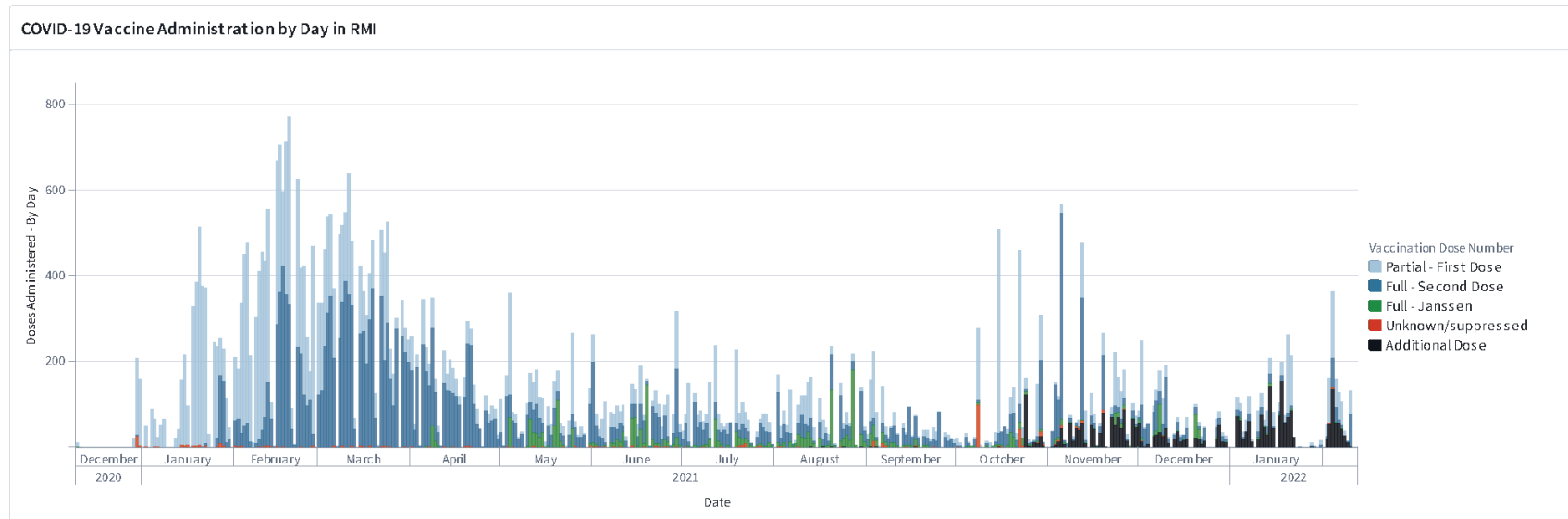

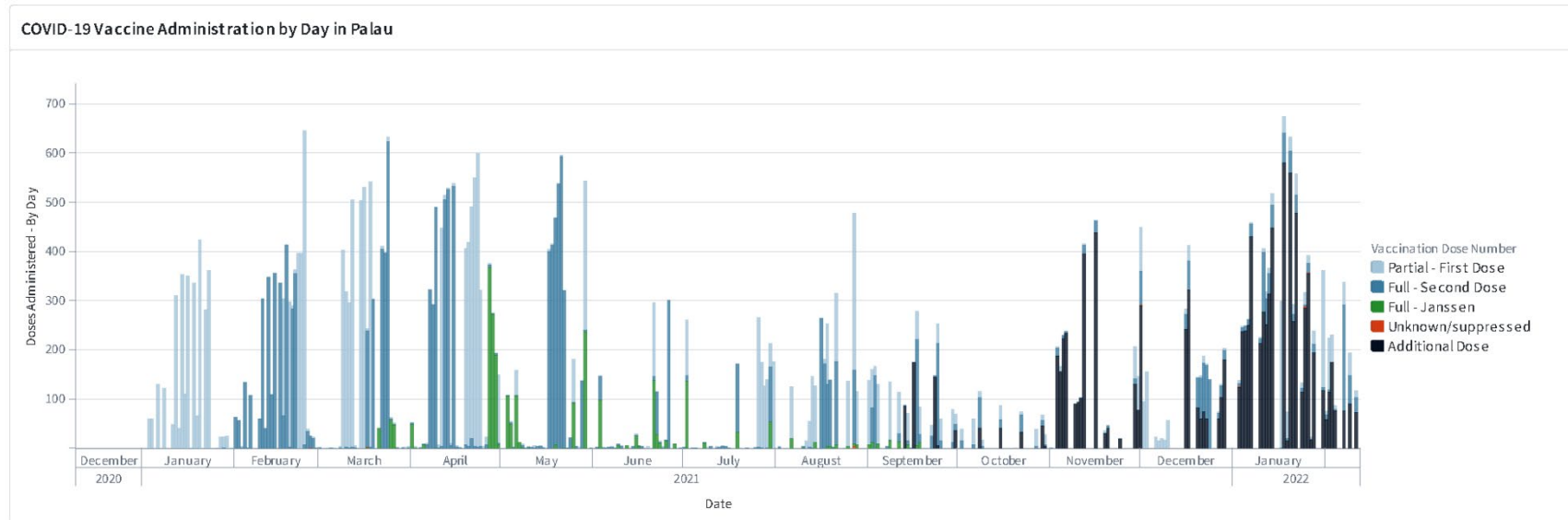
Republic of the Marshall Islands
