**Regional Summary:**

- COVID-19 cases
  - Guam has reported 47,541 total cases with 352 deaths; 230 new cases (↓ from 261 last week) and 3 new deaths this week (↓ from 9 last week); 7-day average test positivity 7.0% (↓ from 7.4% last week); 16 hospitalized cases (↑ from 12 last week)
  - CNMI has reported 10,862 total cases with 33 deaths; 40 new cases (↓ from 106 last week) and 0 new deaths this week (– from 0 last week); 7-day average test positivity 7.6% (↓ from 11.3% last week); 0 hospitalized cases (↓ from 1 last week)
  - Palau has reported 4,098 total cases with 6 deaths; 56 new cases reported this week (↑ from 55 last week) and 0 new deaths this week (– from 0 last week); 0 cases hospitalized (– from 0 last week)
  - American Samoa has reported 5,373 total cases with 12 deaths; 960 new cases (↓ from 1,196 last week) and 5 new deaths this week (– from 5 last week); 1,943 (36%) were treated with therapeutics
  - FSM and RMI have had no community transmission with 0 new cases reported this week
- COVID-19 Vaccine distribution summary (See USAPI Vaccine Summary with 22 updated tables and figures listed below)
  - Based on jurisdictional reports: a total of 316,359 people in the region are fully vaccinated (84.0% of all eligible individuals [5 and older]/ +2.0%)
    - An additional 27,026 people in the region are partially vaccinated (7.2% of eligible individuals in the region)
  - Based on data submitted into Tiberius via WebIZ: **90% of all people aged 5 years and older have had at least one dose of a COVID-19 vaccine; 81% are fully vaccinated; and 33% have an additional dose.**

- COVID-19 Containment strategies
  - Guam no longer requires quarantine for travelers and DPHSS has ceased processing travelers at ports of entry.
  - CNMI is allowing vaccinated travelers to enter without quarantine and unvaccinated travelers to enter with 5-day self-quarantine, testing is no longer required on day 5 or arrival.
  - Palau is running regular Guam and Taiwan flights with restriction of movement for vaccinated travelers with negative PCR test within 3 days of departure to Palau or negative antigen test within 1 day of departure to Palau and testing on day 4.
  - AS is running limited flights under Talofa Pass system with in-country quarantine and testing requirements and has not yet opened borders.
  - RMI has regular repatriation flights ongoing with HNL (3 days) and in-country quarantine (14 days) and testing requirements.
  - FSM has resumed repatriation flights and has reduced quarantine to 5 days in Guam then at least 5 days in FSM.

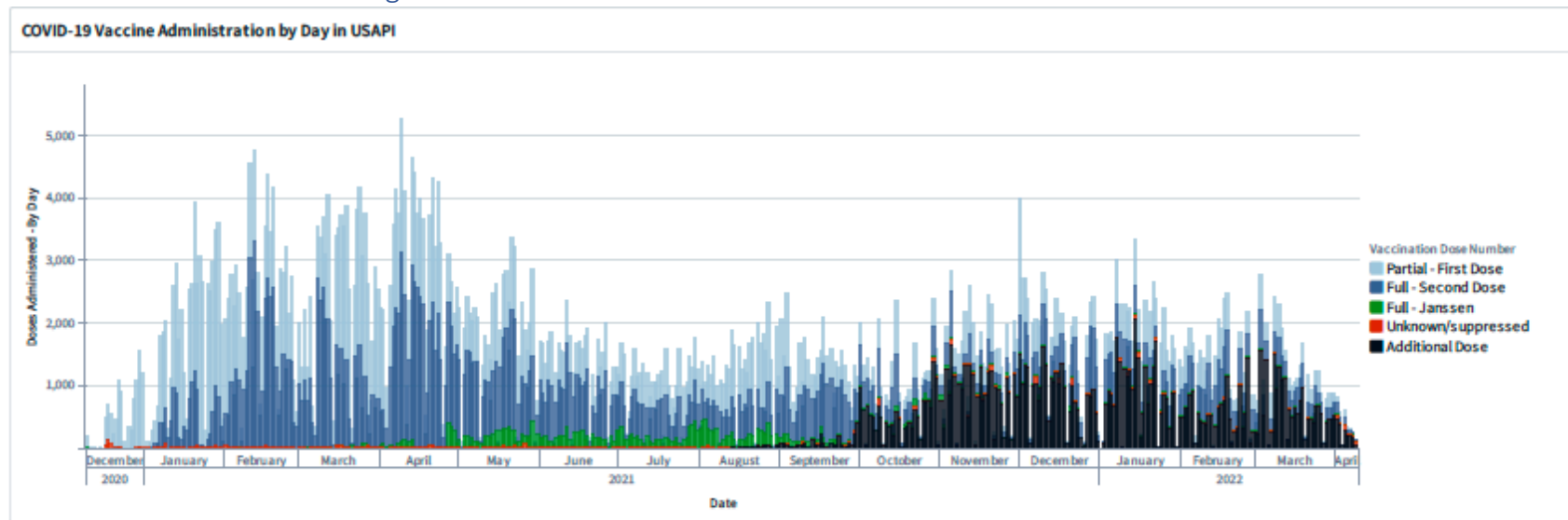

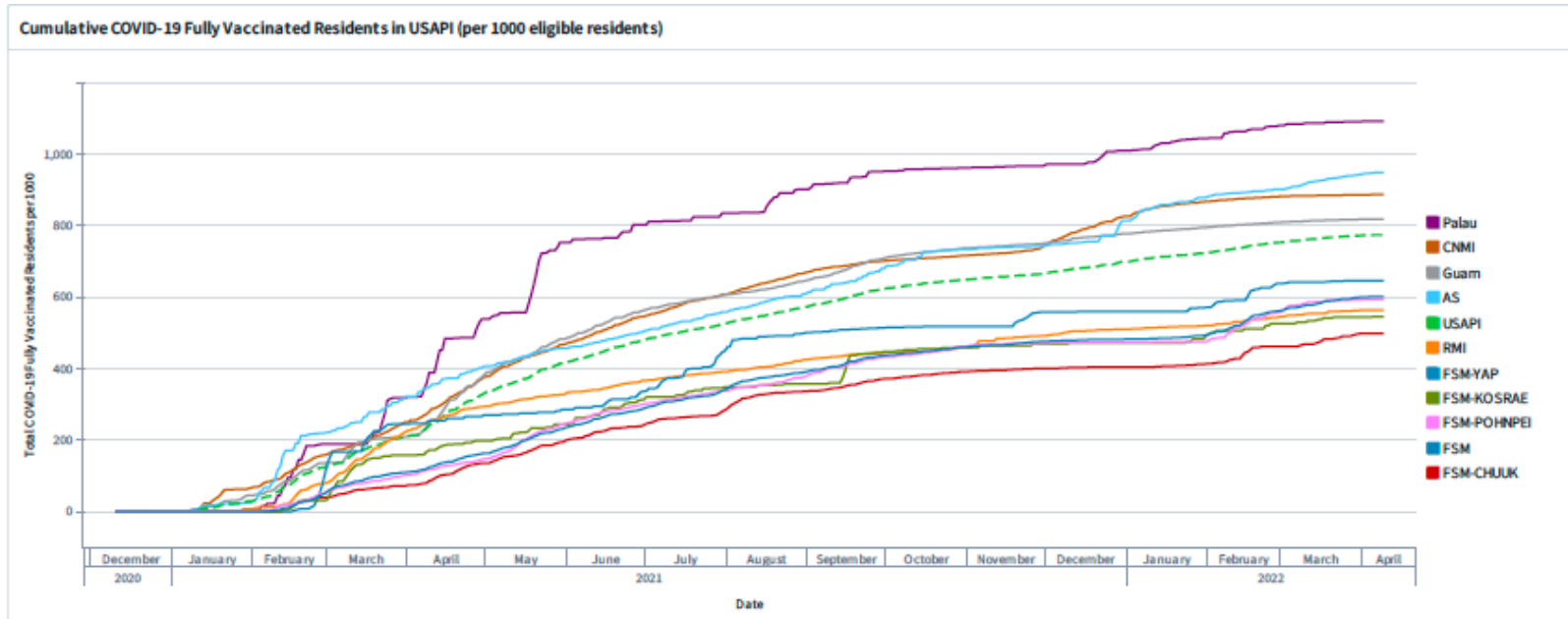
### US-affiliated Pacific Islands Region

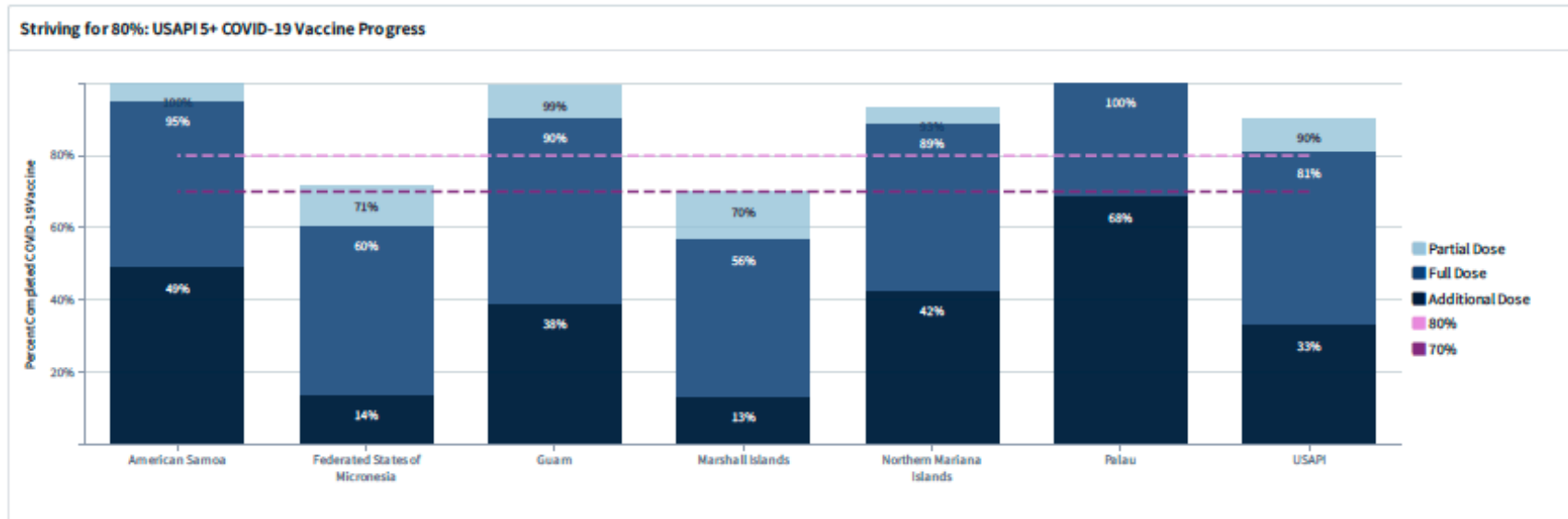

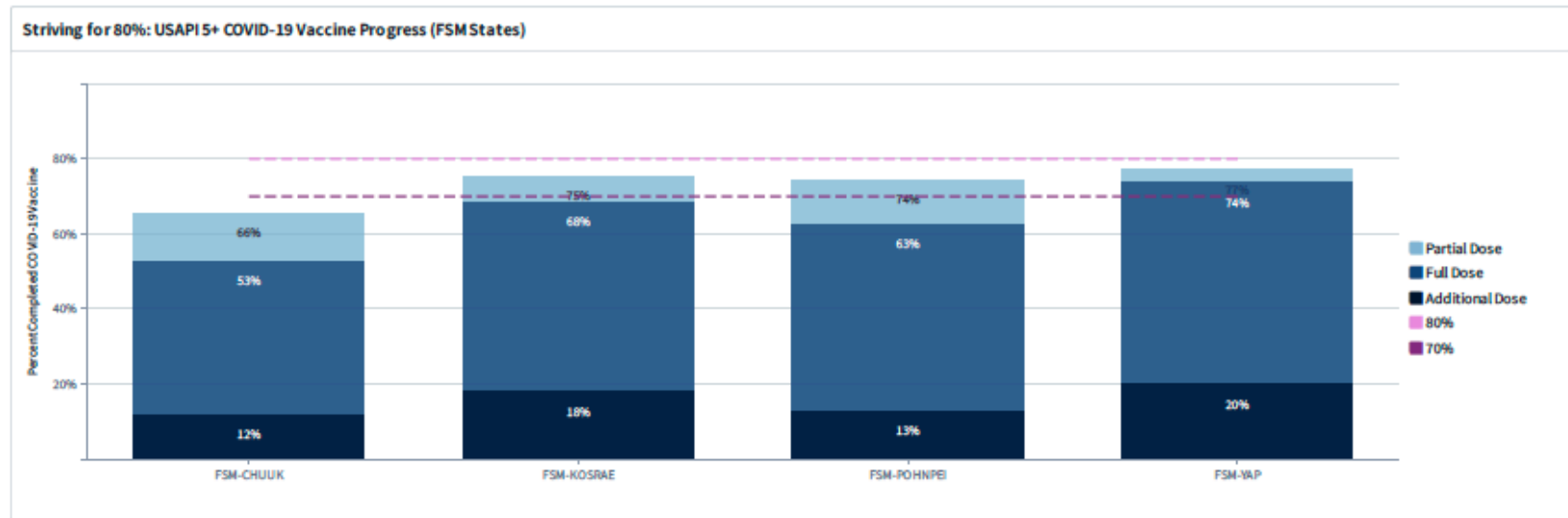

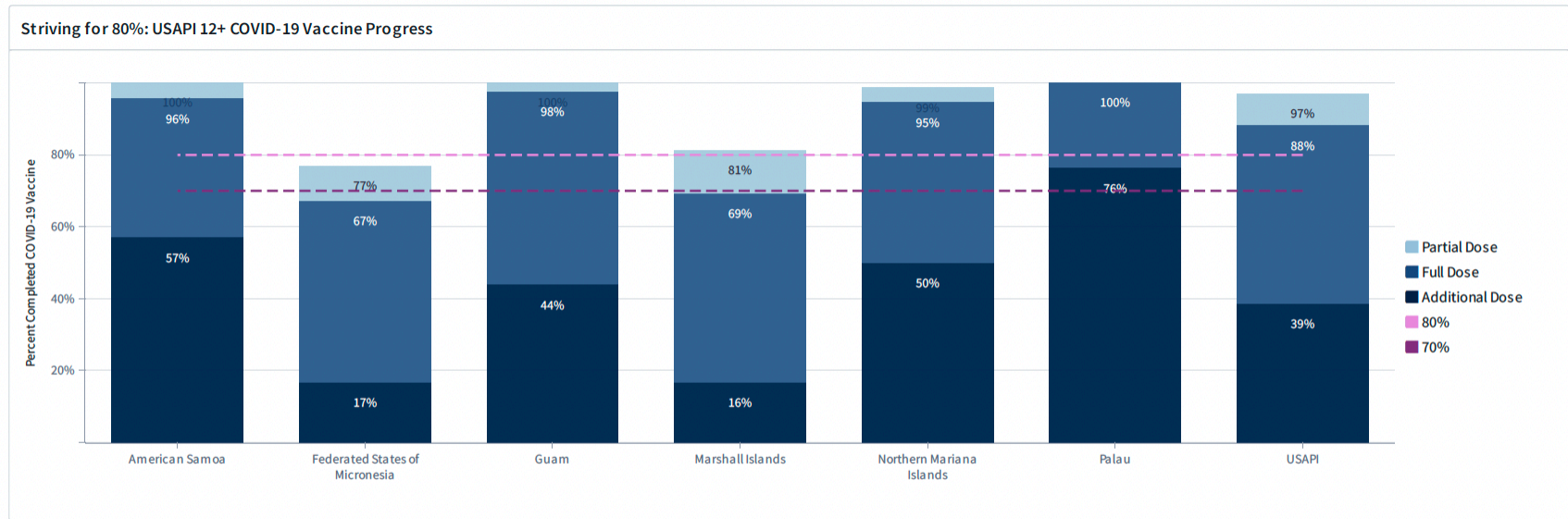

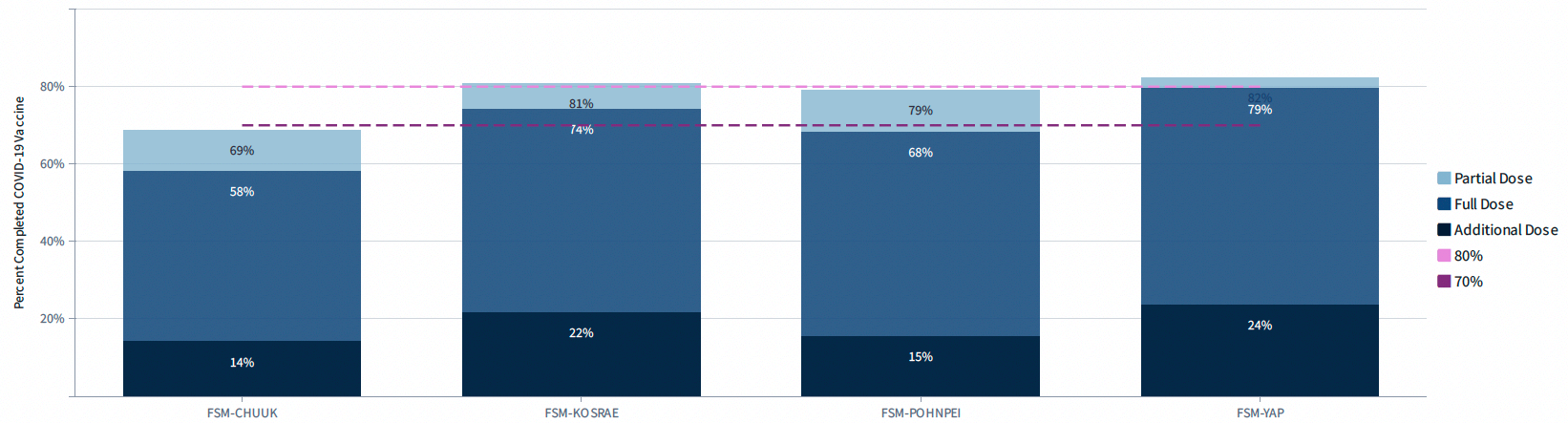

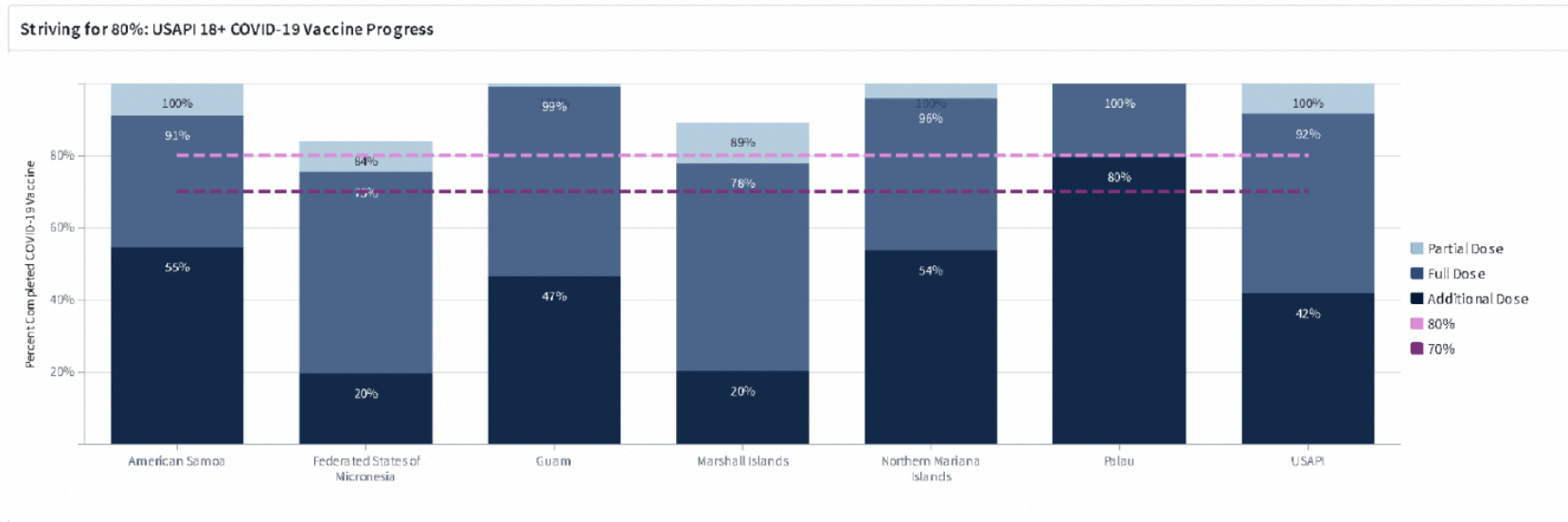
Striving for 80%: USAPI 12+ COVID-19 Vaccine Progress (FSM States)

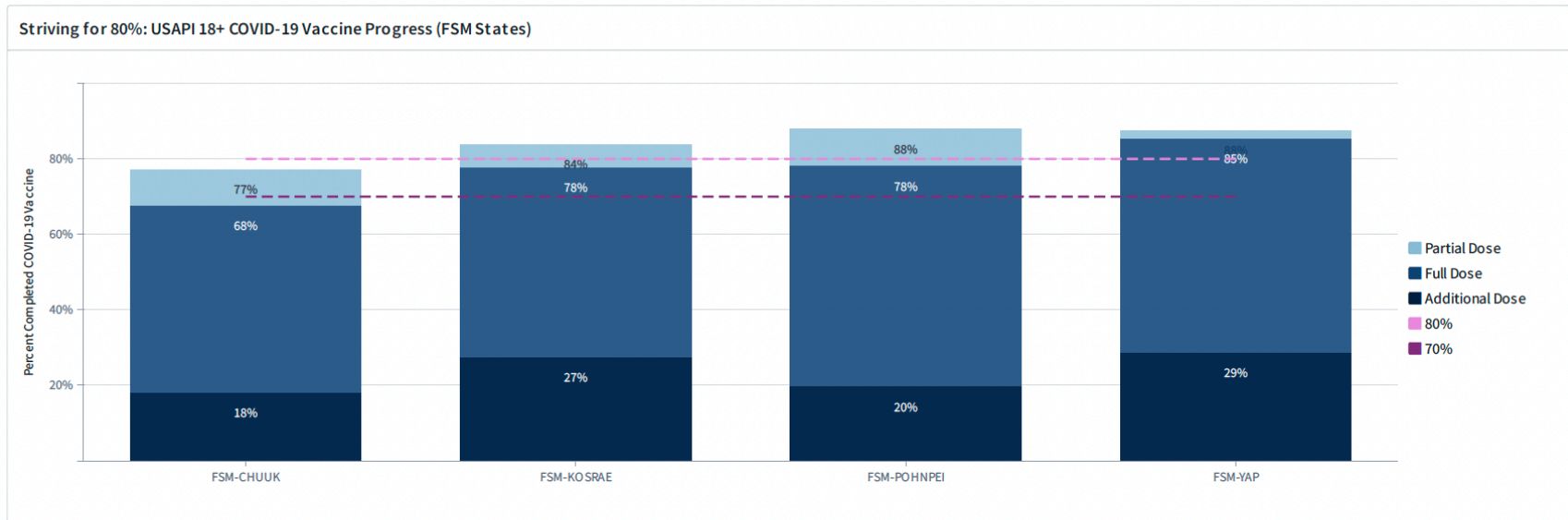

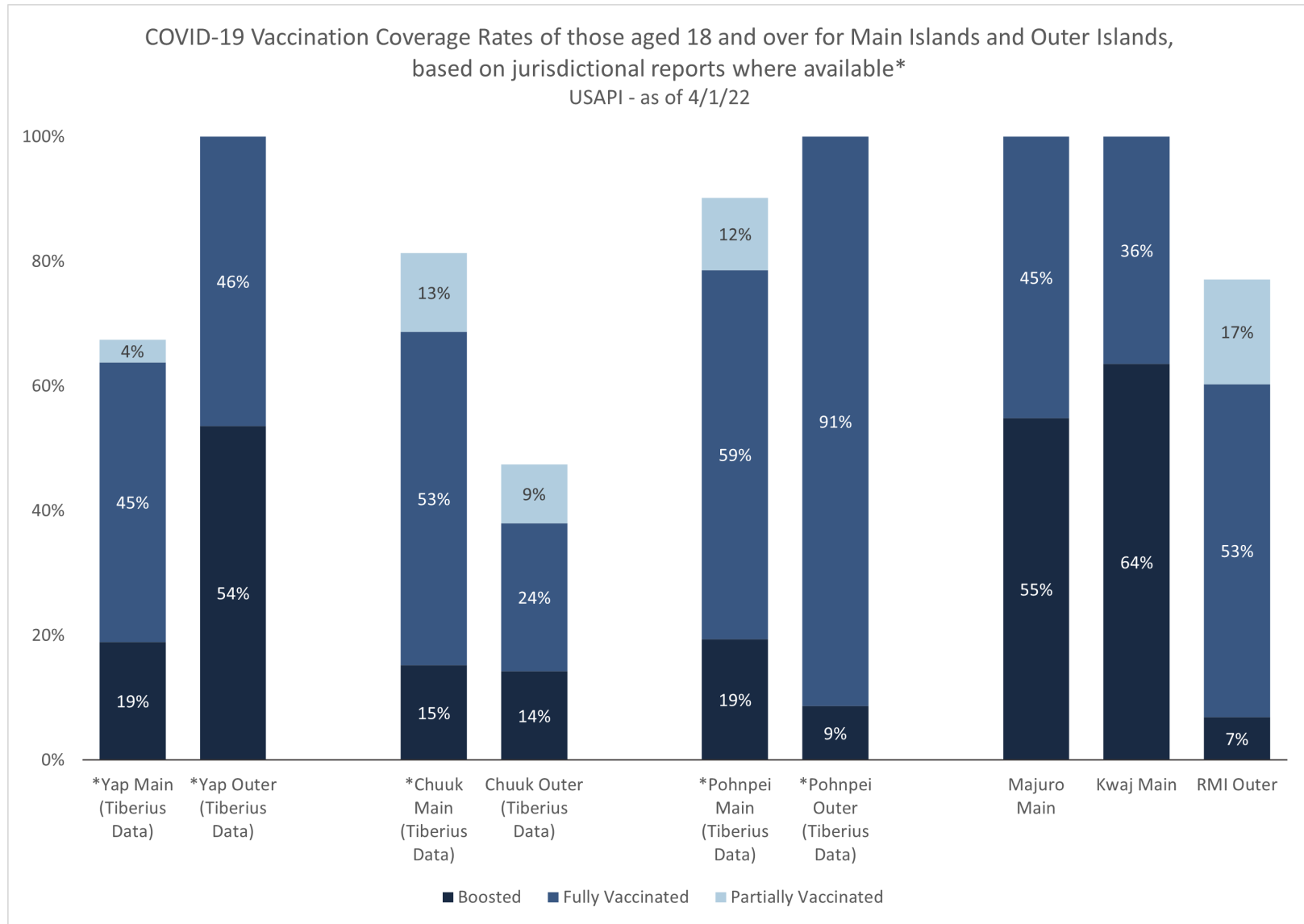

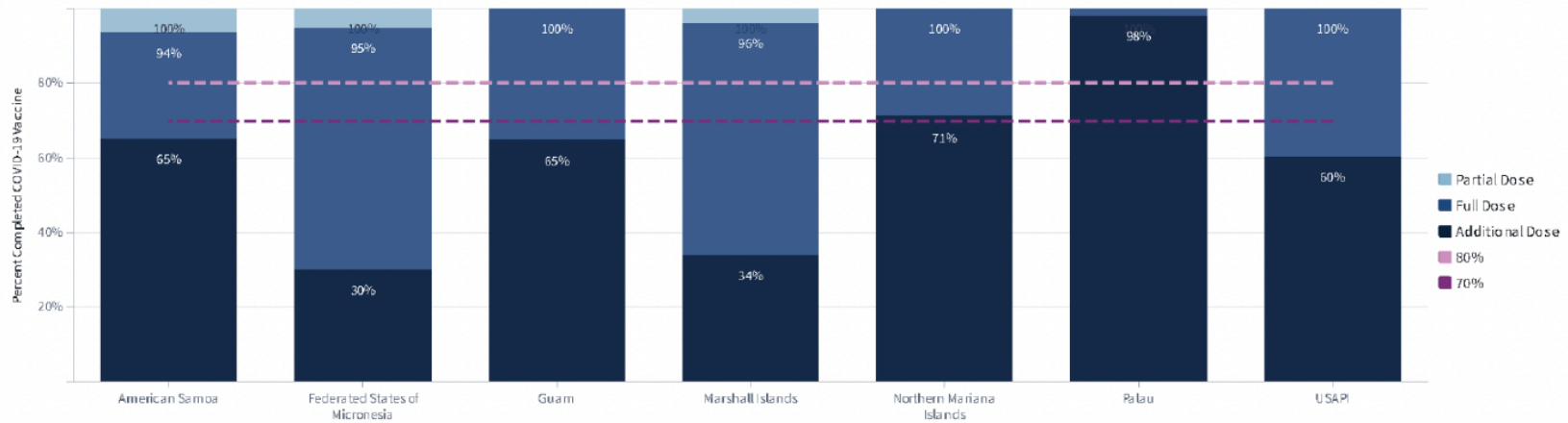

**Striving for 80%: USAPI 50+ COVID-19 Vaccine Progress**

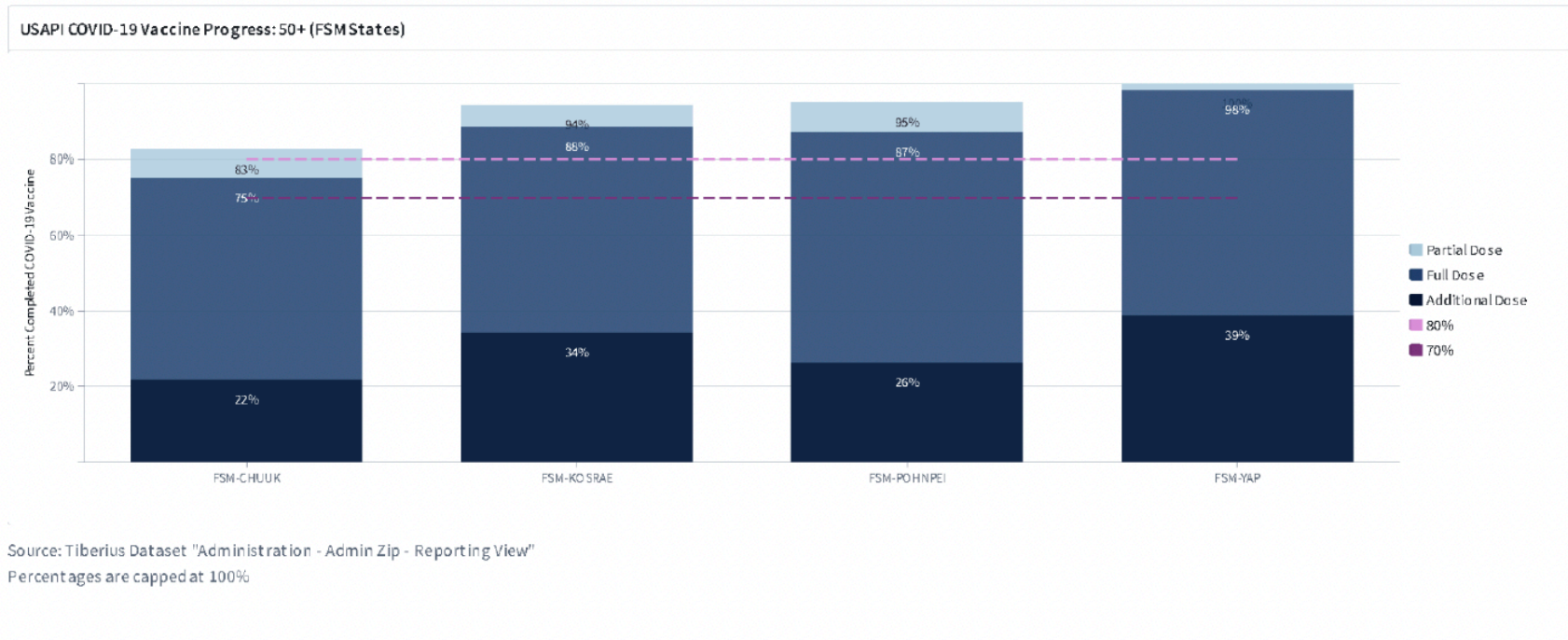

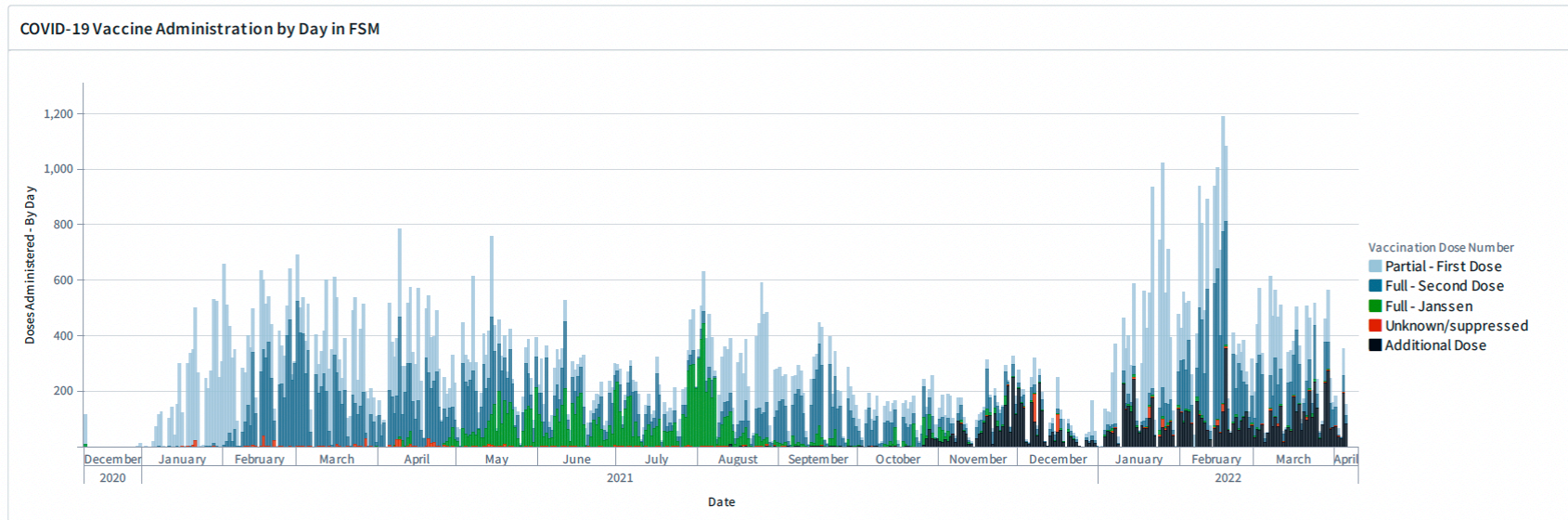

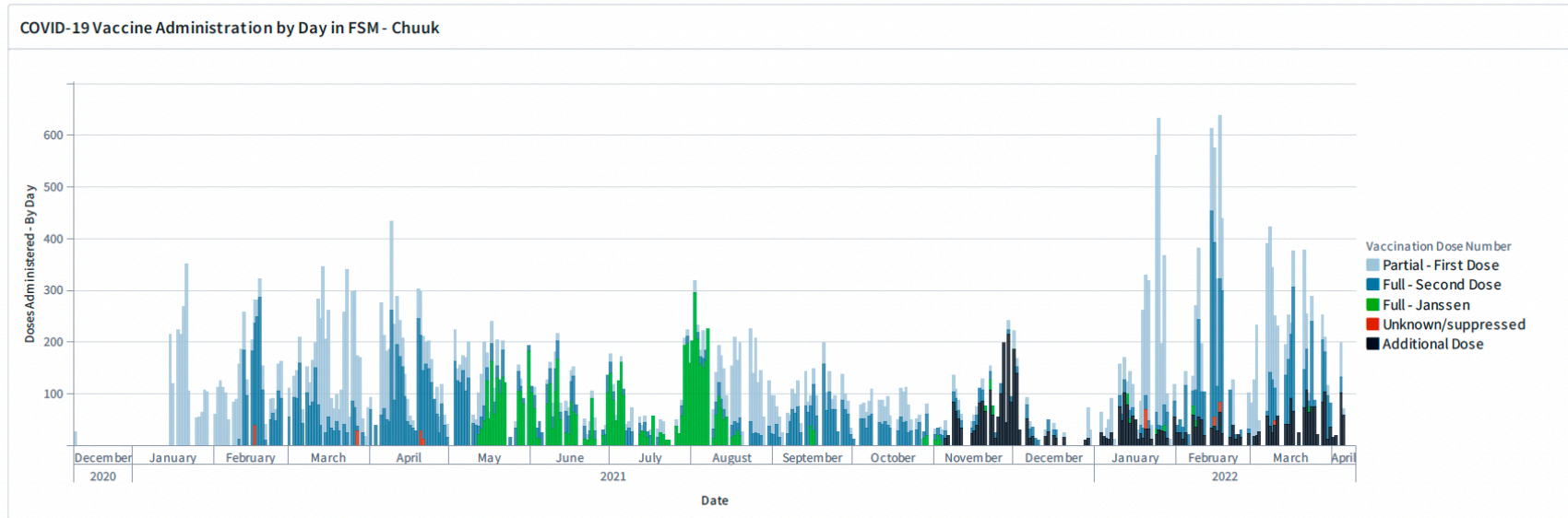

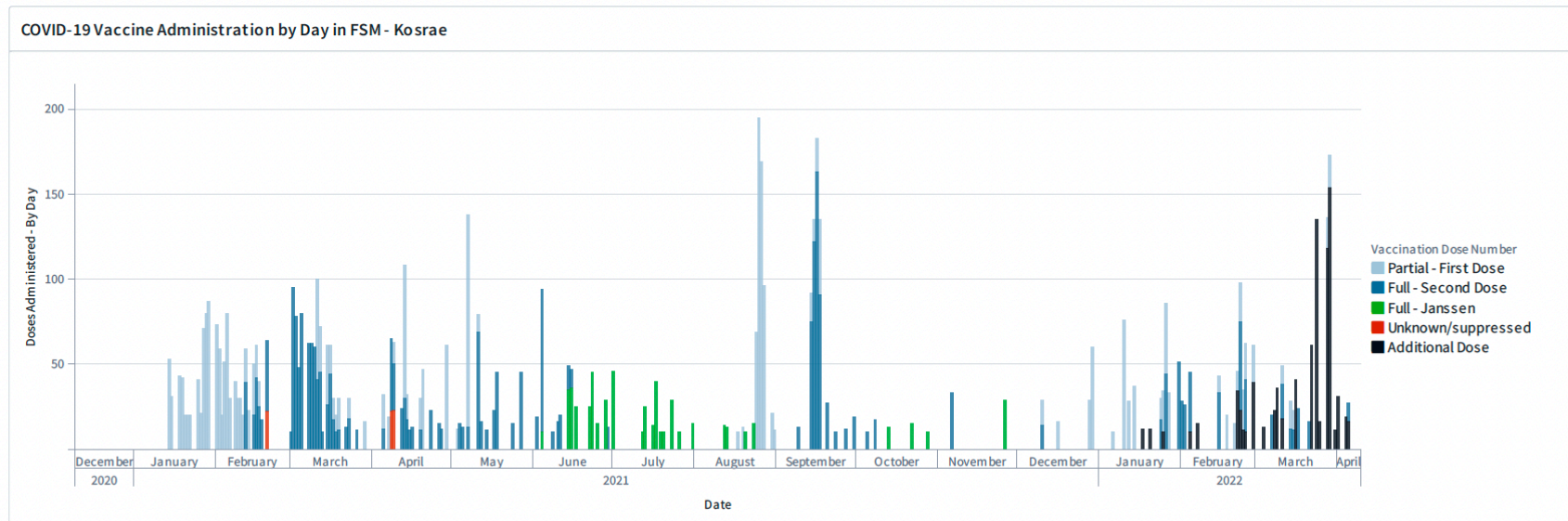

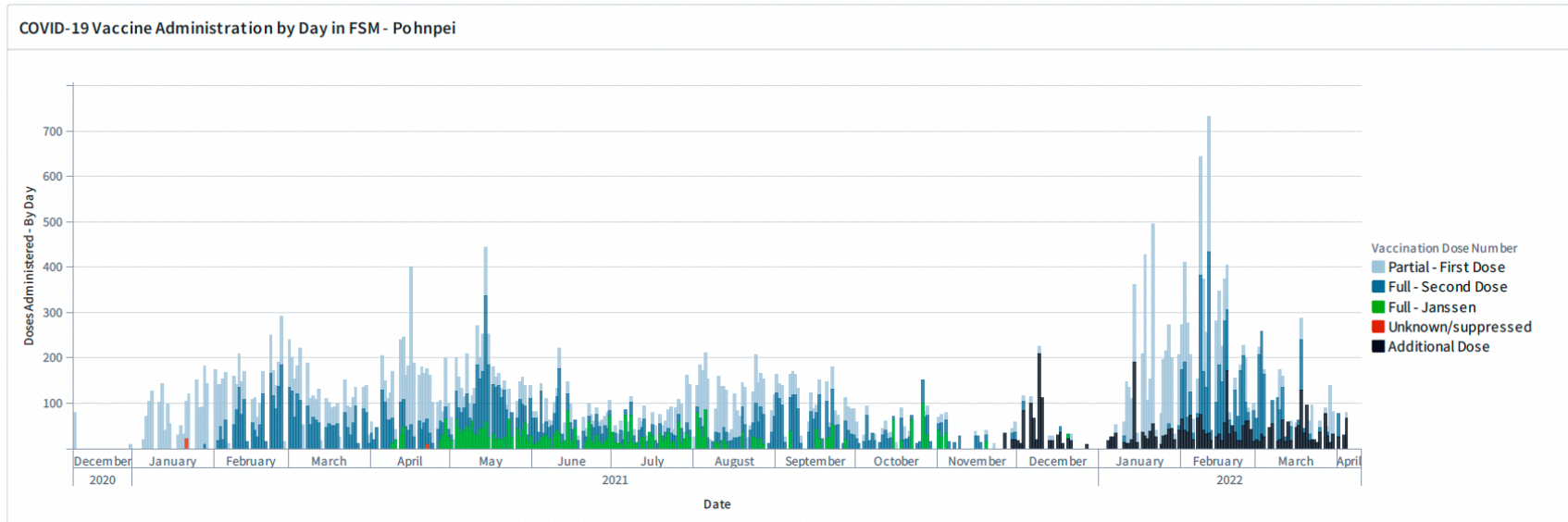

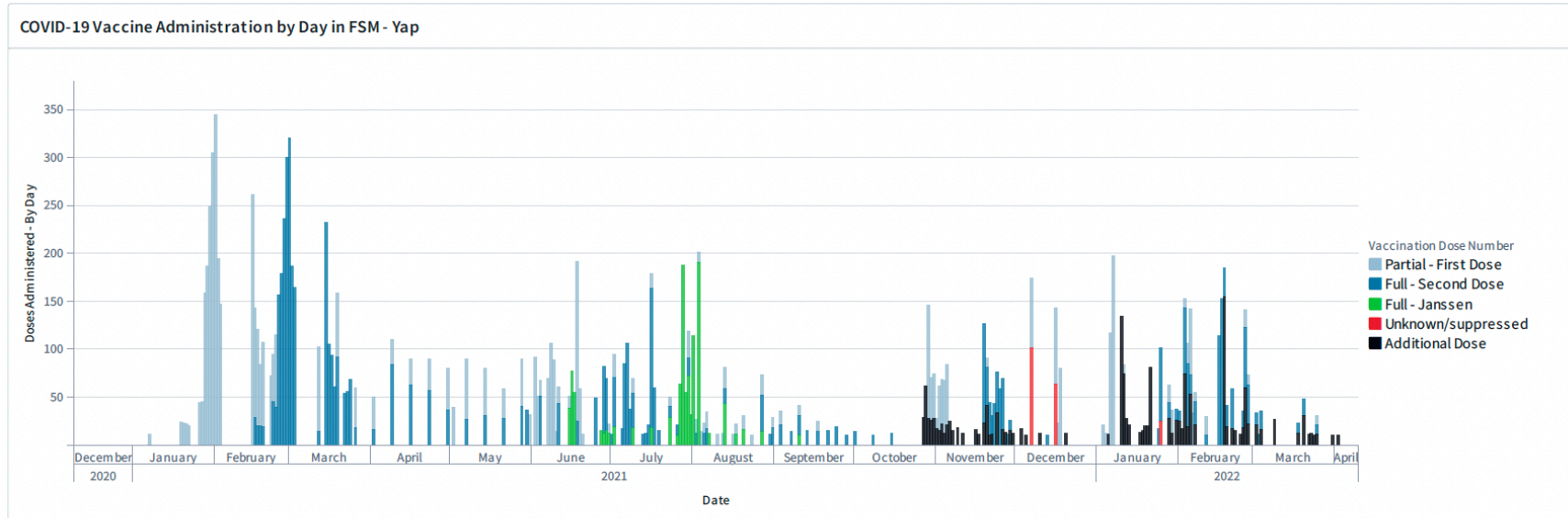

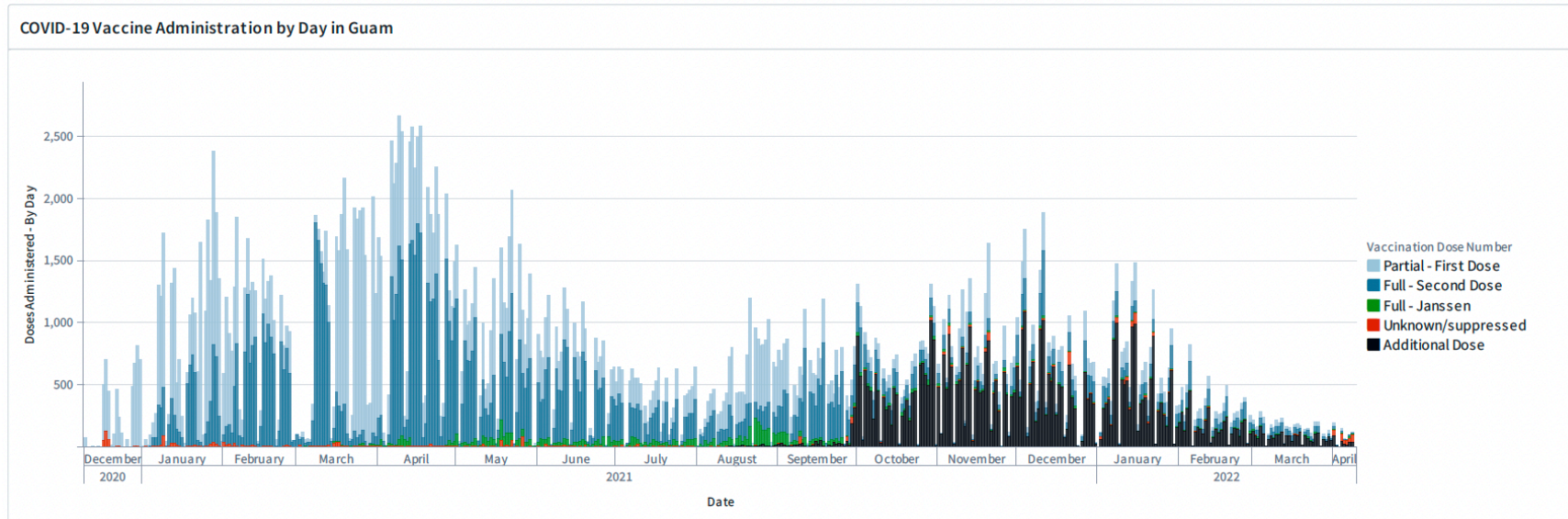

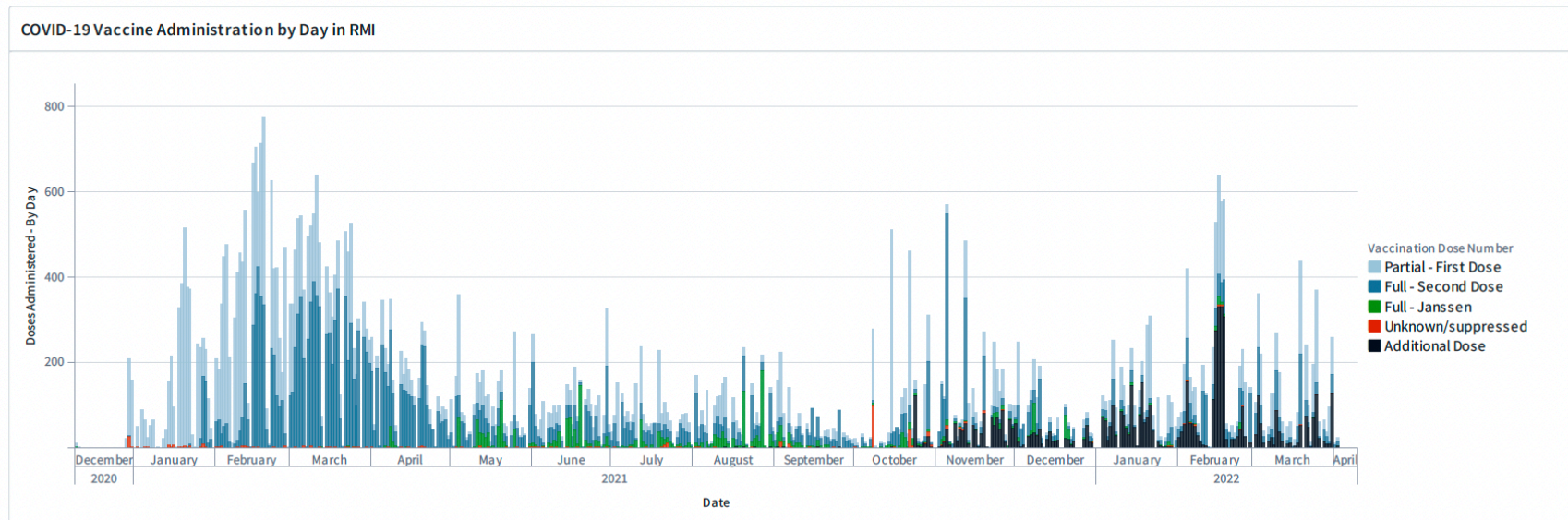

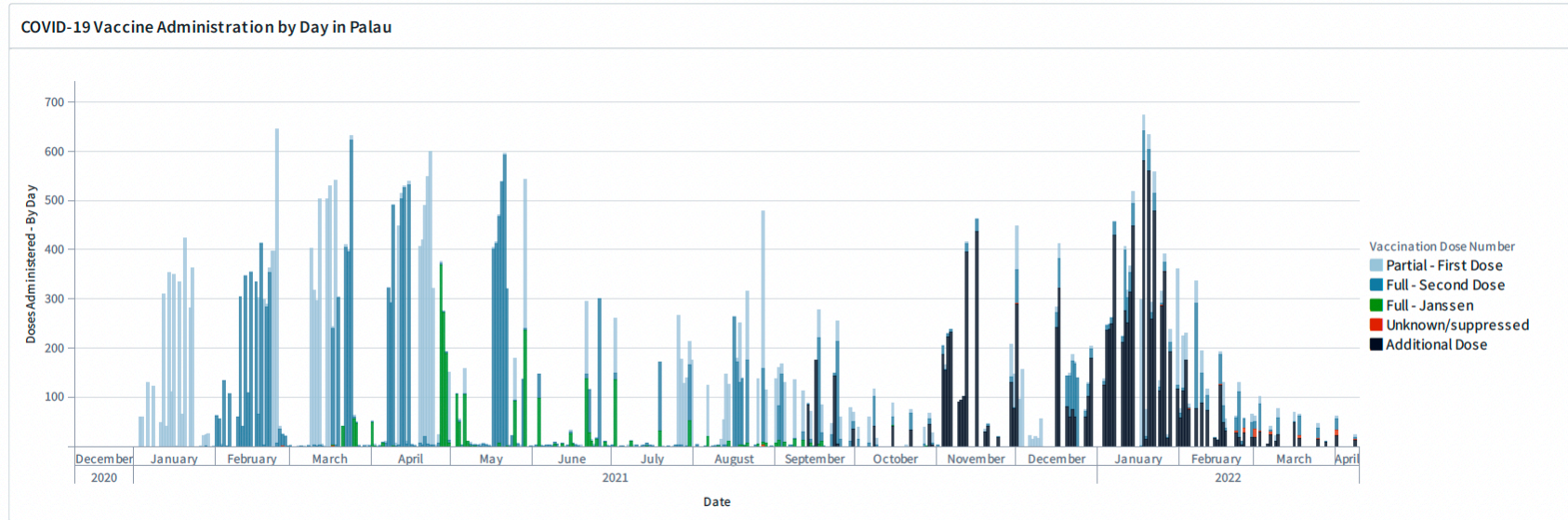
