Regional Summary:

- COVID-19 cases
 - Guam has reported 55,208 total cases with 380 deaths and 53,957 recovered; 1,607 new cases (↑ from 1,534 last report) and 4 new deaths this report (– from 4 last report); 7-day average test positivity 8.8% (↓ from 9.3% last report); 20 hospitalizations (↑ from 15 last report)
 - CNMI has reported 12,698 total cases with 38 deaths and 12,429 recovered; 505 new cases (↑ from 305 last report) and 3 new deaths this report (↑ from 0 last report) in the last 14 days; 7-day average test positivity 7.4% (↓ from 9.1% last report); 5 new hospitalizations (↑ from 0 last report)
 - American Samoa has reported 7,755 total cases with 33 deaths and 7,332 recovered; 295 new cases (↓ from 996 last report) and 0 new deaths this report (↓ from 2 last report); 3,079 (40%) treated with therapeutics; 10 new COVID-19-related hospitalizations (↑ from 5 last report)
 - Palau has reported 5,232 total cases with 6 deaths and 5,217 recovered; 25 new cases and 0 new deaths this report (– from 0 last report); 0 cases hospitalized (– from 0 last report)
 - FSM identified its first community transmission in Kosrae and Pohnpei on July 18 and 19 with symptomatic cases presenting for care at clinics and hospitals; 4,195 cases have been reported in FSM (Pohnpei: 3,356 total cases with 4 deaths; Kosrae: 839 total cases with 0 deaths); rapid spread in both states; earliest cases identified in Kosrae reported recent travel from Pohnpei and those in Pohnpei reported recent travel from Kosrae; some cases have been linked to recent 2022 Micronesia Expo hosted in Pohnpei from 7/18-7/22
 - RMI have had no community transmission with 11 new cases identified in facility quarantine
- COVID-19 Vaccine distribution summary (See USAPI Vaccine Summary with 22 updated tables and figures listed below)
 - Vaccination for children 6 months through 5 years of age are now available in all USAPI jurisdictions.
 - Based on data submitted into Tiberius via WebIZ: **94% of all people aged 5 years and older have had at least one dose of a COVID-19 vaccine (–% from last report); 84% are fully vaccinated (–% from last report); and 41% have had at least one additional dose (+1% from last report).**

COVID-19 Containment strategies

- Guam no longer requires quarantine for travelers and DPHSS has ceased processing travelers at ports of entry.
- CNMI no longer requires quarantine for travelers.
- Palau is running regular Guam and Taiwan flights for vaccinated travelers with mitigation orders on arrival.
- American Samoa is running limited flights under the Talofa Pass system for vaccinated travelers with pre-departure testing (for travelers from outside the US and Samoa) and arrival testing for all travelers with mask requirement on vessel until receipt of arrival testing results.
- RMI has regular repatriation flights ongoing with in-country quarantine of 14 days and testing requirements.
- FSM has resumed repatriation flights and has reduced quarantine to 3 days in Guam then at least 5 days in FSM (varies by state) with testing. Healthy Border Act to begin August 1, 2022; removes quarantine requirement for incoming travelers, continue to require vaccination and pre-arrival negative test

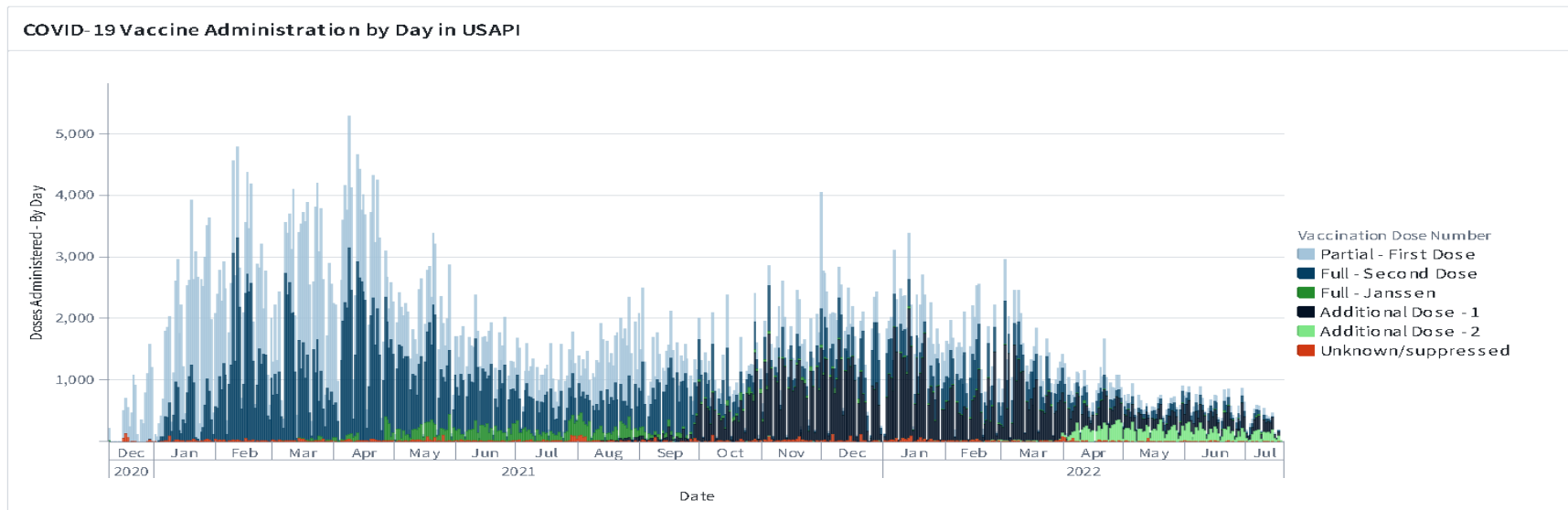

US-affiliated Pacific Islands Region

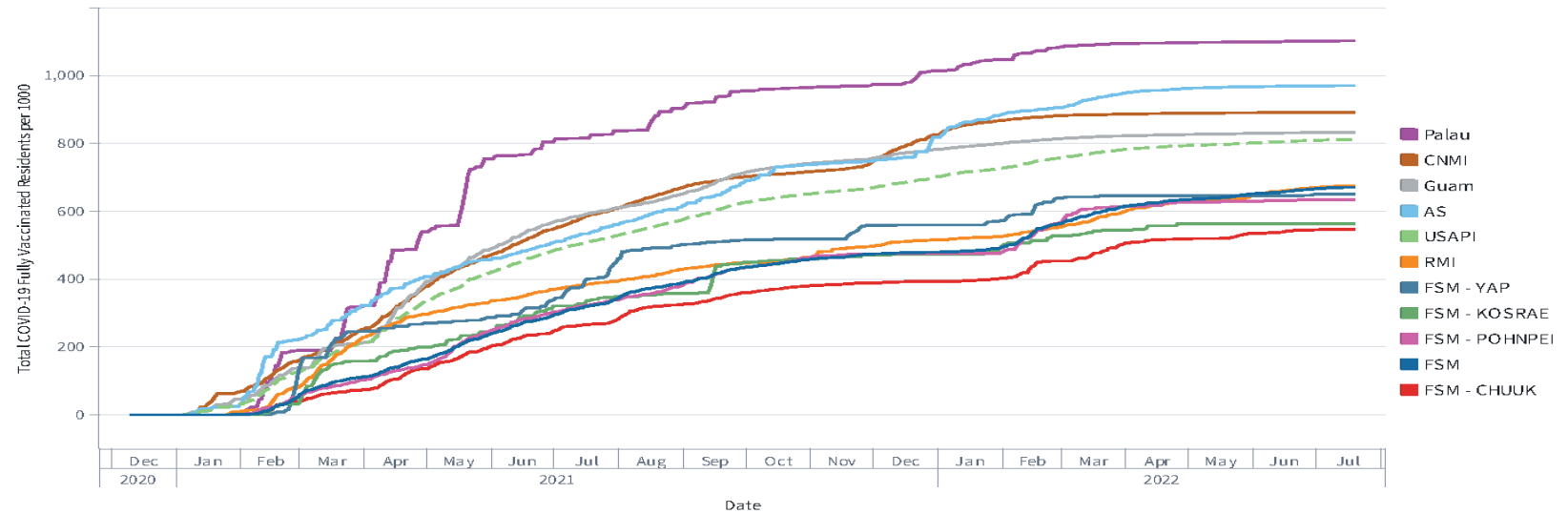

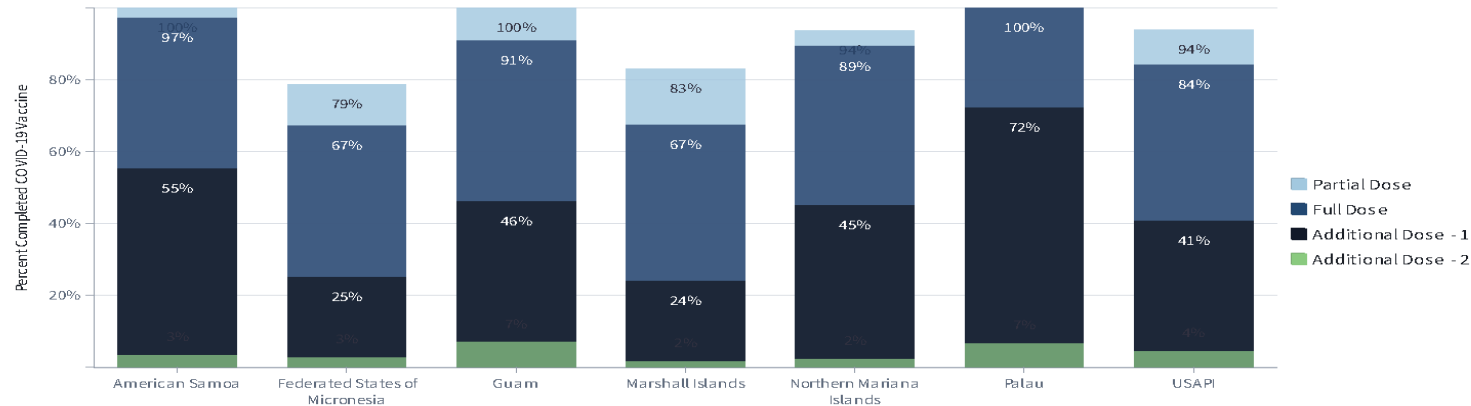

Striving for 80%: USAPI 5+ COVID-19 Vaccine Progress

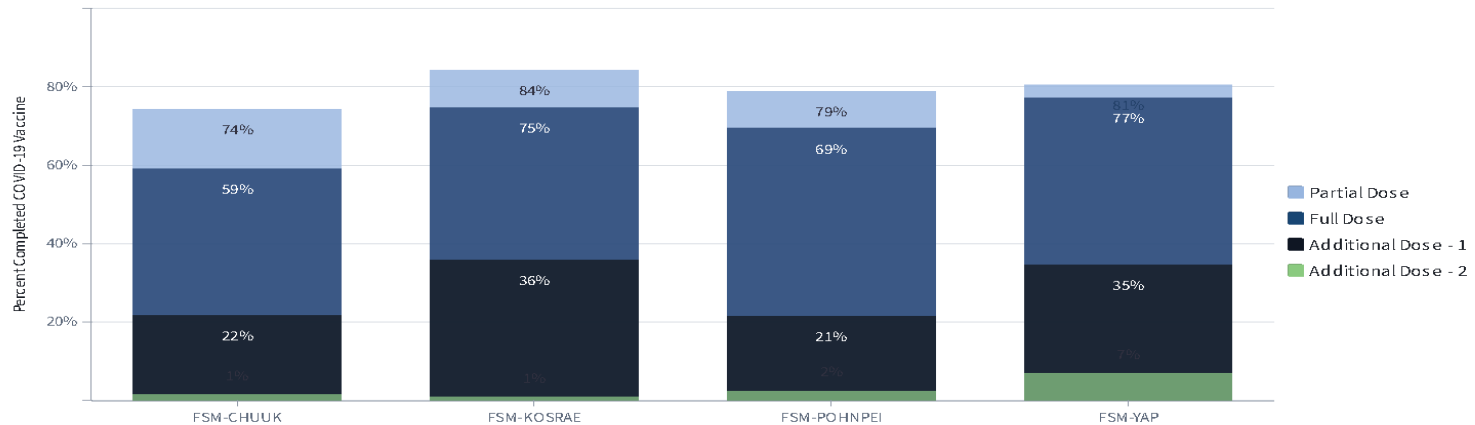

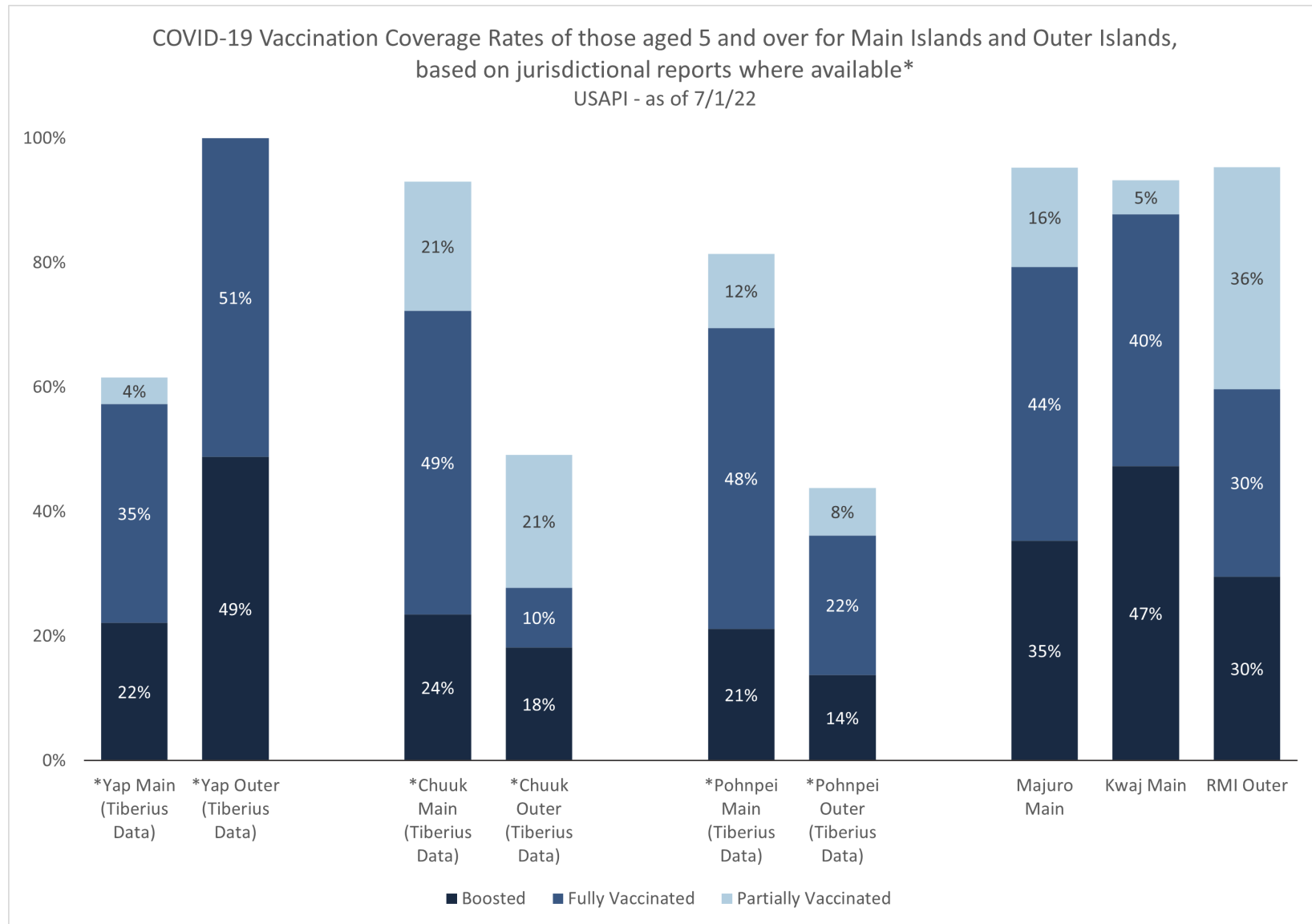
Striving for 80%: USAPI 5+ COVID-19 Vaccine Progress (FSM States)

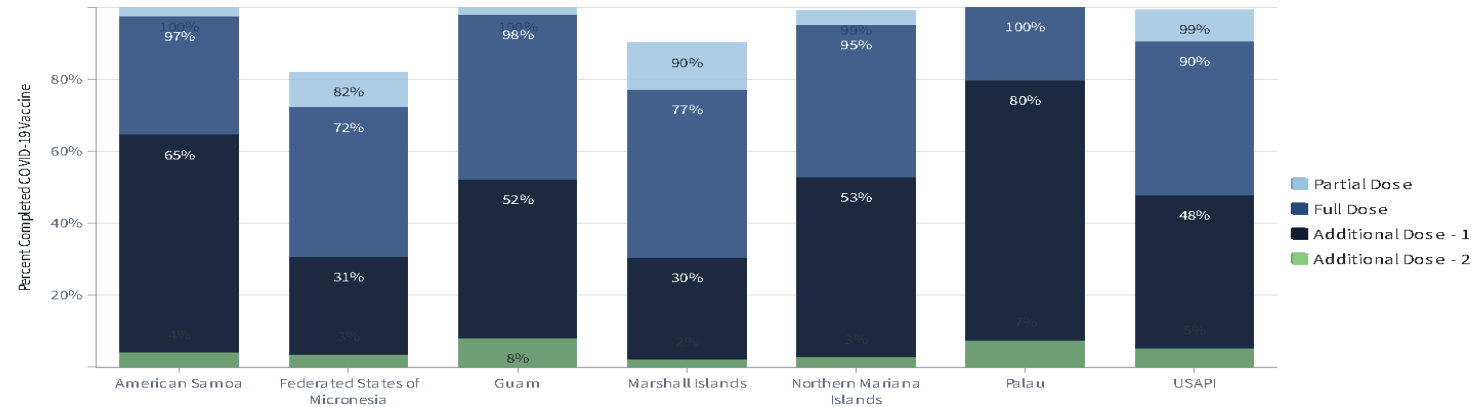

Striving for 80% USAPI 12+ COVID-19 Vaccine Progress

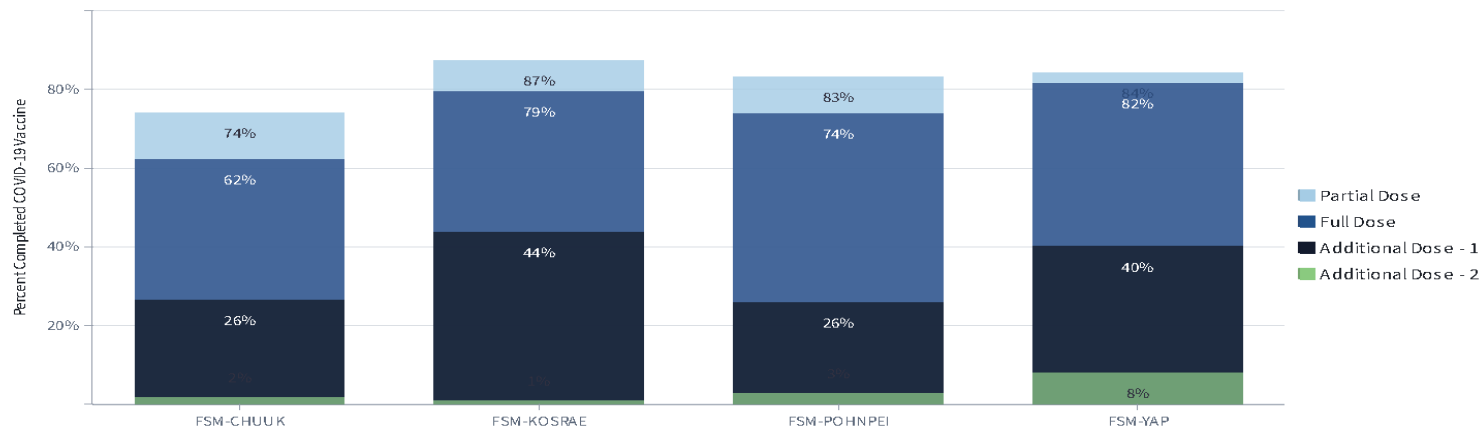

Striving for 80% USAPI 12+ COVID-19 Vaccine Progress (FSM States)

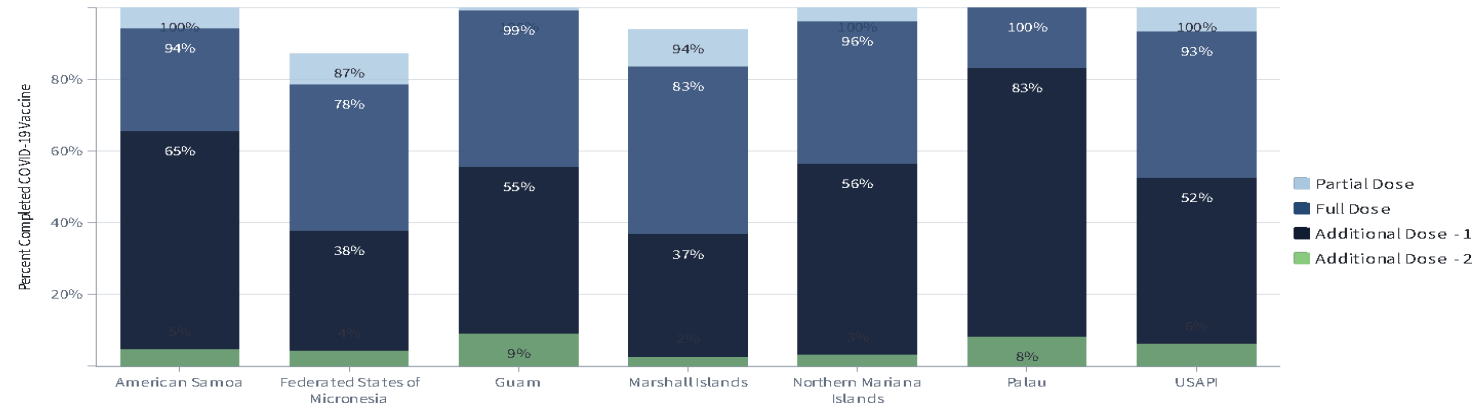

Striving for 80%: USAPI 18+ COVID-19 Vaccine Progress

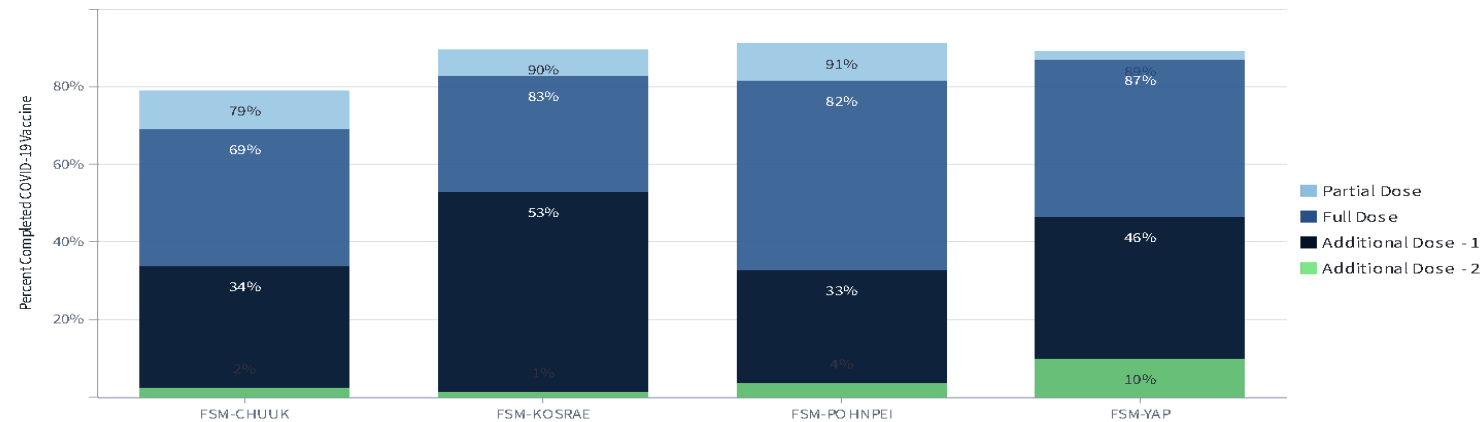

Striving for 80%: USAPI 18+ COVID-19 Vaccine Progress (FSM States)

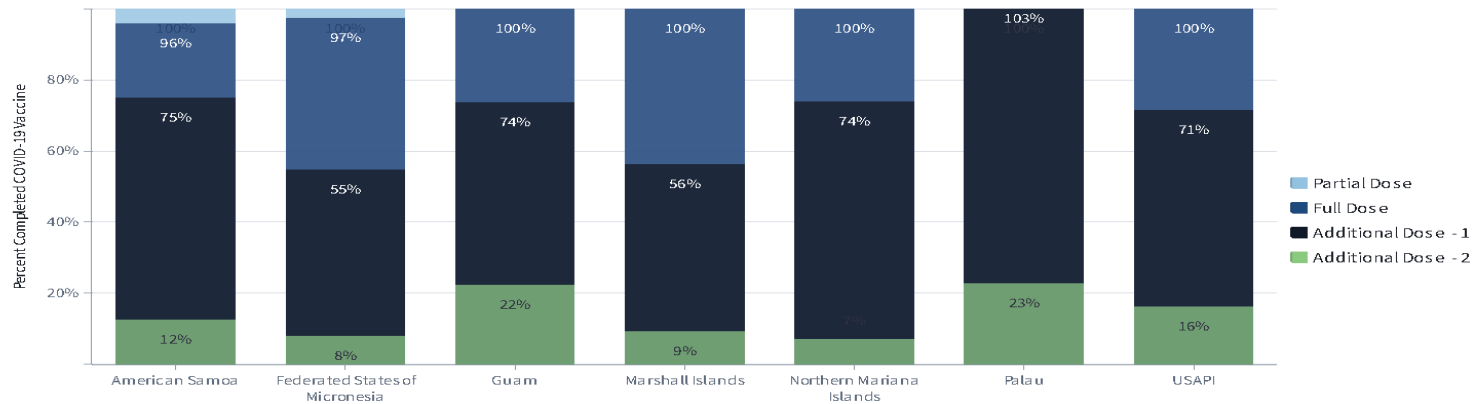

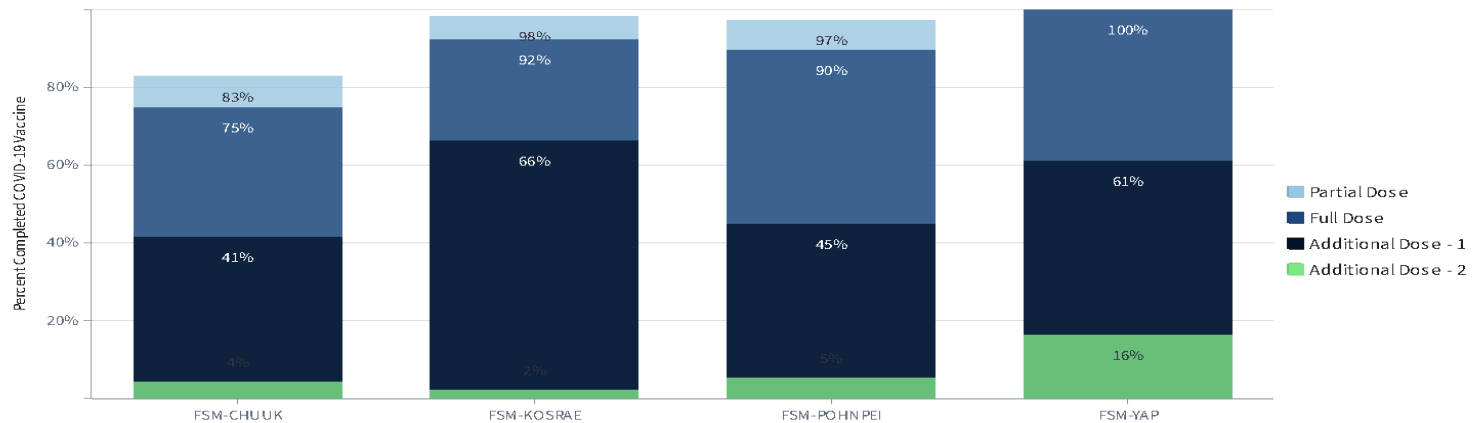

USAPI COVID-19 Vaccine Progress: 50 yrs and over (FSM States)



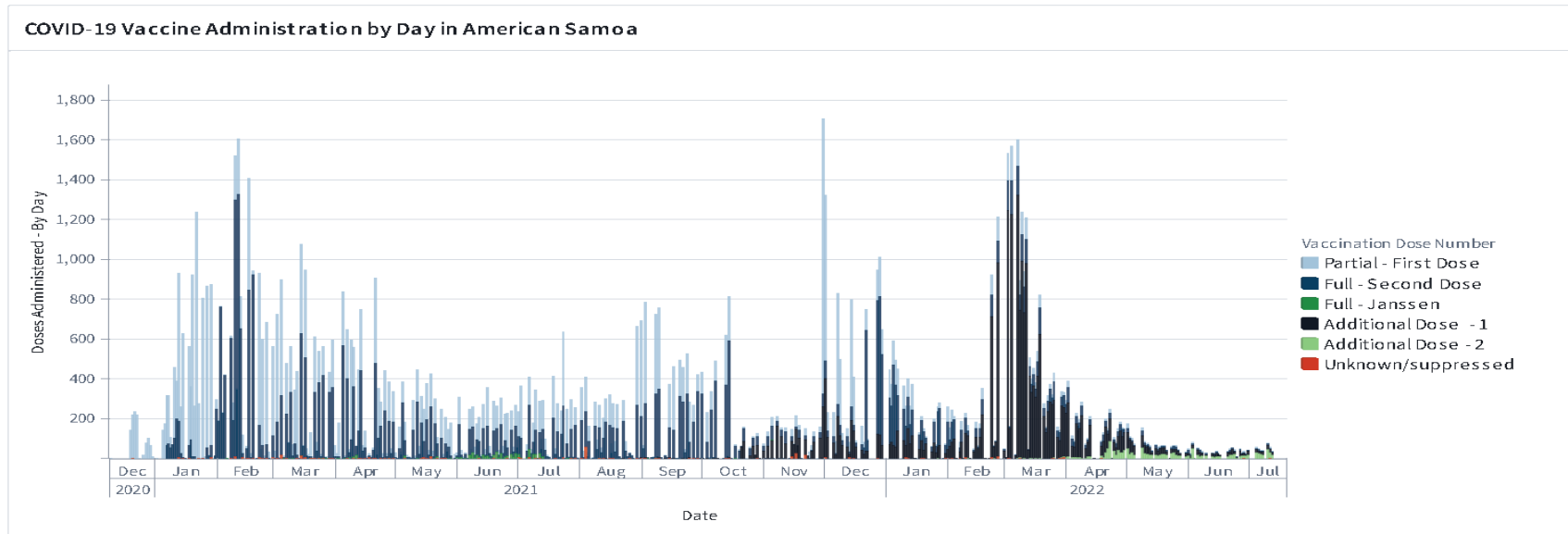

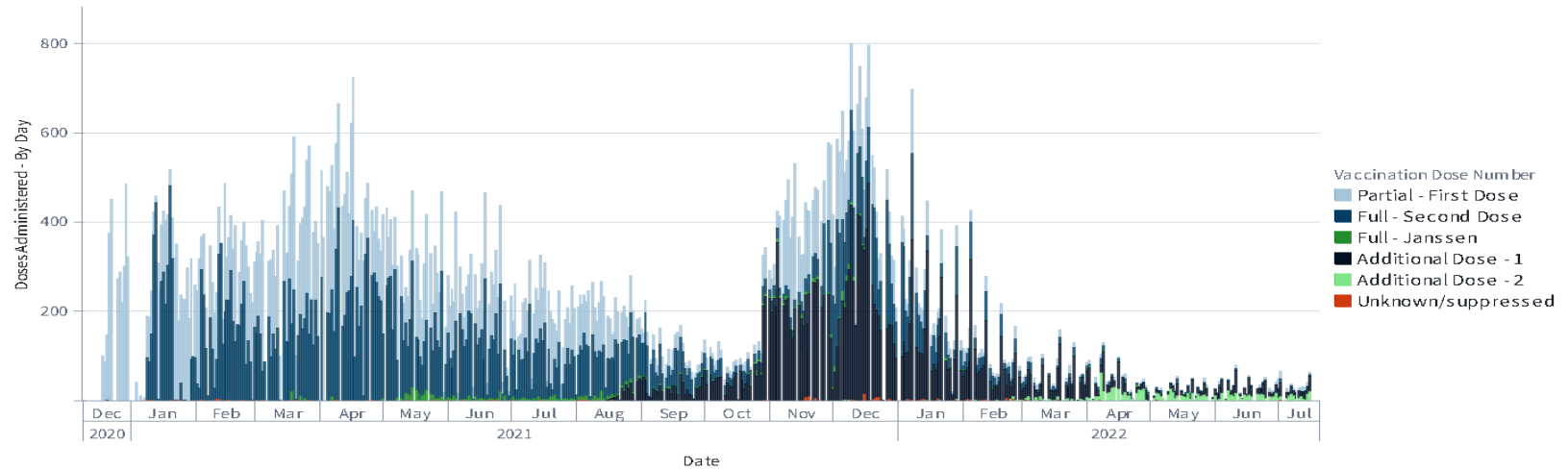

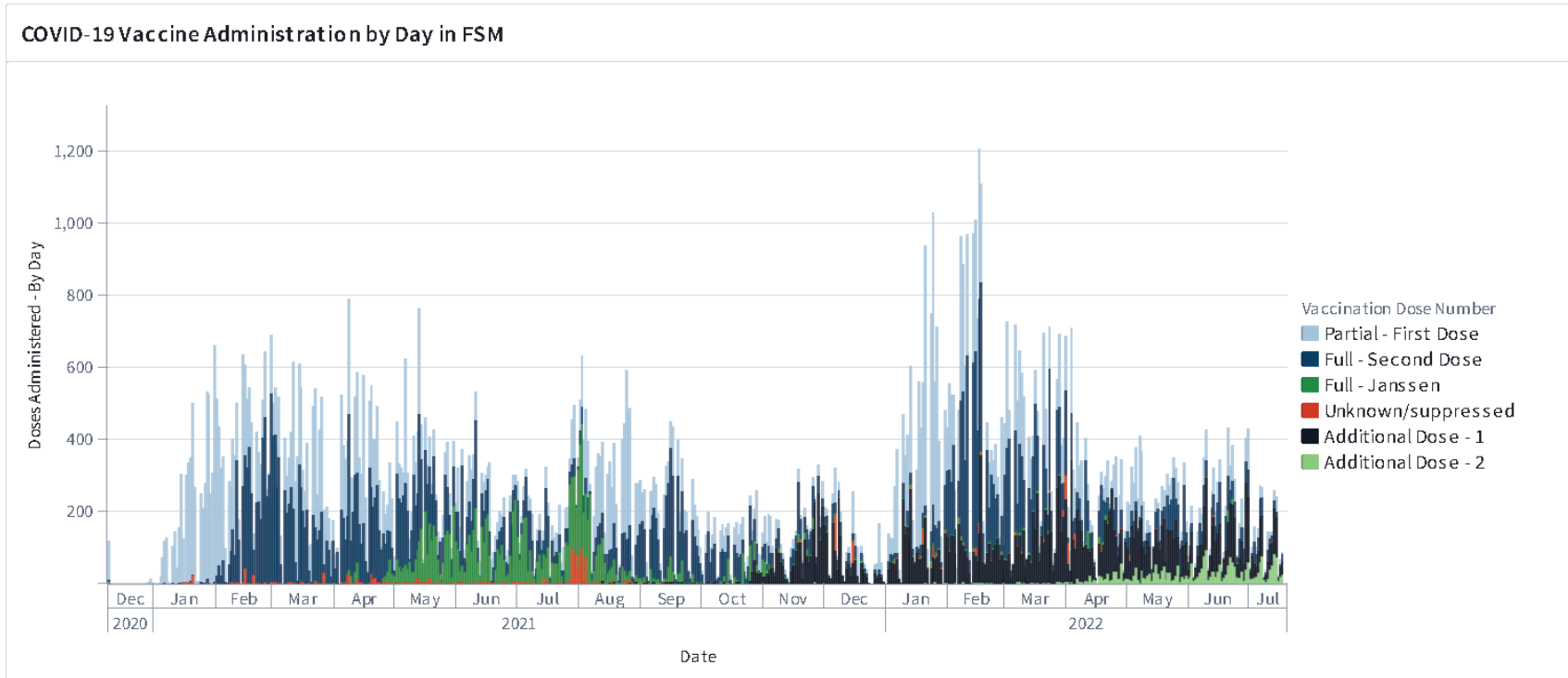
COVID-19 Vaccine Administration by Day in CNMI

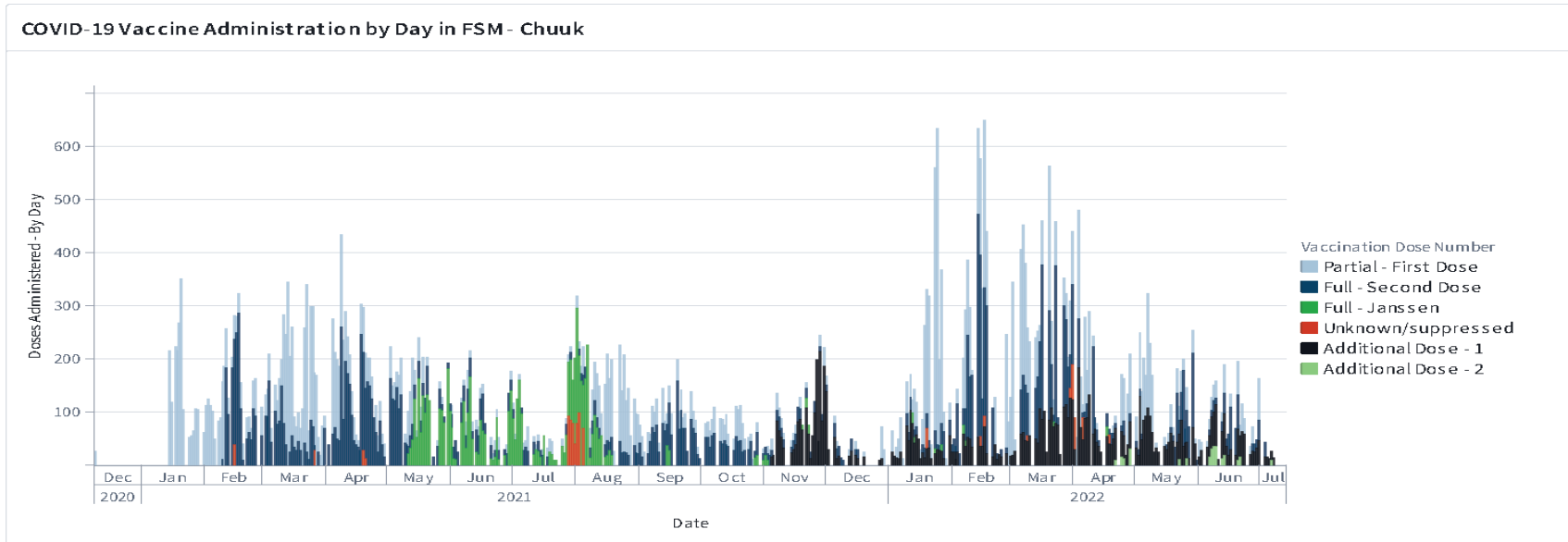

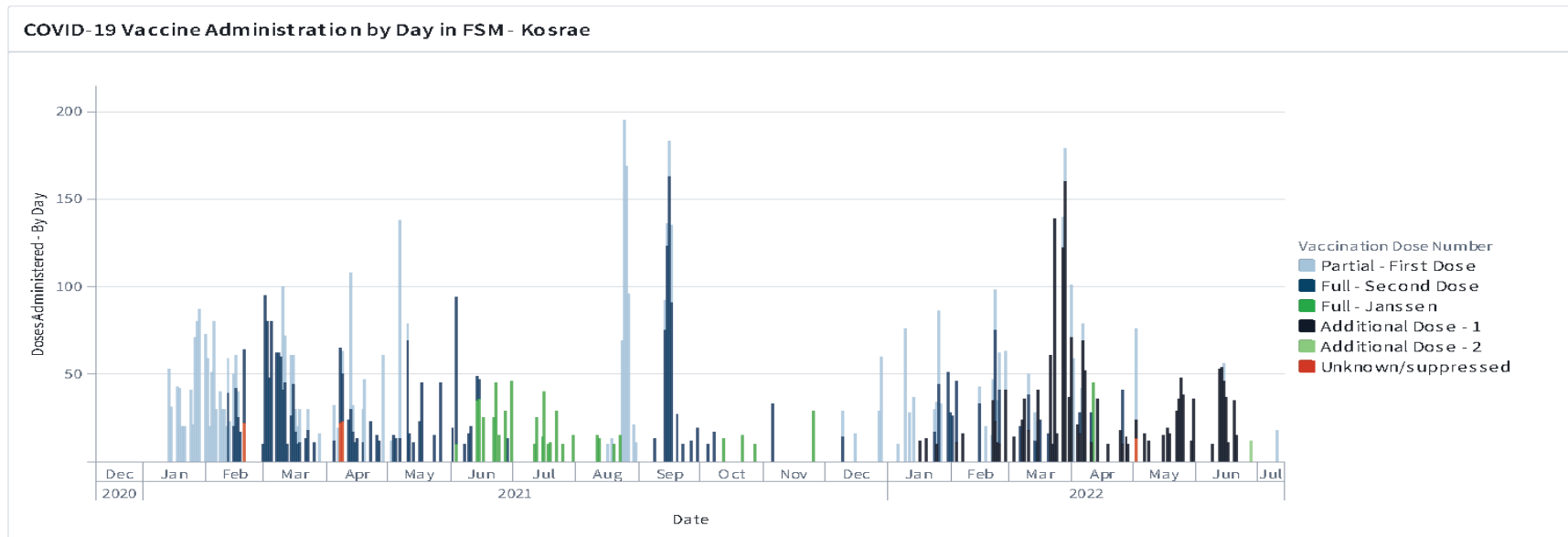

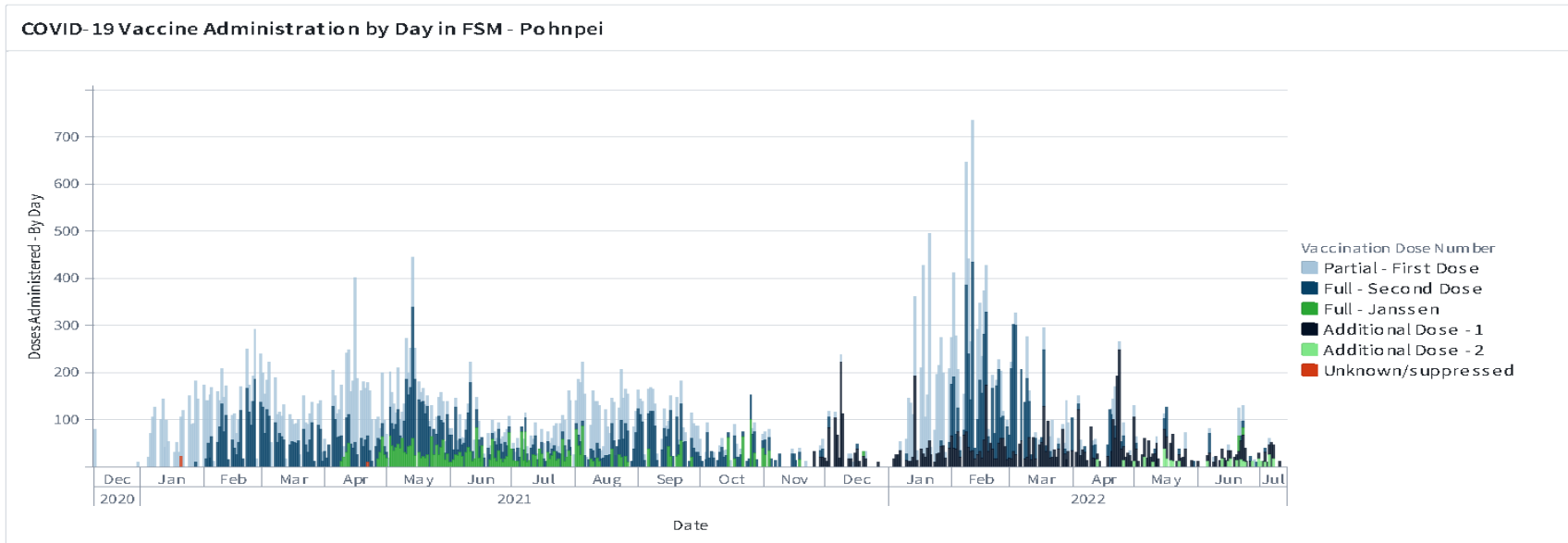

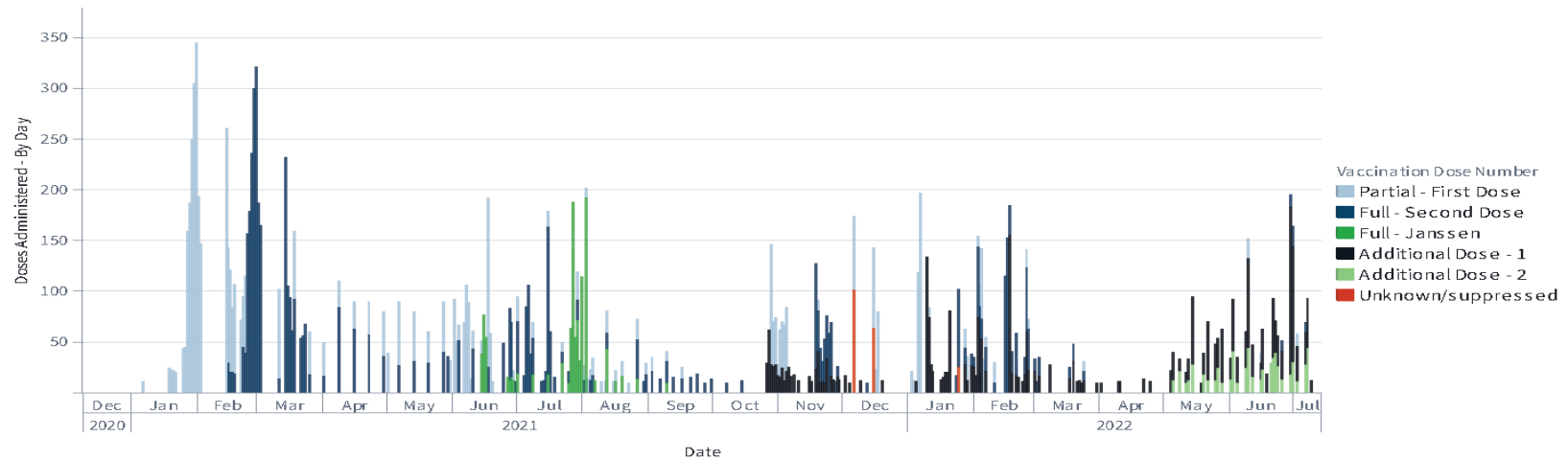

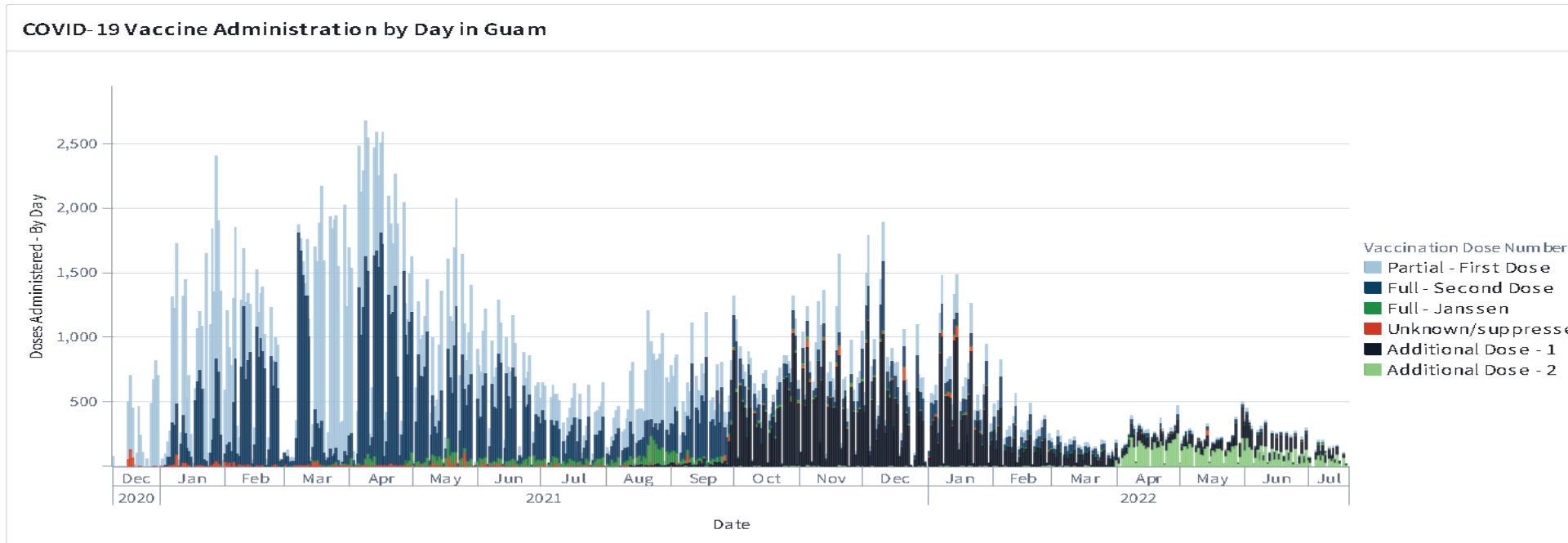
COVID-19 Vaccine Administration by Day in FSM - Yap

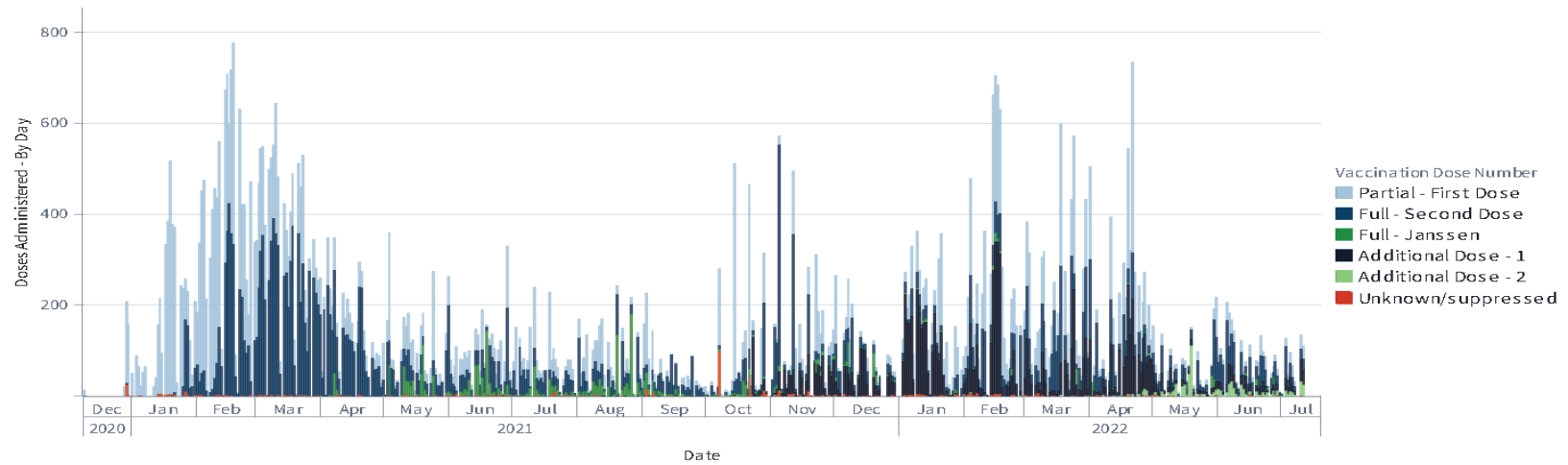

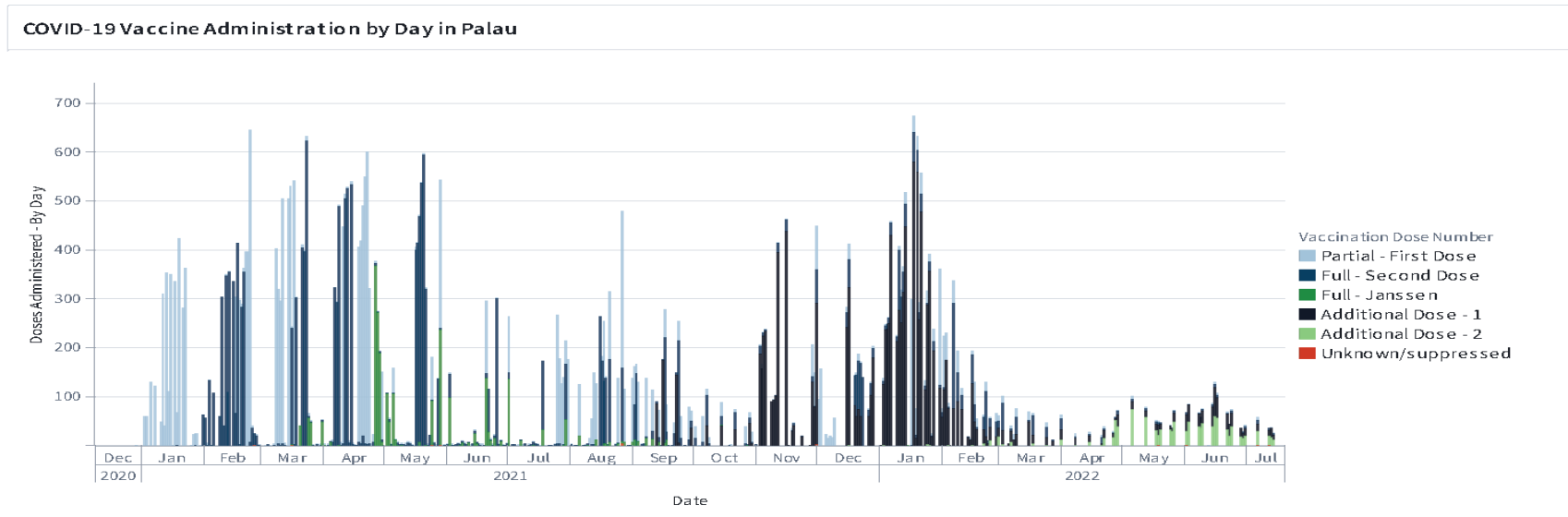
COVID-19 Vaccine Administration by Day in RMI
